(57) **CLAIM**

The ornamental design for a vehicle step, as shown and described.

DESCRIPTION

FIG. 1 is a front/left-side perspective view of the vehicle step according to the present design;

FIG. 2 is a front elevational view of the vehicle step of FIG. 1;

FIG. 3 is a top plan view of the vehicle step of FIG. 1;

FIG. 4 is a bottom plan view of the vehicle step of FIG. 1;

FIG. 5 is a rear elevational view of the vehicle step of FIG. 1;

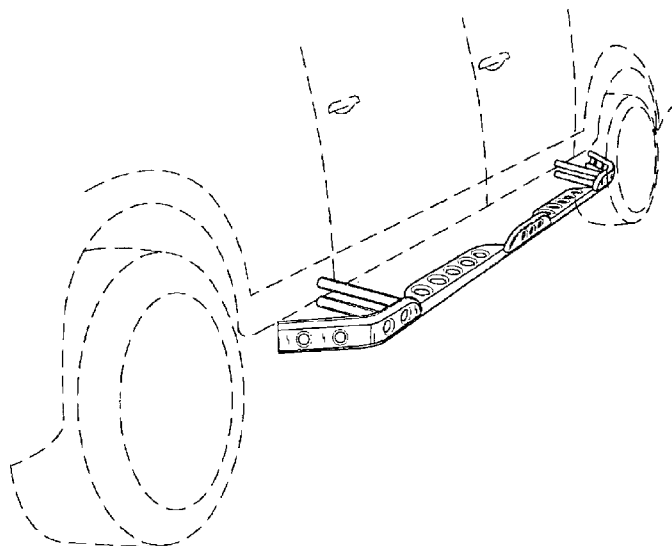
FIG. 6 is an enlarged right-side elevational view of the vehicle step of FIG. 1;

FIG. 7 is an enlarged left-side elevational view of the vehicle step of FIG. 1; and,

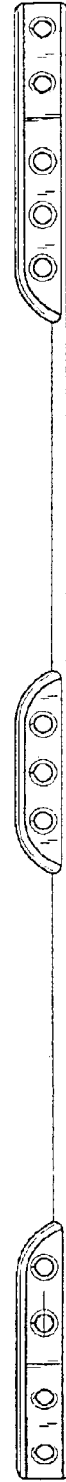
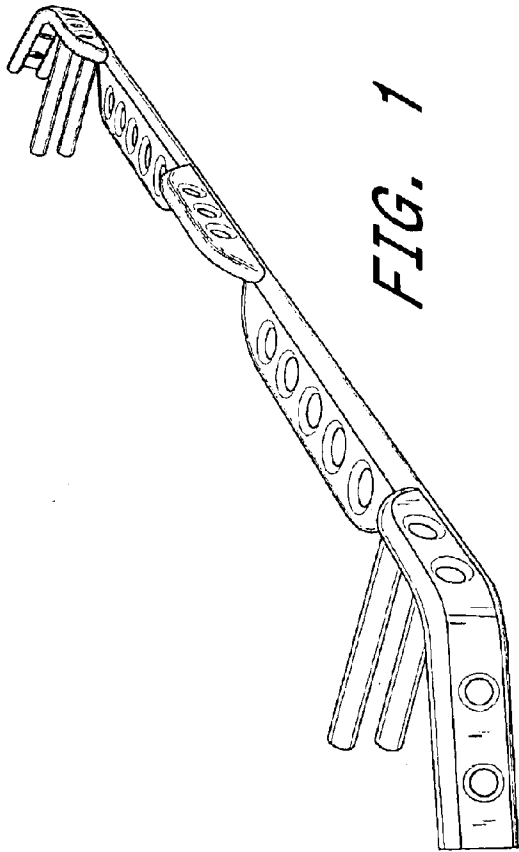

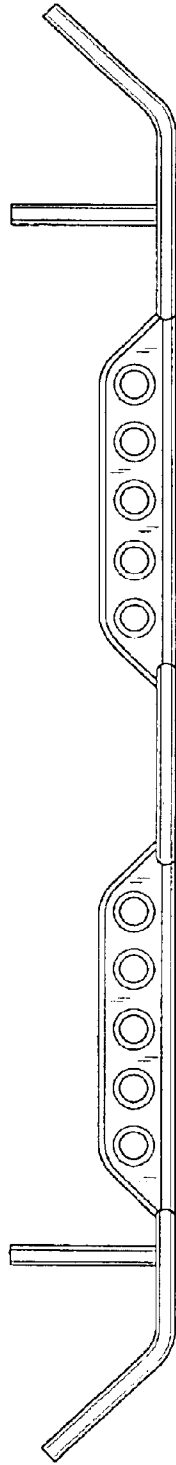

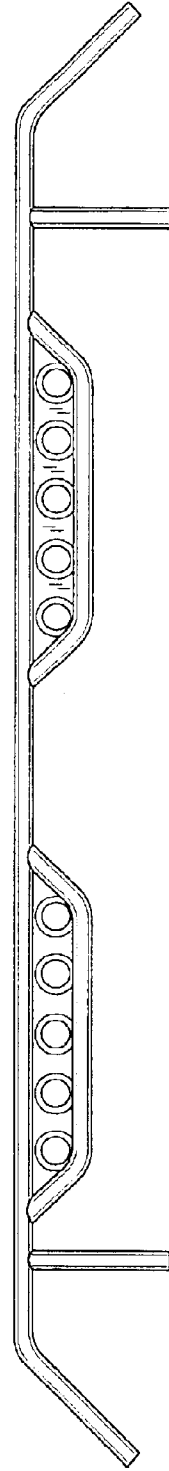

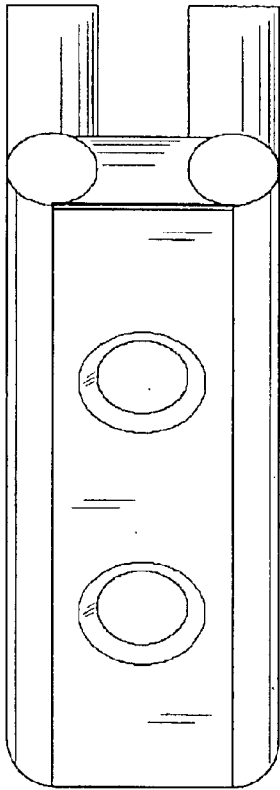

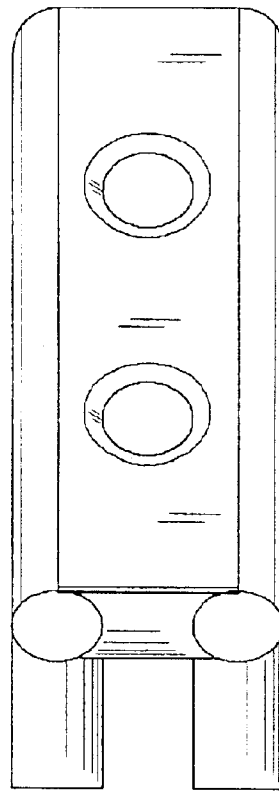

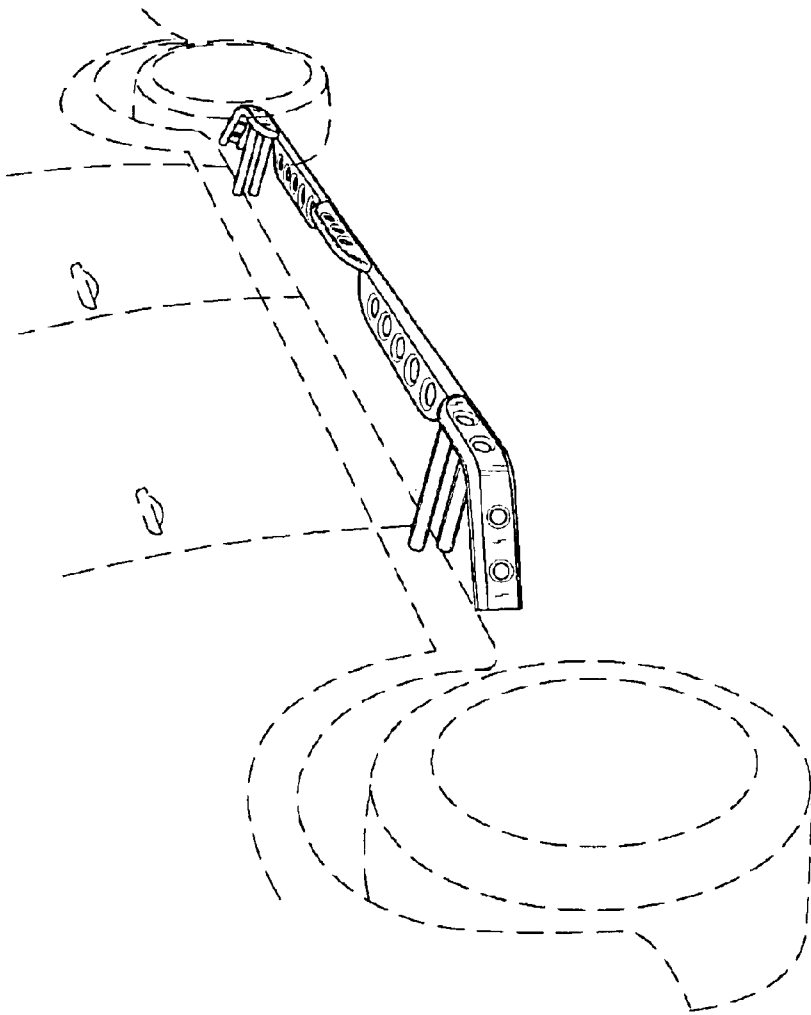
