(57) **CLAIM**

The ornamental design for a blank for making tissue container having an interior reflective surface, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a blank for making tissue container having an interior reflective surface showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear view thereof;


FIG. 4 is a front view thereof;










