(57) **CLAIM**

The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a garment that is in a laid-flat configuration showing the present design in a first configuration;

FIG. 2 is a front view of the garment of FIG. 1 showing the present design in a second configuration;

FIG. 3 is a lower front perspective view of FIG. 1 showing the present design in the first configuration;

FIG. 4 is a lower front perspective view of FIG. 2 showing the present design in the second configuration;

FIG. 5 is a back view of FIG. 1;

FIG. 6 is a left side view thereof;

FIG. 7 is a right side view thereof;

FIG. 8 is a top view thereof; and,

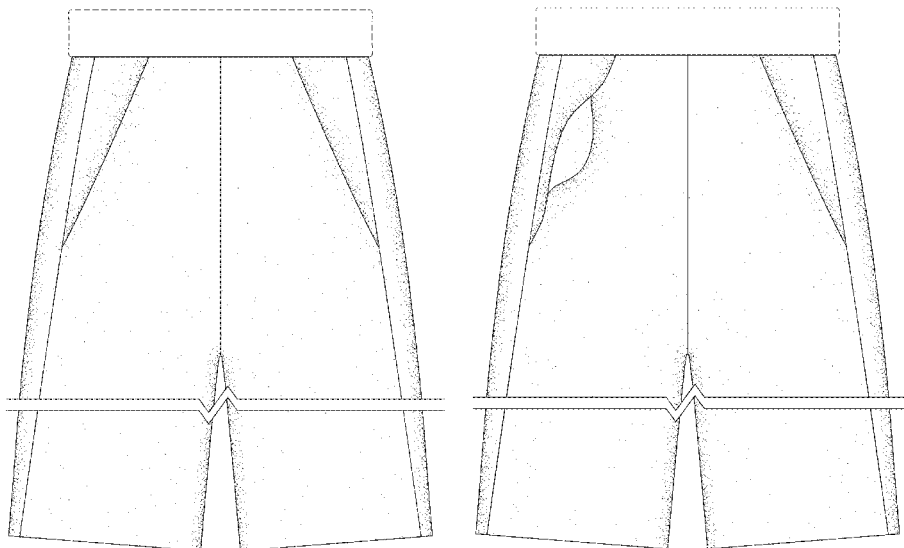
FIG. 9 is a bottom view thereof.

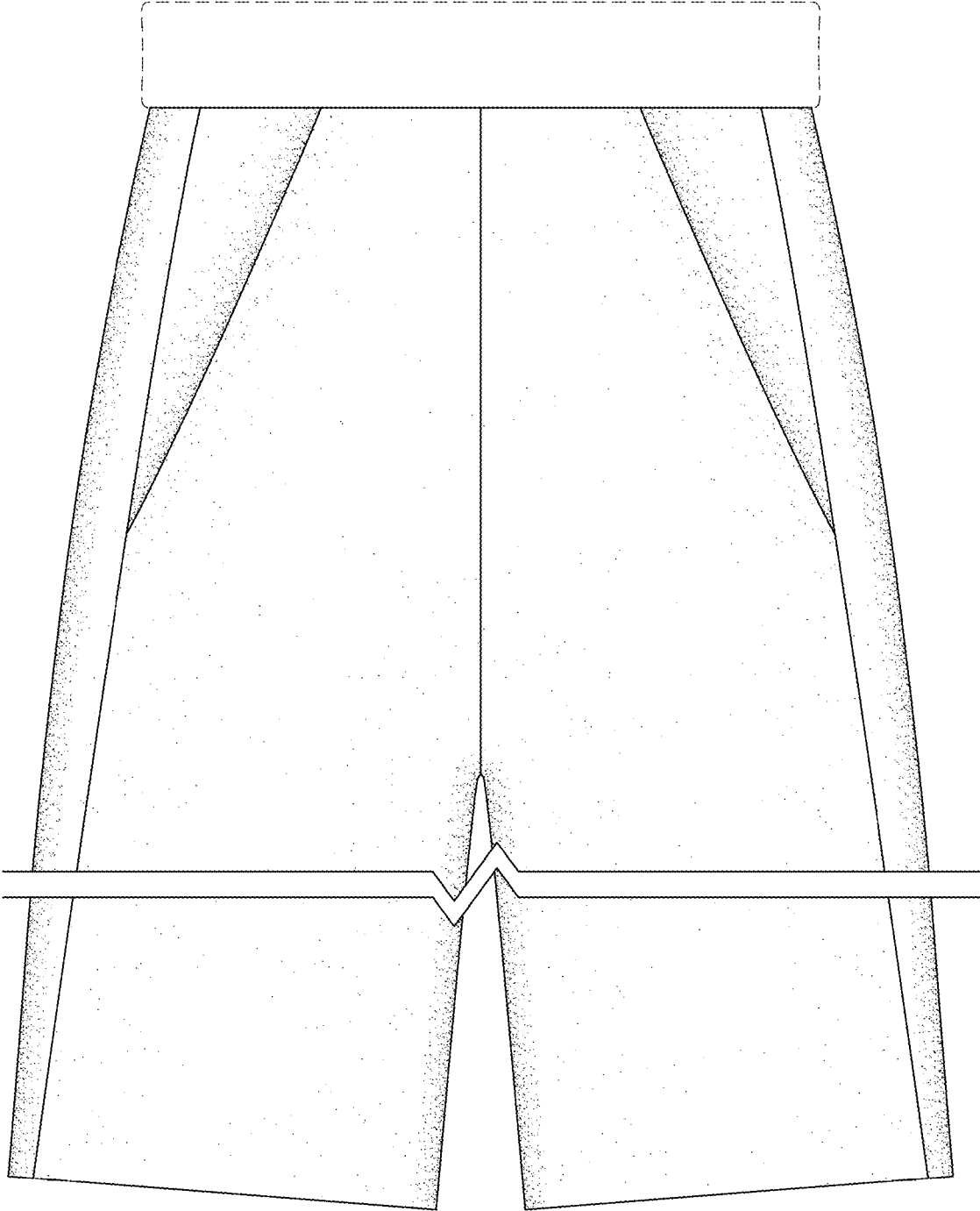

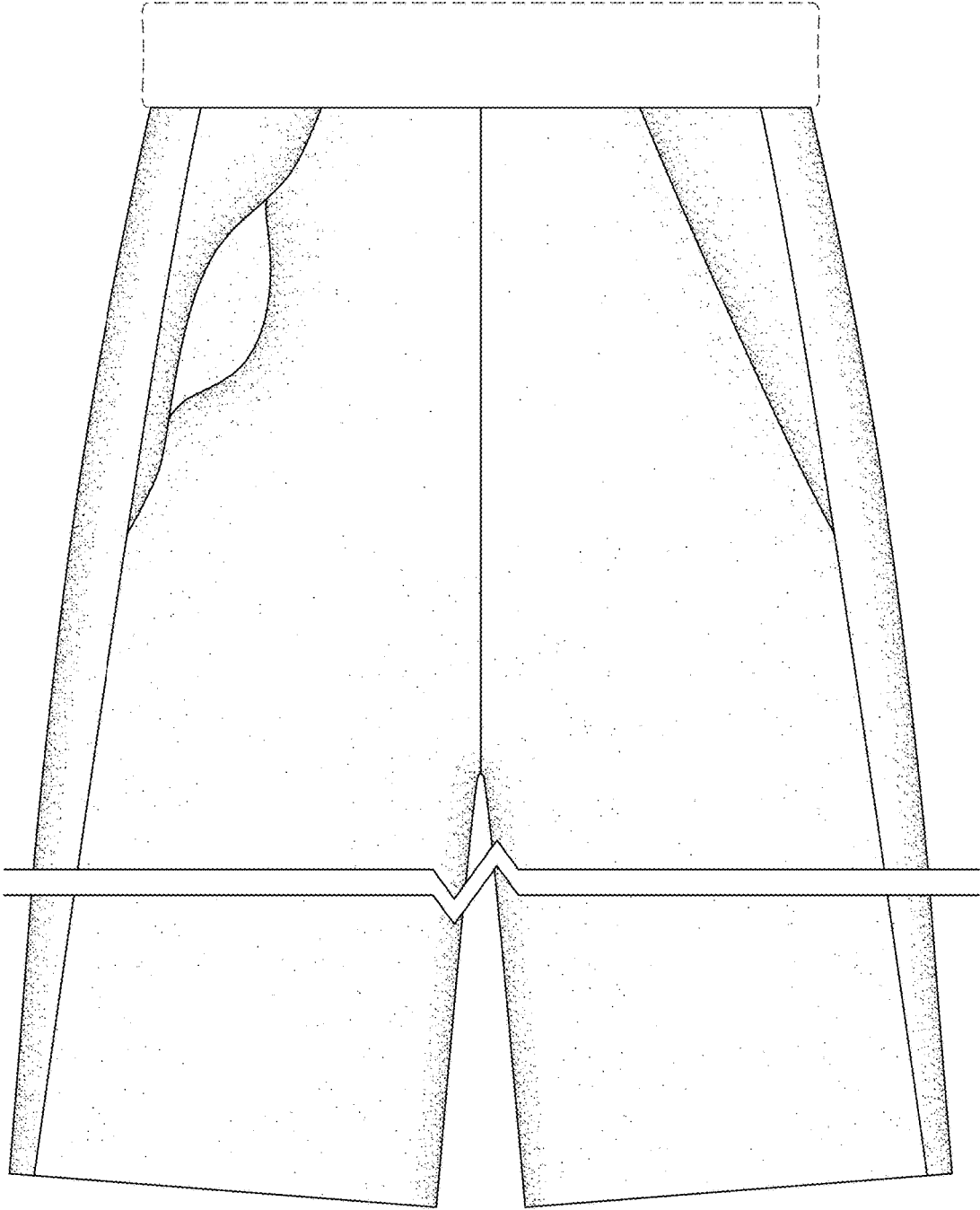

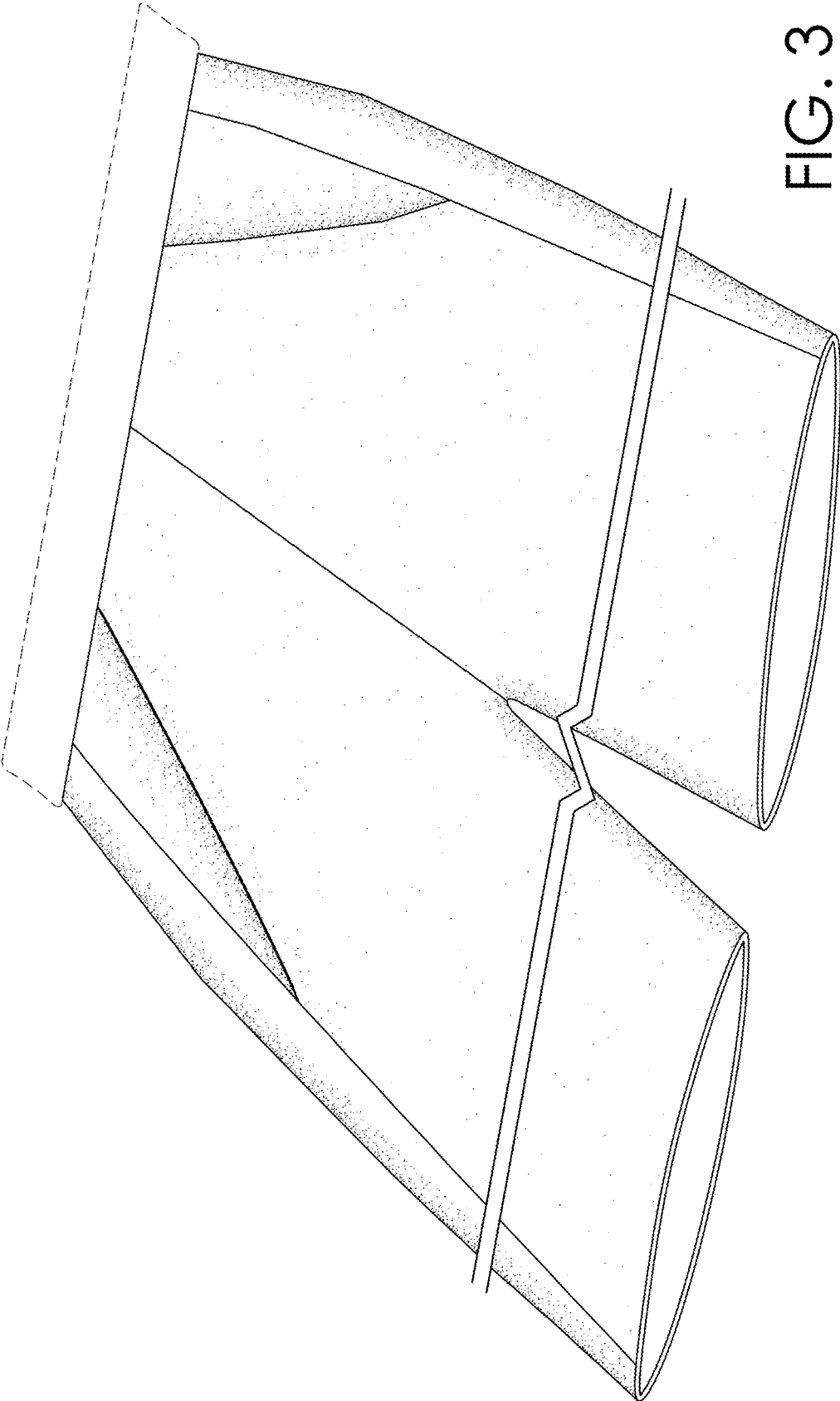

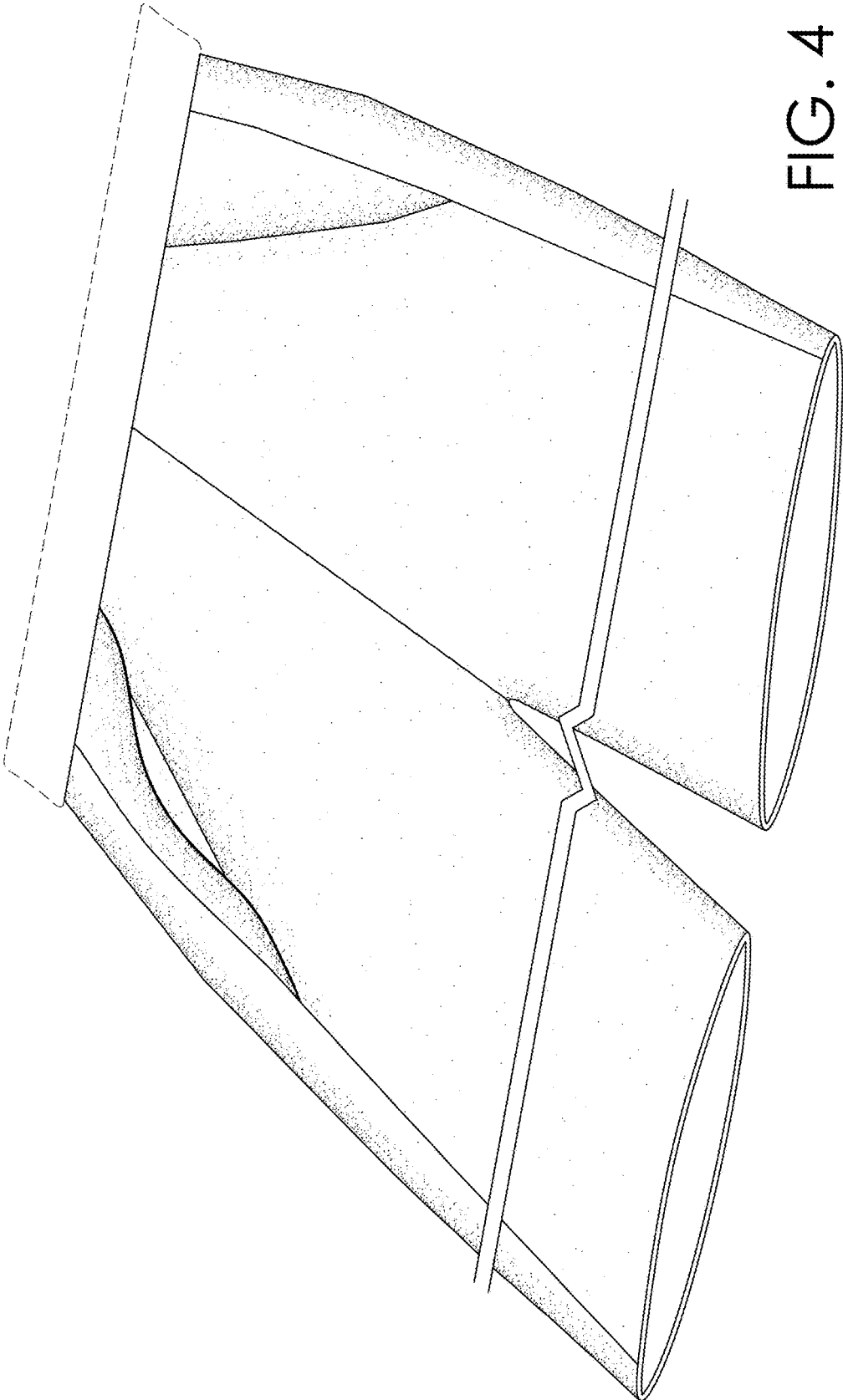

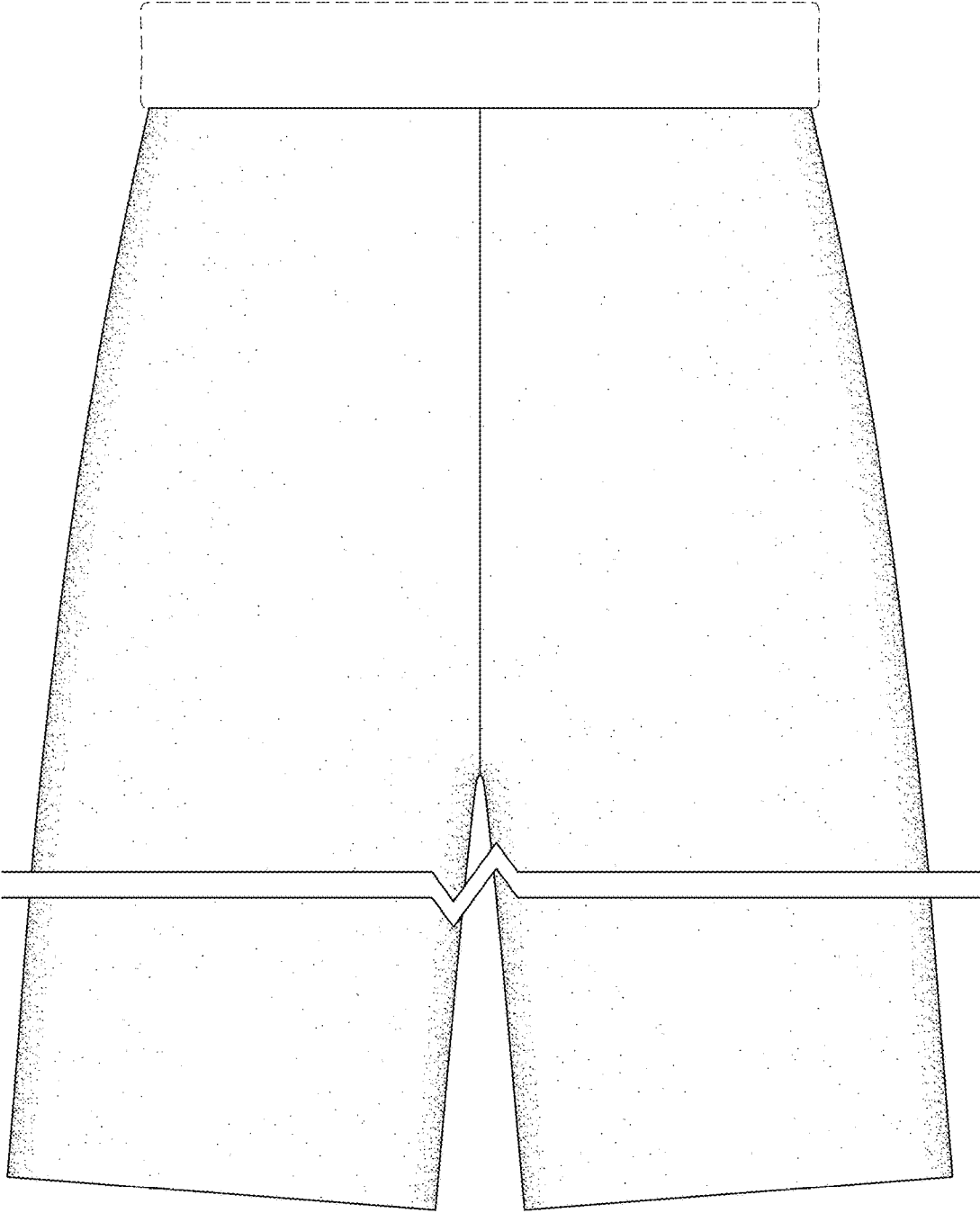

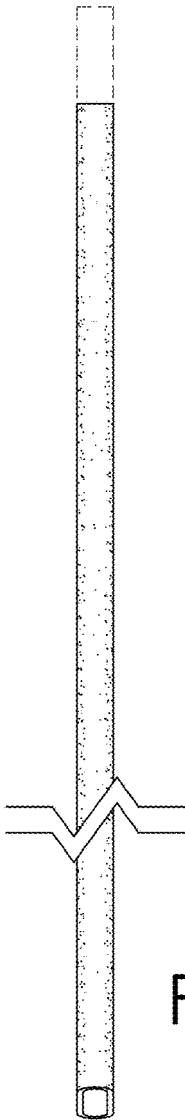

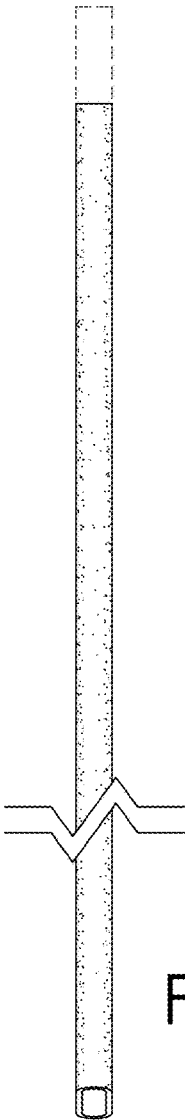

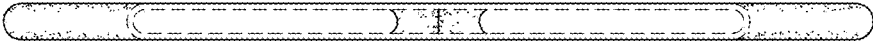

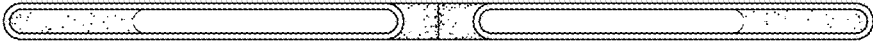
