(57) **CLAIM**

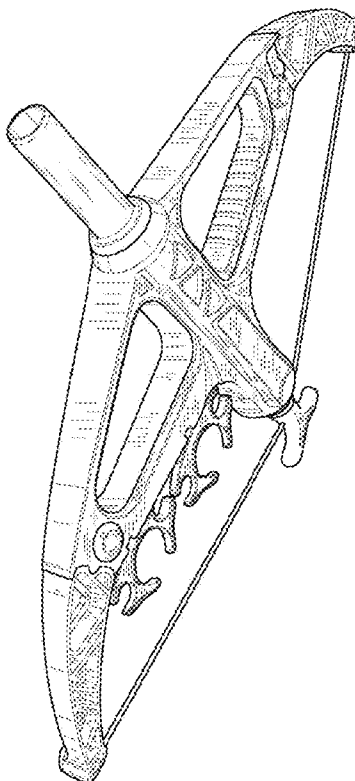
The ornamental design for a toy pneumatic launcher with bow configuration, as shown and described.

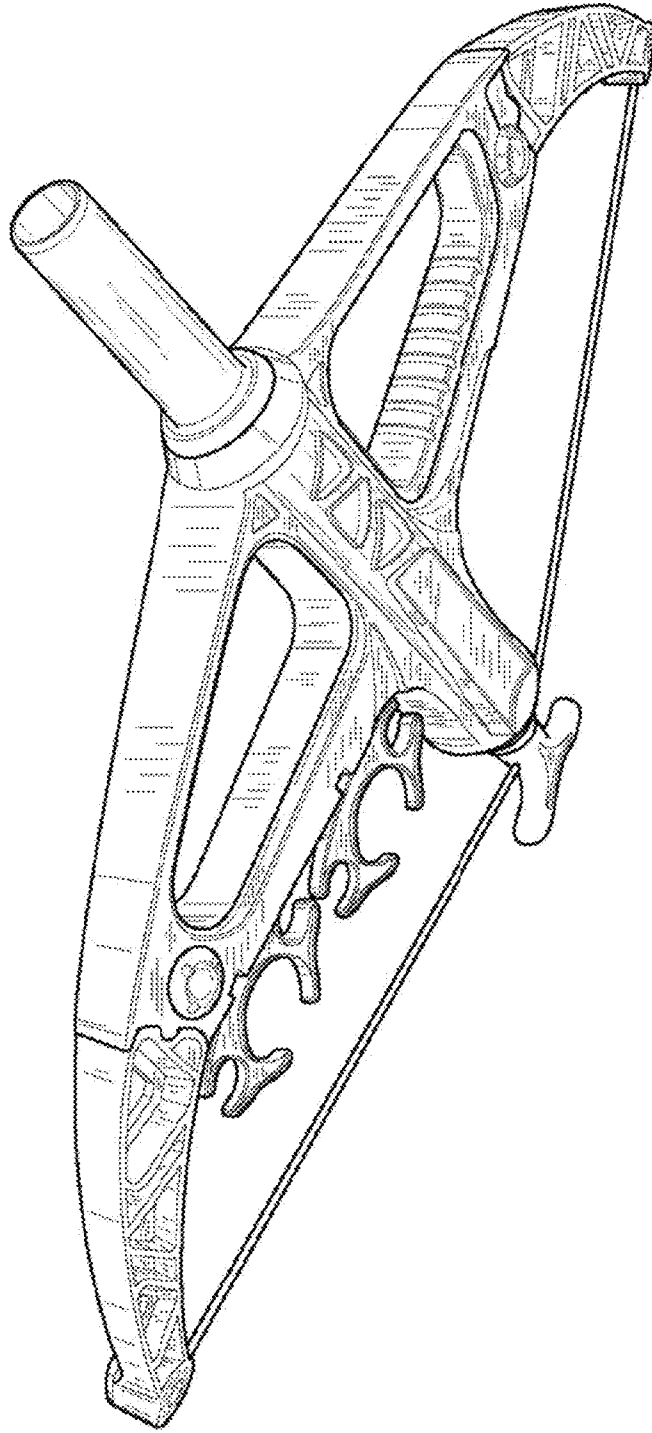

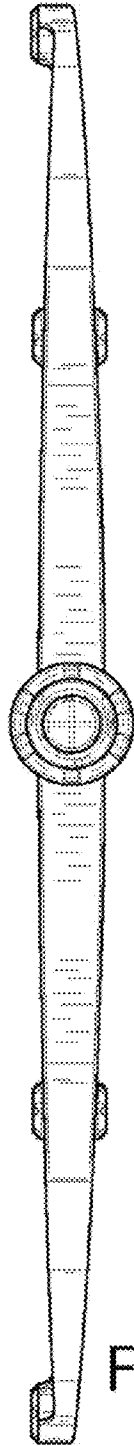

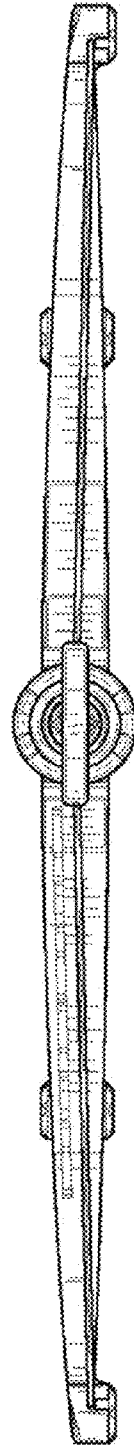

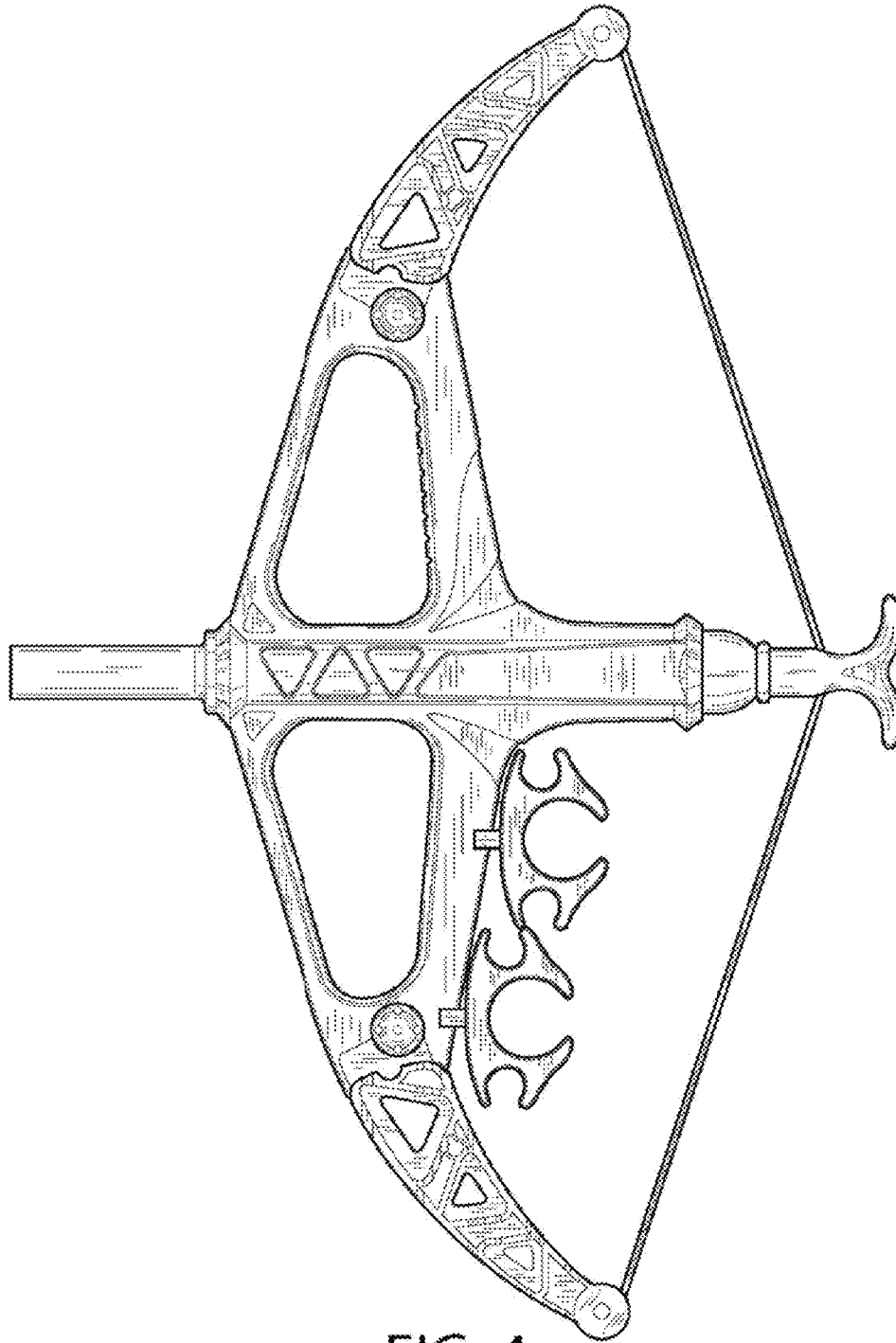

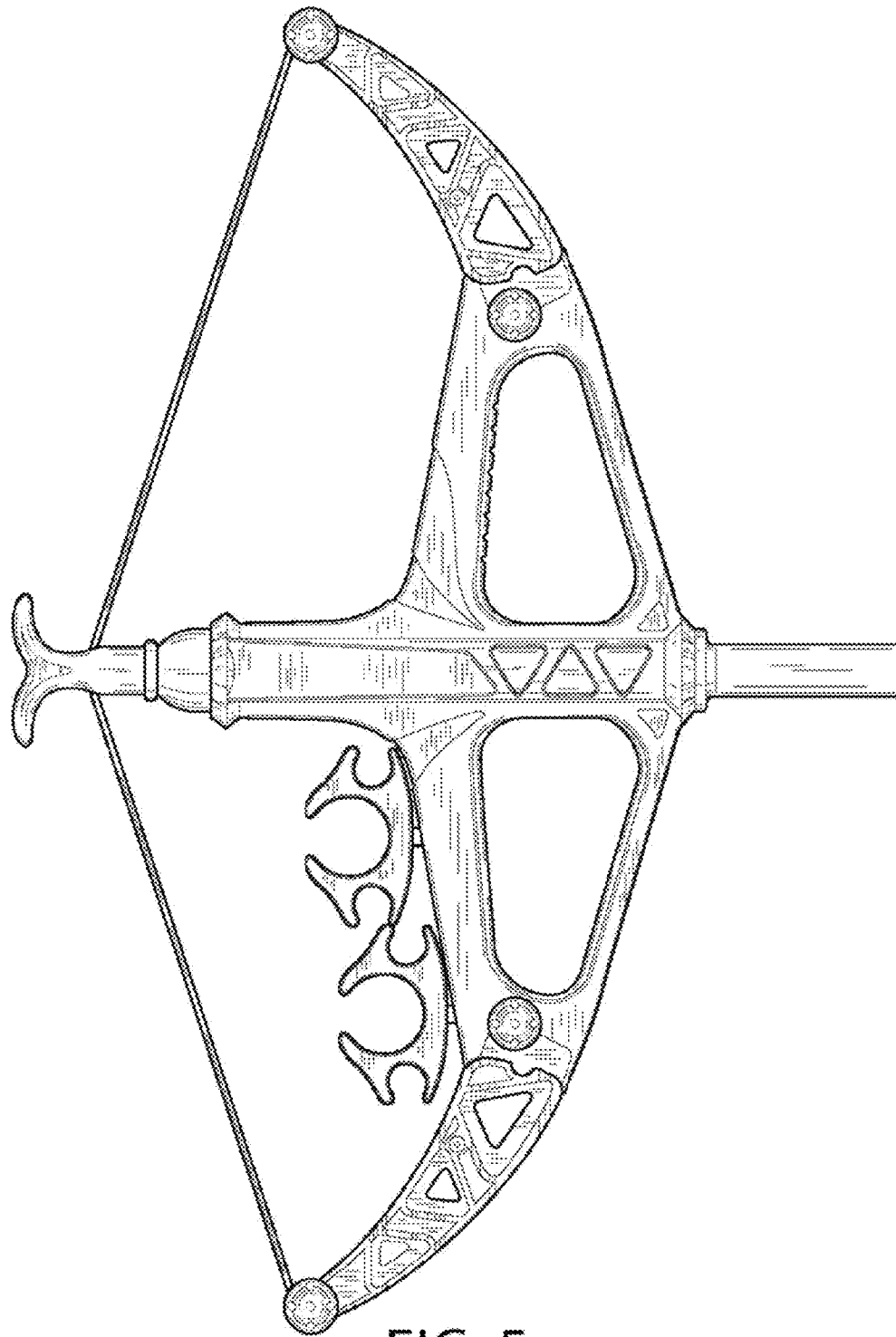

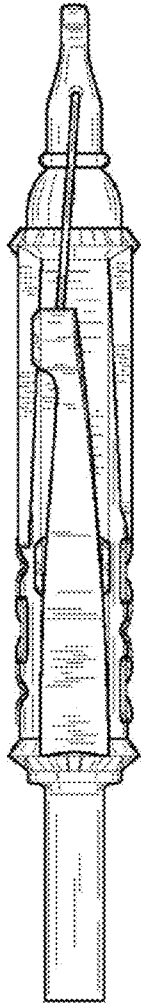

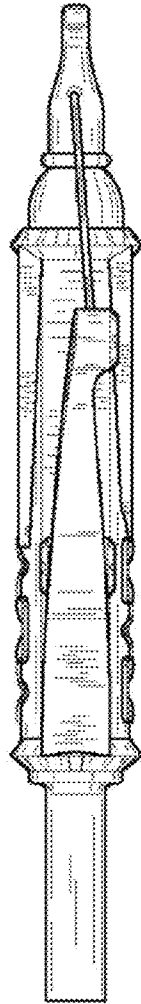
