FIG. 5 is a perspective view of a water bottle showing a second embodiment of our new design;

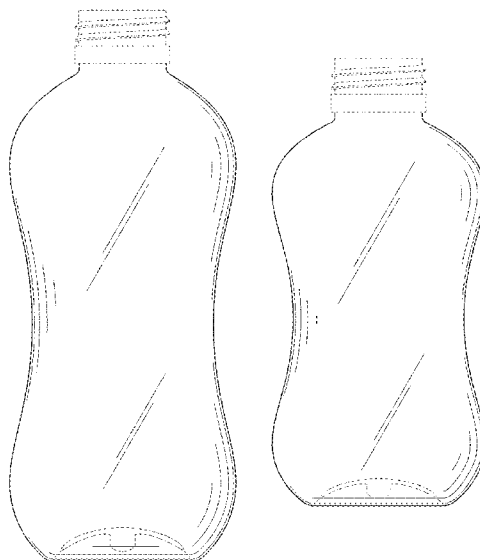
FIG. 6 is a side view of the second embodiment.

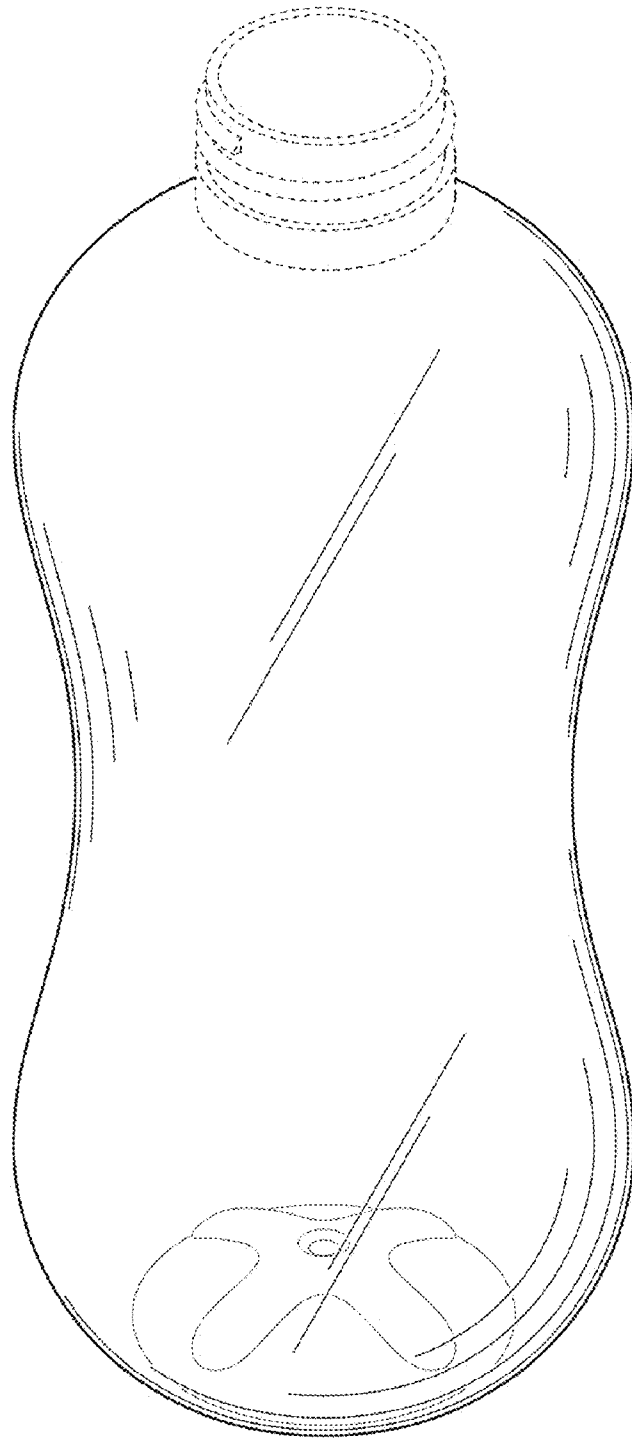

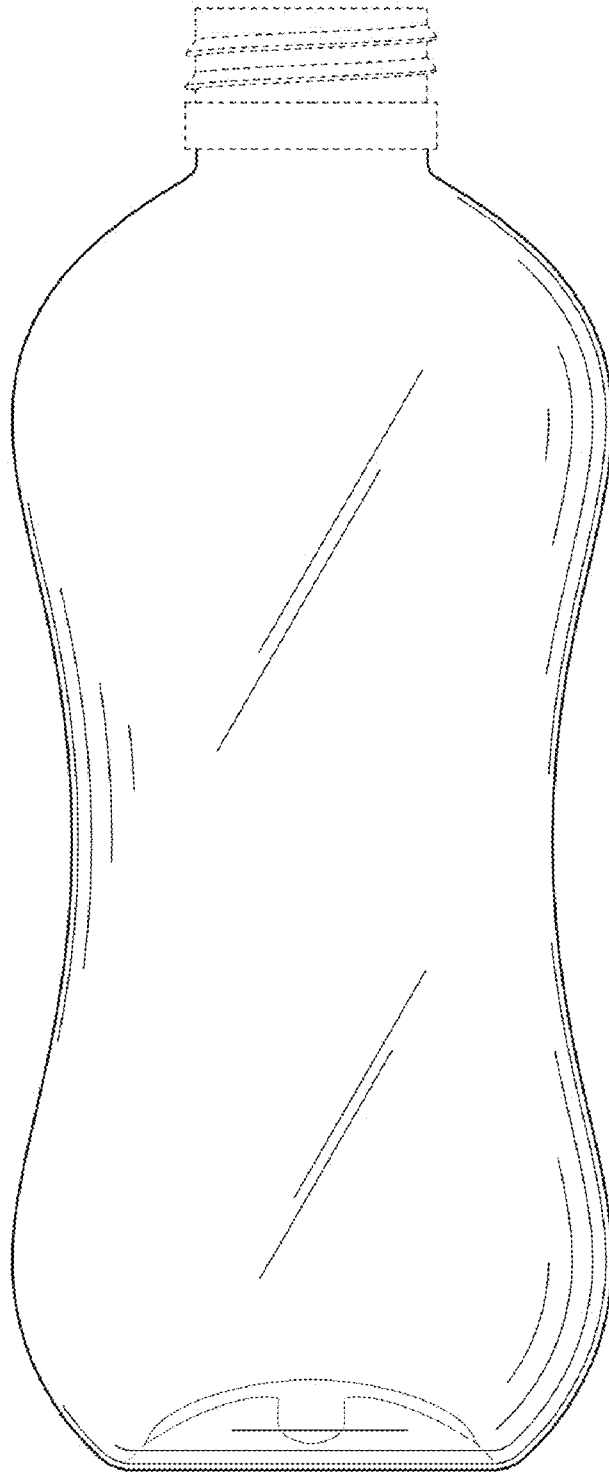

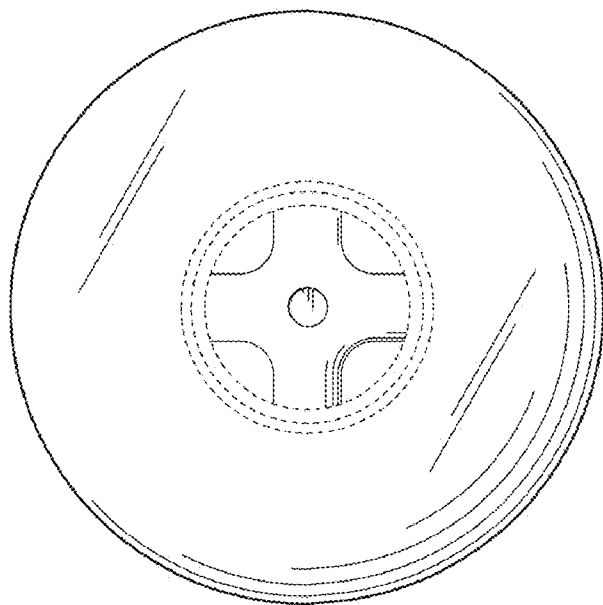

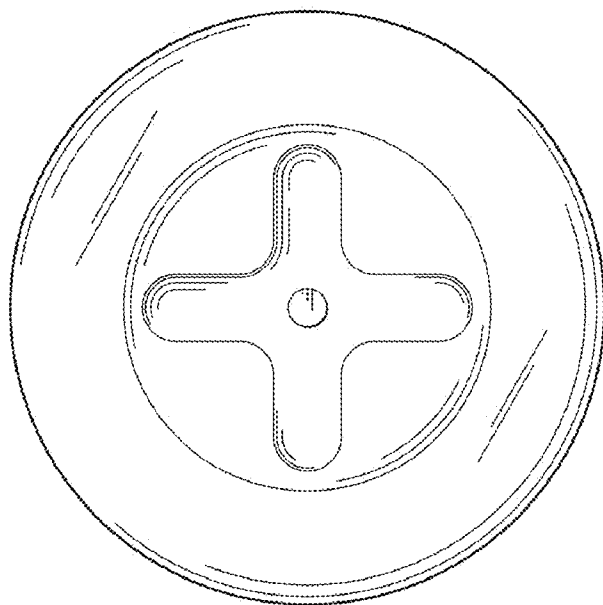

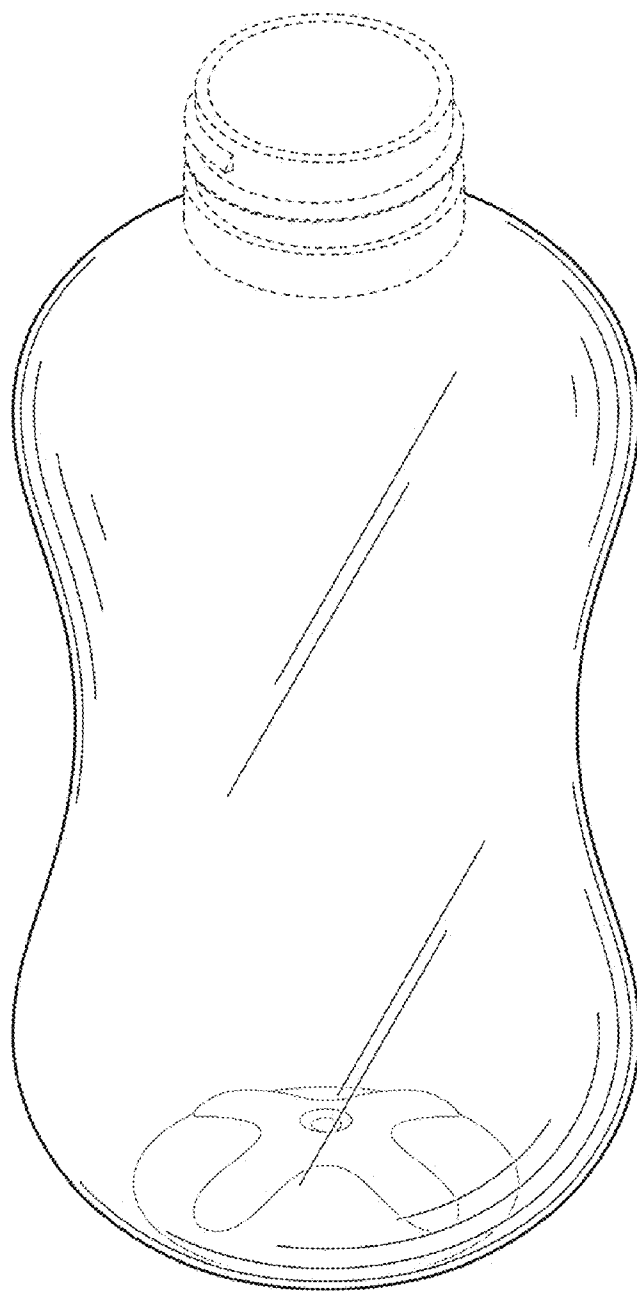

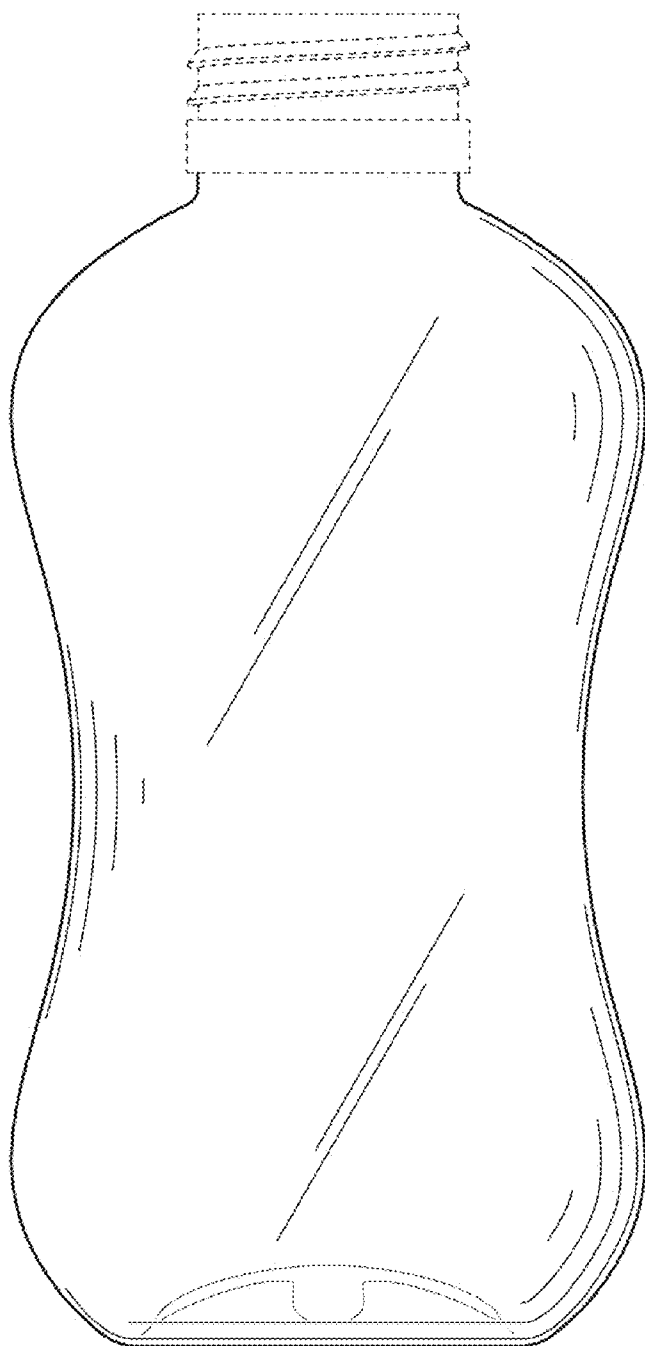

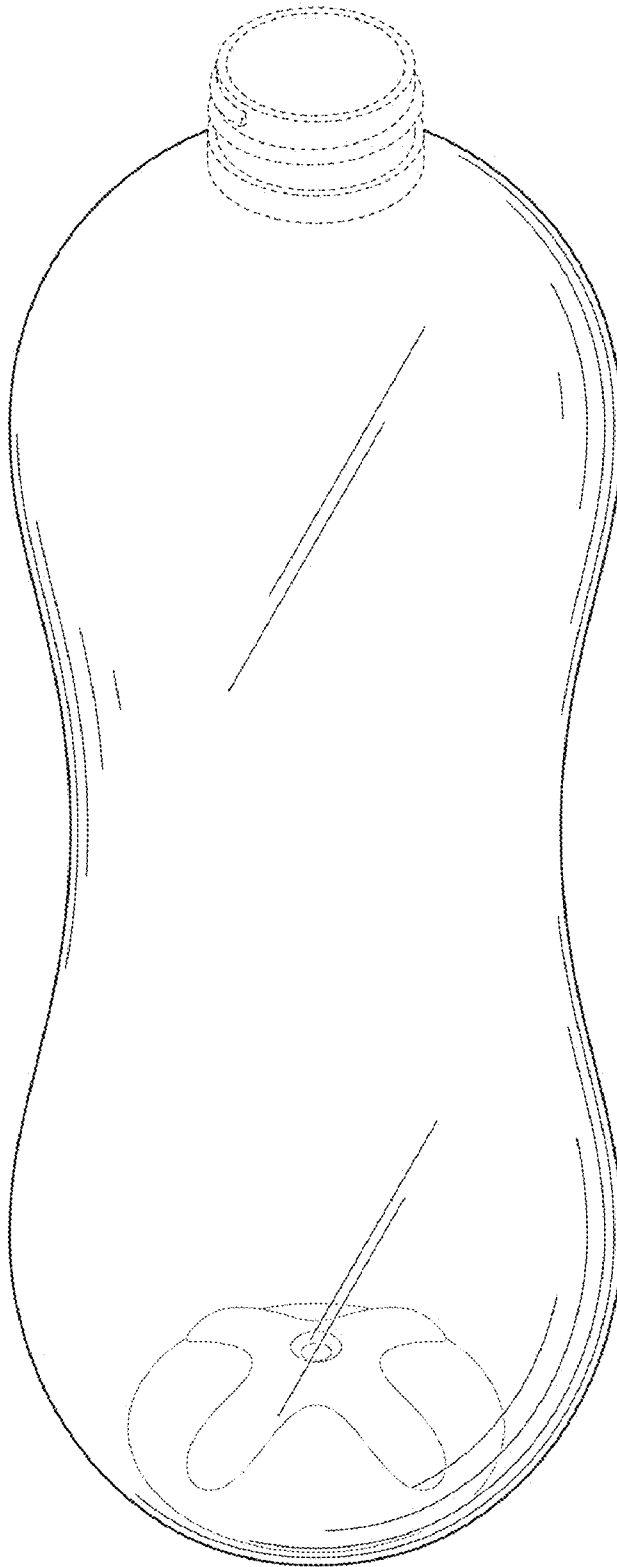

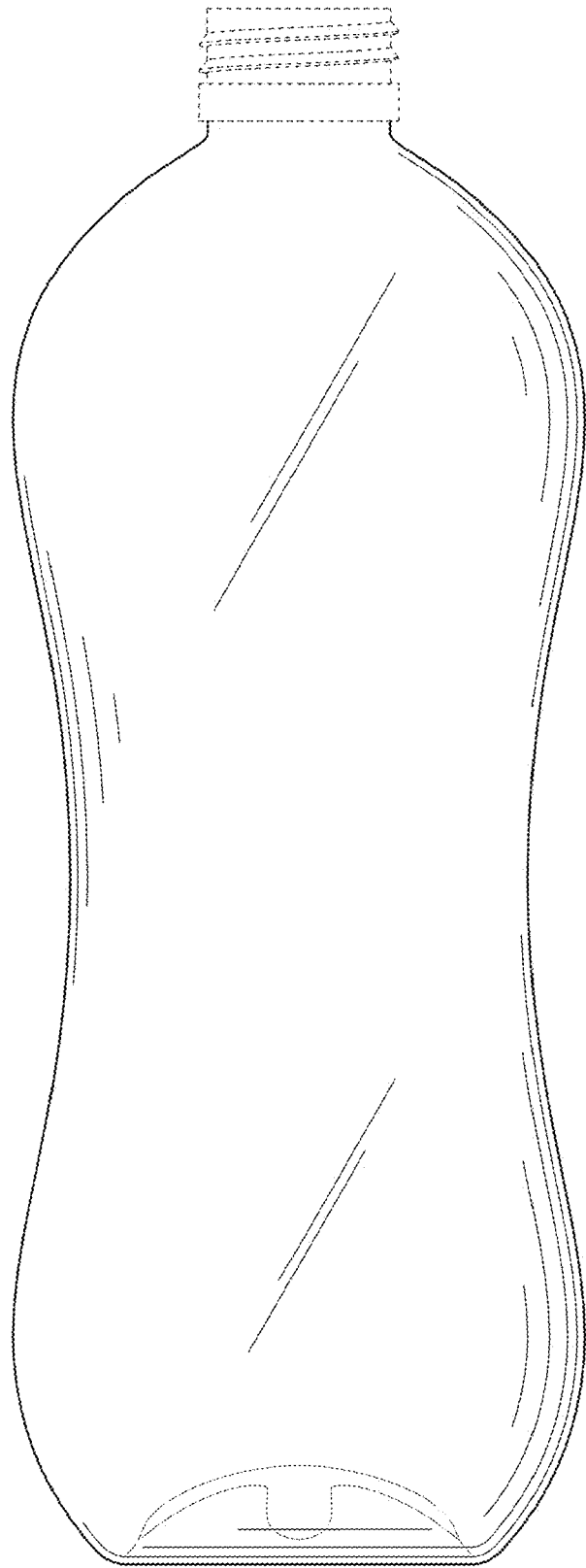
