

(57) Abstract: A method for generating refrigeration for cooling a product gas wherein a first or working gas undergoes a staged expansion to a first temperature and after warming undergoes a subsequent turboexpansion to a second higher temperature and both the expanded gas and the turboexpanded gas provide cooling to the product gas.
