

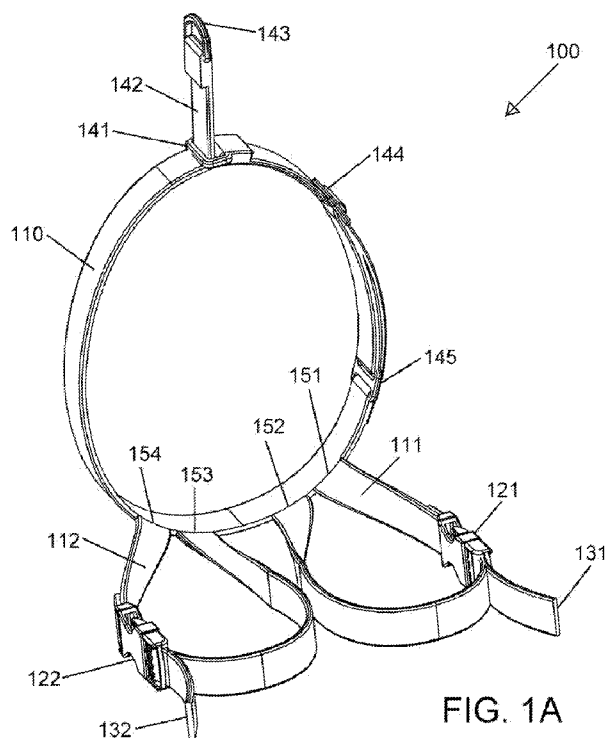

(54) Title: ANIMAL HARNESS



(57) Abstract: A harness for restraining an animal, particularly a dog, includes: a body loop to encircle a rear abdominal area of the animal, wherein the body loop comprises a connector to a leash to be held by a person; and at least one rear-leg loop to encircle a top area of a rear leg of the animal; wherein the body loop comprises a lasso mechanism to create a lasso effect upon an outburst of said animal.
