(57) **CLAIM**

The ornamental design for a two-bar cup, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two-bar cup of my design; FIG. 2 is a front view of the cup of FIG. 1, the back view being identical to the front view;

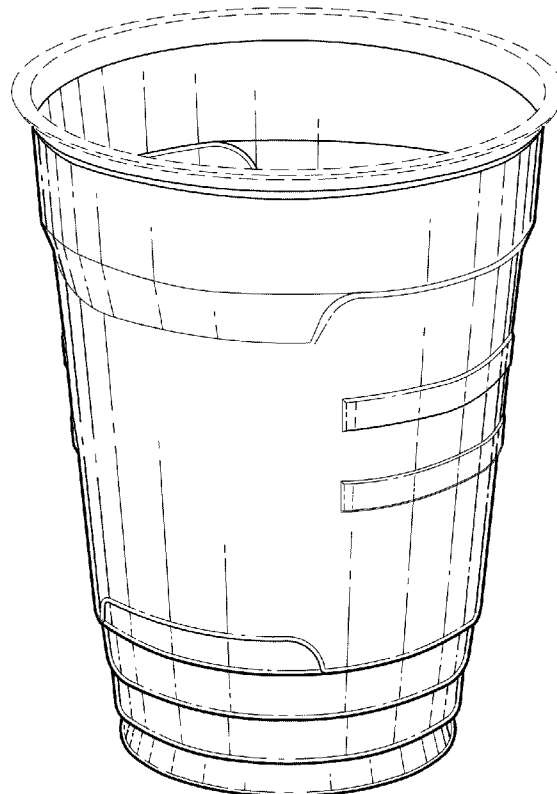
FIG. 3 is a right side view of the cup of FIG. 1, the left side view being identical to the right side view;

FIG. 4 is a top view of the cup of FIG. 1; and,

FIG. 5 is a bottom view of the cup of FIG. 1.

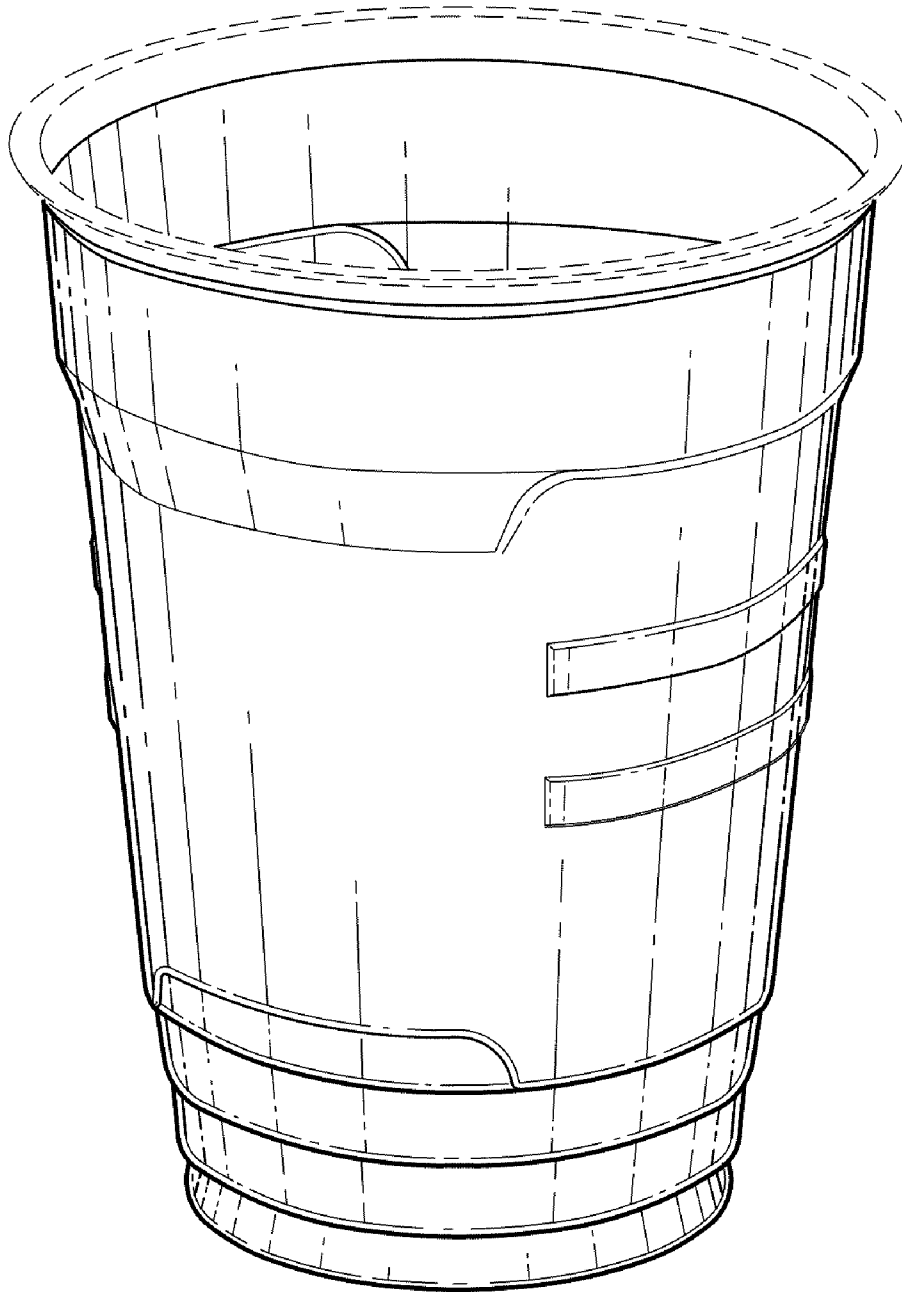

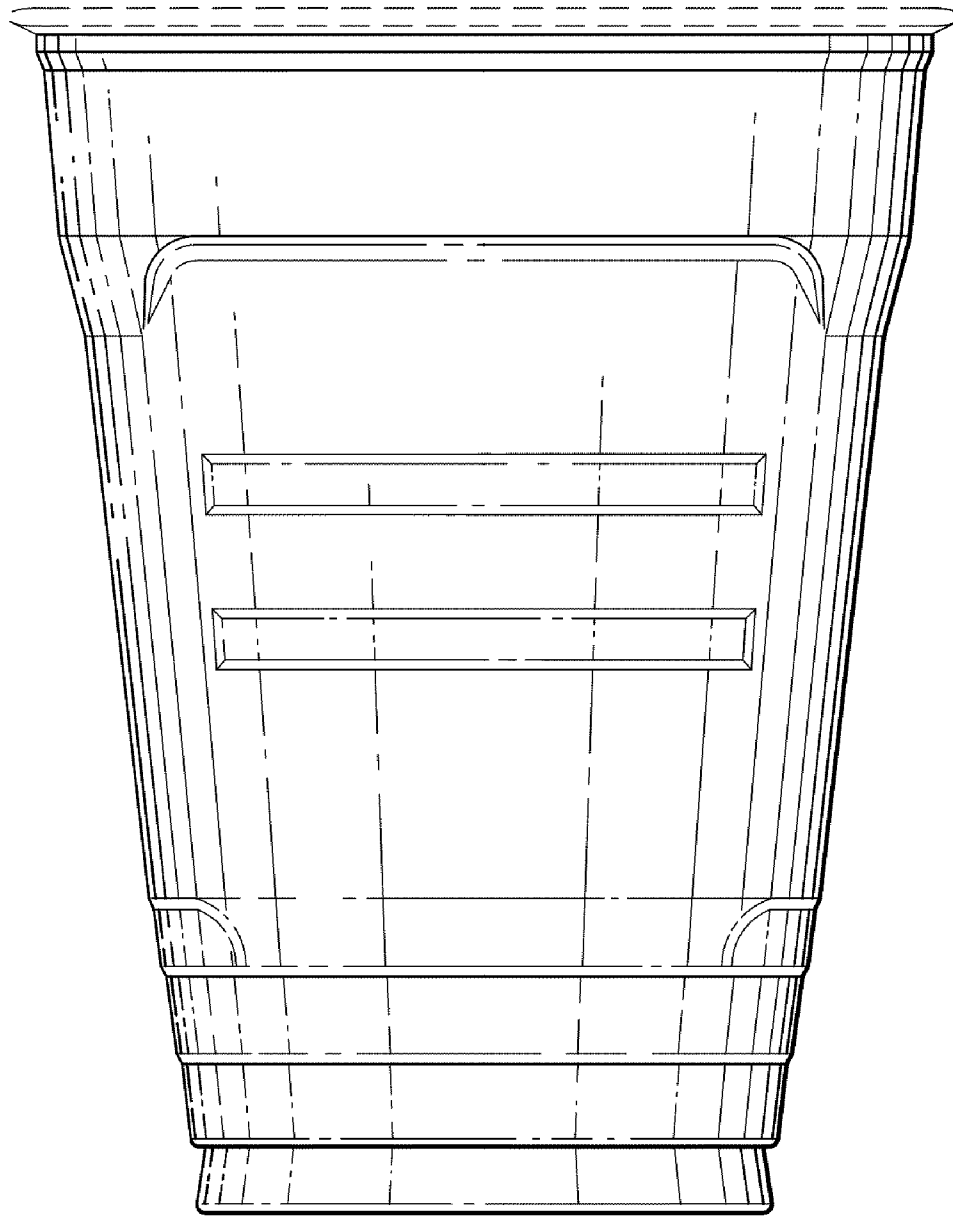

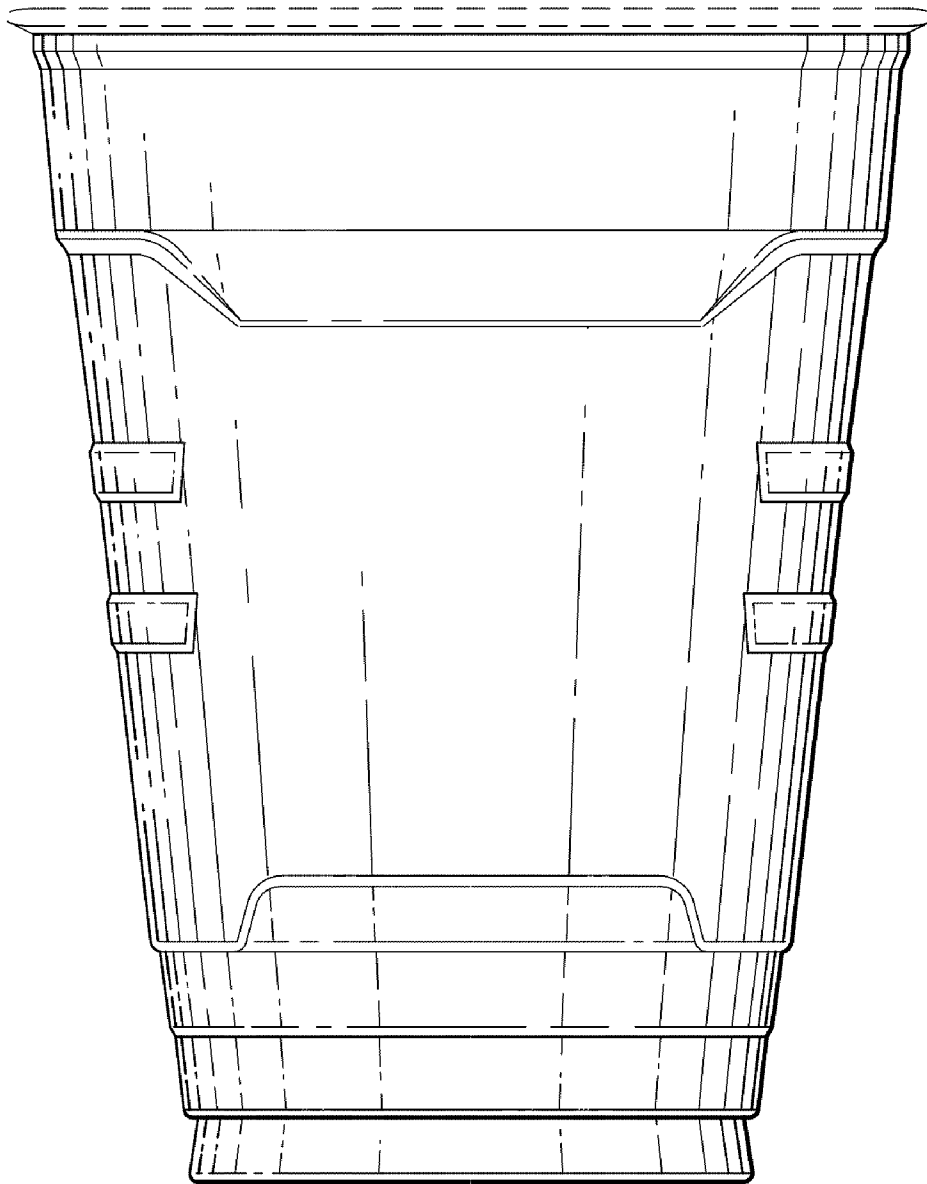

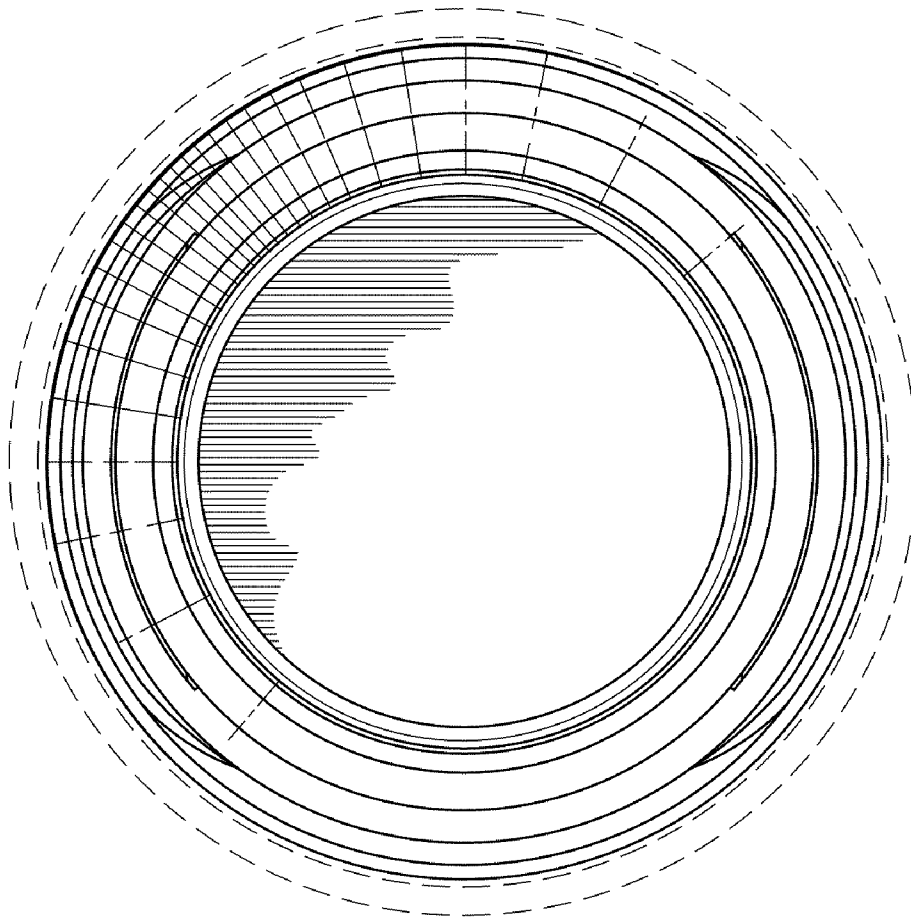

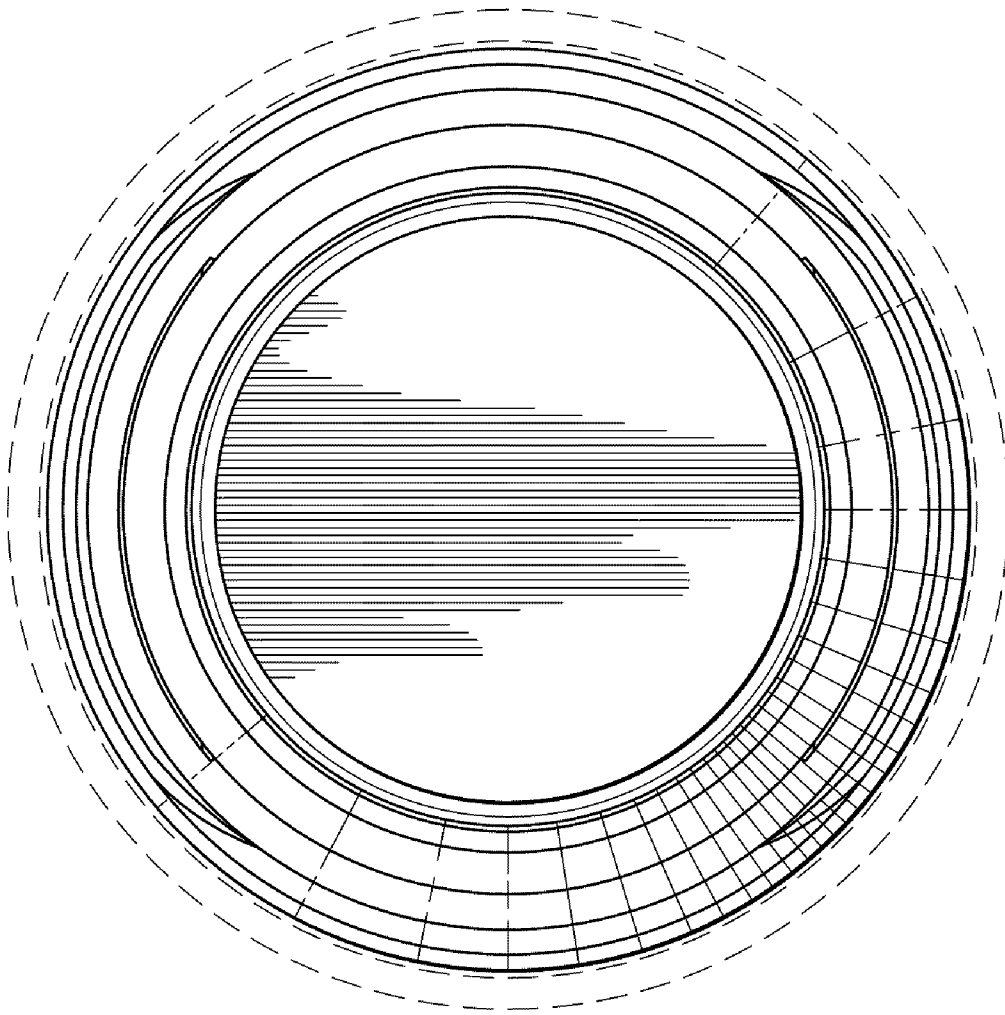
