(57) **CLAIM**

The ornamental design for a portion of a display panel with an animated computer icon, substantially as shown and described.

DESCRIPTION

FIG. 4 is a fourth image of the portion of the display panel with an animated computer icon.


FIG. 5 is a fifth image of the portion of the display panel with an animated computer icon; and,












