(57) **CLAIM**

The ornamental design for combined necklace and ear-
phone, as shown and described.

DESCRIPTION

FIG. 1 shows a top and front perspective view of the
combined necklace and earphone with the earphone sepa-
rated.

FIG. 2 shows a bottom and rear perspective view thereof.

FIG. 3 shows a front elevation view thereof, the rear
elevation view being a mirror image thereof.

FIG. 4 shows a left side elevation view thereof.

FIG. 5 shows a right side elevation view thereof.

FIG. 6 shows a bottom plan view thereof.

FIG. 7 shows a top plan view thereof.

FIG. 8 shows a bottom and rear perspective view of the
combined necklace and earphone with the earphones mag-
netically attached forming a necklace.

FIG. 9 shows a bottom and rear view thereof.

FIG. 10 shows a front side elevation view thereof, the rear
side elevation view being a mirror image thereof.

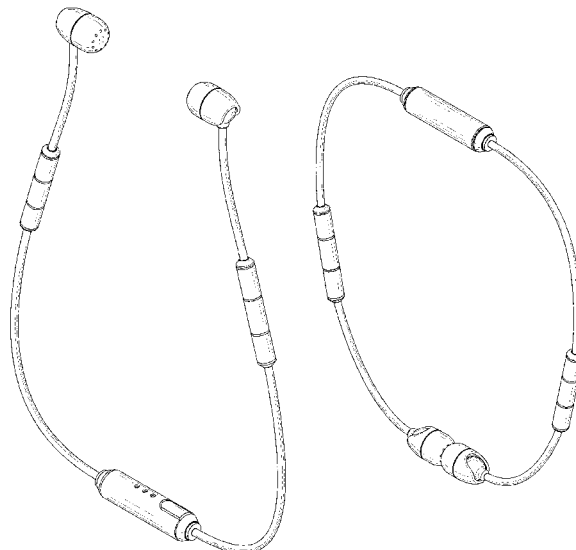
FIG. 11 shows a left side elevation view thereof.

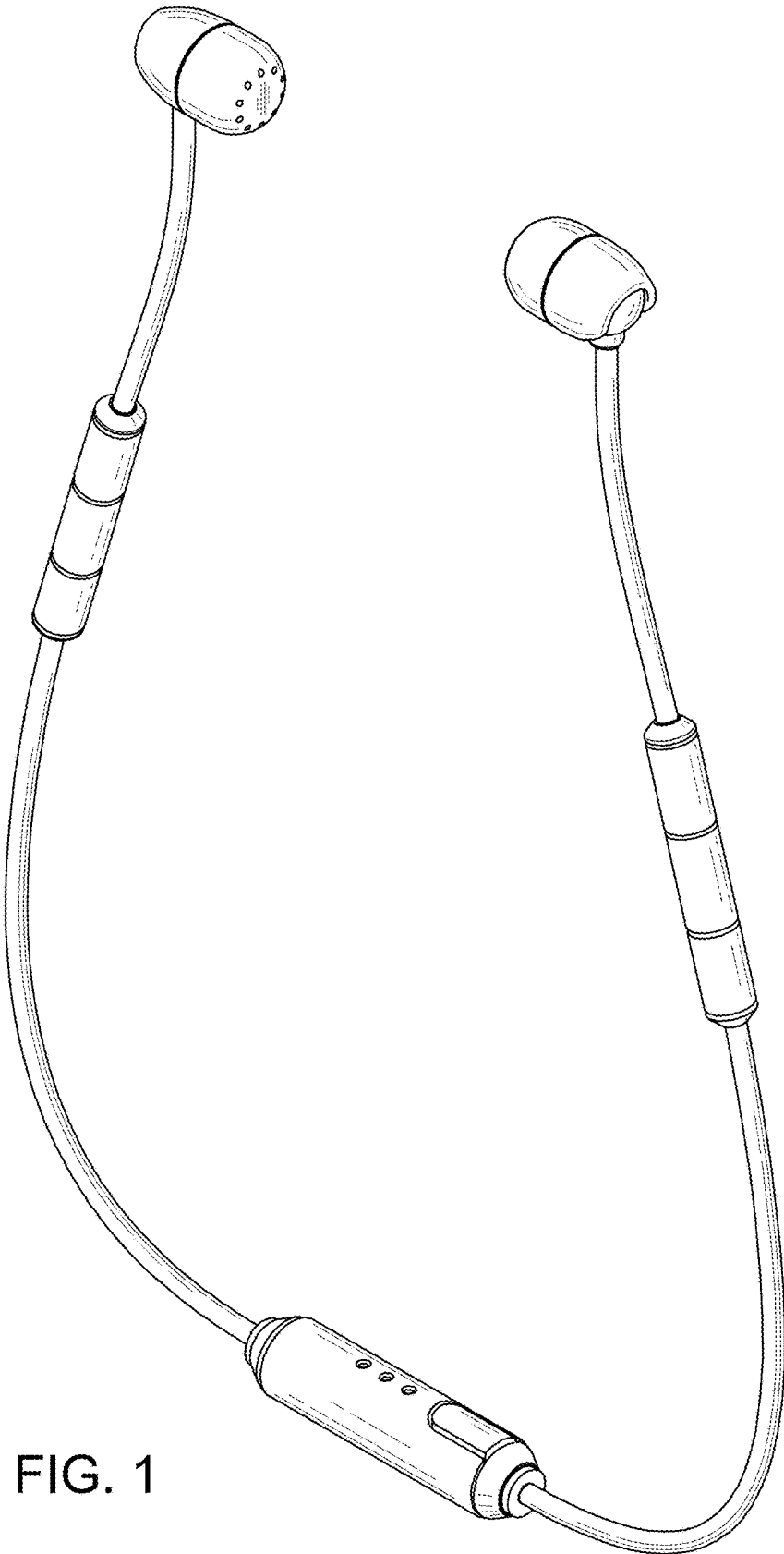

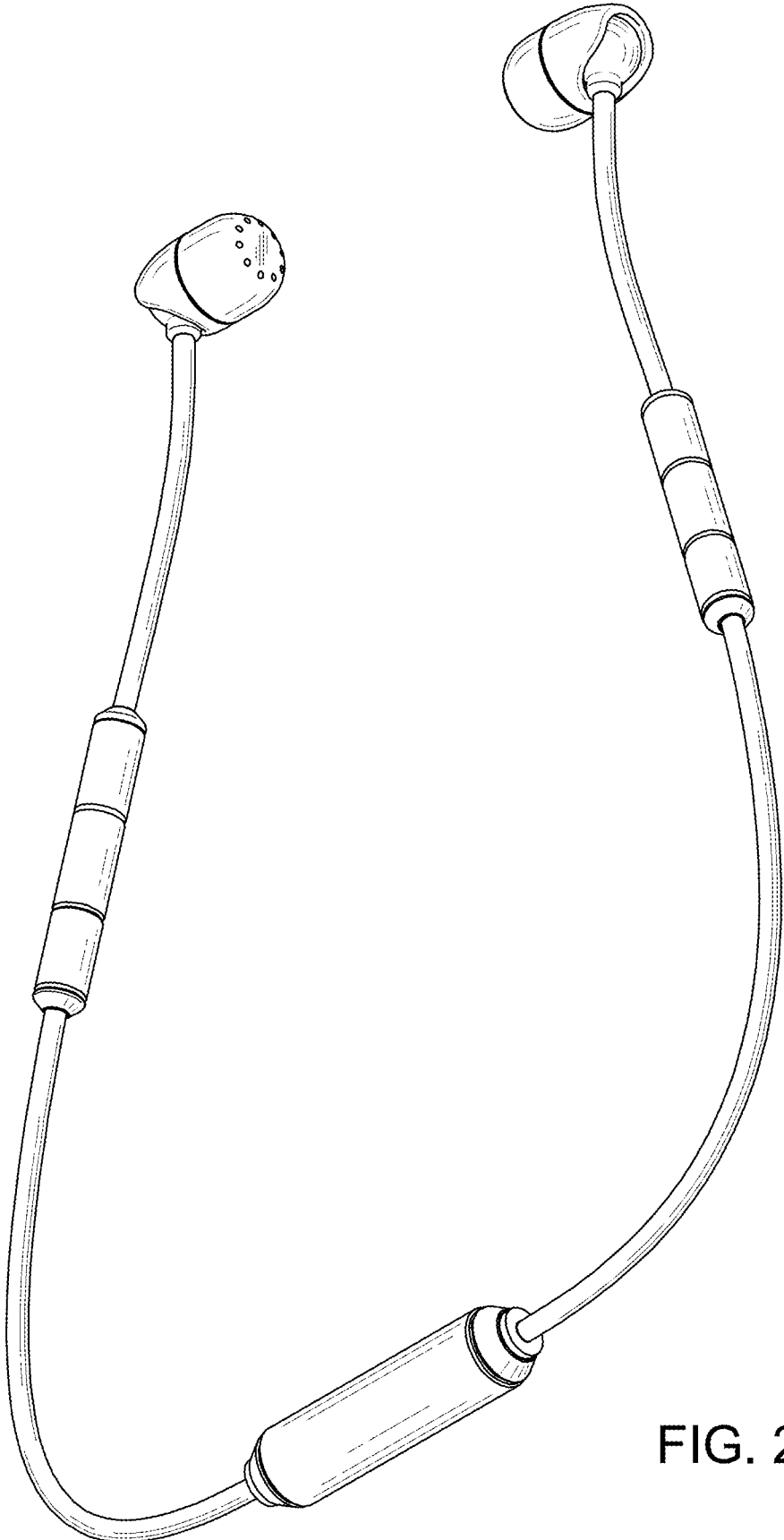

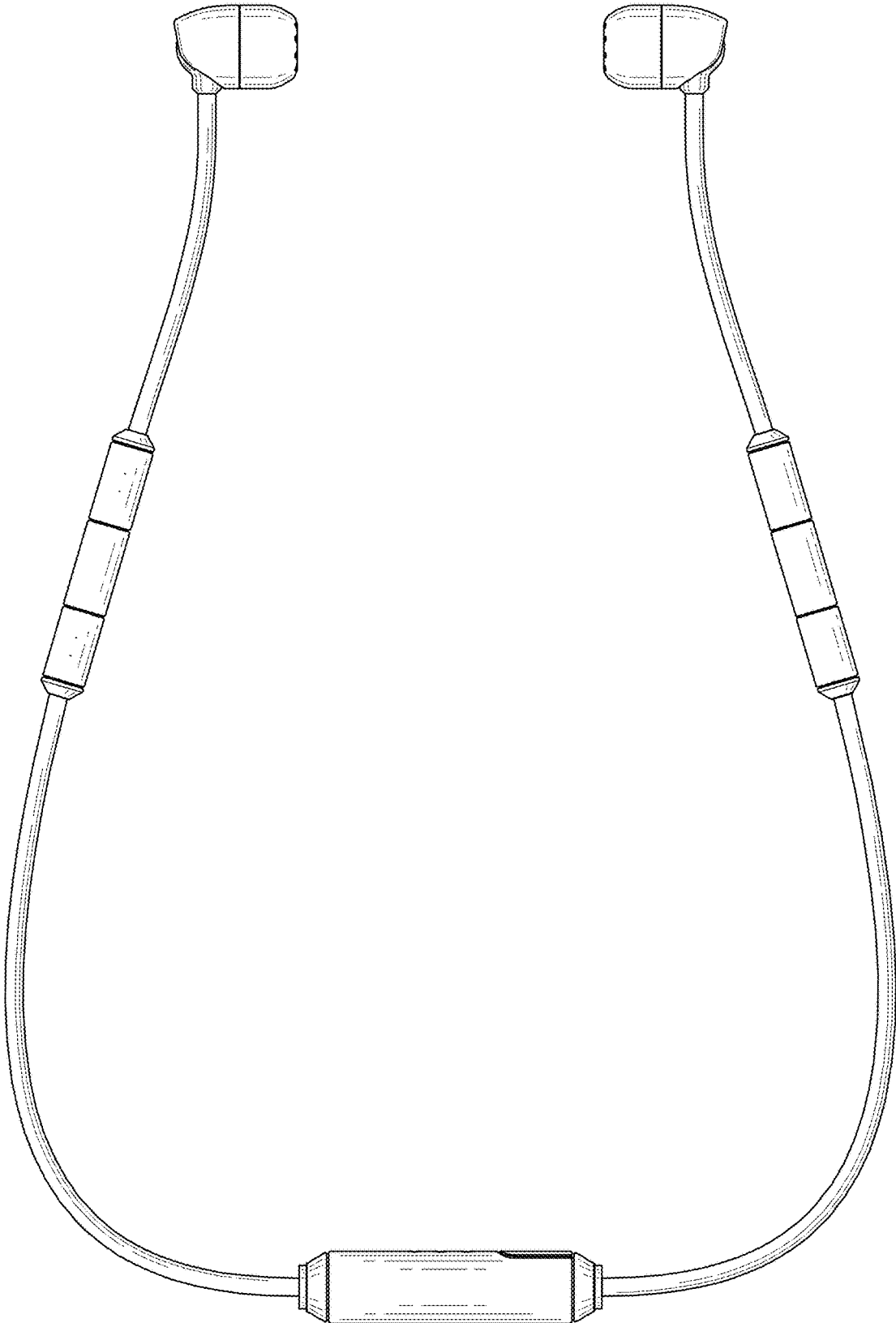

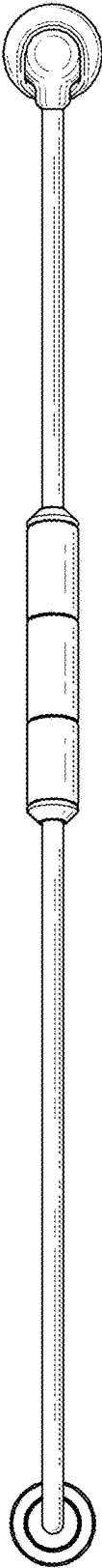

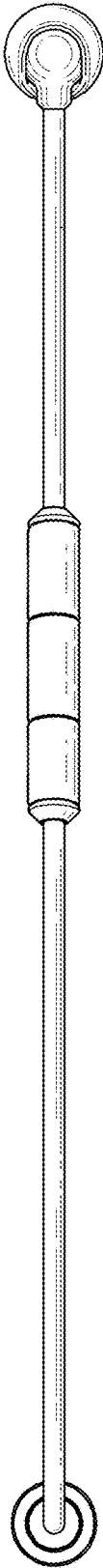

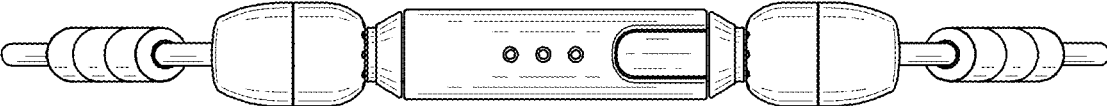

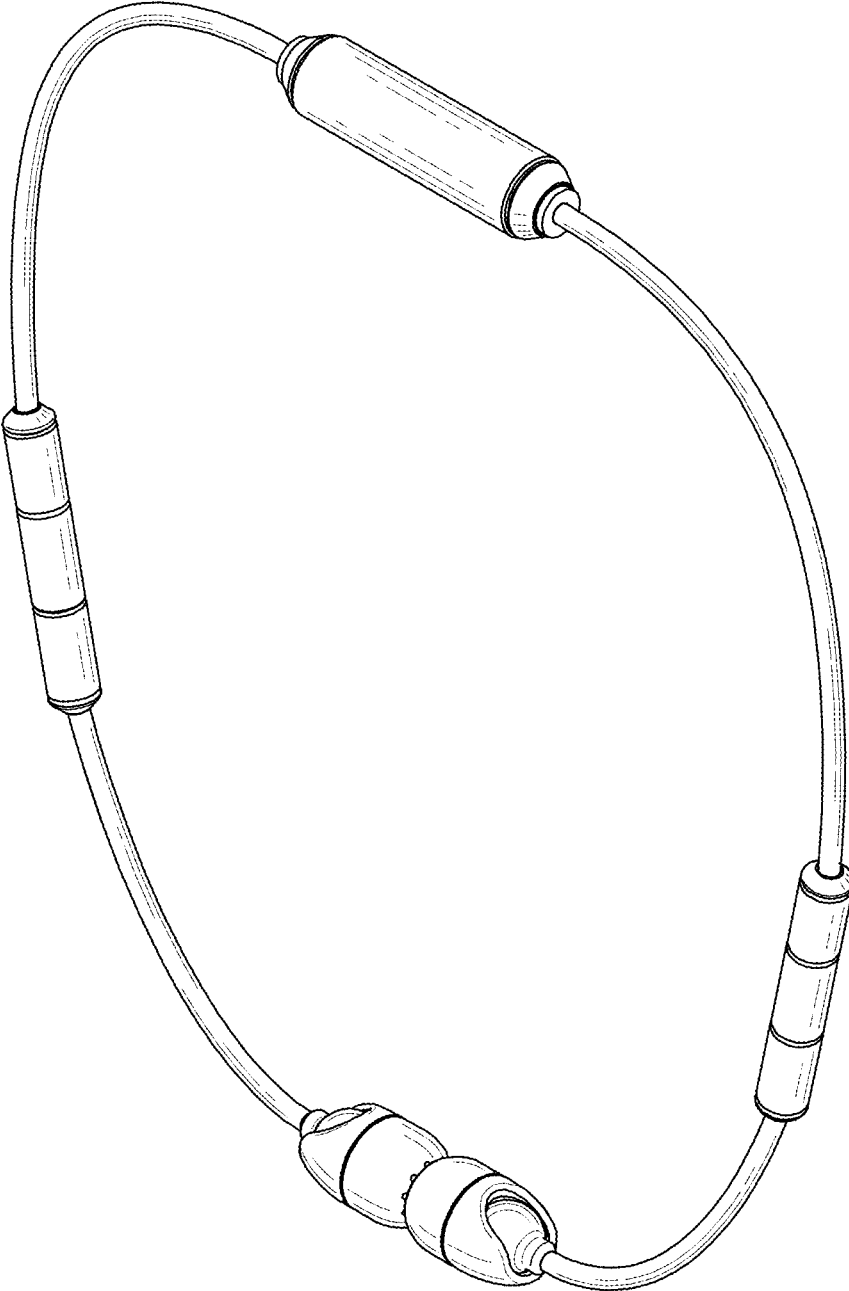

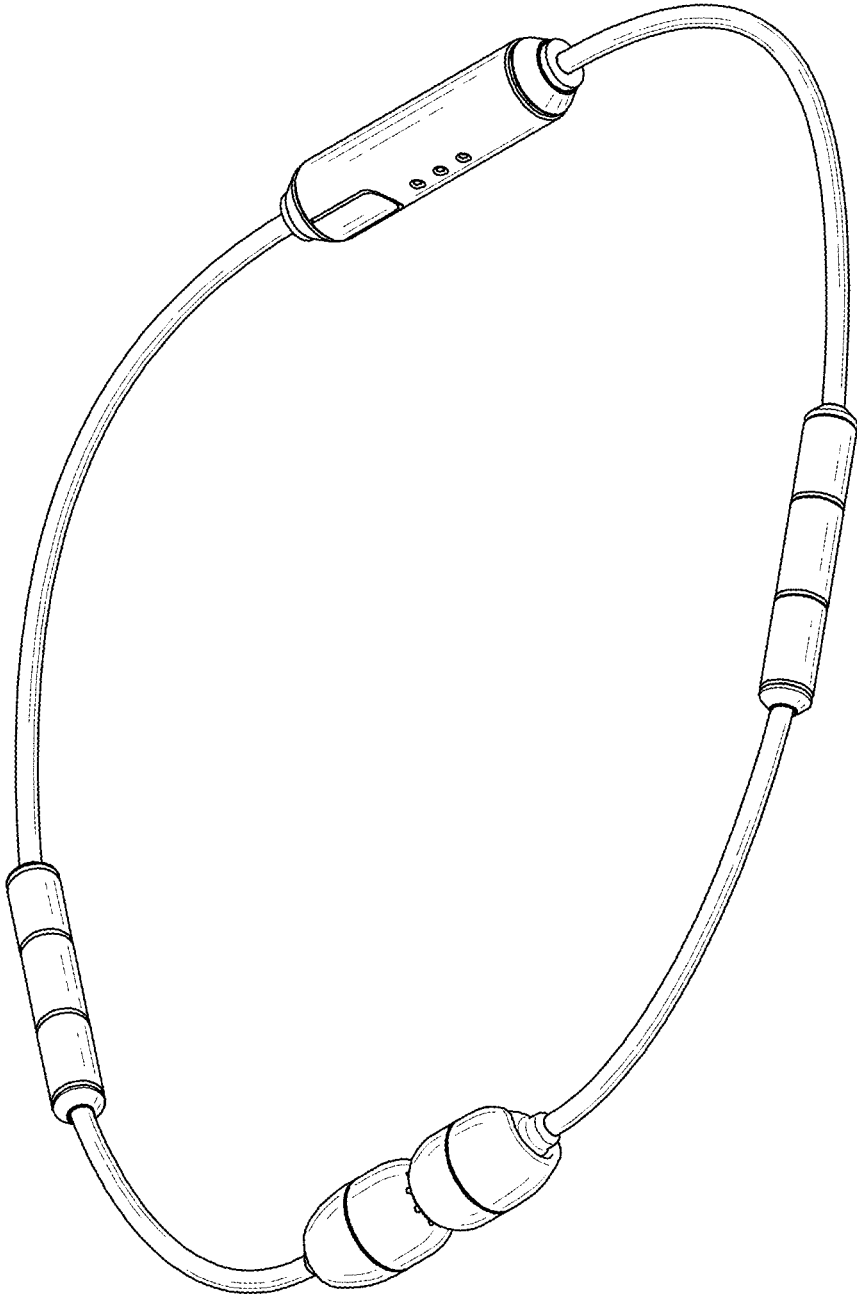

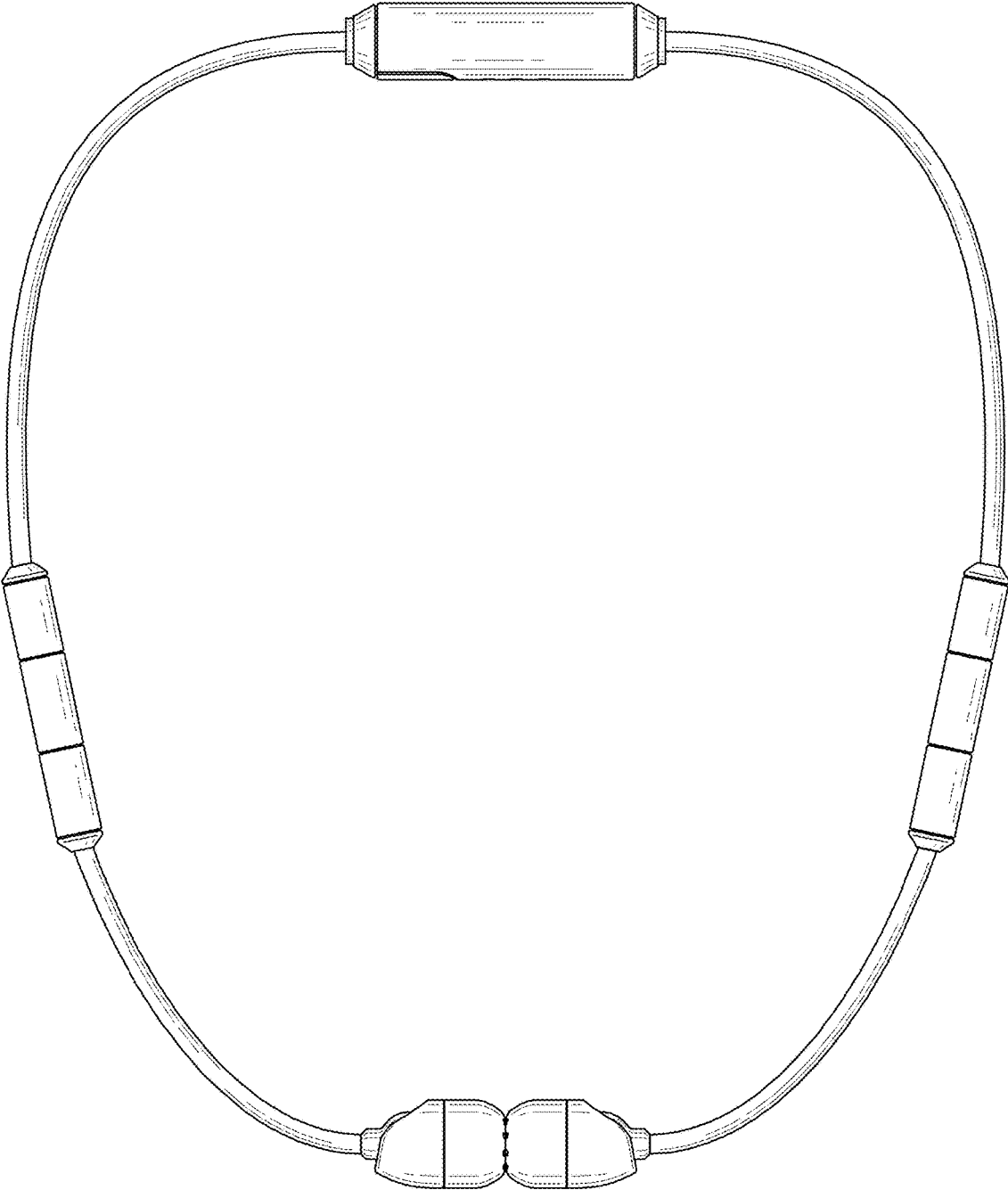

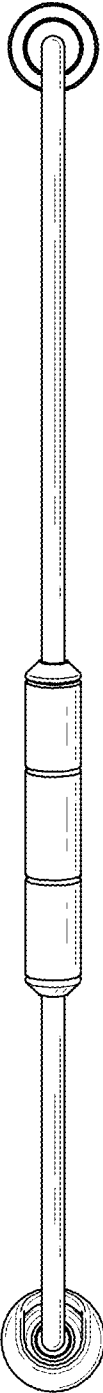

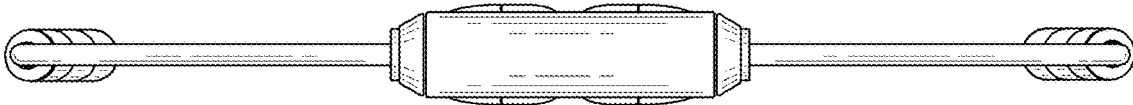
