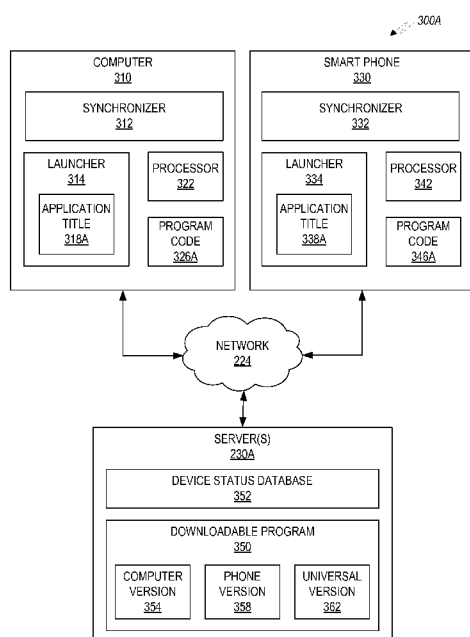

(57) Abstract: A system and method for utilizing a server (230A) to syn-
chronize launchers (314, 334) among multiple computing devices (310, 330)
of a user. When a user installs an application on a first computing device
(310), the launcher(s) (334) of at least one of his or her other computing
devices (330) are automatically updated. In at least two of the user's comput-
ing devices, the installation includes or is followed by downloading different
platform versions (354, 358, 362) of program code to execute on the comput-
ing devices' processors (322, 342).
