and form no part of our design.

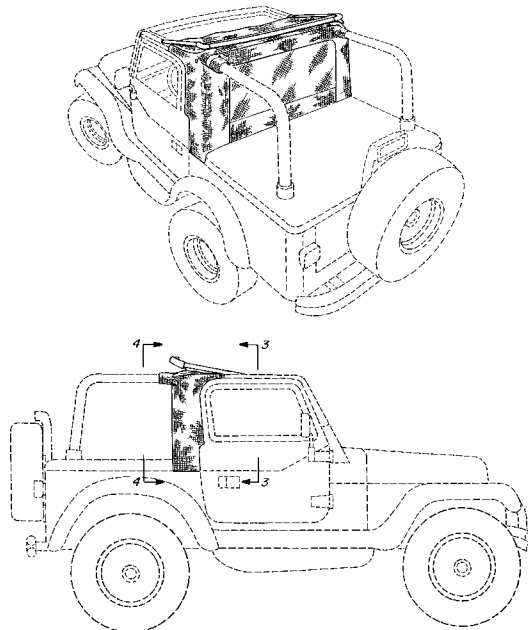
FIG. 3 is a front elevational view thereof taken along line

4-4 of FIG. 2.

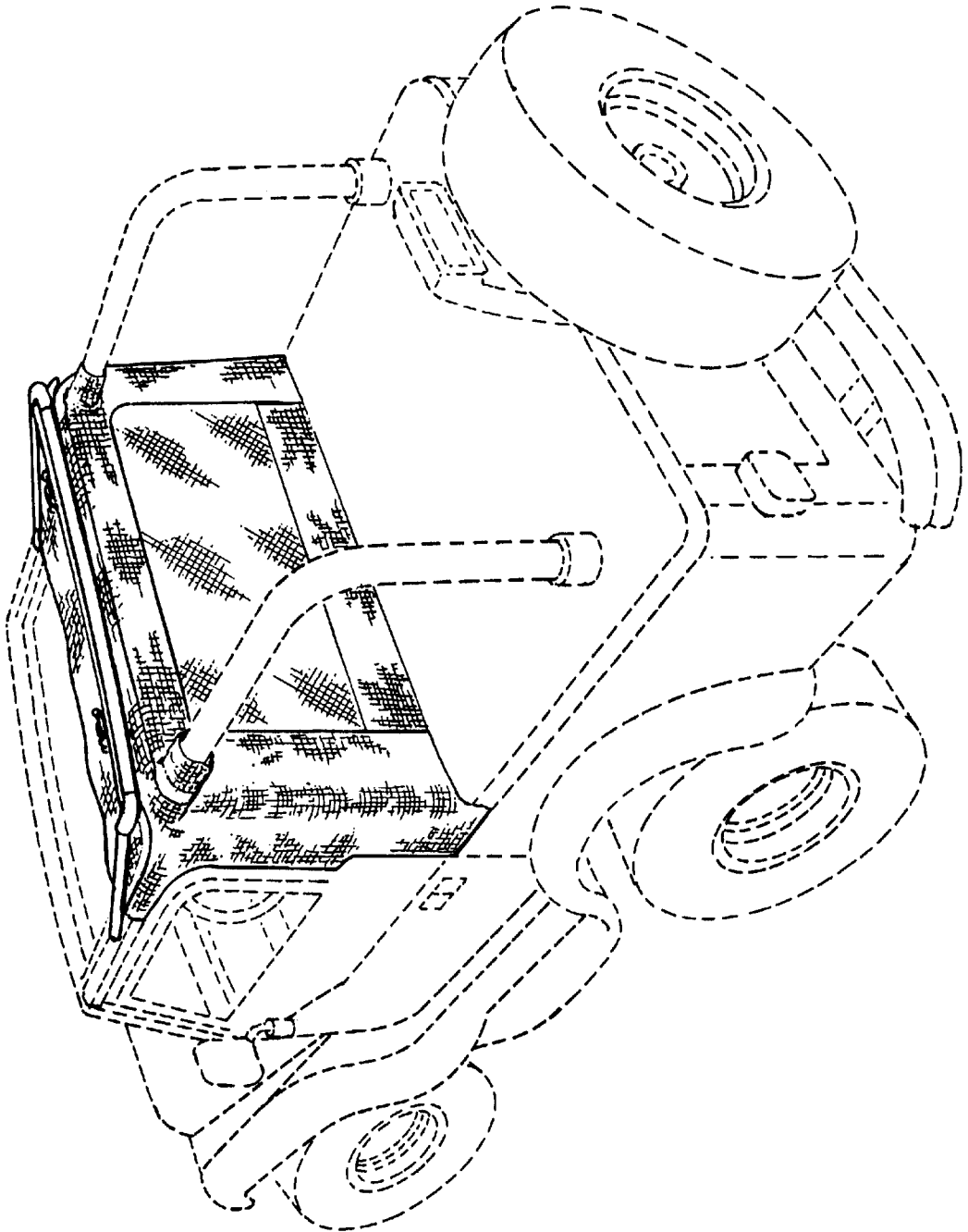
FIG. 5 is a top plan view thereof taken along line 5-5 of  
FIG. 3; and,

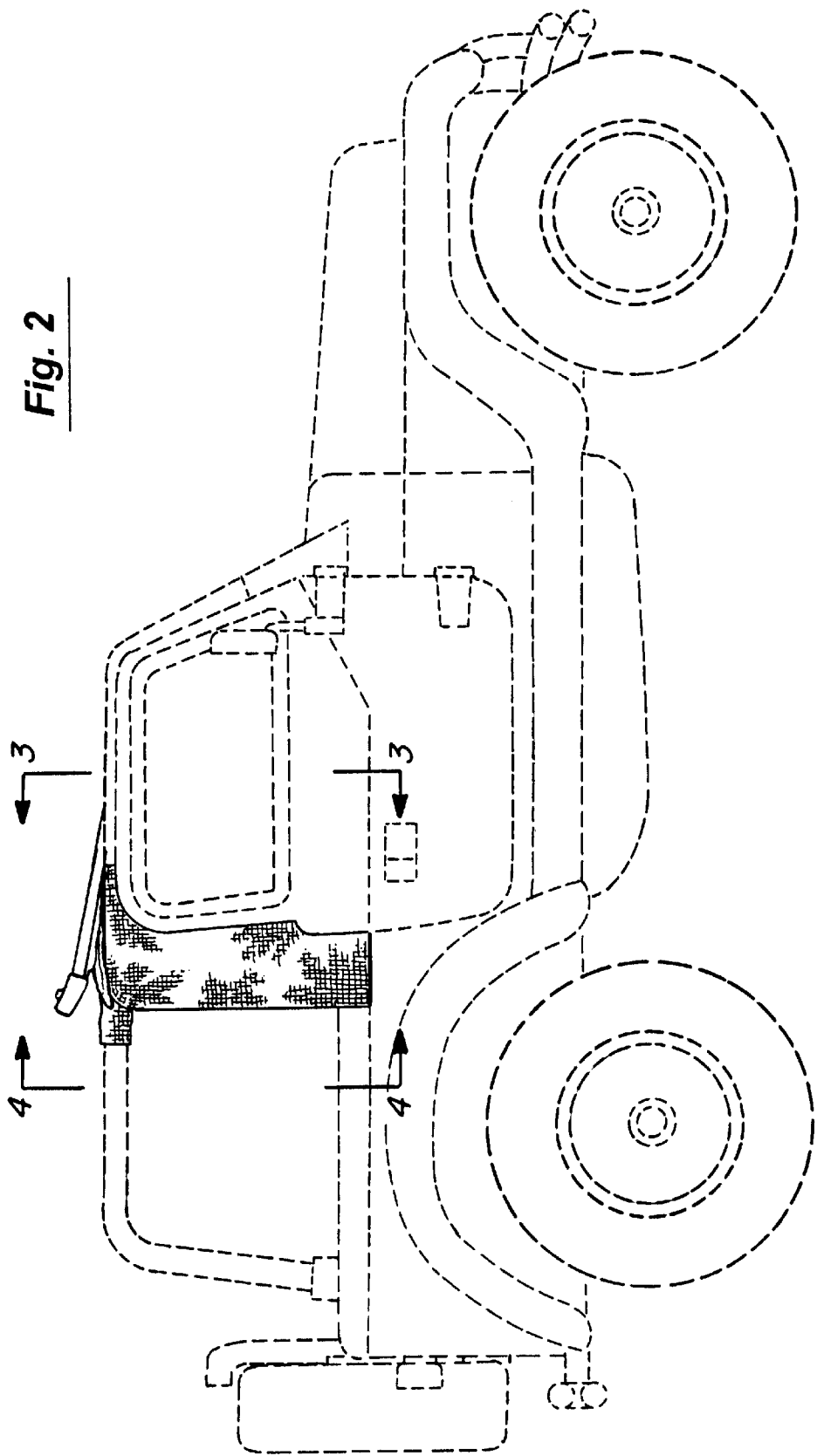
FIG. 6 is a bottom plan view thereof taken along line 6-6

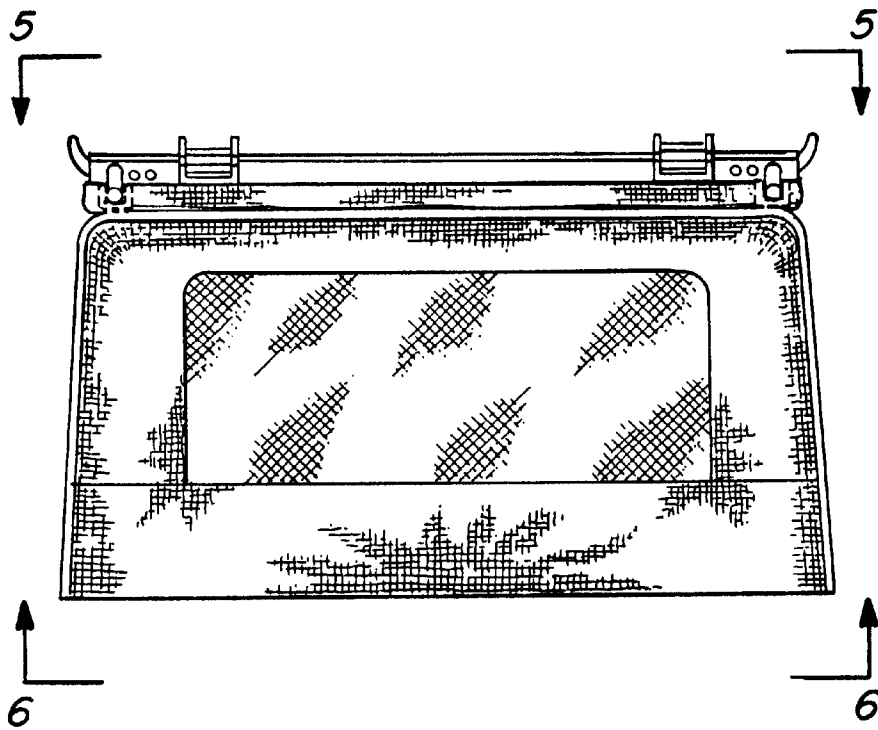

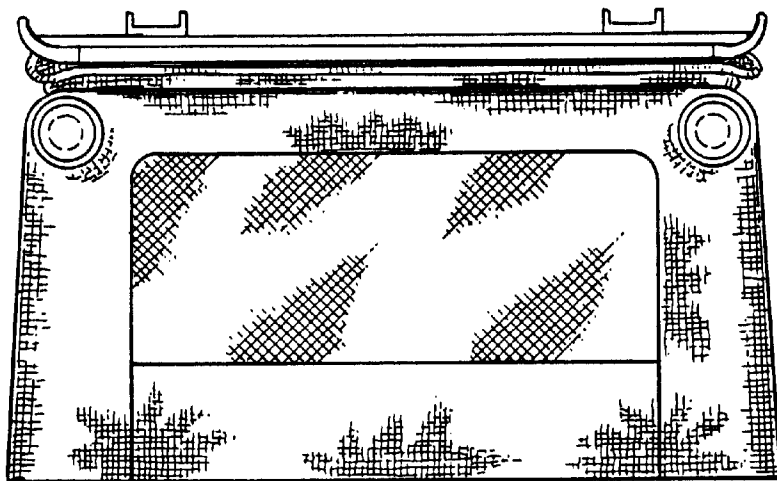

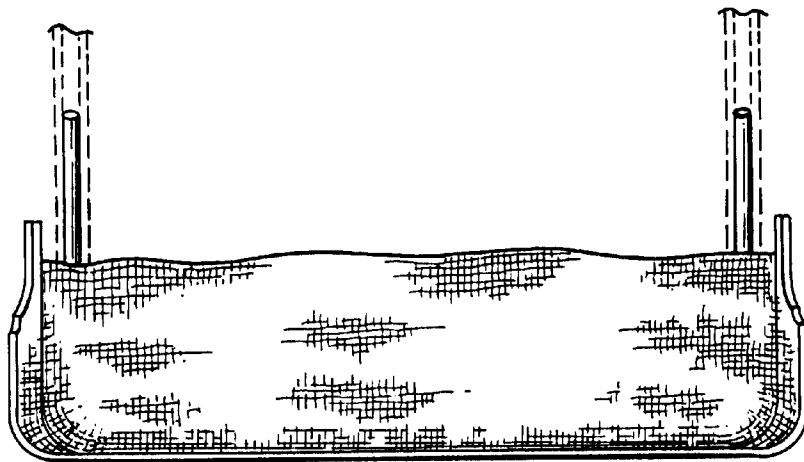
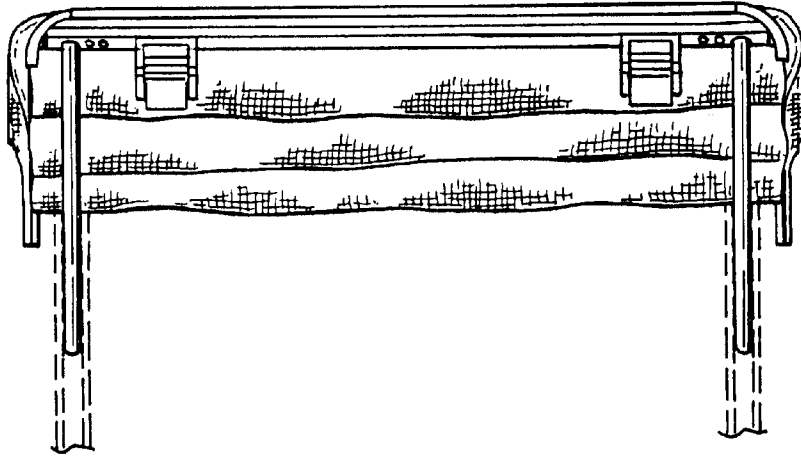
