
(57) **CLAIM**

The ornamental design for an exercise apparatus with hand holds, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the exercise apparatus with hand holds embodying our new design, FIG. 2 is a rear view of the exercise apparatus with hand holds, FIG. 3 is a top view of the exercise apparatus with hand holds, FIG. 4 is a bottom view of the exercise apparatus with hand holds, FIG. 5 is a right side view of the exercise apparatus with hand holds, the left side view being a mirror image thereof; and, FIG. 6 is a right side perspective view of the exercise apparatus with hand holds.












