DESCRIPTION

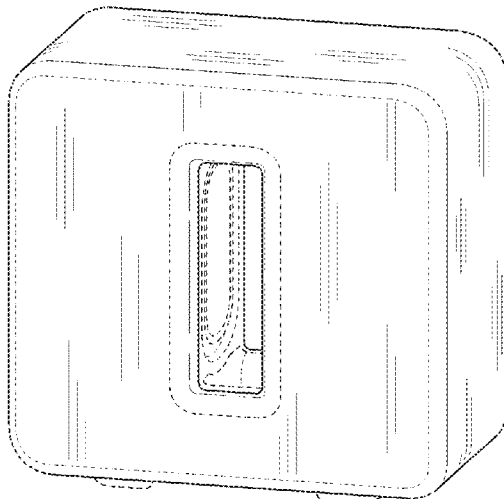
FIG. 1 is an isometric front view of a playback device.

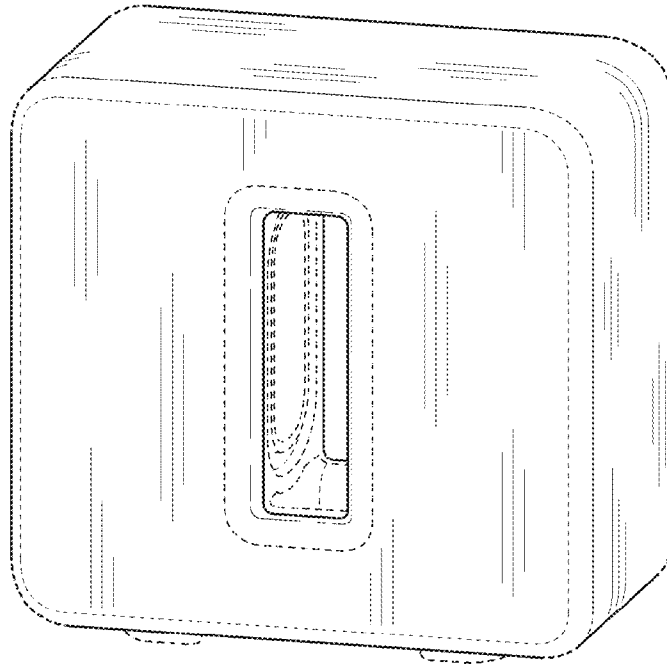

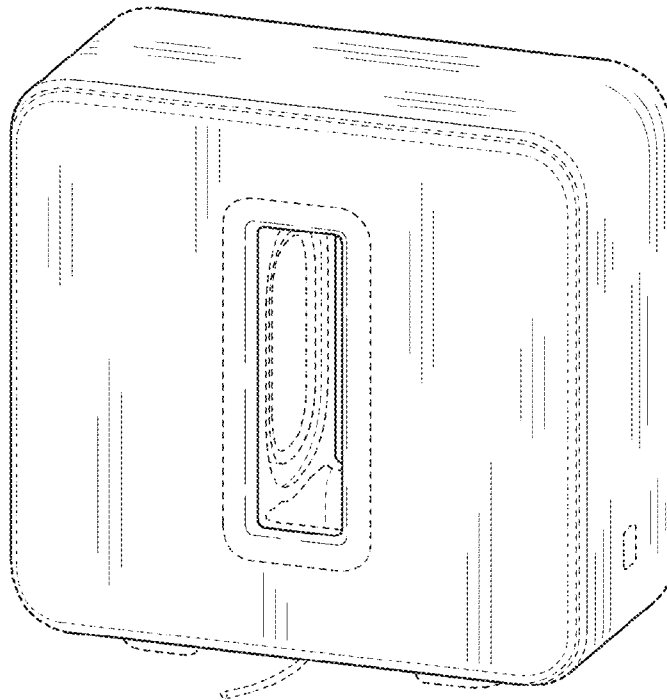

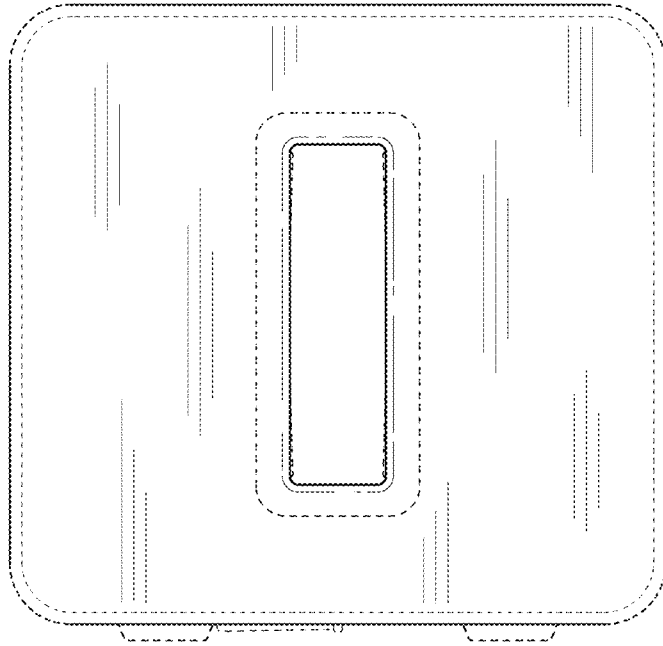

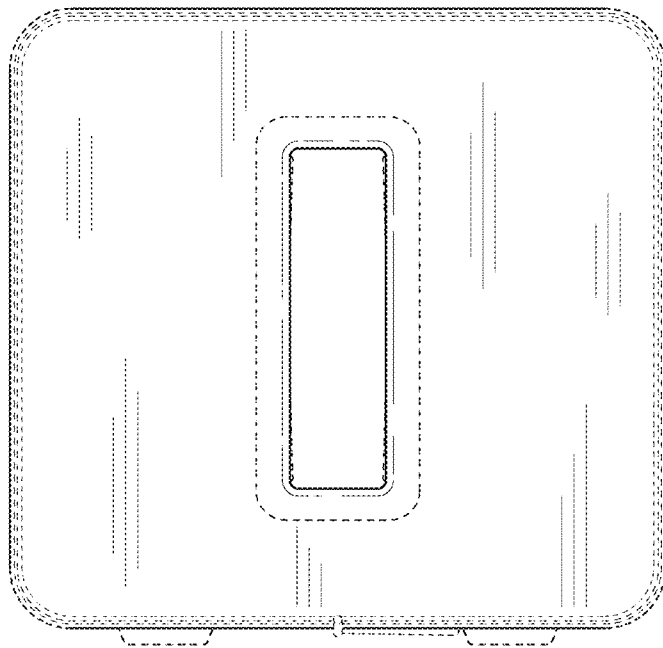

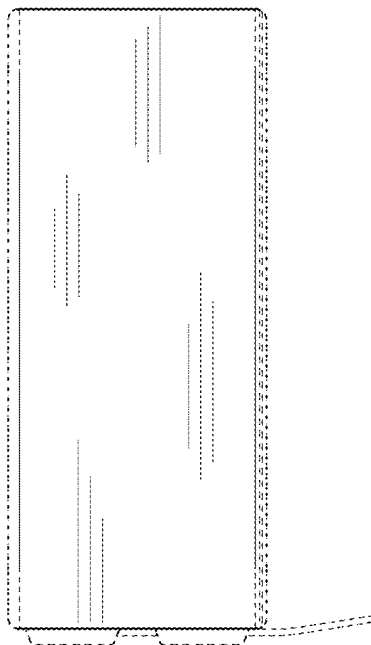

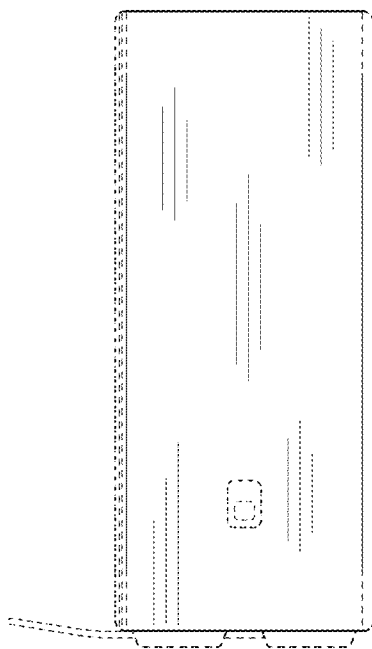

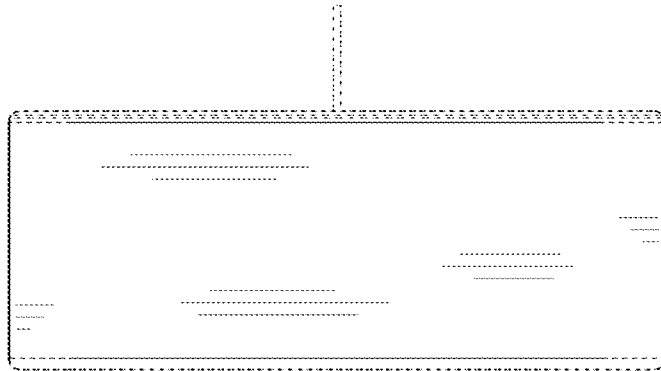

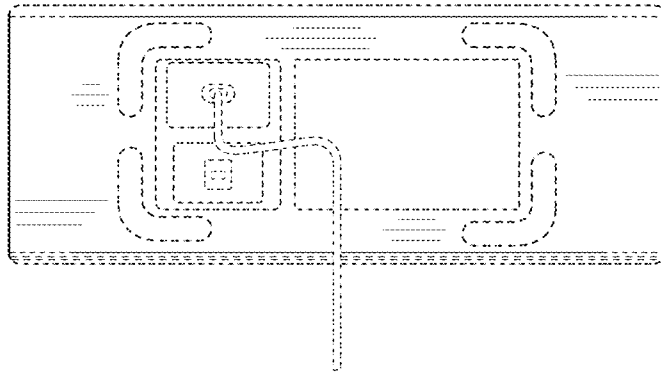

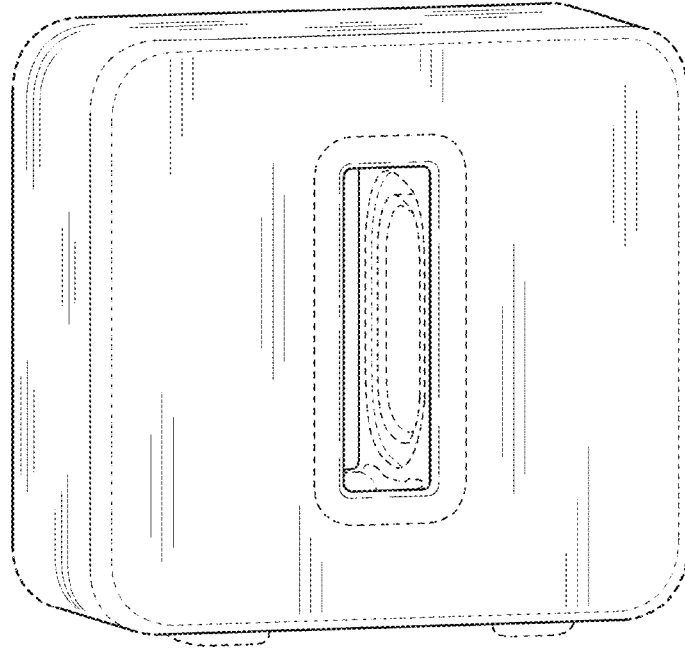

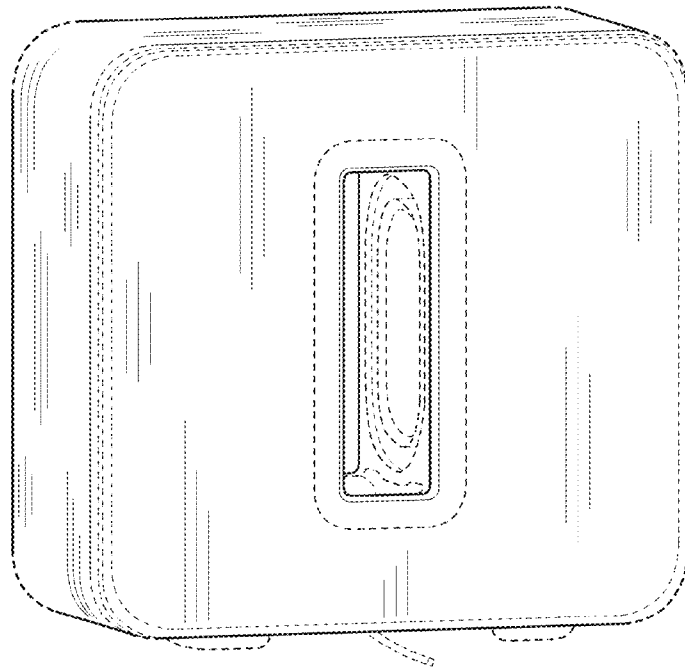

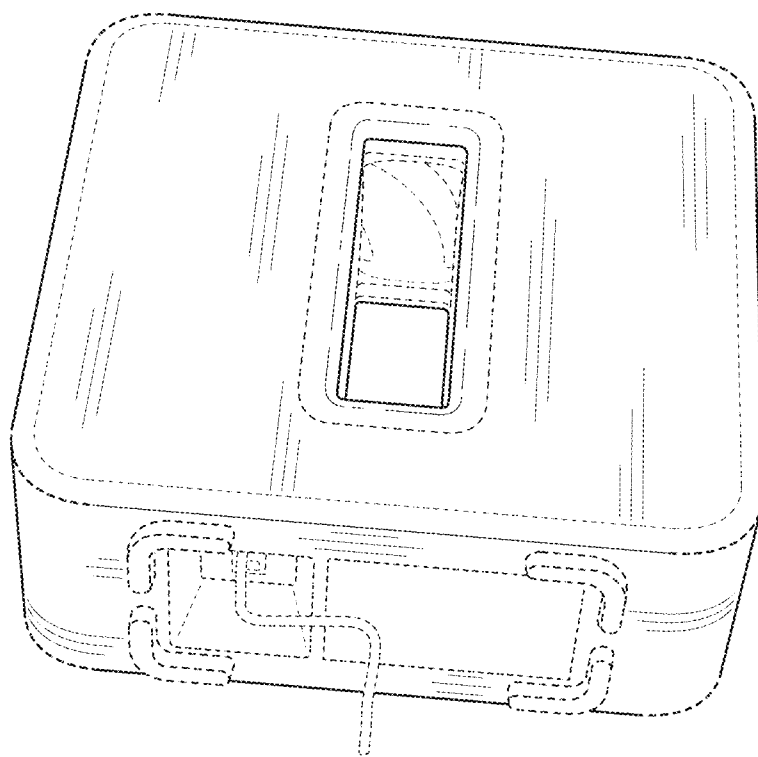
