
(57) **CLAIM**
The ornamental design for an A-shaped garment rack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of an A-shaped garment rack;
 FIG. 2 is a front view of the garment rack of FIG. 1;
 FIG. 3 is a left side view of a garment rack of FIG. 1, wherein the right side view is the same as the left side view;
 FIG. 4 is a top view of a garment rack of FIG. 1;
 FIG. 5 is a perspective view of the left bottom holding element of the garment rack of FIG. 1;
 FIG. 6 is left side view of the left bottom holding element of FIG. 5;
 FIG. 7 is a front view of the left bottom holding element of FIG. 5;
 FIG. 8 is a perspective view of the left top connecting element of the garment rack of FIG. 1, when the two pieces are de-attached;
 FIG. 9 is a left side view of the left top connecting element of FIG. 8; and,
 FIG. 10 is a front side view of the left top connecting element of FIG. 9, when the two pieces are de-attached.




















