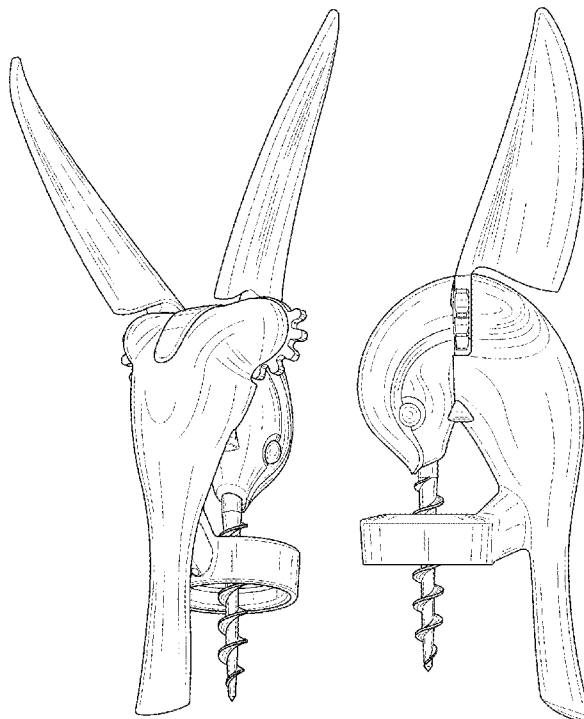
(57) **CLAIM**

I claim the ornamental design for a bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle opener showing my new design;
FIG. 2 is a rear perspective view of the bottle opener of FIG. 1;
FIG. 3 is a front view of the bottle opener of FIG. 1;
FIG. 4 is a rear view of the bottle opener of FIG. 1;

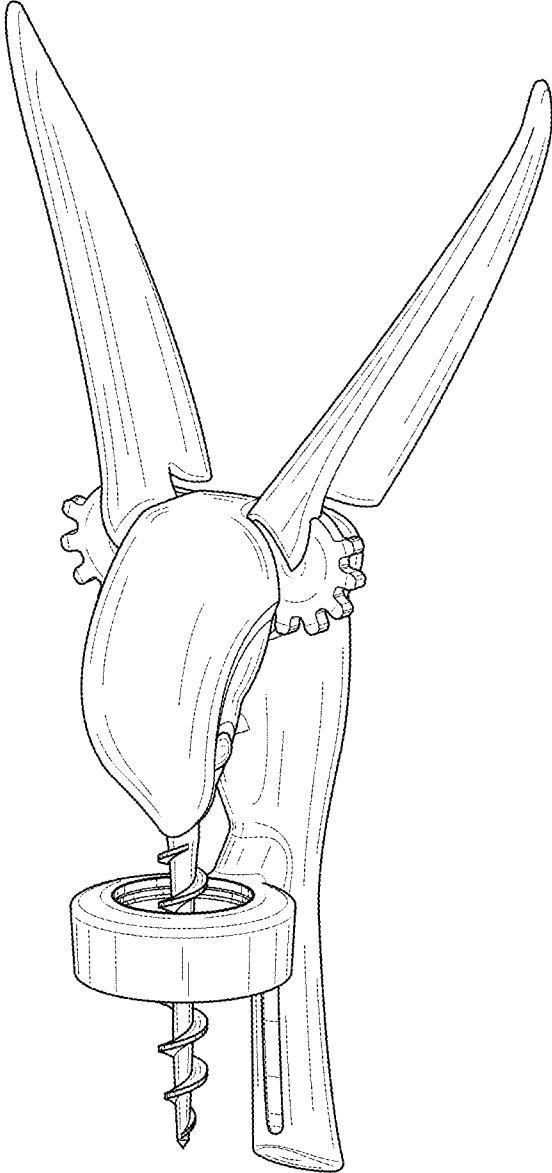

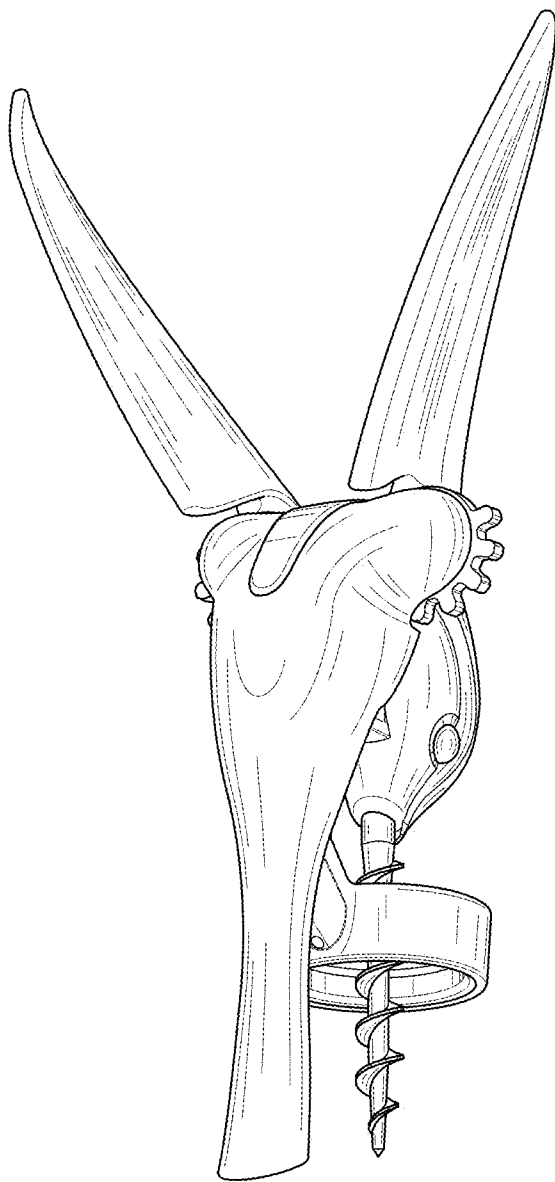

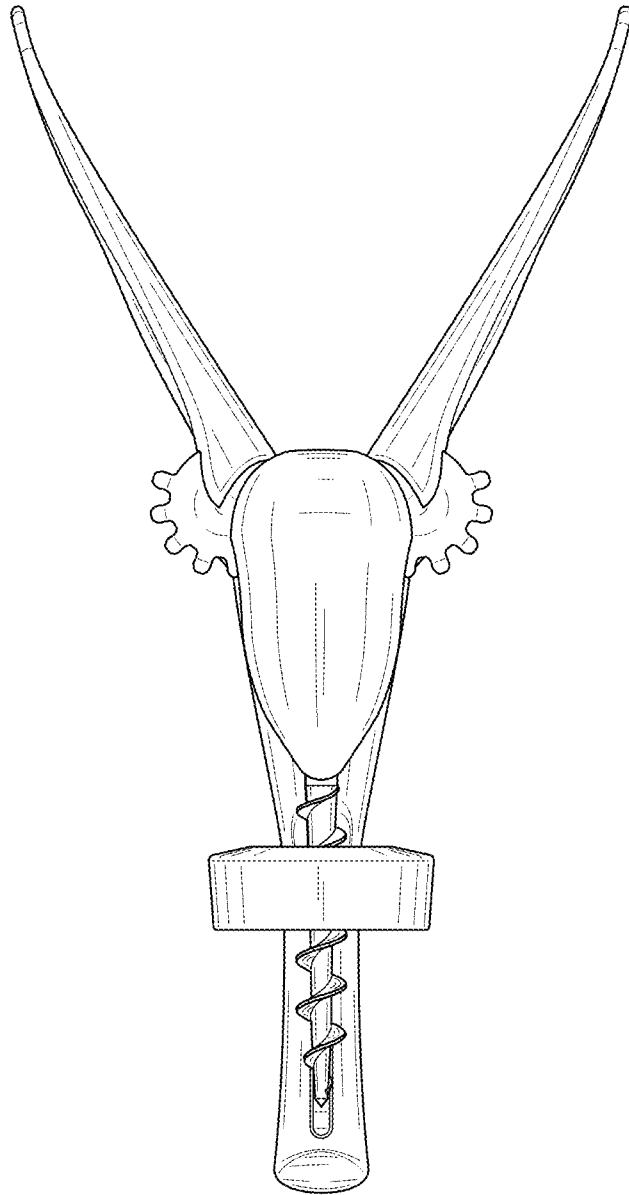

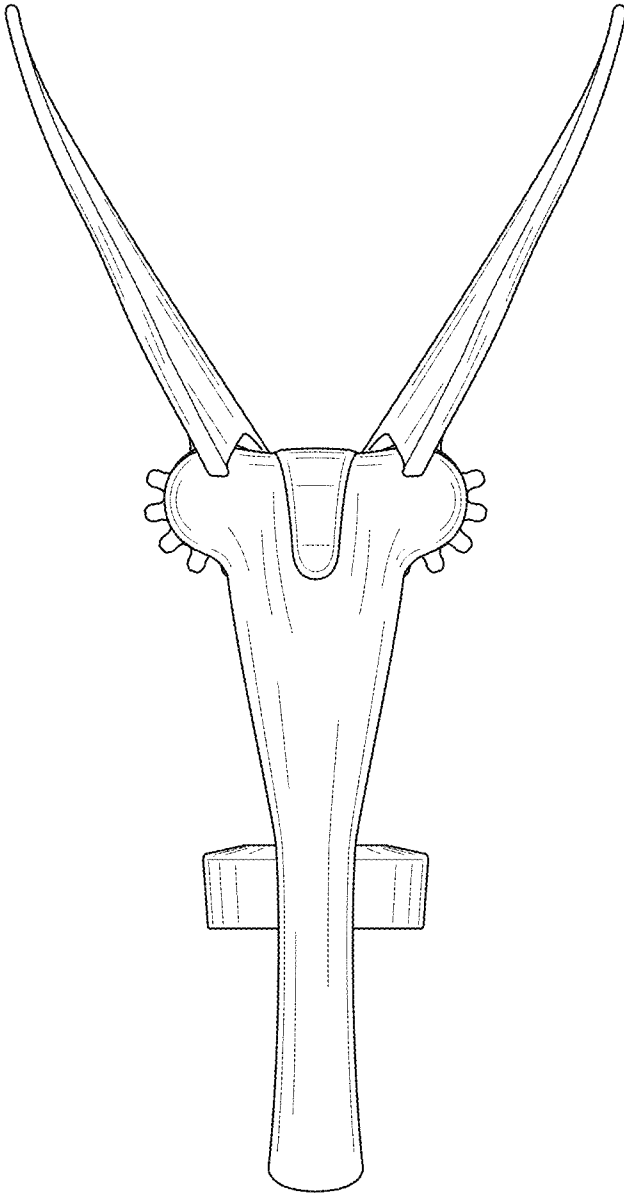

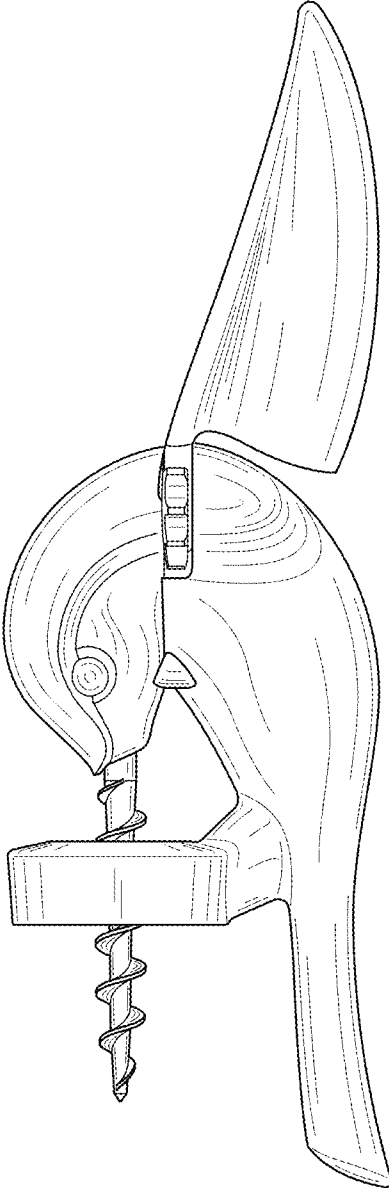

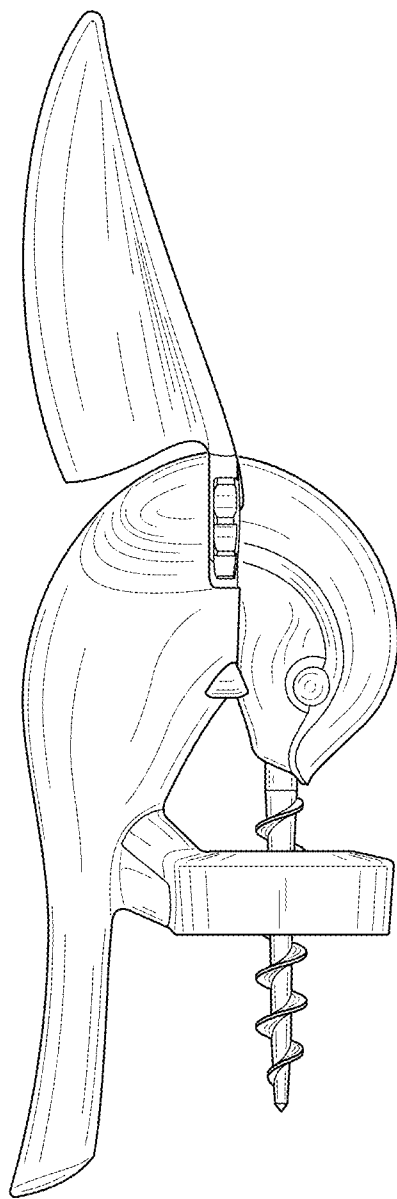

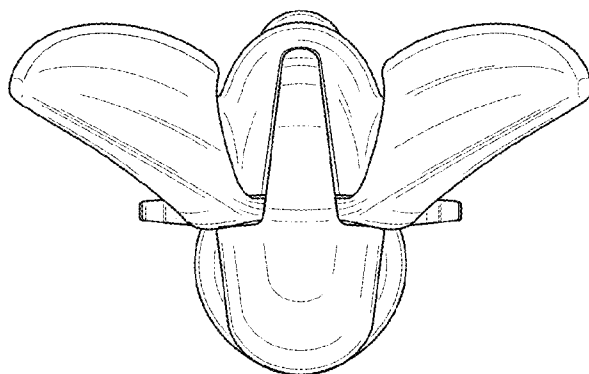

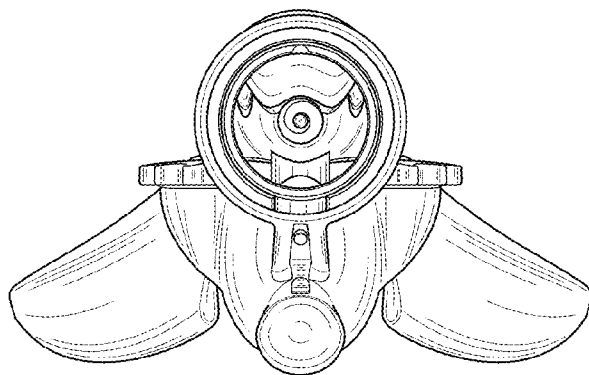
