(57) **CLAIM**

The ornamental design of a handle for a jack assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top, left and front perspective view of a handle for a jack assembly showing my new design;

FIG. 2 is another perspective view of the handle thereof;

FIG. 4 is a back view thereof;

FIG. 5 is a left side view thereof;

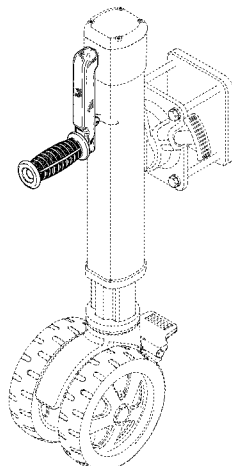
FIG. 6 is a right side view thereof;

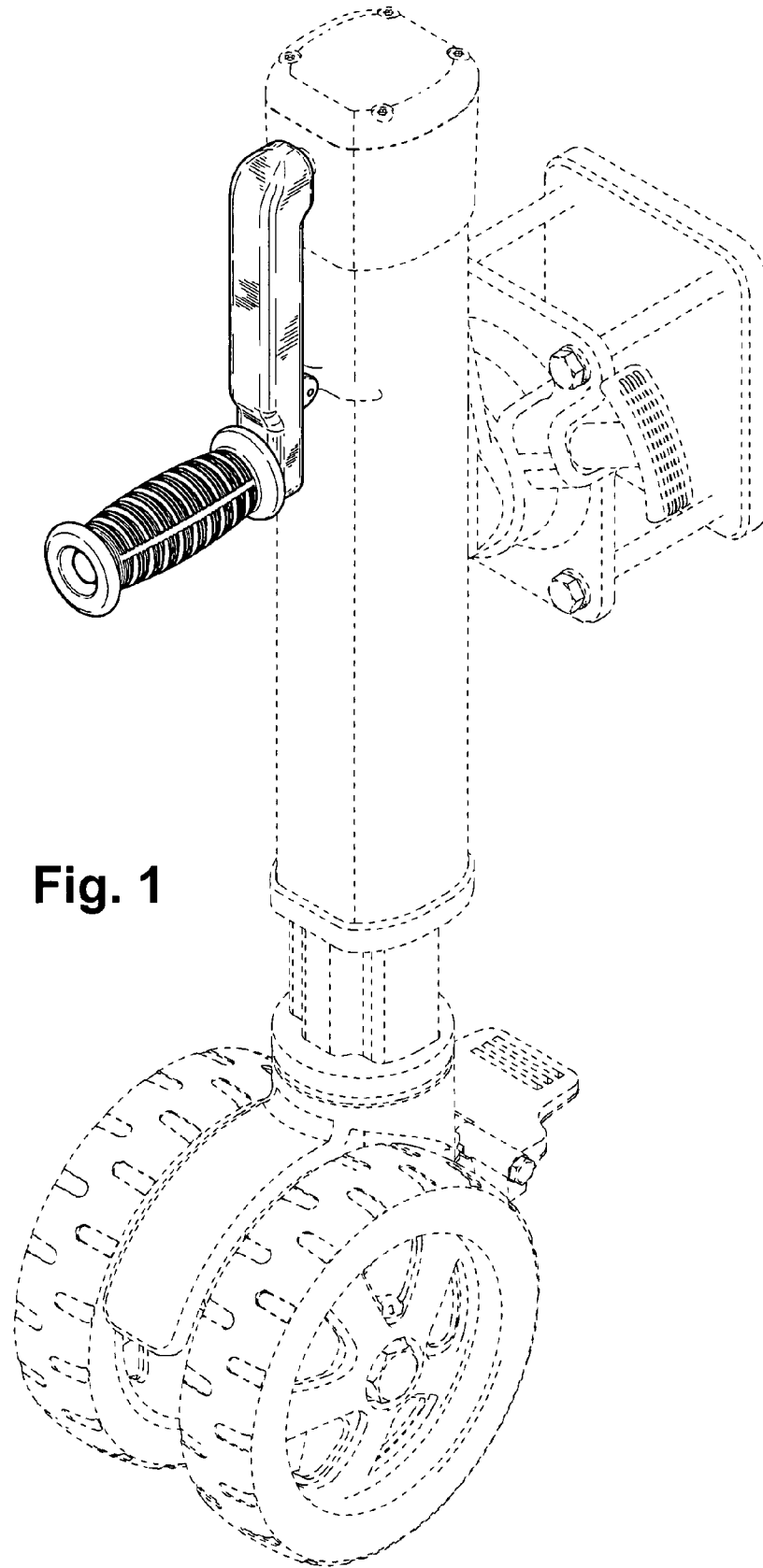

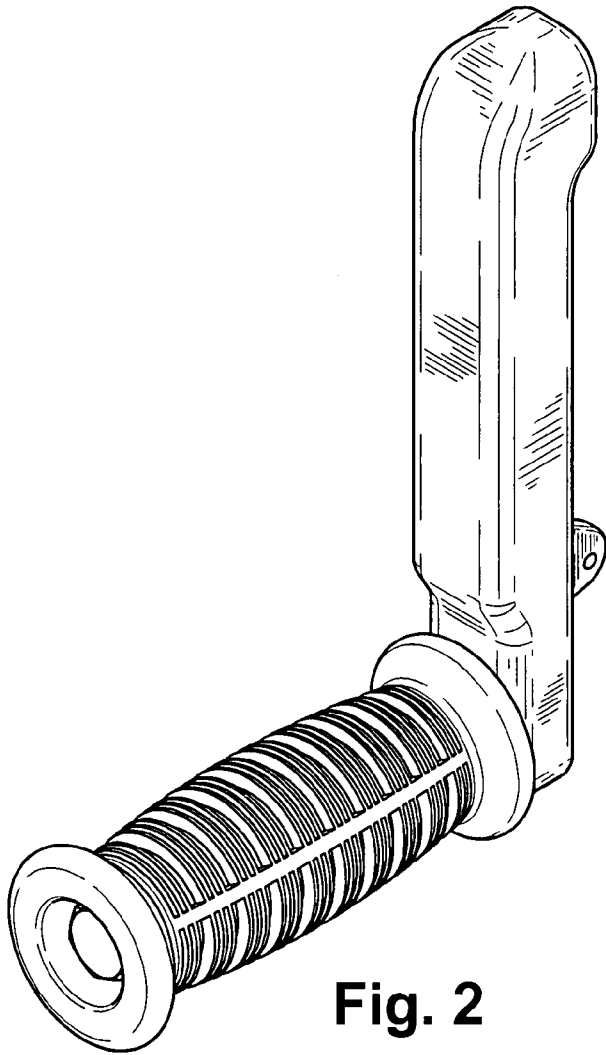

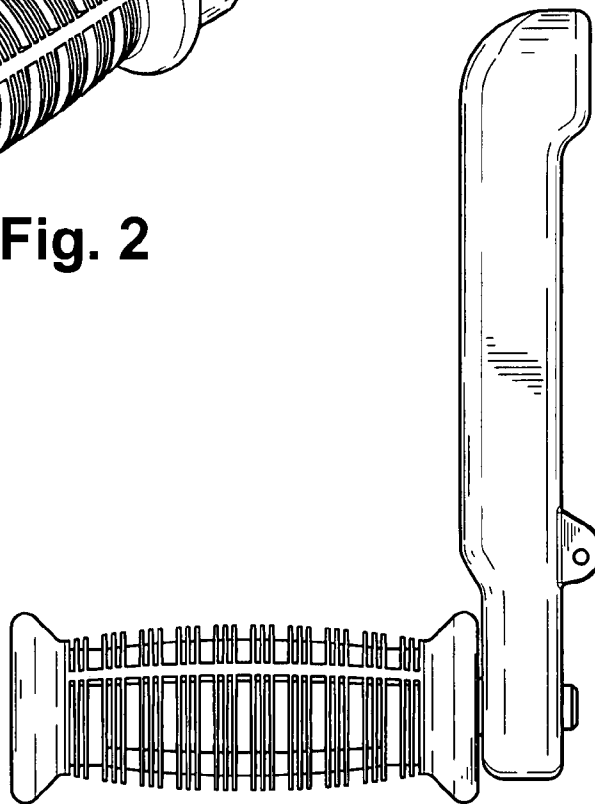

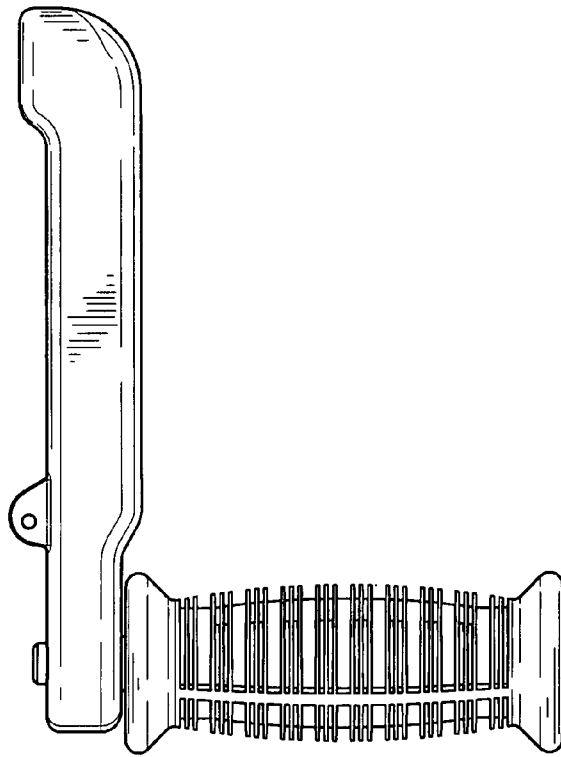

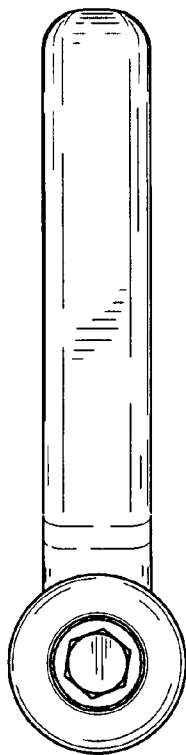

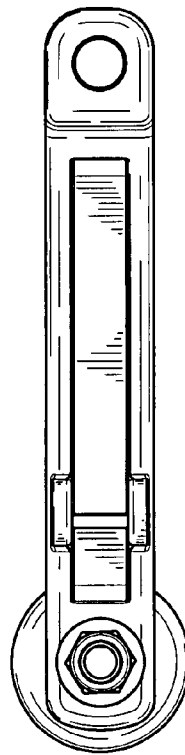

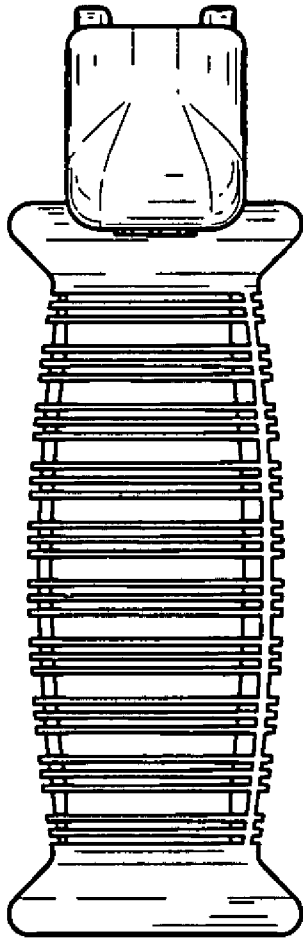

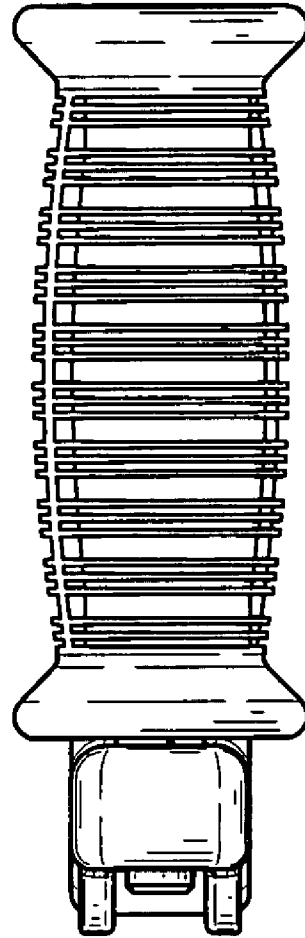
