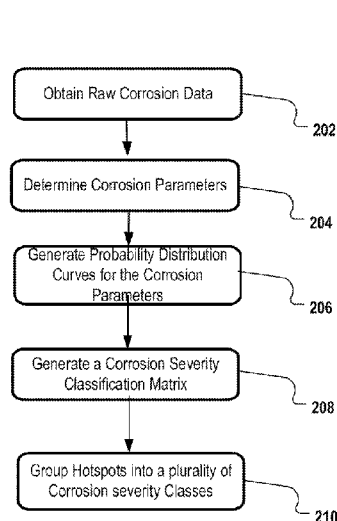

(54) **Title:** STATISTICAL METHODS FOR ASSESSING DOWNHOLE CASING INTEGRITY AND PREDICTING CASING LEAKS

(57) **Abstract:** The present disclosure describes methods and systems, including computer-implemented methods, computer program products, and computer systems, for predicting casing leaks. One computer-implemented method includes obtaining raw electromagnetic (EM) corrosion data (202) for a hotspot, wherein the raw EM corrosion data includes a metal thickness loss value for the hotspot; determining a corrosion parameter (204) based on the raw EM corrosion data; generating a probability distribution curve (206) for the corrosion parameter; generating a corrosion severity classification matrix (208) based on the probability distribution curve, wherein the corrosion severity classification matrix includes a plurality of corrosion severity classes and cutoff values for each of the plurality of corrosion severity classes; and assigning the hotspot into one of the plurality of corrosion severity classes (210) based on the corrosion severity classification matrix and the corrosion parameter of the hotspot.

STATISTICAL METHODS FOR ASSESSING DOWNHOLE CASING INTEGRITY AND PREDICTING CASING LEAKS

CLAIM OF PRIORITY

5 [0001] This application claims priority to U.S. Patent Application No. 14/795,183 filed on July 9, 2015, the entire contents of which are hereby incorporated by reference.

BACKGROUND

10 [0002] In the petroleum industry, a service company can monitor corrosion process and/or progress of downhole drilling pipe casing hotspots (areas likely to develop casing damage due to thermal and related effects on a casing) and develop log and casing repair schedules accordingly. In some cases, the service company can use electromagnetic (EM) corrosion logging tools to collect raw EM corrosion data
15 associated with casing hotspots to monitor the corrosion process and to provide an assessment of the integrity of multiple casings. However, EM tools only provide circumferential average readings of metal thickness loss across multiple strings rather than directional ones. Consequently, wells with casing failures show average metal loss values less than 100% unless the failure occurs around the 360° circumference. In
20 other words, 50% average metal loss could mean a failure if one part of the casing is completely gone and the other is intact. This wide range of possibilities and uncertainty has made it extremely challenging to both interpret and analyze EM corrosion logging data.

SUMMARY

25 [0003] The present disclosure describes methods and systems, including computer-implemented methods, computer program products, and computer systems, for assessing downhole casing integrity and predicting casing leaks. One computer-implemented method includes obtaining, by a data processing apparatus, raw
30 electromagnetic (EM) corrosion data for a hotspot, wherein the raw EM corrosion data includes a metal thickness loss value for the hotspot; determining, by the data processing apparatus, a corrosion parameter based on the raw EM corrosion data, wherein the corrosion parameter includes at least one of an average remaining barrier,

a corrosion rate, or an expected life; generating, by the data processing apparatus, a probability distribution curve for the corrosion parameter; generating, by the data processing apparatus, a corrosion severity classification matrix based on the probability distribution curve, wherein the corrosion severity classification matrix includes a plurality of corrosion severity classes and cutoff values for each of the plurality of corrosion severity classes; and assigning, by the data processing apparatus, the hotspot into one of the plurality of corrosion severity classes based on the corrosion severity classification matrix and the corrosion parameter of the hotspot.

[0004] Other implementations of this aspect include corresponding computer systems, apparatuses, and computer programs recorded on one or more computer storage devices, each configured to perform the actions of the methods. A system of one or more computers can be configured to perform particular operations or actions by virtue of having software, firmware, hardware, or a combination of software, firmware, or hardware installed on the system that in operation causes the system to perform the actions. One or more computer programs can be configured to perform particular operations or actions by virtue of including instructions that, when executed by data processing apparatus, cause the apparatus to perform the actions.

[0005] The foregoing and other implementations can each optionally include one or more of the following features, alone or in combination:

[0006] A first aspect, combinable with the general implementation, wherein the generation of the probability distribution curve includes determining whether the hotspot is a leaking hotspot or a non-leaking hotspot; if the hotspot is a leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for leaking hotspots; and if the hotspot is a non-leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for non-leaking hotspots.

[0007] A second aspect, combinable with any of the previous aspects, wherein the raw EM corrosion data includes metal loss values for a plurality of strings, and the corrosion parameter includes the average remaining barrier that is calculated based on a nominal thickness value for each of the plurality of strings, and a thickness loss value for each of the plurality of strings.

[0008] A third aspect, combinable with any of the previous aspects, wherein the corrosion parameter includes the corrosion rate that is calculated based on an

original thickness value, a remaining thickness value, and a number of years.

[0009] A fourth aspect, combinable with any of the previous aspects, wherein the generation of the probability distribution curve for the corrosion parameter includes calculating a mean value and a standard deviation value of the corrosion parameter for leaking hotspots; calculating a mean value and a standard deviation value of the corrosion parameter for non-leaking hotspots; generating a probability distribution function of the leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for leaking hotspots; and generating a probability distribution function of the non-leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for non-leaking hotspots.

[0010] A fifth aspect, combinable with any of the previous aspects, wherein the cutoff values for each of the plurality of corrosion severity classes is determined based on a mean value of the corrosion parameter for leaking hotspots, a standard deviation value of the corrosion parameter for leaking hotspots, a mean value of the corrosion parameter for non-leaking hotspots, and a standard deviation value of the corrosion parameter for non-leaking hotspots.

[0011] A sixth aspect, combinable with any of the previous aspects, wherein each of the plurality of corrosion severity classes is associated with a logging frequency for the respective corrosion severity class.

[0012] The subject matter described in this specification can be implemented in particular implementations so as to realize one or more of the following advantages. This approach may provide service companies a robust and practical methodology to analyze raw Electromagnetic (EM) corrosion logs' data and predict casing leaks. For example, this approach includes data-driven models and dynamic decision processes that can be used to analyze raw EM corrosion data, predict downhole casing leaks, and forecast completion life. This approach converts the qualitative measurements of the raw EM corrosion data into quantitative assessment of casing failures. Moreover, the approach provides a risk-based corrosion logging frequency model for safe and practical monitoring of downhole casing integrity. Other advantages will be apparent to those of ordinary skill in the art.

DESCRIPTION OF DRAWINGS

[0014] FIG. 1 is a chart illustrating example metal loss scenarios for casing
5 hotspots according to an implementation.

[0015] FIG. 2 illustrates an example method for predicting downhole casing leaks according to an implementation.

[0016] FIG. 3 is a high-level architecture block diagram of a casing leak prediction data processing system according to an implementation.

DETAILED DESCRIPTION

[0025] The following description is presented to enable any person skilled in the art to make and use the disclosed subject matter, and is provided in the context of
30 one or more particular implementations. Various modifications to the disclosed implementations will be readily apparent to those skilled in the art, and the general principles defined herein may be applied to other implementations and applications without departing from scope of the disclosure. Thus, the present disclosure is not

intended to be limited to the described and/or illustrated implementations, but is to be accorded the widest scope consistent with the principles and features disclosed herein.

[0026] This disclosure generally describes methods and systems, including computer-implemented methods, computer program products, and computer systems, for predicting downhole casing leaks. In some cases, electromagnetic (EM) corrosion logging tools can provide raw corrosion data related to a casing hotspot (“hotspot”), which is an area likely to develop casing damage due to galvanic, chemical or mechanical effects on a casing. The raw EM corrosion data may include circumferential average readings of metal thickness loss. However, these readings may not include directional data or consider the different combinations and sizes of downhole casings. These factors make interpretation and analysis of raw corrosion data produced by the EM corrosion logging tools challenging because of a wide range of corrosion scenario possibilities and resultant uncertainty. For example, wells with casing failures may have average metal loss values less than 100% unless the failure occurs around the 360 degree circumference.

[0027] FIG. 1 is a chart 100 illustrating example metal-loss scenarios for casing hotspots according to an implementation. The chart 100 includes metal-loss scenarios 102, 104, 106, and 108. In the metal-loss scenario 102, the example hotspot has no metal loss and the casing is intact. Each casing in the metal-loss scenarios 104, 106, and 108 has 50% average metal loss. In the metal-loss scenario 104, the casing has a uniform loss around the 360 degree circumference of the example casing. In the metal-loss scenario 106, the casing has a loss resulting in a cross-sectional oval shape. In the metal-loss scenario 108, the illustrated top half of the example casing has corroded away and is gone while the other side of the example casing is intact. While all three scenarios illustrate a 50% average metal loss, metal-loss scenario 108 represents a casing failure. Additionally, metal-loss scenario 104 may result in a longer expected life of the casing than the metal-loss scenario 106. Accordingly, determining whether to suspend the well from production and take the necessary remedial actions based on metal-loss scenarios is difficult.

[0028] In some cases, data-driven models and dynamic decision processes can be used to analyze electromagnetic (EM) corrosion logs, predict downhole casing leaks, and/or forecast a well completion life. Moreover, a risk-based corrosion logging frequency model can be developed to provide safe and practical monitoring of

downhole casing integrity.

[0029] FIG. 2 illustrates an example method 200 for predicting downhole casing leaks according to an implementation. For clarity of presentation, the description that follows generally describes method 200 in the context of FIGS. 1, 3, 4A-4D, and 5-6. However, it should be understood by those of ordinary skill in the art that method 200 may be performed, for example, by any other suitable system, environment, software, and hardware, or a combination of systems, environments, software, and hardware as appropriate. In some implementations, various steps of method 200 can be run in parallel, in combination, in loops, and/or in any order.

[0030] At 202, raw corrosion data is obtained. In some cases, the raw corrosion data can be obtained from EM corrosion logs associated with downhole casings. For example, a user from the service company analyzing hotspots can run EM corrosion logging tools to generate corrosion logs. In some cases, raw corrosion data for more than one hotspot can be obtained from the logging tools. A casing string (“string”) is a long section of connected oilfield pipe that can be lowered into a wellbore and cemented. In some cases, the corrosion logs for a hotspot can include both nominal thickness and thickness loss for one or more strings.

[0031] Turning now to FIG. 6, FIG. 6 illustrates a top-level view 600 of example layered strings according to an implementation. As shown in FIG. 6, the top-level view 600 includes a top view of strings 610, 620, and 630. In some cases, the raw corrosion data generated by EM logging tools can include a nominal thickness value for each of the strings 610, 620, and 630. The raw corrosion data can also include a metal thickness loss value for each of casing strings 610, 620, and 630.

[0032] Returning to FIG. 2, from 202, method 200 proceeds to 204.

[0033] At 204, one or more corrosion parameters for a hotspot is determined. The examples of the corrosion parameters can include an Average Remaining Barrier (ARB) value, a Corrosion Rate (CR) value, and an Expected Life (EL) value. The ARB for the hotspot is calculated based on metal thickness values for the hotspot. The ARB represents a circumferential average of a number of remaining strings between a subsurface formation, e.g., shallow water-bearing formations, and the wellbore. The ARB is a normalized parameter that accounts for different combinations and sizes of downhole casings. The following equation represents an example definition of the ARB for a hotspot:

$$ARB = X - \left[\frac{T_{L1}}{T_{N1}} + \frac{T_{L2}}{T_{N2}} + \frac{T_{L3}}{T_{N3}} \dots \dots \frac{T_{LX}}{T_{NX}} \right]$$

[0034] where X represents the number of strings in the hotspot, T_{Li} represents the thickness loss of the i-th string, and T_{Ni} represents the nominal thickness of the i-th string. From 204, method 200 proceeds to 206.

[0035] In some cases, the CR value can be calculated based on an average metal loss rate per year. For example, the CR value can be calculated based on the metal loss and a number of years since the date of a previous log. In some cases, the completion date of the hotspot can be used if the date of the last base log is not available. In some cases, the metal loss can be calculated based on the original thickness and the remaining thickness. The remaining thickness may represent the existing total average thickness of all casing strings read by the EM corrosion logging tool across the entire hotspot. The following equation represents an example definition of the CR for a hotspot in mills per year.

$$[0036] \quad \text{Corrosion Rate(mpy)} = \frac{[Original\ Thickness(in) - Remaining\ Thickness(in)] \times 1000}{Number\ of\ years\ since\ the\ last\ baselog}$$

[0037] Alternatively or in combination, the CR can also be calculated based on average weight loss per year or rate of penetration into a casing. In some cases, CRs for leaking hotspots are not calculated because the leaking hotspots may need to be repaired before resuming service.

[0038] Based on the calculated CR, EL can be calculated based on the CR, an average remaining thickness, and a retirement thickness. In some cases, the retirement thickness can be a predefined value that represents a statistically estimated threshold below which a casing may be retired. The following equation represents an example definition of the EL:

$$[0039] \quad \text{Expected Life(years)} = \frac{[Remaining\ thickness(in) - Retirement\ thickness\ (in)] \times 1000}{Corrosion\ rate\ (mpy)}$$

[0040] In some cases, ELs for leaking hotspots are not calculated because the leaking hotspots may need to be repaired before resuming service.

[0041] From 204, method 200 proceeds to 206, where the probability distribution curves for the corrosion parameters are generated. In some cases, probability distribution curves for leaking hotspots and non-leaking hotspots are generated separately. The leaking hotspots can include wells that have been confirmed to have casing failures. The non-leaking hotspots can include wells that do not have

casing integrity issues. In some cases, whether a hotspot has casing failure can be determined based on a well history log or workover rig findings. In some cases, a workover may be a well intervention operation performed by a rig to maintain the wells integrity and/or productivity. In some cases, casing leaks may be confirmed by pressure testing that is conducted after pulling out the tubing and packer using a workover rig.

[0042] In some cases, the normal probability distribution curves for leaking and non-leaking hotspots can be plotted to correlate the risk of developing casing failures versus metal loss values, the ARB values, the CR values, and/or the EL values. In some cases, the metal loss values are output by the EM logging tools, while the ARB, CR, and EL values are calculated as discussed above. In addition, threshold values, beyond which the risk of developing casing leaks sharply increases, can be defined based on normal probability distribution curves. The following equations illustrate an example method of generating normal probability distribution curves based on average metal loss, ARB values, CR values, and EL values.

[0043] The mean and standard deviation of metal loss percentages of non-leaking hotspots can be determined using the following equations:

$$\mu_{NLML} = \frac{\sum_{i=1}^n (MLi)}{n}$$

$$\alpha_{NLML} = \sqrt{\frac{\sum_{i=1}^n (MLi - \mu_{NLML})^2}{n - 1}}$$

[0044] where MLi represents the metal loss values in percentage of the i -th non-leaking hotspot, μ_{NLML} represents the average of the metal loss values of the non-leaking hotspot, and α_{NLML} represents the standard deviation of metal loss values for non-leaking hotspots.

[0045] Similarly, the mean and standard deviation of metal loss percentages of leaking hotspots can be calculated using the following equations:

$$\mu_{LML} = \frac{\sum_{i=1}^n (MLi)}{n}$$

$$\alpha_{LML} = \sqrt{\frac{\sum_{i=1}^n (MLi - \mu_{LML})^2}{n - 1}}$$

[0046] where MLi represents the metal loss values in percentage of the i -th leaking hotspot, μ_{LML} represents the average of the metal loss values of the leaking

hotspot, and α_{LML} represents the standard deviation of metal loss values for the leaking hotspots.

[0047] The metal loss probability distributions for non-leaking (P1) and leaking (P2) hotspots can be calculated in the following equations:

$$P_1(ML \geq ML_0) = \frac{1}{\sqrt{2\pi}\alpha_{NLML}} \int_{ML_0}^{\infty} e^{-\frac{(ML-\mu_{NLML})^2}{2\alpha_{NLML}^2}} dML$$

$$P_2(ML \leq ML_0) = \frac{1}{\sqrt{2\pi}\alpha_{LML}} \int_{-\infty}^{ML_0} e^{-\frac{(ML-\mu_{LML})^2}{2\alpha_{LML}^2}} dML$$

5 [0048] FIG. 4A is an example metal loss probability distribution chart 410 according to an implementation. The example metal loss probability distribution chart 410 includes metal loss probability distribution curves for the leaking and non-leaking hotspots based on the above-described equations. For example, as shown in FIG. 4A, 50% of the leaking hotspots have average metal loss values of about 60% or higher,
10 while 50% of the non-leaking hotspots have average metal loss values of about 30% or higher.

[0049] Referring to FIG. 2, the mean and standard deviation of ARB values for non-leaking hotspots can be calculated as follows:

$$\mu_{NLARB} = \frac{\sum_{i=1}^n (ARB_i)}{n}$$

$$\alpha_{NLARB} = \sqrt{\frac{\sum_{i=1}^n (ARB_i - \mu_{NLARB})^2}{n-1}}$$

[0050] where ARB_i represents the ARB of the i-th non-leaking hotspot, μ_{NLARB}
15 represents the average ARB value of the non-leaking hotspot, and α_{NLARB} represents the standard deviation of ARB values for non-leaking hotspots.

[0051] Similarly, the mean and standard deviation of ARB values for leaking hotspots can be calculated as follows:

$$\mu_{LARB} = \frac{\sum_{i=1}^n (ARB_i)}{n}$$

$$\alpha_{LARB} = \sqrt{\frac{\sum_{i=1}^n (ARB_i - \mu_{LARB})^2}{n-1}}$$

[0052] where ARB_i represents the ARB of the i-th leaking hotspot, μ_{LARB}
20 represents the average ARB value of the leaking hotspot, and α_{LARB} represents the

standard deviation of ARB values for leaking hotspots.

[0053] The ARB probability distributions for non-leaking (P3) and leaking (P4) hotspots with respect to a ARB threshold ARB_0 can be calculated in the following equations:

$$P_3(ARB \leq ARB_0) = \frac{1}{\sqrt{2\pi}\alpha_{NLARB}} \int_{-\infty}^{ARB_0} e^{-\frac{(ARB-\mu_{NLARB})^2}{2\alpha_{NLARB}^2}} dARB$$

$$P_4(ARB \geq ARB_0) = \frac{1}{\sqrt{2\pi}\alpha_{LARB}} \int_{ARB_0}^{\infty} e^{-\frac{(ARB-\mu_{LARB})^2}{2\alpha_{LARB}^2}} dARB$$

5 [0054] FIG. 4B is an example ARB probability distribution chart 420 according to an implementation. The example ARB probability distribution chart 420 includes ARB probability distribution curves for the leaking and non-leaking hotspots based on the above calculations. For example, as shown in FIG. 4B, 50% of the leaking hotspots have ARBs of about 2.1 or higher, while 50% of the non-leaking
10 hotspots have ARBs of about 1.1 or higher.

[0055] Referring to FIG. 2, the mean and standard deviation of CR values for non-leaking hotspots can be calculated as follows:

$$\mu_{NLCR} = \frac{\sum_{i=1}^n (CR_i)}{n}$$

$$\alpha_{NLCR} = \sqrt{\frac{\sum_{i=1}^n (CR_i - \mu_{NLCR})^2}{n - 1}}$$

[0056] where CR_i represents the CR of the i-th non-leaking hotspot, μ_{NLCR} represents the average CR value of the non-leaking hotspot, and α_{NLCR} represents the
15 standard deviation of CR values for non-leaking hotspots.

[0057] The CR probability distribution for non-leaking (P5) hotspots can be calculated in the following equation:

$$P_5(CR) = \frac{1}{\sqrt{2\pi}\alpha_{NLCR}} \times e^{-\frac{(CR-\mu_{NLCR})^2}{2\alpha_{NLCR}^2}}$$

[0058] FIG. 4C is an example CR probability distribution chart 430 according to an implementation. The example CR probability distribution chart 430 includes a
20 CR probability distribution curve for the non-leaking hotspots based on the above calculations. For example, as shown in FIG. 4C, 50% of the non-leaking hotspots have CRs at about 7.5 mpy or higher.

[0059] Referring to FIG. 2, the mean and standard deviation of EL values for

non-leaking hotspots can be calculated as follows:

$$\mu_{NLEL} = \frac{\sum_{i=1}^n (EL)_i}{n}$$

$$\alpha_{NLEL} = \sqrt{\frac{\sum_{i=1}^n (EL)_i - \mu_{NLEL})^2}{n - 1}}$$

[0060] where EL_i represents the EL of the i -th non-leaking hotspot, μ_{NLEL} represents the average EL value of the non-leaking hotspot, and α_{NLEL} represents the standard deviation of EL values for non-leaking hotspots.

5 [0061] The EL probability distribution for non-leaking (P6) hotspots can be calculated in the following equation:

$$P_6(EL \leq EL_0) = \int_{-\infty}^{EL_0} \frac{1}{\sqrt{2\pi}\alpha_{NLEL}} e^{-\frac{(EL-\mu_{NLEL})^2}{2\alpha_{NLEL}^2}}$$

[0062] FIG. 4D is an example EL probability distribution chart 440 according to an implementation. The example EL probability distribution chart 440 includes an EL probability distribution curve for the non-leaking hotspots based on the above calculations. For example, as shown in FIG. 4D, 50% of the non-leaking hotspots
10 have ELs of 40 years or higher.

[0063] Referring back to FIG. 2, from 206, method 200 proceeds to 208.

[0064] At 208, a corrosion severity classification matrix is generated. In some cases, the corrosion severity classification matrix can be generated using risk-based
15 cutoffs for the metal loss, ARB, CR, EL values, or any combination thereof. The risk-based cutoffs can be determined based on a function of standard deviations and the averages of the metal loss, ARB, CR, or EL values. For example, the cutoffs can be set as multiples of the standard deviations from the averages. The corrosion severity classification matrix can include a plurality of corrosion severity classes, each
20 corresponding to a risk-based cutoff value.

[0065] FIG. 5A illustrates an example corrosion severity classification definition table 510 according to an implementation. The corrosion severity classification definition table 510 defines corrosion severity classes 0-3, where class 0 represents the class with most severe loss. As illustrated, cutoffs of the metal loss,
25 ARB, CR, and EL values for each of the corrosion severity classes 0-3 are listed in the corrosion severity classification definition table 510. For example, X_{ML0} , X_{ML1} , and X_{ML2} are cutoffs for the metal loss values. X_{ML0} is set to the larger value of ($\mu_{LML} -$

α_{LML}) and $(\mu_{NLML} + \alpha_{NLML})$; X_{ML1} is set to $X_{ML0} - \alpha_{LML}$; X_{ML2} is set to $X_{ML1} - \alpha_{NLML}$.

For class 3, the average metal loss is less than X_{ML2} ; for class 2, the average metal loss is between X_{ML2} and X_{ML1} ; for class 1, the average metal loss is between X_{ML1} and X_{ML0} ; and for class 0, the average metal loss is greater or equal to X_{ML0} . Cutoffs for
 5 ARB, CR, and EL can similarly be defined for each corrosion severity class.

[0066] FIG. 5B illustrates an example corrosion severity classification matrix
 520 according to an implementation. The corrosion severity classification matrix 520 includes the numerical values of cutoffs for each class. The corrosion severity classification matrix 520 is generated based on the definitions listed in the corrosion
 10 severity classification definition table 510 and the numerical values of average metal loss, ARB, CR, and EL of more than 100 wells.

[0067] In some cases, each class is associated with one or more remedial measures or actions. This approach may alert the service companies about the different risk levels for each hotspot and, therefore, provision different actions. For
 15 example, each class can be associated with an inspection frequency. A more severe class may be associated with a higher inspection frequency. In some cases, the frequency can be calculated as a weighted average of the expected life values fallen within each class interval according to the severity classification matrix. A safety factor can also be included in the frequency calculation to account for the uncertainty
 20 of extrapolating the metal loss growth. This safety factor correlates with the variation of corrosion rate values. The following equation represents an example calculation of the safety factor as a function of the ratio between the lowest and the highest expected corrosion rates, respectively:

$$SF = \frac{CR_{z=-1}}{CR_{z=+1}}$$

where SF represents a dimensionless risk-based safety factor, $CR_{z=-1}$ represents the
 25 CR value one standard deviation less than the average value, and $CR_{z=+1}$ represents the CR value one standard deviation more than the average value. $CR_{z=-1}$ and $CR_{z=+1}$ are dependent on both the average and standard deviation of the corrosion rate data. Therefore, the safety factor is dynamic and can be updated when more corrosion rate data is collected. The following equation represents an example calculated of the
 30 corrosion logging frequency for each severity class:

$$Freq_i = SF \frac{\int_{t_i}^{t_{i+1}} f(t) t dt}{\int_{t_i}^{t_{i+1}} f(t) dt}$$

[0068] where, $Freq_i$ represents the corrosion logging frequency of the i -th class, $f(t)$ represents the probability density function of the EL values, and t represents the EL. As illustrated, the corrosion severity classification matrix 520 includes an inspection frequency of 2, 4, and 8 years for class 1, 2, and 3, respectively.

5 The corrosion severity classification matrix 520 also indicates that class 0 has a high risk to develop a leak. By setting the remedial action for each class, the service company can determine the remedial action for each hotspot based on the classification of the hotspot and take the predefined remedial action accordingly.

[0069] Referring back to FIG. 2, from 208, method 200 proceeds to 210.

10 [0070] At 210, hotspots are grouped into the plurality of corrosion severity classes based on the corrosion severity classification matrix. In some cases, the grouping is based on the cutoffs defined in the matrix and the metal loss, ARB, CR, EL, or any combination thereof. For example, if a hotspot has an average metal loss between X_{ML1} and X_{ML0} , an ARB between X_{ARB1} and X_{ARB0} , an CR greater or equal to X_{CR1} , and an EL greater or equal to X_{EL1} , the hotspot can be grouped into class 1. In some cases, different parameters, e.g., the metal loss, ARB, CR, EL, of a hotspot may fall into ranges of different corrosion classes according to the corrosion severity classification matrix. In these or other cases, the hotspot may be classified based on the most severe class. For example, the average metal loss of a hotspot may be
 20 between X_{ML1} and X_{ML0} , which may be the range for corrosion class 1, while the ARB of the hotspot may be between X_{ARB2} and X_{ARB1} , which may be the range for corrosion class 2. In this example, the hotspot may be grouped into corrosion class 1, which is more severe than class 2.

[0071] The casing leaking prediction approach discussed is data driven and
 25 dynamic. For example, any combination of the steps discussed above can be the repeated when additional raw EM corrosion data is obtained. In one example, when additional raw corrosion data for one well is obtained, the metal loss, ARB, CR, and EL for the well can be calculated. A determination can be made on whether the well is leaking or not leaking. If the well is leaking, then the mean and average of the metal
 30 loss, ARB, CR, and EL of leaking hotspots can be updated to include the values of the

well. The probability distribution curves for the leaking hotspots can also be re-generated accordingly. Similarly, if the well is not leaking, then the mean and average of the metal loss, ARB, CR, and EL of non-leaking hotspots can be updated to include the values of the well. The probability distribution curves for the non-leaking hotspots
5 can also be re-generated accordingly, and accordingly, the corrosion severity classification matrix can also be updated. In some cases, the logging frequencies for different classes can also be re-calculated to incorporate the additional raw EM corrosion data.

[0072] FIG. 3 is a high-level architecture block diagram of a casing leak
10 prediction data processing system 300 according to an implementation. At a high level, the illustrated system 300 includes a user 370 that is communicably coupled with a casing leak prediction data processing computer 302 through a network 330. The described illustration is only one possible implementation of the described subject matter and is not intended to limit the disclosure to the single described
15 implementation. Those of ordinary skill in the art will appreciate the fact that the described components can be connected, combined, and/or used in alternative ways consistent with this disclosure.

[0073] The user 370 represents a person, an application, set of applications, software, software modules, hardware, or combination thereof that can be used to
20 predict casing leaks. For example, the user 370 can be a service personnel in a service company that is responsible for well maintenance.

[0074] The network 330 facilitates communications between the components of the system 300 (e.g., between the user 370 and the casing leak prediction data processing computer 302). In some cases, the user 370 can access the casing leak
25 prediction data processing computer 302 from a remote network. In these or other cases, the network 330 can be a wireless or a wireline network. In some cases, the user 370 can access the casing leak prediction data processing computer 302 locally. In these or other cases, the network 330 can also be a memory pipe, a hardware connection, or any internal or external communication paths between the components.

[0075] The casing leak prediction data processing computer 302 includes a
30 computing system configured to predict casing leaks. In some cases, the algorithm of the casing leak prediction process can be implemented in an executable computing code, e.g., C/C++ executable codes. Alternatively or in combination, the algorithm of

the casing leak prediction process can be implemented in an application program, e.g., EXCEL. In some cases, the casing leak prediction data processing computer 302 can include a standalone Linux system that runs batch applications. In some cases, the casing leak prediction processing computer 302 can include mobile or personal computers that run the application program.

[0076] The computer 302 may comprise a computer that includes an input device, such as a keypad, keyboard, touch screen, microphone, speech recognition device, other device that can accept user information, and/or an output device that conveys information associated with the operation of the computer 302, including digital data, visual and/or audio information, or a GUI.

[0077] The computer 302 can serve as a client, network component, a server, a database or other persistency, and/or any other component of the system 300. In some implementations, one or more components of the computer 302 may be configured to operate within a cloud-computing-based environment.

[0078] At a high level, the computer 302 is an electronic computing device operable to receive, transmit, process, store, or manage data and information associated with the system 300. According to some implementations, the computer 302 may also include or be communicably coupled with an application server, e-mail server, web server, caching server, streaming data server, business intelligence (BI) server, and/or other server.

[0079] The computer 302 can receive requests over network 330 from a client application (e.g., executing on another computer 302) and respond to the received requests by processing the said requests in an appropriate software application. In addition, requests may also be sent to the computer 302 from internal users (e.g., from a command console or by another appropriate access method), external or third parties, other automated applications, as well as any other appropriate entities, individuals, systems, or computers.

[0080] Each of the components of the computer 302 can communicate using a system bus 503. In some implementations, any and/or all the components of the computer 302, both hardware and/or software, may interface with each other and/or the interface 304 over the system bus 303 using an application programming interface (API) 312 and/or a service layer 313. The API 312 may include specifications for routines, data structures, and object classes. The API 312 may be either computer

language-independent or -dependent and refer to a complete interface, a single function, or even a set of APIs. The service layer 313 provides software services to the computer 302 and/or the system 300. The functionality of the computer 302 may be accessible for all service consumers using this service layer. Software services,
5 such as those provided by the service layer 313, provide reusable, defined business functionalities through a defined interface. For example, the interface may be software written in JAVA, C++, or other suitable language providing data in Extensible Markup Language (XML) format or other suitable format. While illustrated as an integrated component of the computer 302, alternative implementations may illustrate the API
10 312 and/or the service layer 313 as stand-alone components in relation to other components of the computer 302 and/or system 300. Moreover, any or all parts of the API 312 and/or the service layer 313 may be implemented as child or sub-modules of another software module, enterprise application, or hardware module without departing from the scope of this disclosure.

15 [0081] The computer 302 includes an interface 304. Although illustrated as a single interface 304 in FIG. 3, two or more interfaces 304 may be used according to particular needs, desires, or particular implementations of the computer 302 and/or system 300. The interface 304 is used by the computer 302 for communicating with other systems in a distributed environment - including within the system 300 -
20 connected to the network 330 (whether illustrated or not). Generally, the interface 304 comprises logic encoded in software and/or hardware in a suitable combination and operable to communicate with the network 330. More specifically, the interface 304 may comprise software supporting one or more communication protocols associated with communications such that the network 330 or interface's hardware is operable to
25 communicate physical signals within and outside of the illustrated system 300.

[0082] The computer 302 includes a processor 305. Although illustrated as a single processor 305 in FIG. 3, two or more processors may be used according to particular needs, desires, or particular implementations of the computer 302 and/or the system 300. Generally, the processor 305 executes instructions and manipulates data
30 to perform the operations of the computer 302. Specifically, the processor 305 executes the functionality required for predicting casing leaks.

[0083] The computer 302 also includes a memory 306 that holds data for the computer 302 and/or other components of the system 300. Although illustrated as a

single memory 306 in FIG. 3, two or more memories may be used according to particular needs, desires, or particular implementations of the computer 302 and/or the system 300. While memory 306 is illustrated as an integral component of the computer 302, in alternative implementations, memory 306 can be external to the computer 302 and/or the system 300.

[0084] The application 307 is an algorithmic software engine providing functionality according to particular needs, desires, or particular implementations of the computer 302 and/or the system 300, particularly with respect to functionality required for predicting casing leaks. For example, application 307 can serve as one or more components/applications described in FIGS. 1-2 and 4-6. Further, although illustrated as a single application 307, the application 307 may be implemented as multiple applications 307 on the computer 302. In addition, although illustrated as integral to the computer 302, in alternative implementations, the application 307 can be external to the computer 302 and/or the system 300.

[0085] There may be any number of computers 302 associated with, or external to, the system 300 and communicating over network 330. Further, the terms "client," "user," and other appropriate terminology may be used interchangeably as appropriate without departing from the scope of this disclosure. Moreover, this disclosure contemplates that many users may use one computer 302, or that one user may use multiple computers 302.

[0086] Implementations of the subject matter and the functional operations described in this specification can be implemented in digital electronic circuitry, in tangibly embodied computer software or firmware, in computer hardware, including the structures disclosed in this specification and their structural equivalents, or in combinations of one or more of them. Implementations of the subject matter described in this specification can be implemented as one or more computer programs, i.e., one or more modules of computer program instructions encoded on a tangible, non-transitory computer-storage medium for execution by, or to control the operation of, data processing apparatus. Alternatively or in addition, the program instructions can be encoded on an artificially generated propagated signal, e.g., a machine-generated electrical, optical, or electromagnetic signal that is generated to encode information for transmission to suitable receiver apparatus for execution by a data processing apparatus. The computer-storage medium can be a machine-readable

storage device, a machine-readable storage substrate, a random or serial access memory device, or a combination of one or more of them.

[0087] The terms “data processing apparatus,” “computer,” or “electronic computer device” (or equivalent as understood by one of ordinary skill in the art) refer to data processing hardware and encompass all kinds of apparatus, devices, and machines for processing data, including by way of example, a programmable processor, a computer, or multiple processors or computers. The apparatus can also be or further include special purpose logic circuitry, e.g., a central processing unit (CPU), an FPGA (field programmable gate array), or an ASIC (application-specific integrated circuit). In some implementations, the data processing apparatus and/or special purpose logic circuitry may be hardware-based and/or software-based. The apparatus can optionally include code that creates an execution environment for computer programs, e.g., code that constitutes processor firmware, a protocol stack, a database management system, an operating system, or a combination of one or more of them. [00101] What is claimed is:

CLAIMS

1. A method for predicting downhole casing leaks of hotspots, comprising:

obtaining, by a data processing apparatus, raw electromagnetic (EM) corrosion
5 data for a hotspot, wherein the raw EM corrosion data includes a metal thickness loss value for the hotspot;

determining, by the data processing apparatus, a corrosion parameter based on the raw EM corrosion data, wherein the corrosion parameter includes at least one of an average remaining barrier, a corrosion rate, or an expected life;

10 generating, by the data processing apparatus, a probability distribution curve for the corrosion parameter;

generating, by the data processing apparatus, a corrosion severity classification matrix based on the probability distribution curve, wherein the corrosion severity classification matrix includes a plurality of corrosion severity classes and cutoff values
15 for each of the plurality of corrosion severity classes; and

assigning, by the data processing apparatus, the hotspot into one of the plurality of corrosion severity classes based on the corrosion severity classification matrix and the corrosion parameter of the hotspot.

20 2. The method of claim 1, wherein the generation of the probability distribution curve comprises:

determining whether the hotspot is a leaking hotspot or a non-leaking hotspot;

if the hotspot is a leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for leaking hotspots; and

25 if the hotspot is a non-leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for non-leaking hotspots.

3. The method of claim 1, wherein the raw EM corrosion data includes
30 metal loss values for a plurality of strings, and the corrosion parameter includes the average remaining barrier that is calculated based on a nominal thickness value for each of the plurality of strings, and a thickness loss value for each of the plurality of strings.

4. The method of claim 1, wherein the corrosion parameter includes the corrosion rate that is calculated based on an original thickness value, a remaining thickness value, and a number of years.

5

5. The method of claim 1, wherein the generation of the probability distribution curve for the corrosion parameter comprises:

calculating a mean value and a standard deviation value of the corrosion parameter for leaking hotspots;

10 calculating a mean value and a standard deviation value of the corrosion parameter for non-leaking hotspots;

generating a probability distribution function of the leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for leaking hotspots; and

15 generating a probability distribution function of the non-leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for non-leaking hotspots.

6. The method of claim 1, wherein the cutoff values for each of the plurality of corrosion severity classes is determined based on a mean value of the corrosion parameter for leaking hotspots, a standard deviation value of the corrosion parameter for leaking hotspots, a mean value of the corrosion parameter for non-leaking hotspots, and a standard deviation value of the corrosion parameter for non-leaking hotspots.

7. The method of claim 1, wherein each of the plurality of corrosion severity classes is associated with a logging frequency for the respective corrosion severity class.

8. A system for predicting downhole casing leaks of hotspots, comprising:
a memory; and
at least one hardware processor interoperably coupled with the memory and
configured to:

5 obtain raw electromagnetic (EM) corrosion data for a hotspot, wherein
the raw EM corrosion data includes a metal thickness loss value for the
hotspot;

determine a corrosion parameter based on the raw EM corrosion data,
wherein the corrosion parameter includes at least one of an average remaining
10 barrier, a corrosion rate, or an expected life;

generate a probability distribution curve for the corrosion parameter;

generate a corrosion severity classification matrix based on the
probability distribution curve, wherein the corrosion severity classification
matrix includes a plurality of corrosion severity classes and cutoff values for
15 each of the plurality of corrosion severity classes; and

assign the hotspot into one of the plurality of corrosion severity classes
based on the corrosion severity classification matrix and the corrosion
parameter of the hotspot.

20 9. The system of claim 8, wherein the generation of the probability
distribution curve comprises:

determining whether the hotspot is a leaking hotspot or a non-leaking hotspot;

if the hotspot is a leaking hotspot, generating a probability distribution curve
for the corrosion parameter based on corrosion parameters for leaking hotspots; and

25 if the hotspot is a non-leaking hotspot, generating a probability distribution
curve for the corrosion parameter based on corrosion parameters for non-leaking
hotspots.

10. The system of claim 8, wherein the raw EM corrosion data includes
30 metal loss values for a plurality of strings, and the corrosion parameter includes the
average remaining barrier that is calculated based on a nominal thickness value for
each of the plurality of strings, and a thickness loss value for each of the plurality of
strings.

11. The system of claim 8, wherein the corrosion parameter includes the corrosion rate that is calculated based on an original thickness value, a remaining thickness value, and a number of years.

5

12. The system of claim 8, wherein the generation of the probability distribution curve for the corrosion parameter comprises:

calculating a mean value and a standard deviation value of the corrosion parameter for leaking hotspots;

10 calculating a mean value and a standard deviation value of the corrosion parameter for non-leaking hotspots;

generating a probability distribution function of the leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for leaking hotspots; and

15 generating a probability distribution function of the non-leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for non-leaking hotspots.

13. The system of claim 8, wherein the cutoff values for each of the plurality of corrosion severity classes is determined based on a mean value of the corrosion parameter for leaking hotspots, a standard deviation value of the corrosion parameter for leaking hotspots, a mean value of the corrosion parameter for non-leaking hotspots, and a standard deviation value of the corrosion parameter for non-leaking hotspots.

25

14. The system of claim 8, wherein each of the plurality of corrosion severity classes is associated with a logging frequency for the respective corrosion severity class.

15. A non-transitory, computer-readable medium storing computer-readable instructions, the instructions executable by a computer and configured to:

obtain raw electromagnetic (EM) corrosion data for a hotspot, wherein the raw EM corrosion data includes a metal thickness loss value for the hotspot;

5 determine a corrosion parameter based on the raw EM corrosion data, wherein the corrosion parameter includes at least one of an average remaining barrier, a corrosion rate, or an expected life;

generate a probability distribution curve for the corrosion parameter;

10 generate a corrosion severity classification matrix based on the probability distribution curve, wherein the corrosion severity classification matrix includes a plurality of corrosion severity classes and cutoff values for each of the plurality of corrosion severity classes; and

assign the hotspot into one of the plurality of corrosion severity classes based on the corrosion severity classification matrix and the corrosion parameter of the
15 hotspot.

16. The non-transitory, computer-readable medium of claim 15, wherein the generation of the probability distribution curve comprises:

determining whether the hotspot is a leaking hotspot or a non-leaking hotspot;

20 if the hotspot is a leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for leaking hotspots; and

if the hotspot is a non-leaking hotspot, generating a probability distribution curve for the corrosion parameter based on corrosion parameters for non-leaking hotspots.

25

17. The non-transitory, computer-readable medium of claim 15, wherein the raw EM corrosion data includes metal loss values for a plurality of strings, and the corrosion parameter includes the average remaining barrier that is calculated based on a nominal thickness value for each of the plurality of strings, and a thickness loss value
30 for each of the plurality of strings.

18. The non-transitory, computer-readable medium of claim 15, wherein the corrosion parameter includes the corrosion rate that is calculated based on an original thickness value, a remaining thickness value, and a number of years.

5 19. The non-transitory, computer-readable medium of claim 15, wherein the generation of the probability distribution curve for the corrosion parameter comprises:

calculating a mean value and a standard deviation value of the corrosion parameter for leaking hotspots;

10 calculating a mean value and a standard deviation value of the corrosion parameter for non-leaking hotspots;

generating a probability distribution function of the leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for leaking hotspots; and

15 generating a probability distribution function of the non-leaking hotspots based on the mean value and the standard deviation value of the corrosion parameter for non-leaking hotspots.

20 20. The non-transitory, computer-readable medium of claim 15, wherein the cutoff values for each of the plurality of corrosion severity classes is determined based on a mean value of the corrosion parameter for leaking hotspots, a standard deviation value of the corrosion parameter for leaking hotspots, a mean value of the corrosion parameter for non-leaking hotspots, and a standard deviation value of the corrosion parameter for non-leaking hotspots.

25 21. The non-transitory, computer-readable medium of claim 15, wherein each of the plurality of corrosion severity classes is associated with a logging frequency for the respective corrosion severity class.

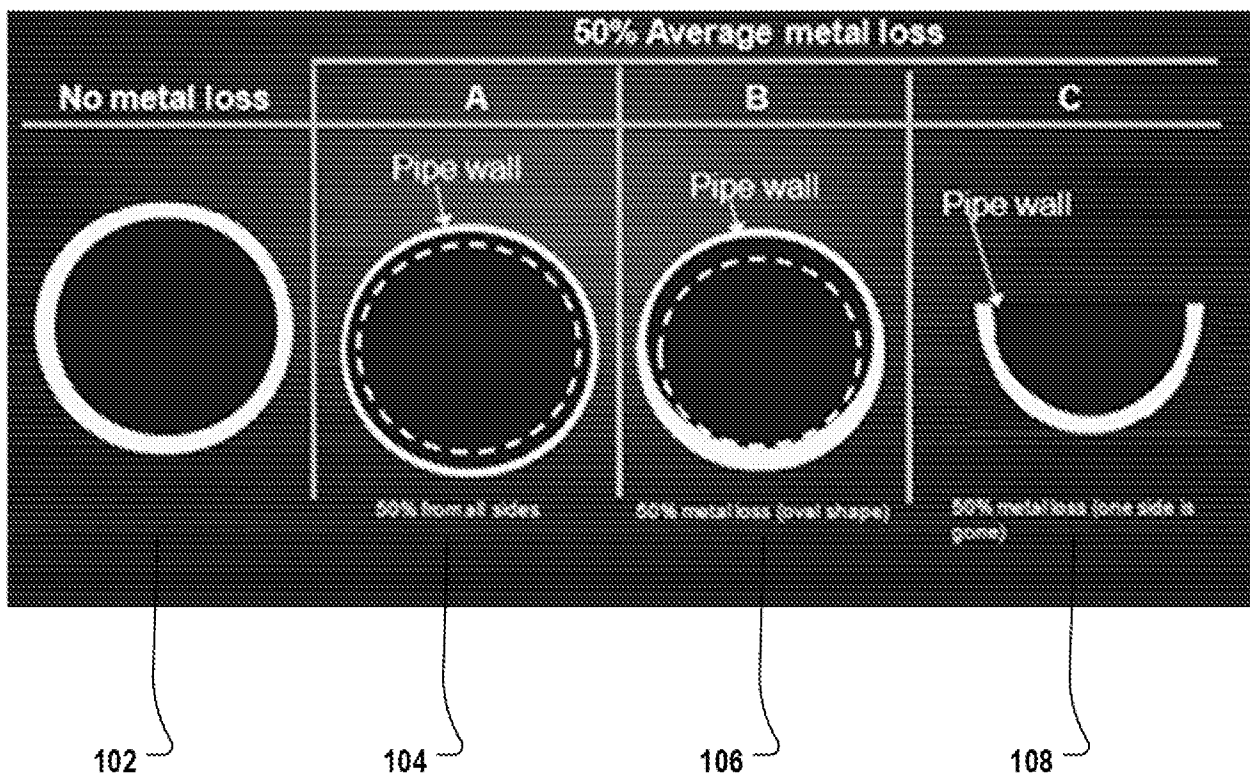

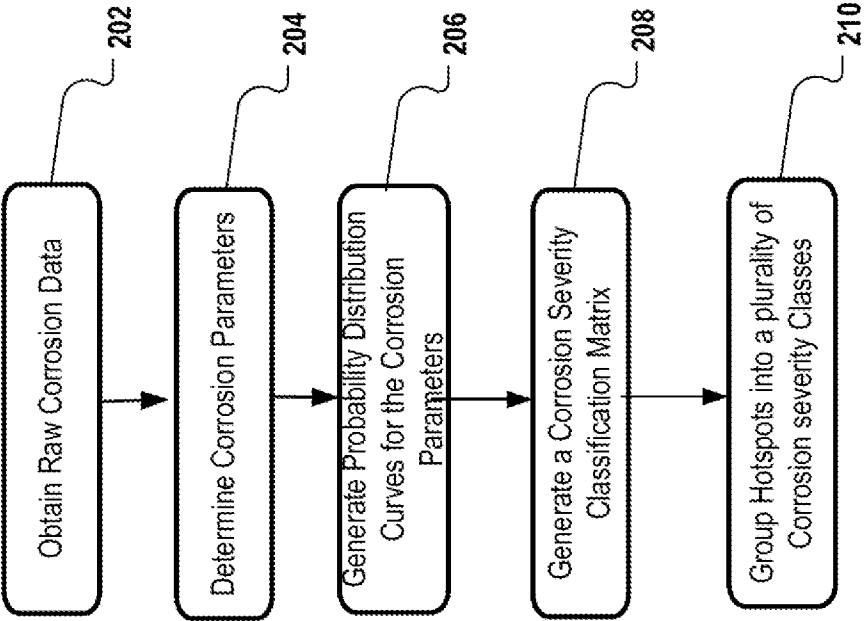

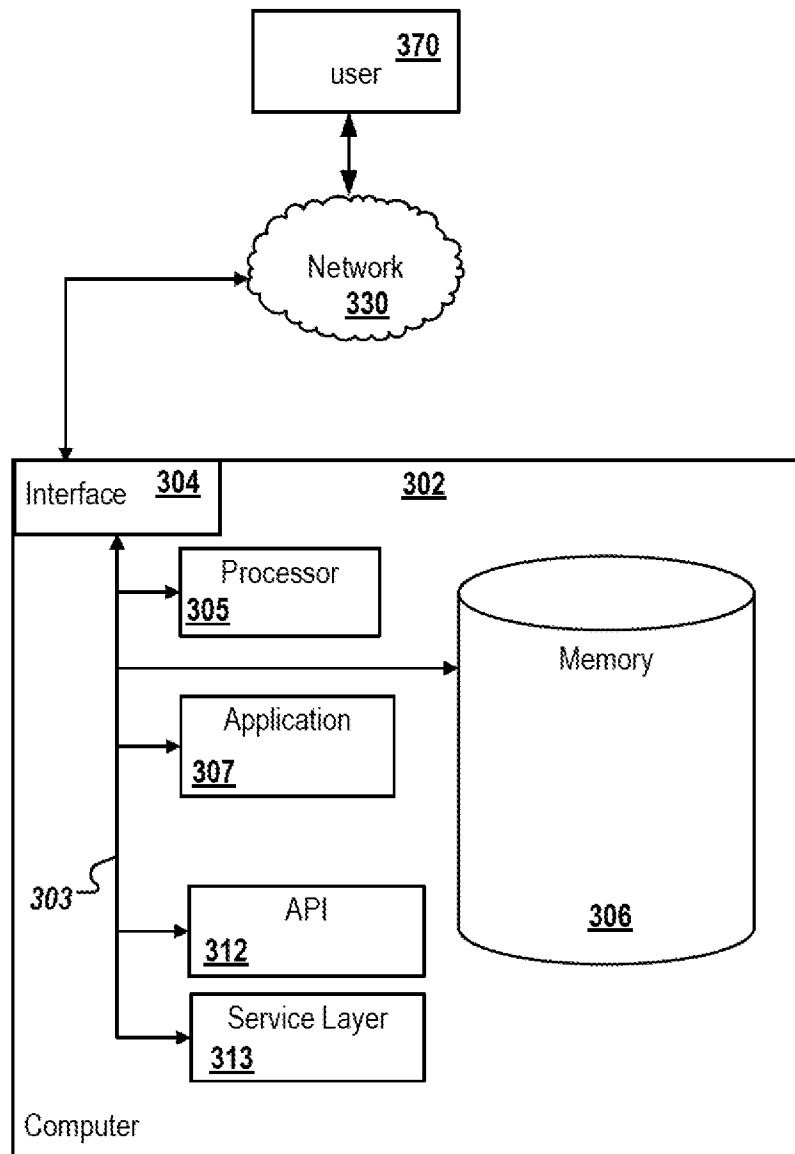

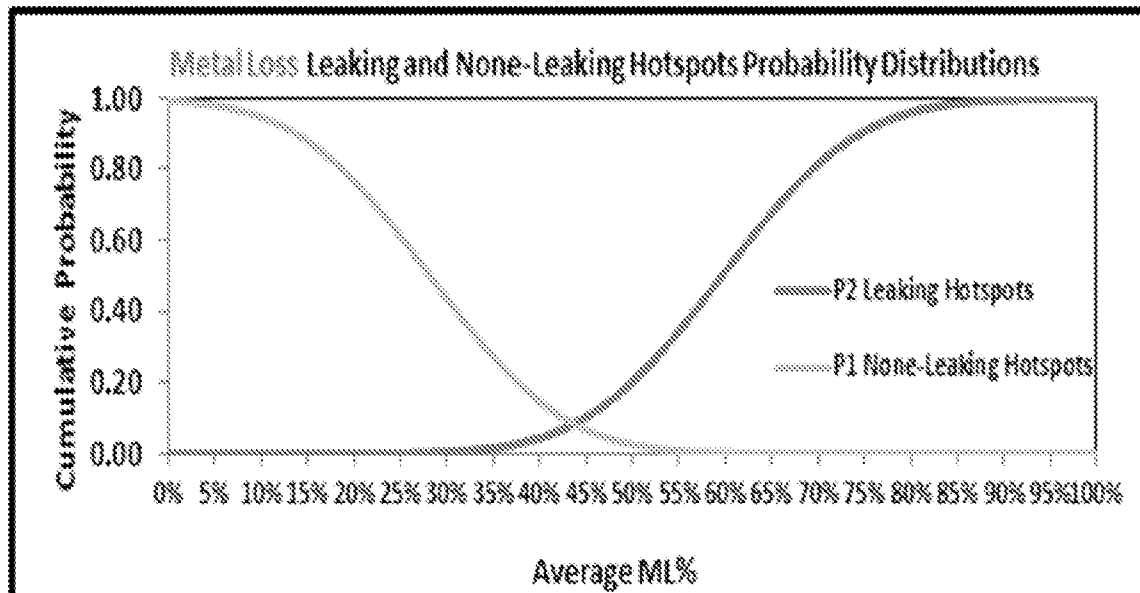
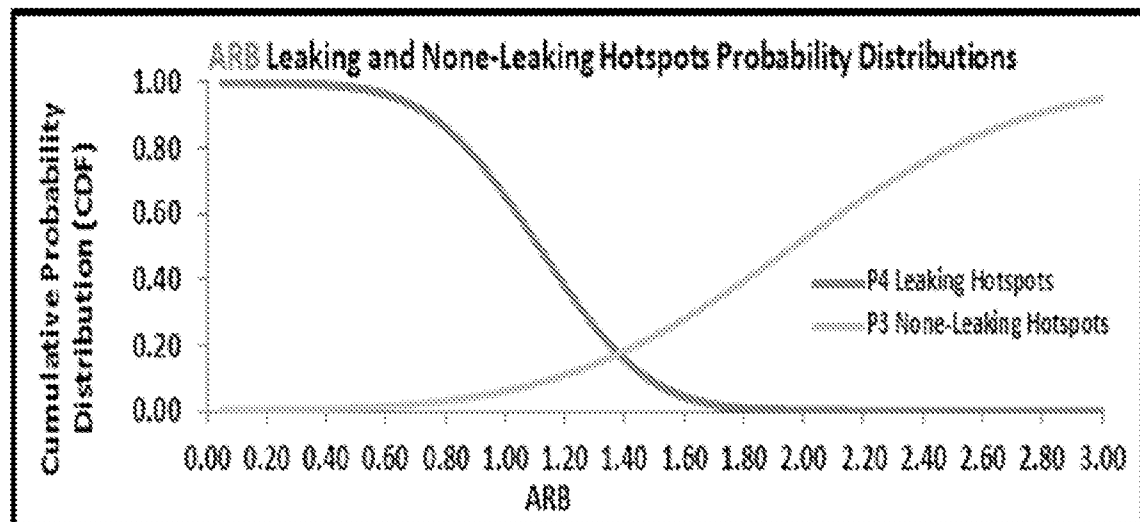

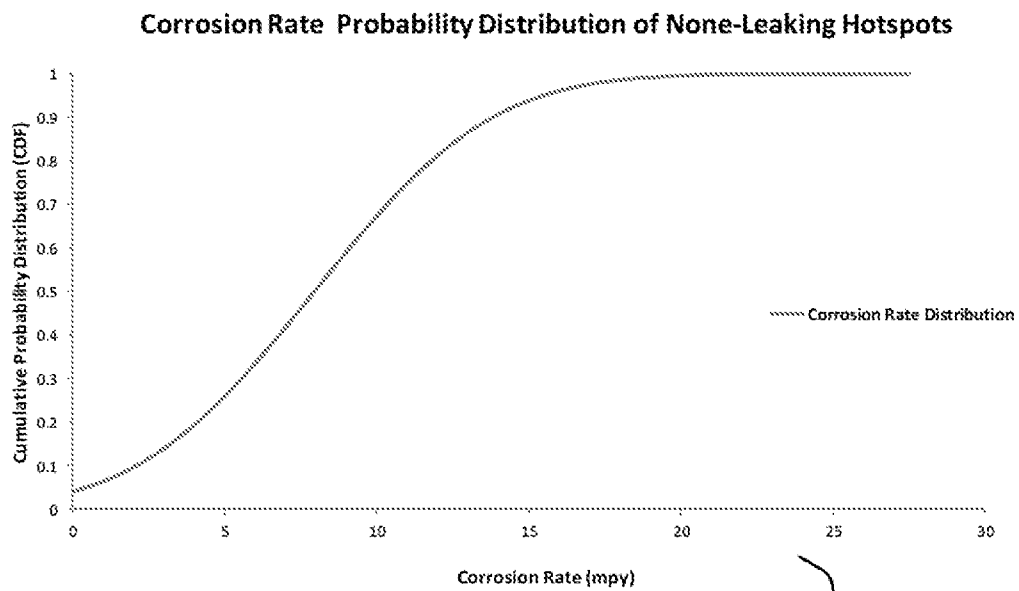

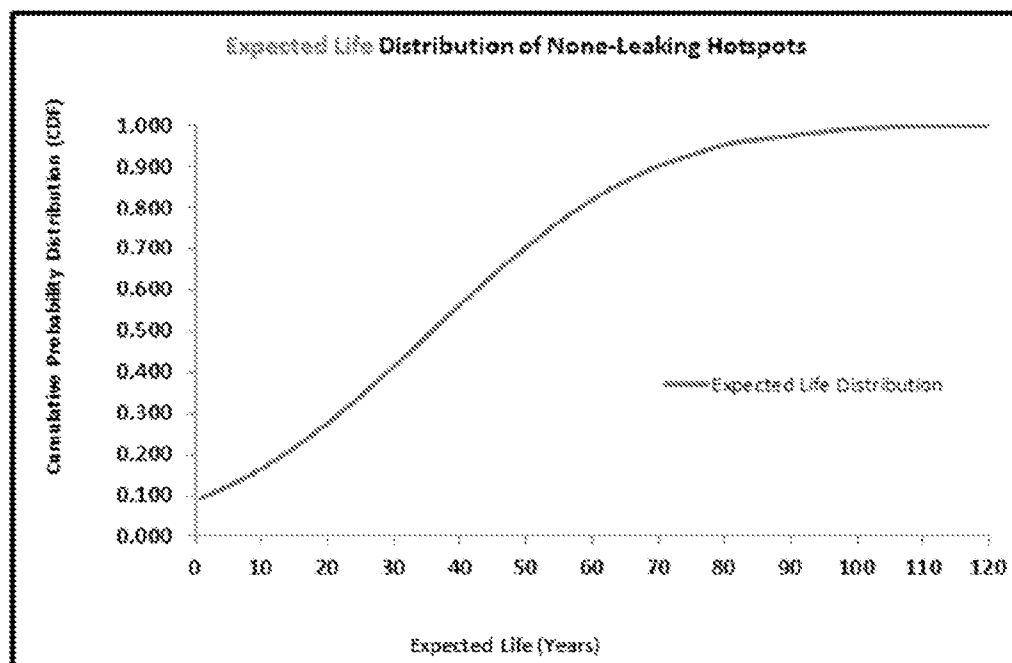

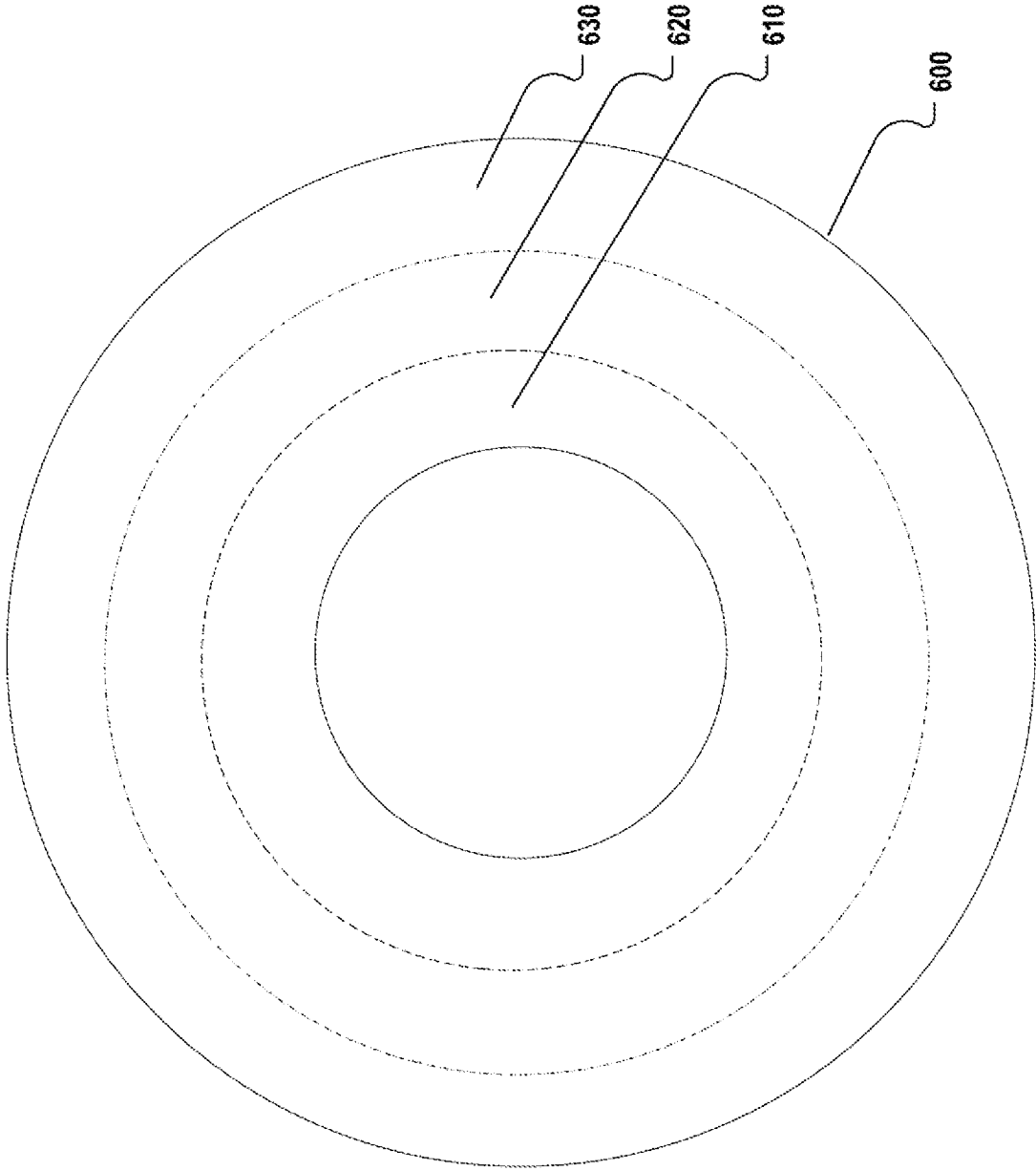
