(57) **CLAIM**


The ornamental design for a sport pet bed cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sport pet bed cover; FIG. 2 is a front elevation view of the sport pet bed cover; FIG. 3 is a rear elevation view of the sport pet bed cover; FIG. 4 is a left side elevation view of the sport pet bed cover, the right side elevation view is identical; FIG. 5 is a top plan view of the sport pet bed cover; FIG. 6 is a bottom plan view of the sport pet bed cover; and, FIG. 7 is another front perspective view of the sport pet bed cover.










