(57) **CLAIM**


The ornamental design for a cue case stand, as shown and described.

DESCRIPTION

FIG. 1 is a front top right perspective view of a cue case stand;
FIG. 2 is a back left bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right elevational view thereof;
FIG. 8 is a left elevational view thereof;
FIG. 9 is a front top right perspective view of a cue case stand in an alternate configuration; and,
FIG. 10 is a front left bottom perspective view of a cue case stand in an alternate configuration.

The broken line showing a hinge in FIGS. 1-10 and the inner edge of the opening for the strap in FIGS. 1 and 9-10 is included for the purpose of illustrating environmental structure and forms no part of the claimed design. The cue case stand is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.




















