[57] **CLAIM**

The ornamental design for a chair seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair seat constituting my new design, shown as part of a chair in phantom which does not form part of the design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a side elevational view of one side thereof, the other side being a mirror image;

FIG. 5 is a view in section taken along the line 5—5 of FIG. 2;

FIG. 6 is a top plan view of the chair seat constituting another embodiment of my new design;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a side elevational view of one side thereof, the other side being a mirror image;

FIG. 9 is a view in section taken along the line 9—9 of FIG. 6;

FIG. 10 is a top plan view of the chair seat constituting another embodiment of my new design;

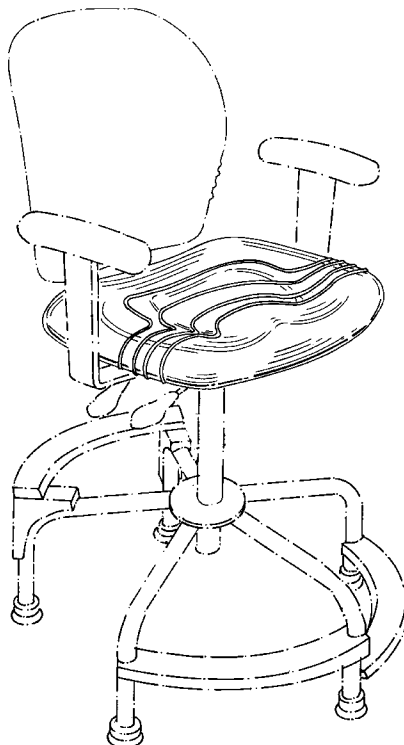
FIG. 11 is a bottom plan view thereof;

FIG. 12 is a side elevational view of one side thereof, the other side being a mirror image; and,

FIG. 13 is a view in section taken along the line 13—13 of FIG. 10.

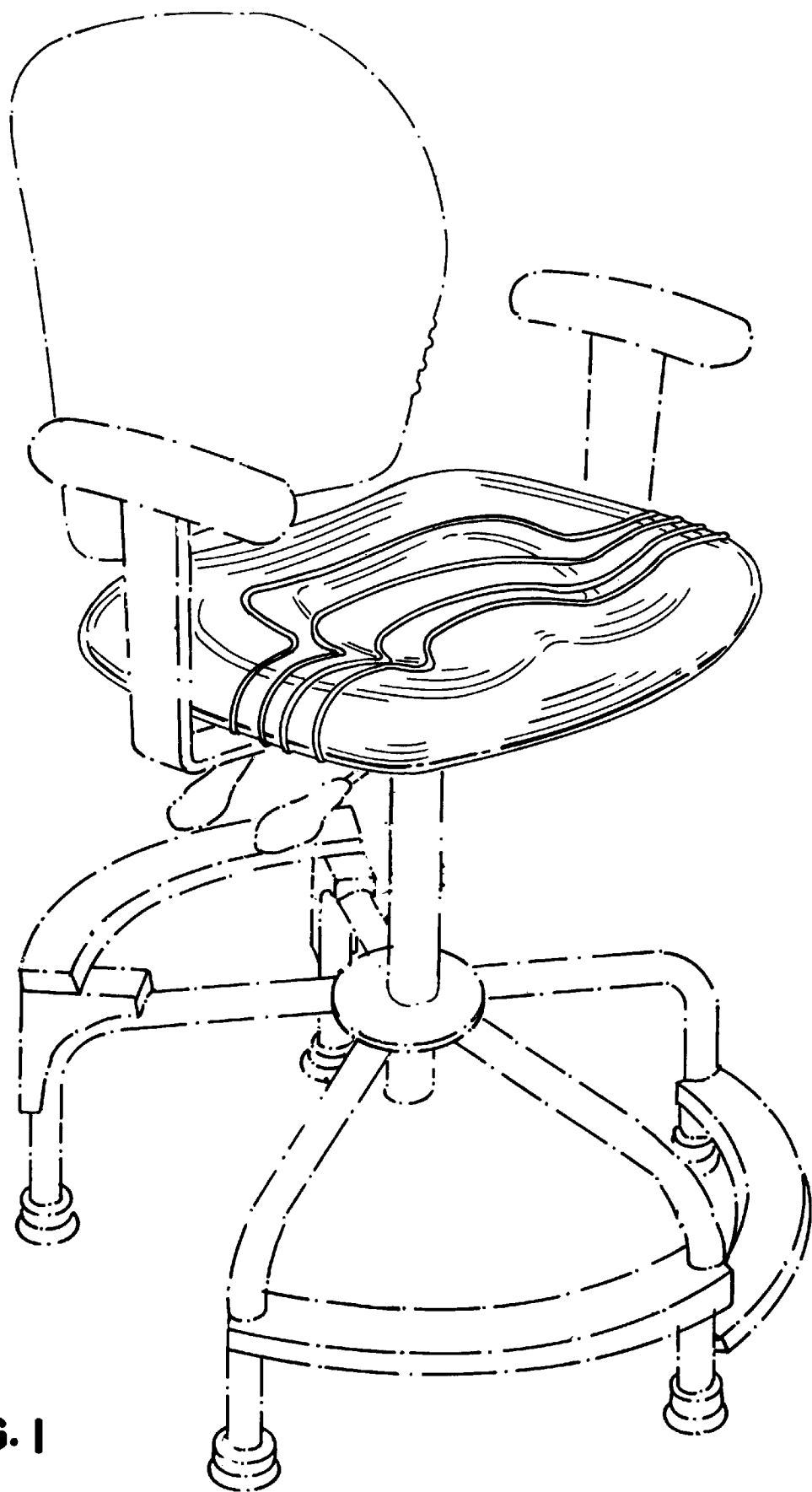

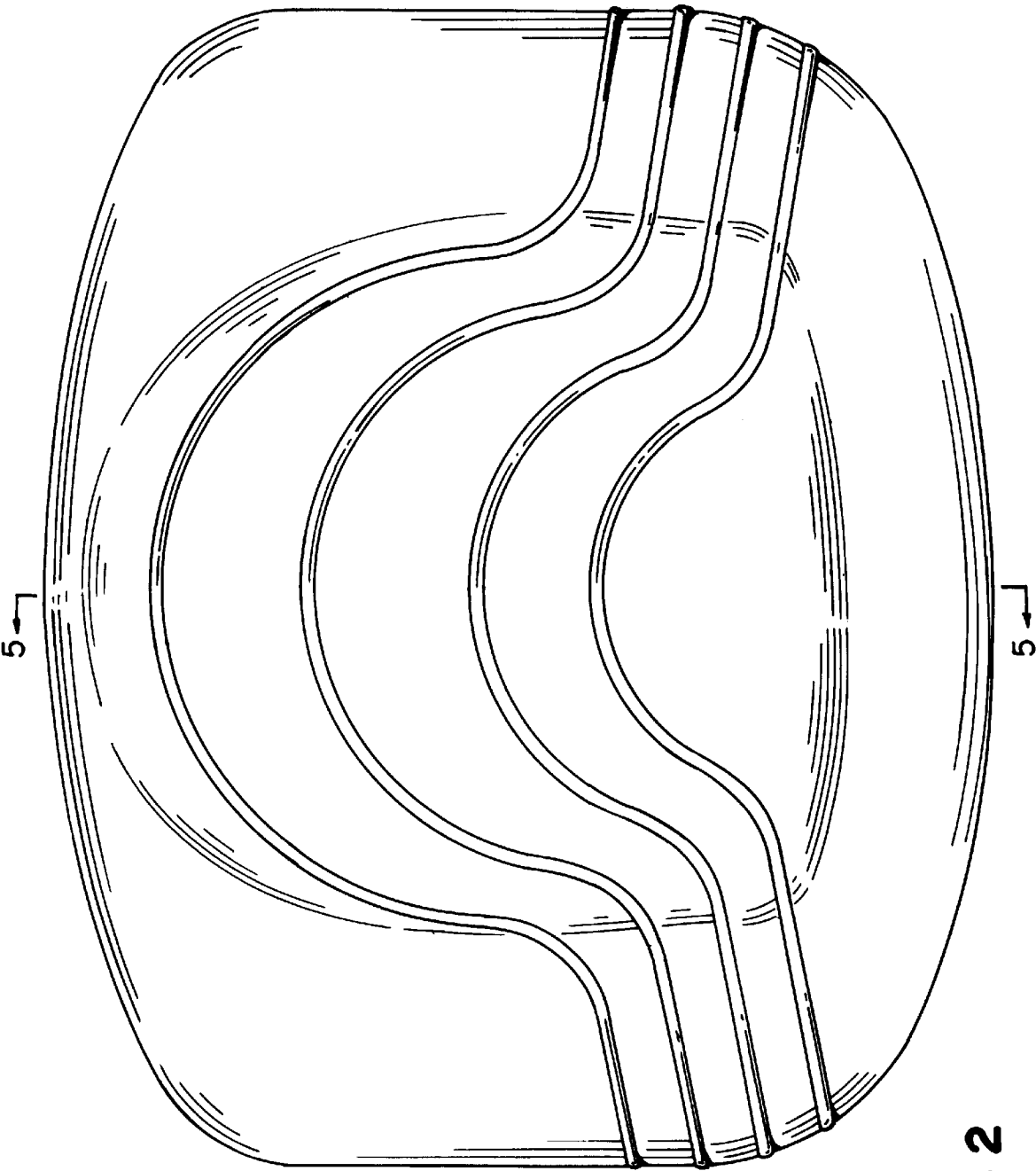

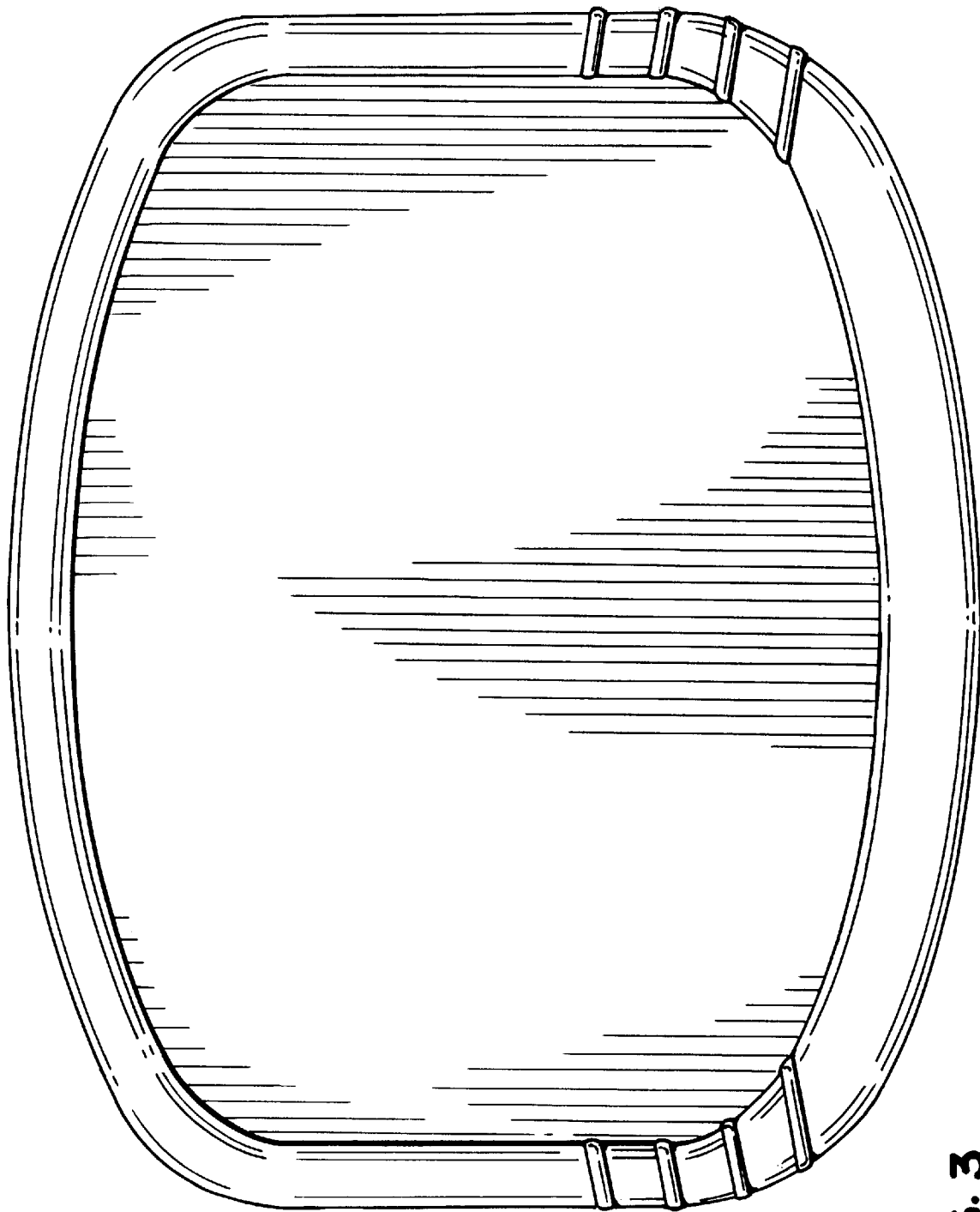

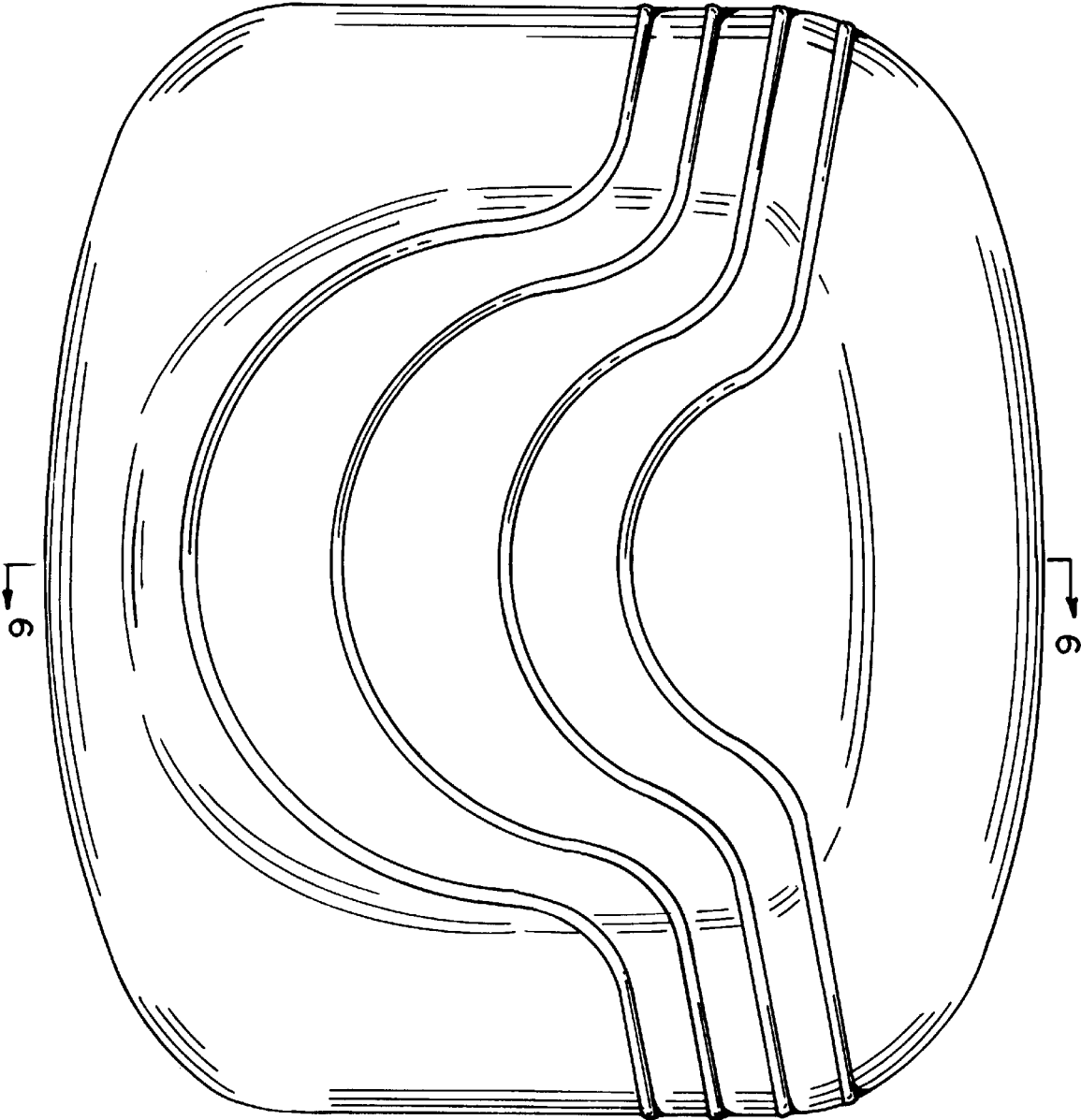

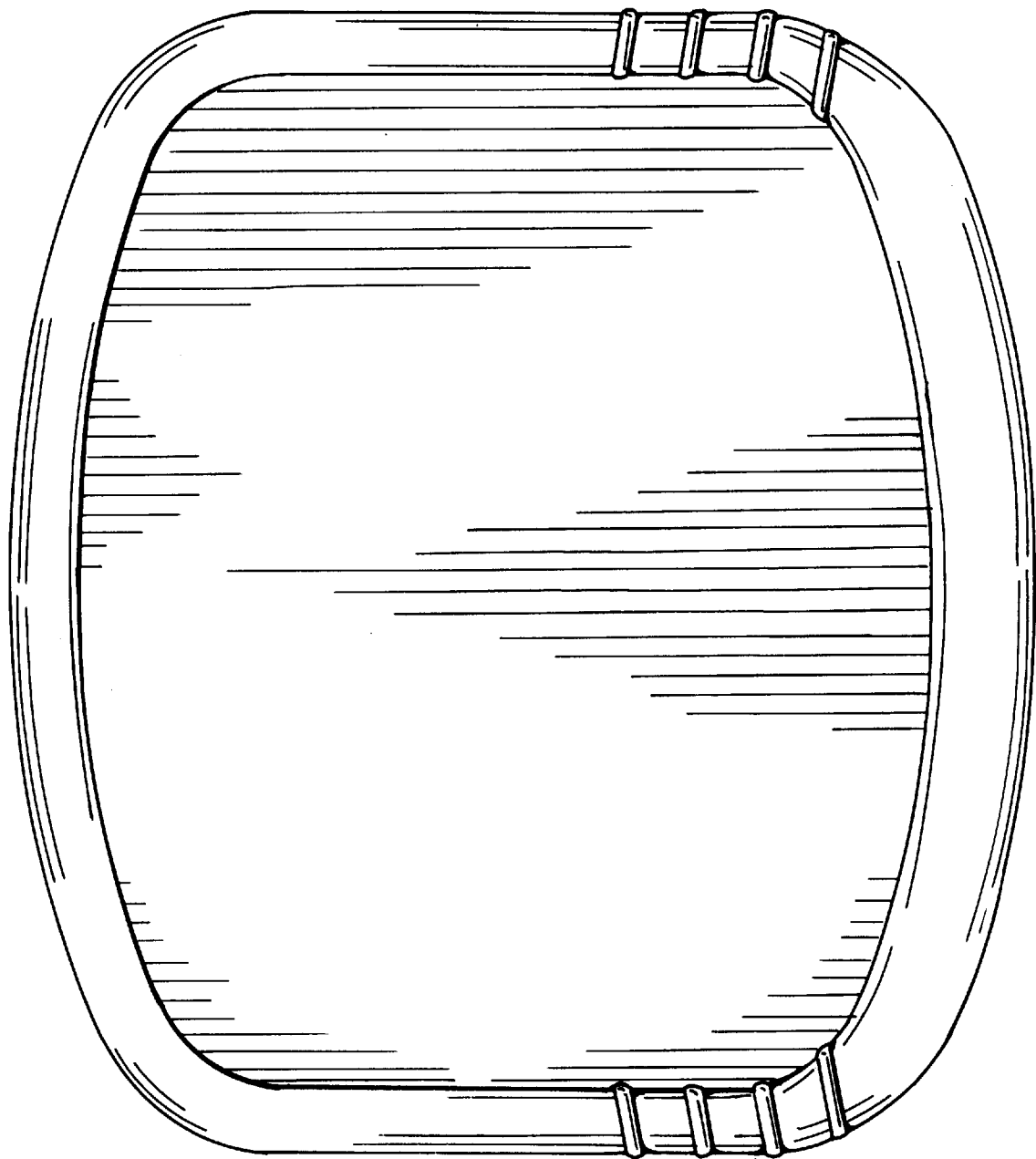

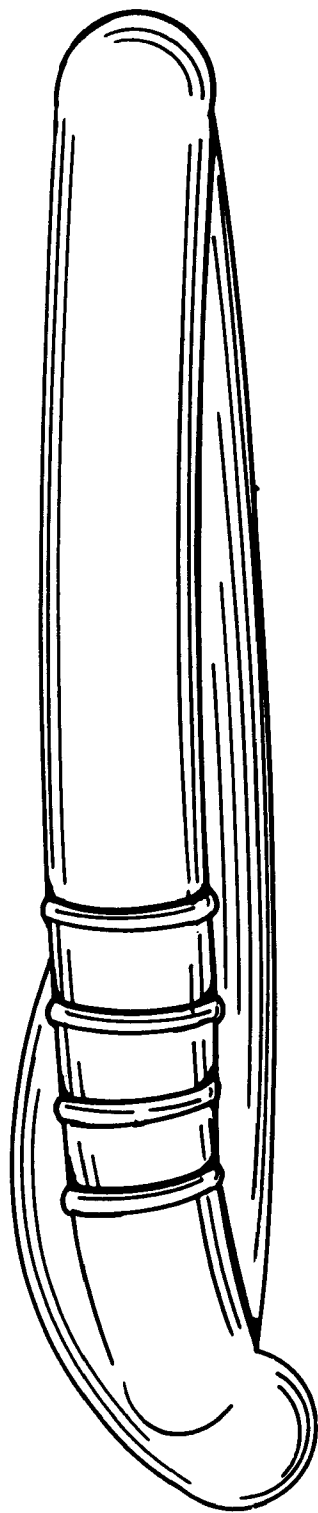

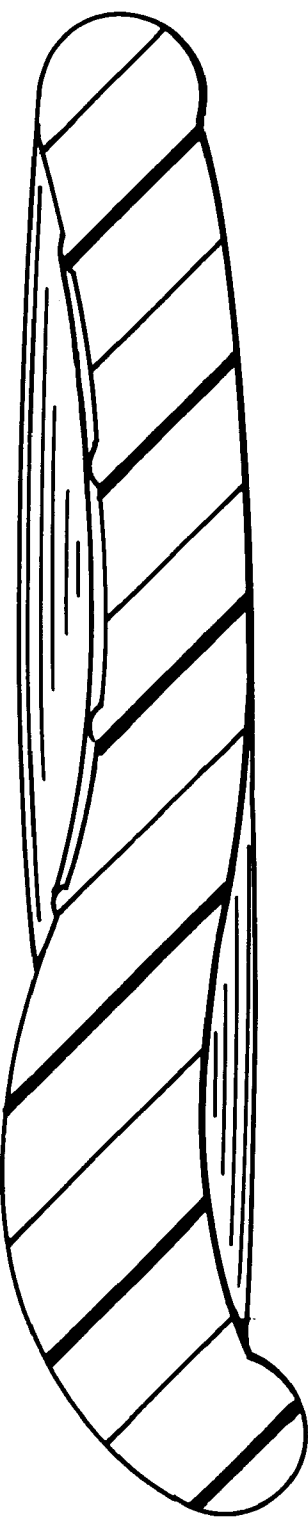

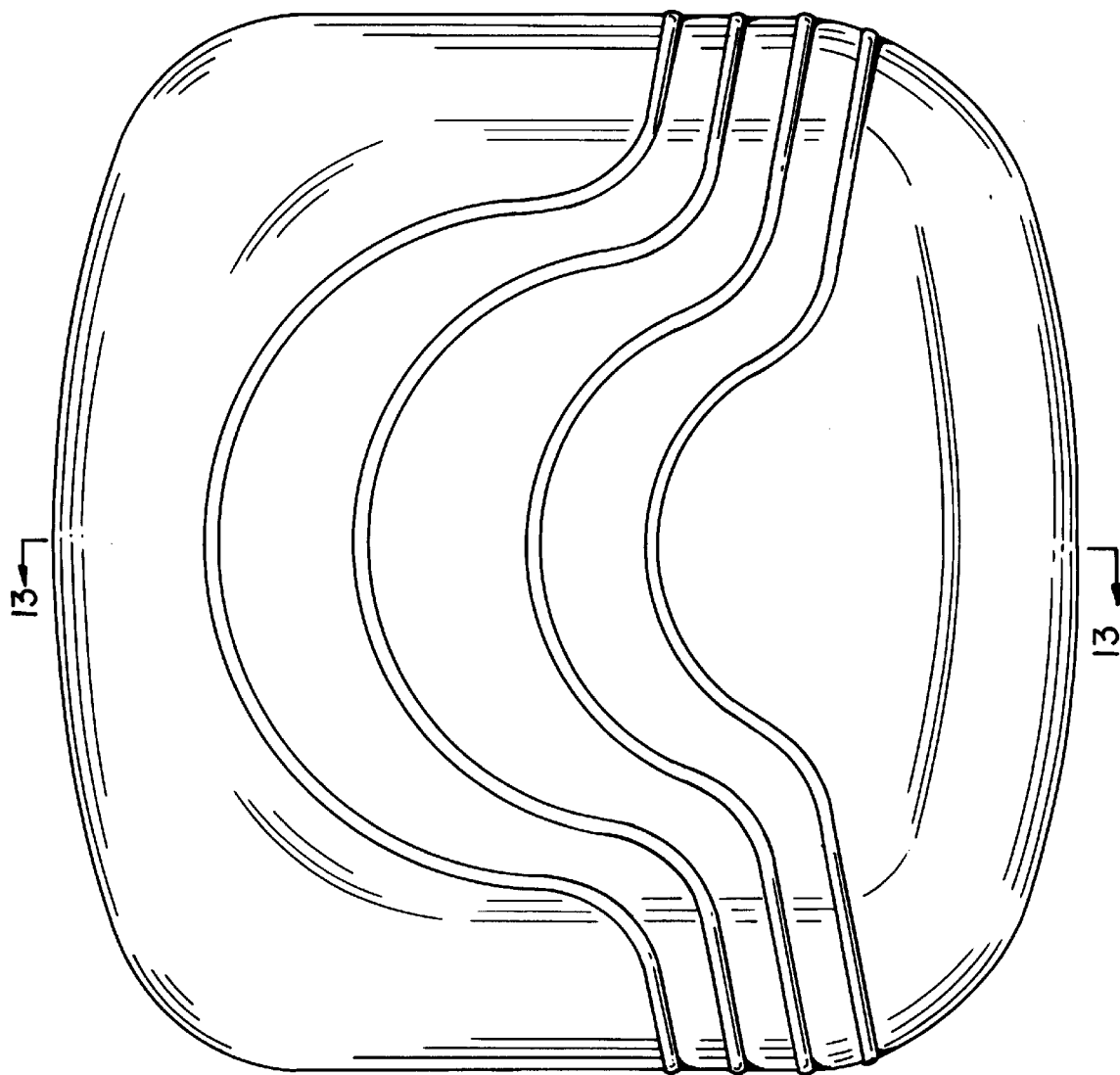

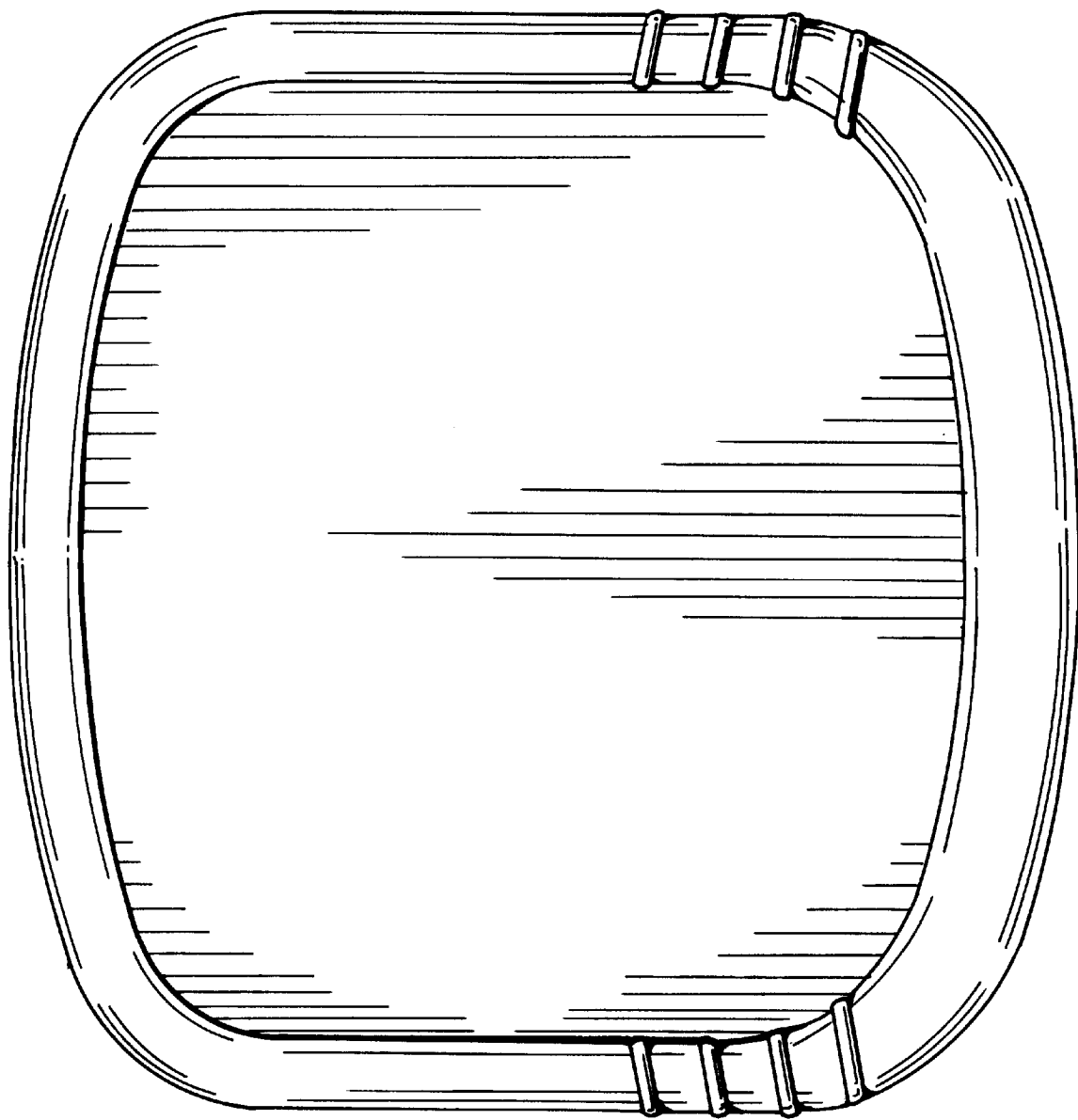

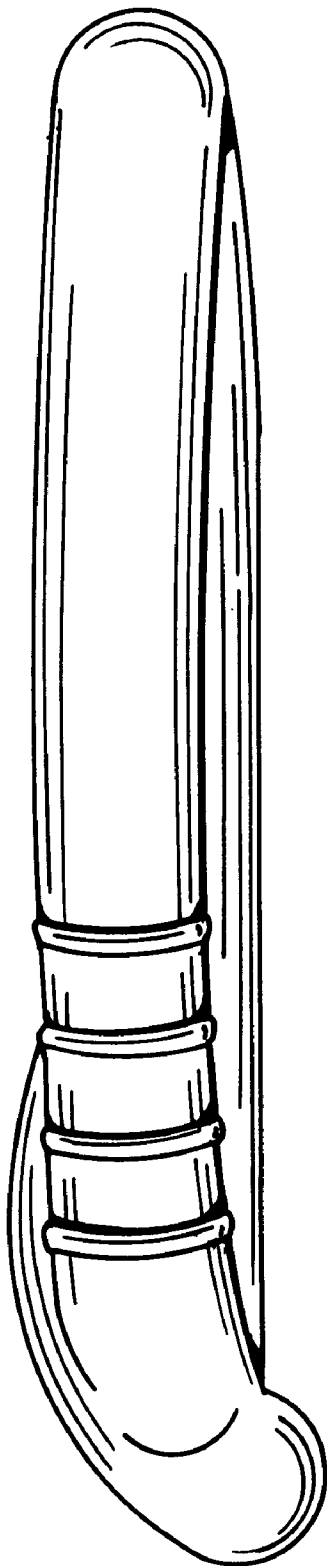

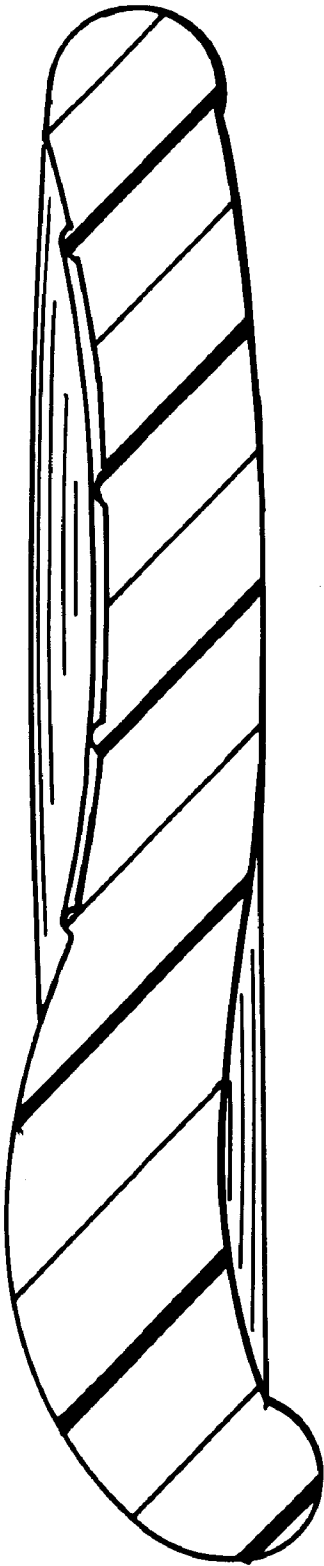
