(57) **CLAIM**

The ornamental design for a beverage container adapter, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a beverage container adapter showing the design.
FIG. 2 is a front elevation view of the beverage container adapter of FIG. 1.
FIG. 3 is a side elevation view of the beverage container adapter of FIG. 1.
FIG. 4 is a top plan view of the beverage container adapter of FIG. 1.
FIG. 5 is a bottom plan view of the beverage container adapter of FIG. 1; and,
FIG. 6 is another isometric view of the beverage container adapter of FIG. 1.
The front elevation view of the beverage container adapter is identical to the rear elevation view of the beverage container adapter, and the left side elevation view of the beverage container adapter is identical to the right side elevation view of the beverage container adapter. The shading lines shown in the drawings represent the approximate three-dimensional contour of the claimed design and are not intended to indicate surface decoration.














