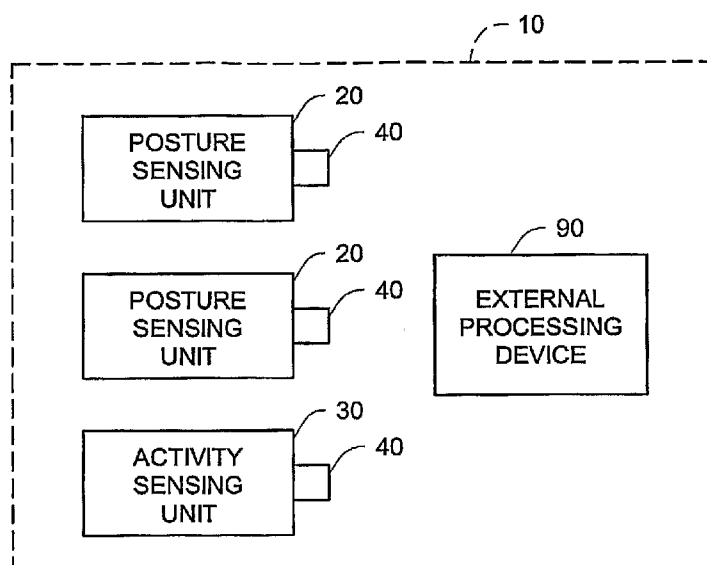

(54) Title: SYSTEMS, METHODS AND DEVICES FOR PROMOTING THERMOGENESIS



(57) Abstract: Systems, methods and devices to measure and potentially promote thermogenesis, preferably non-exercise activity thermogenesis are disclosed. In the various embodiments, the present invention may rely on one or more sensors that detect a subject's body posture and/or activity. Feedback regarding the subject's posture and/or activity (relative to preferred postures and/or activity levels) may preferably be provided after the data is retrieved and analyzed. A power interlock may also be used to control delivery of electrical energy based on a subject's posture and/or activity level.
