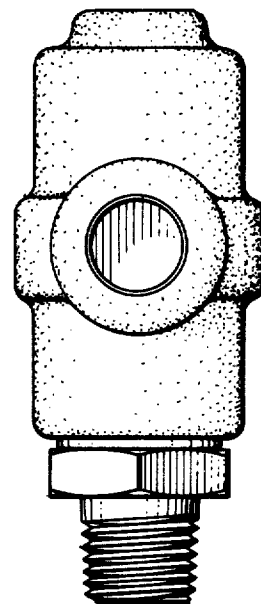
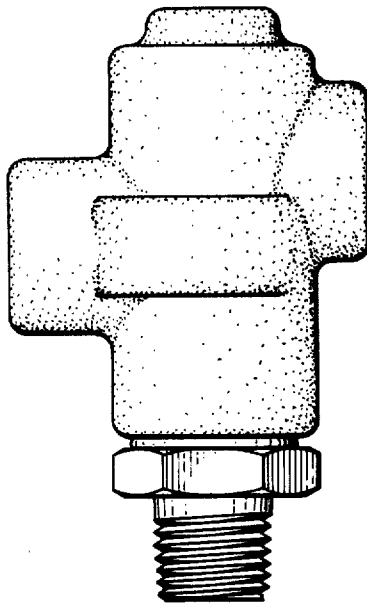

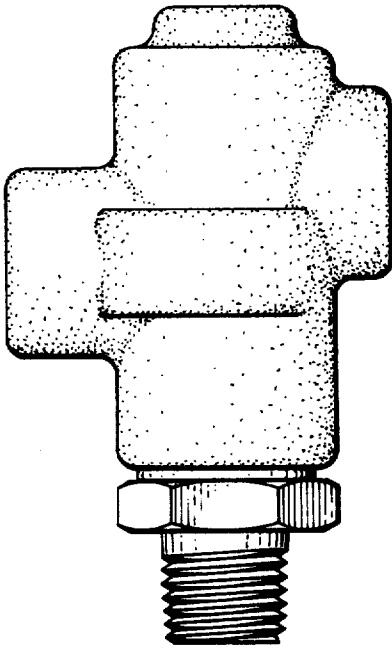
The ornamental design for a bypass valve, as shown and described.

**DESCRIPTION**

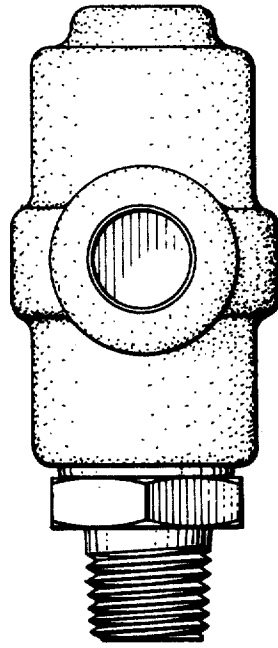
FIG. 1 is a right side elevational view of a bypass valve embodying my new design, the left side being a mirror image of the right side as shown;

 FIG. 5 is a bottom plan view thereof.



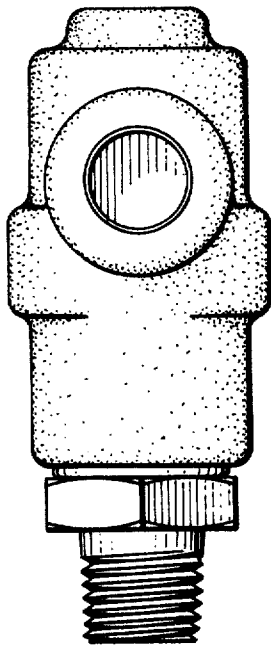

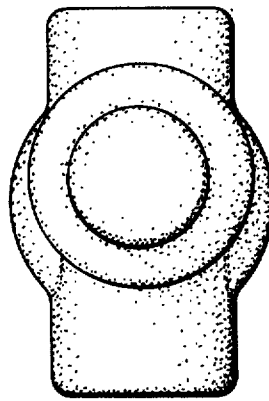
