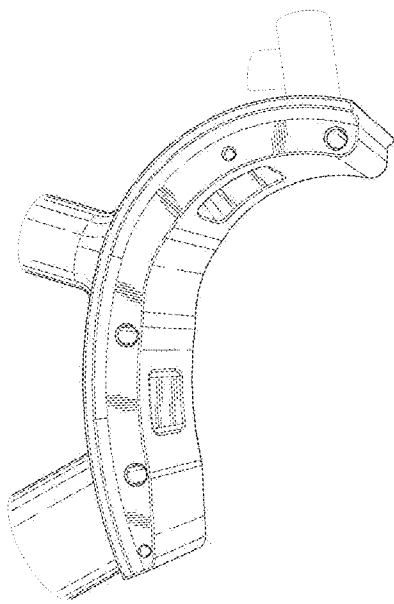
(57) **CLAIM**
 The ornamental design for a member of a frame for a bike, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a member of a frame for a bike showing my new design;
 FIG. 2 is a left side elevational view showing the design for the frame member of FIG. 1;
 FIG. 3 is a right side elevational view showing the design for the frame member of FIG. 1;
 FIG. 4 is a front elevational view showing the design for the frame member of FIG. 1;
 FIG. 5 is a rear elevational view showing the design for the frame member of FIG. 1;
 FIG. 6 is a top elevational view showing the design for the frame member of FIG. 1; and,
 FIG. 7 is a bottom elevational view showing the design for the frame member of FIG. 1.

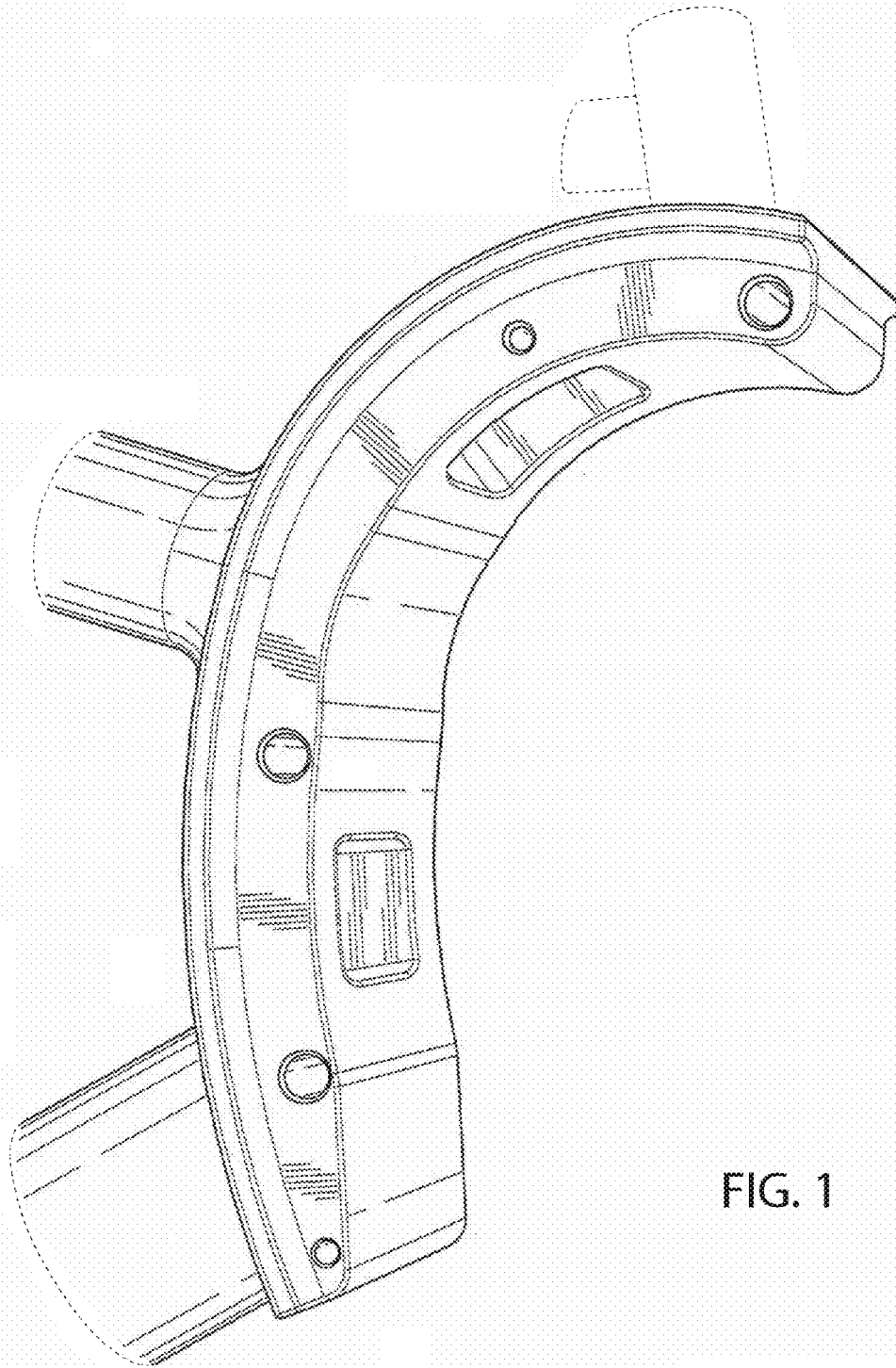

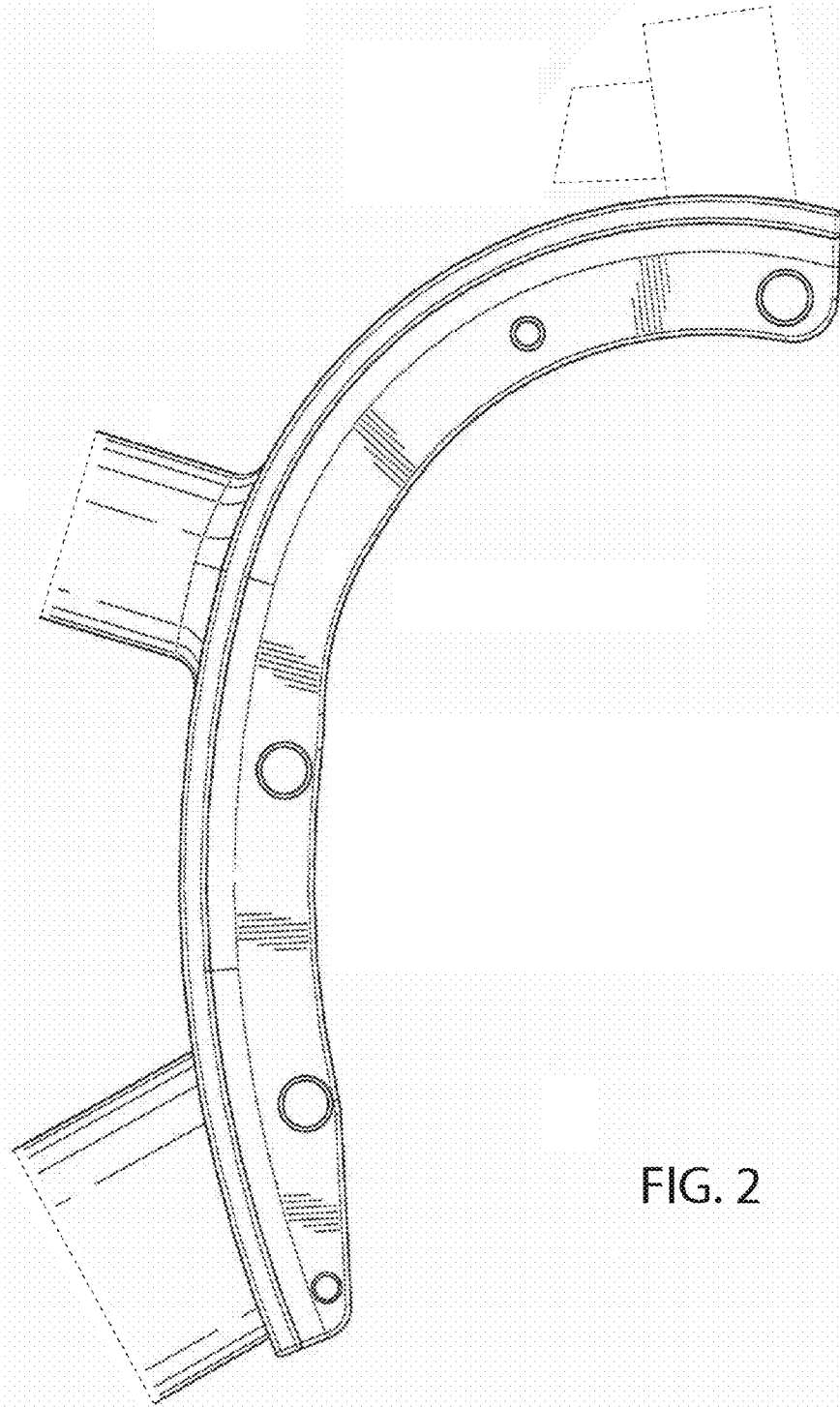

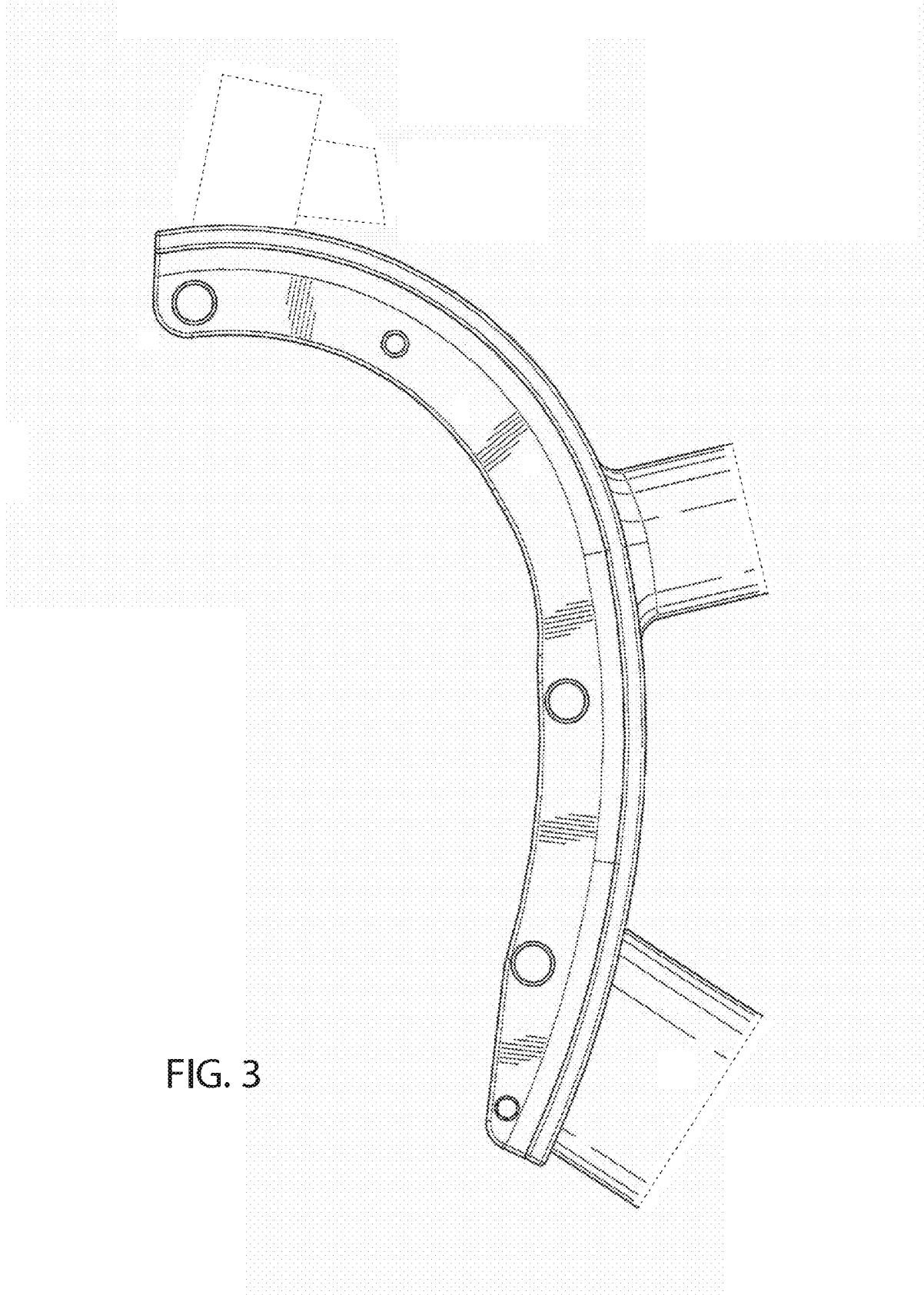

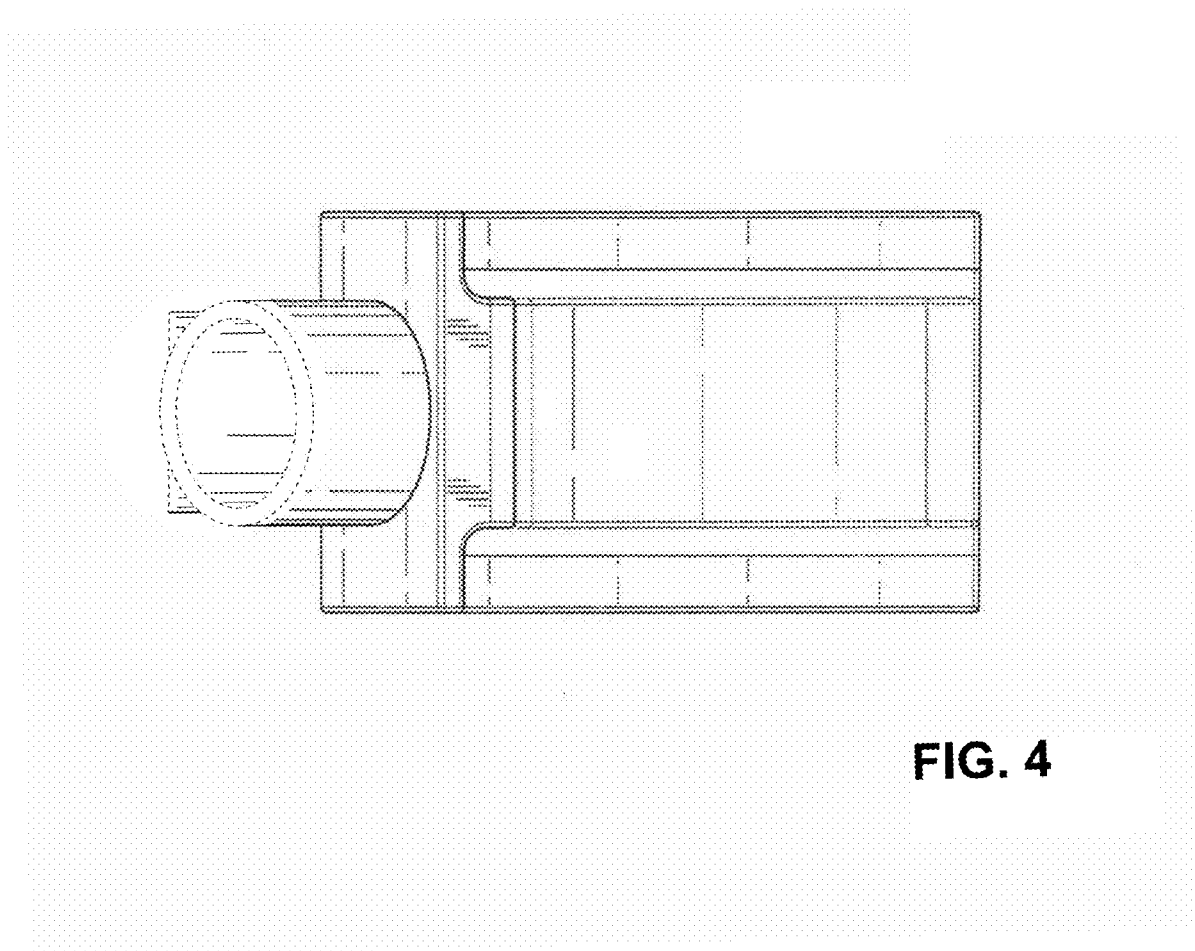

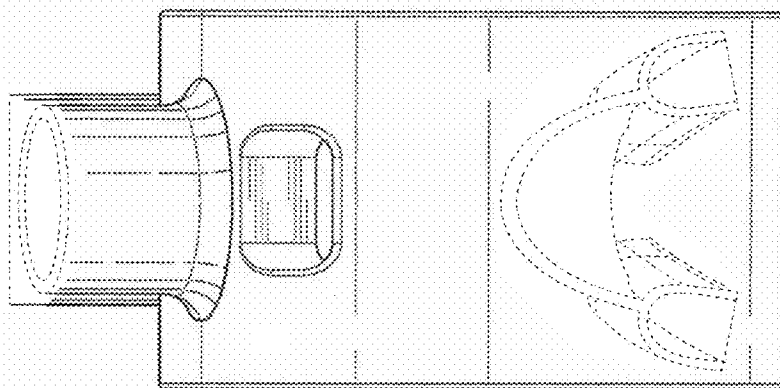

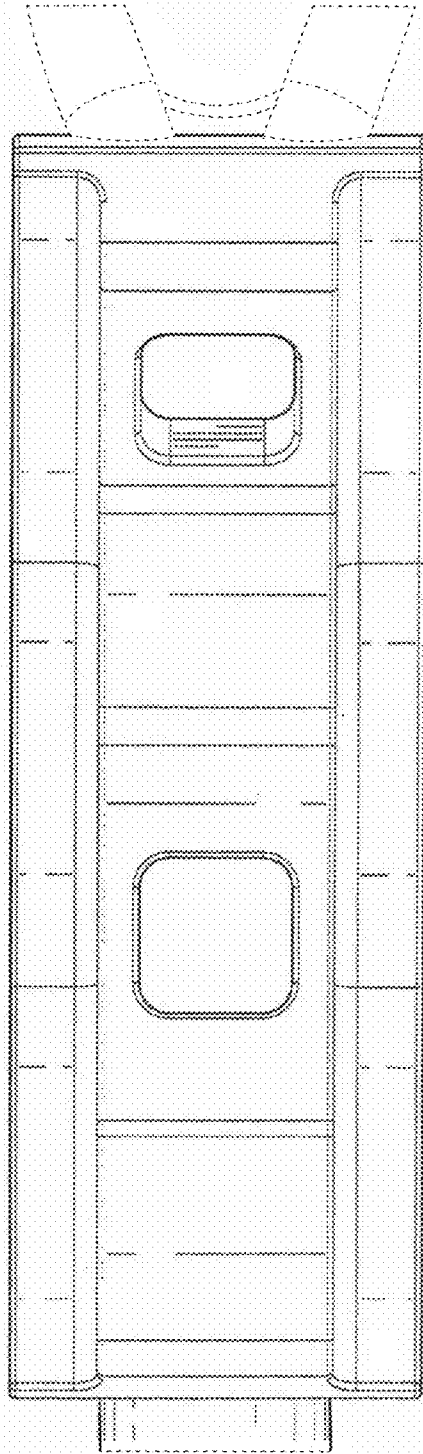

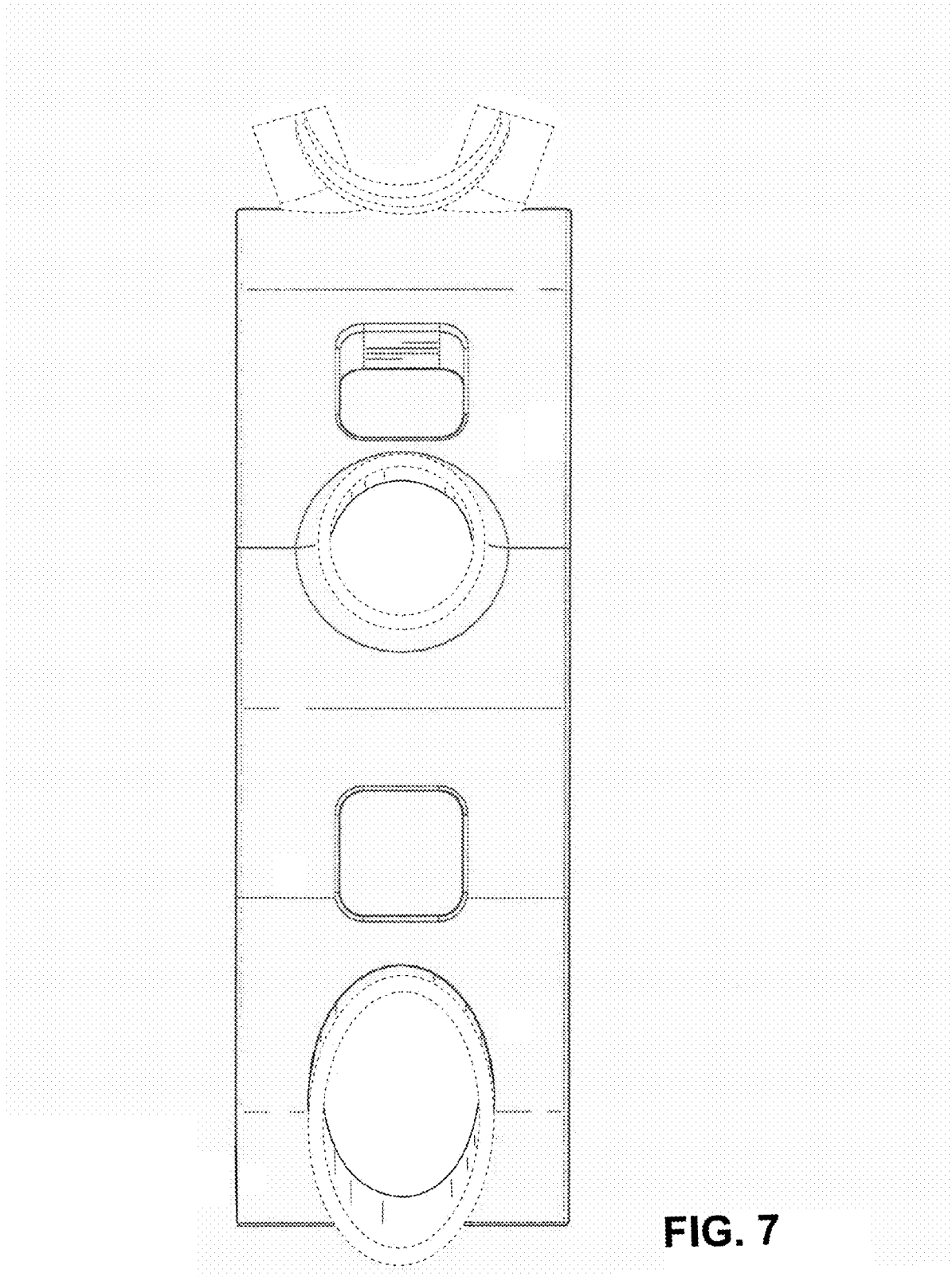
