(57) **CLAIM**

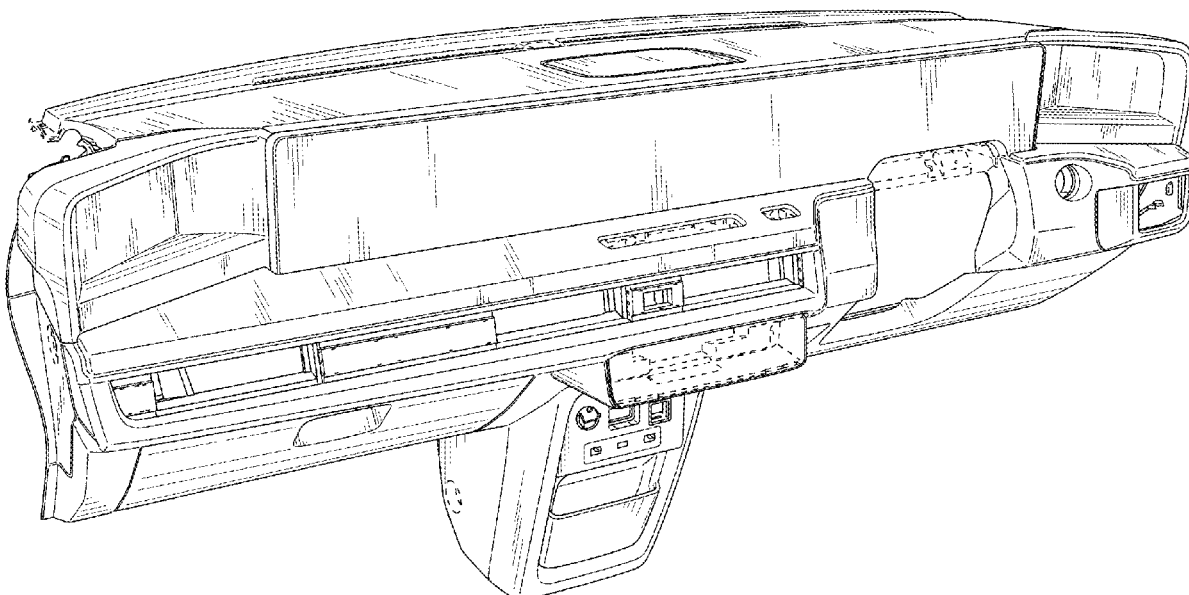
The ornamental design for an instrument panel for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a left front side perspective view of an instrument panel for an automobile, showing my new design; FIG. 2 is a right front side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; and, FIG. 6 is a top plan view thereof.

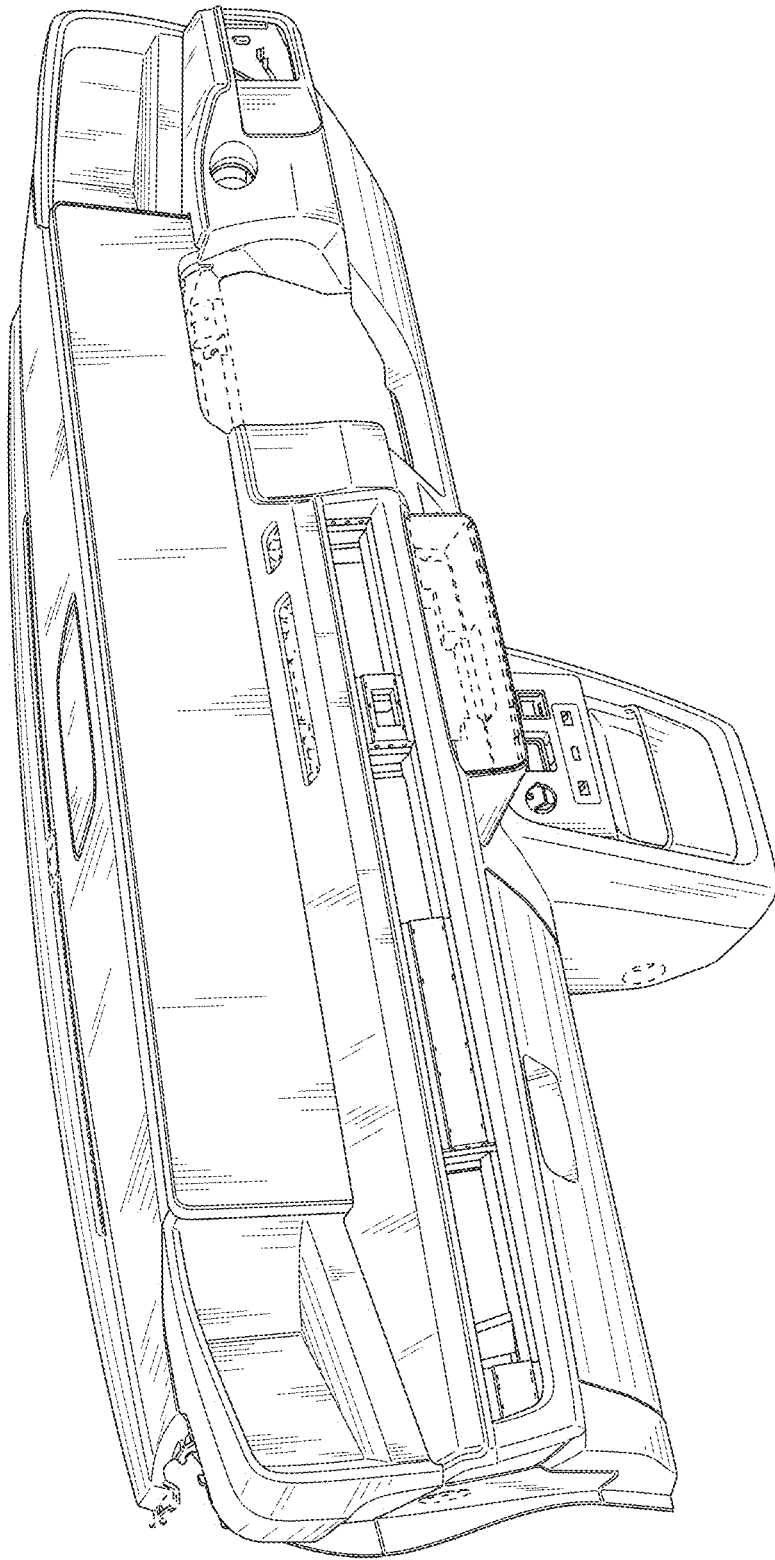

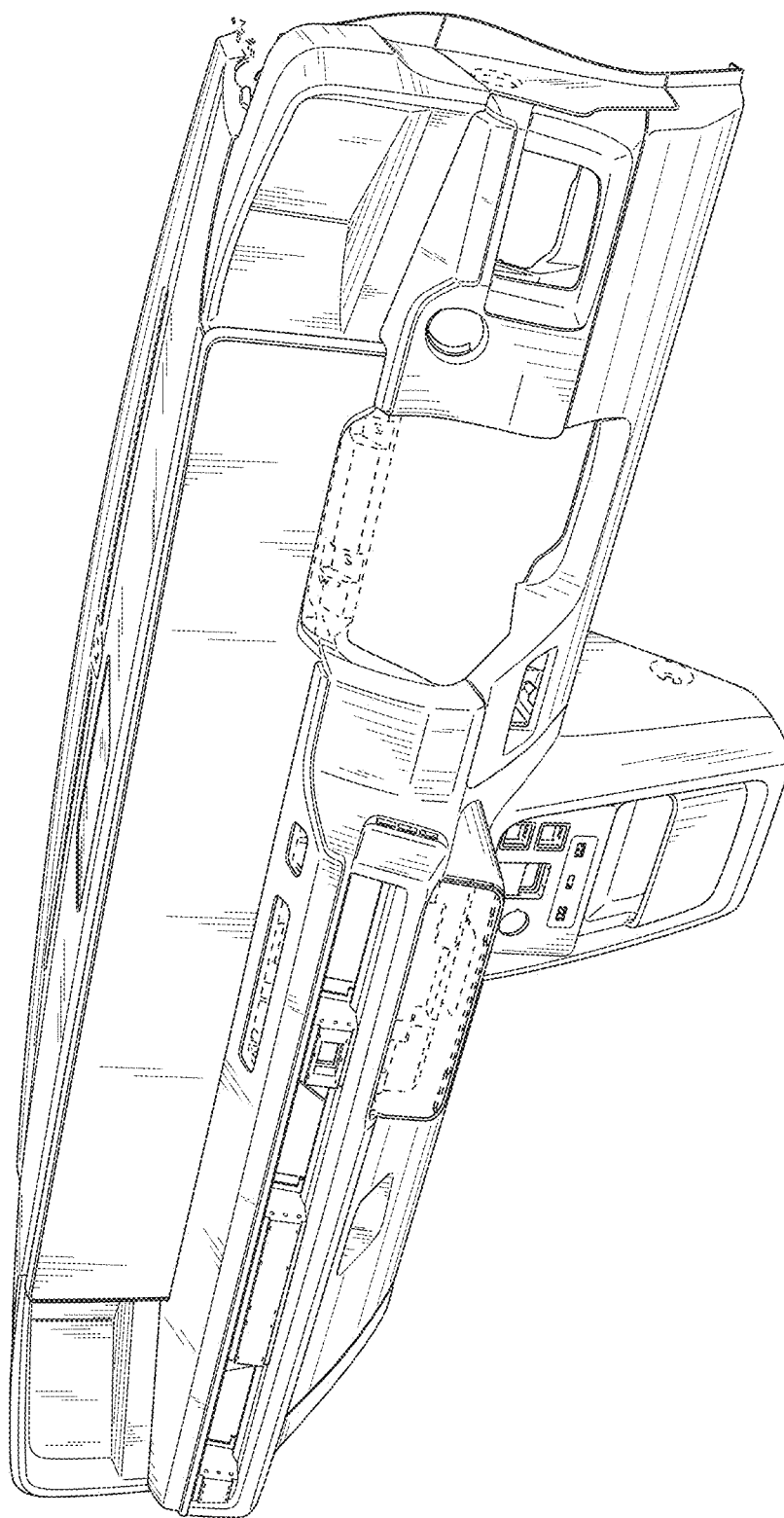

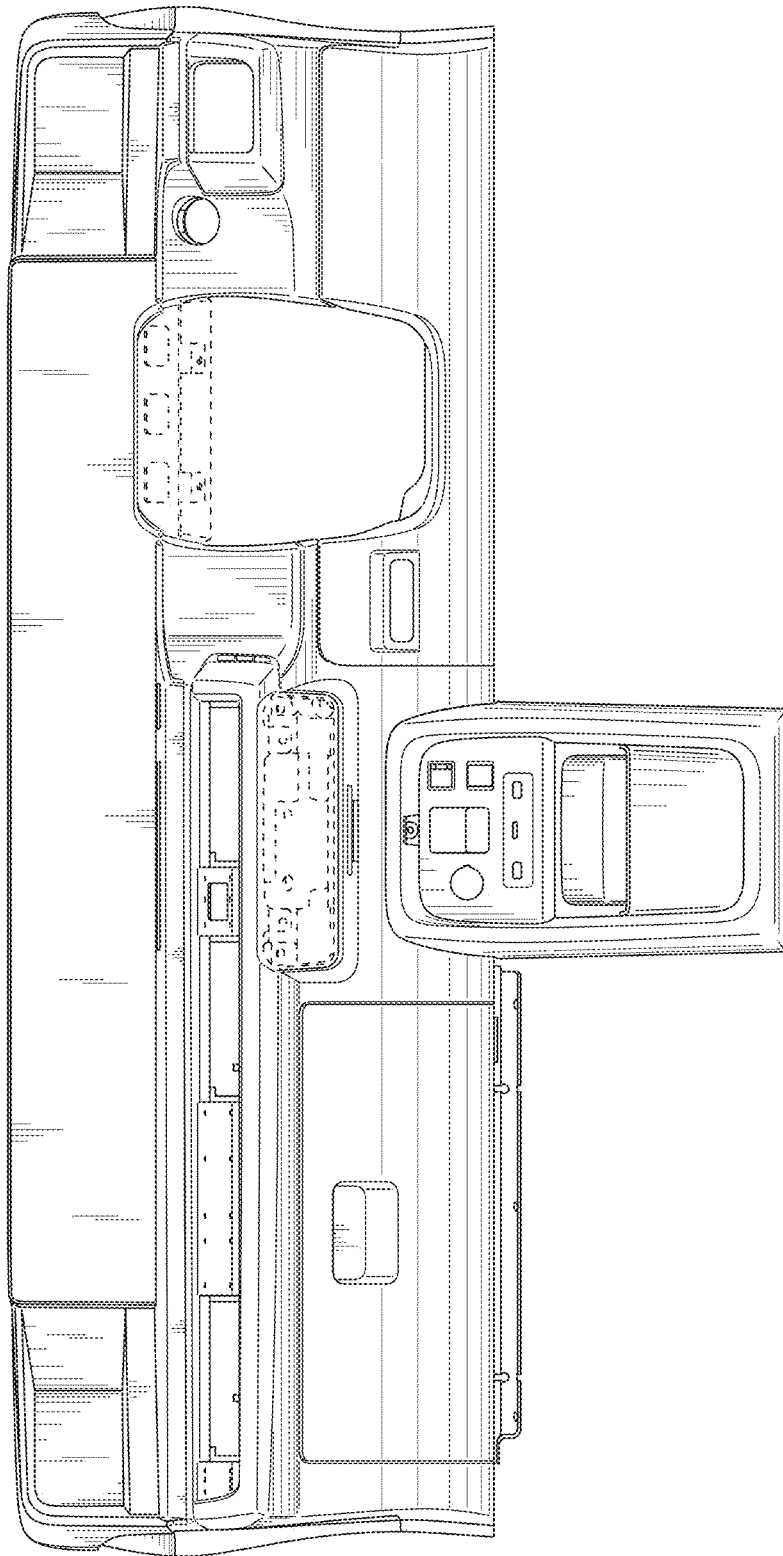

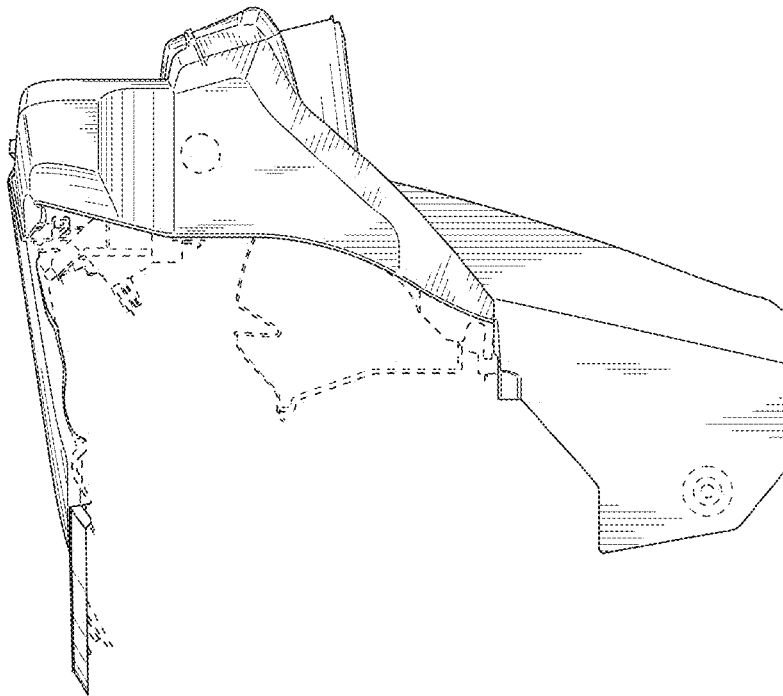

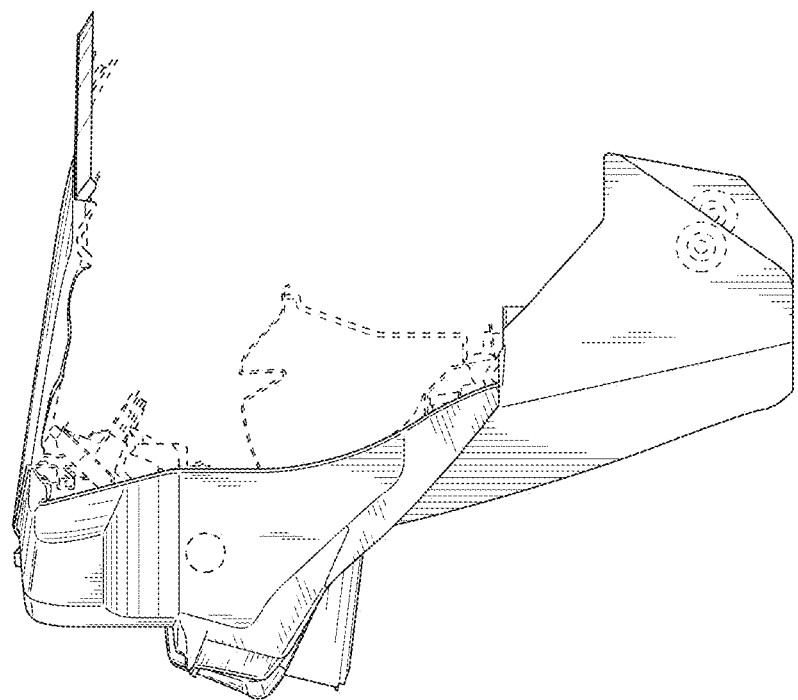

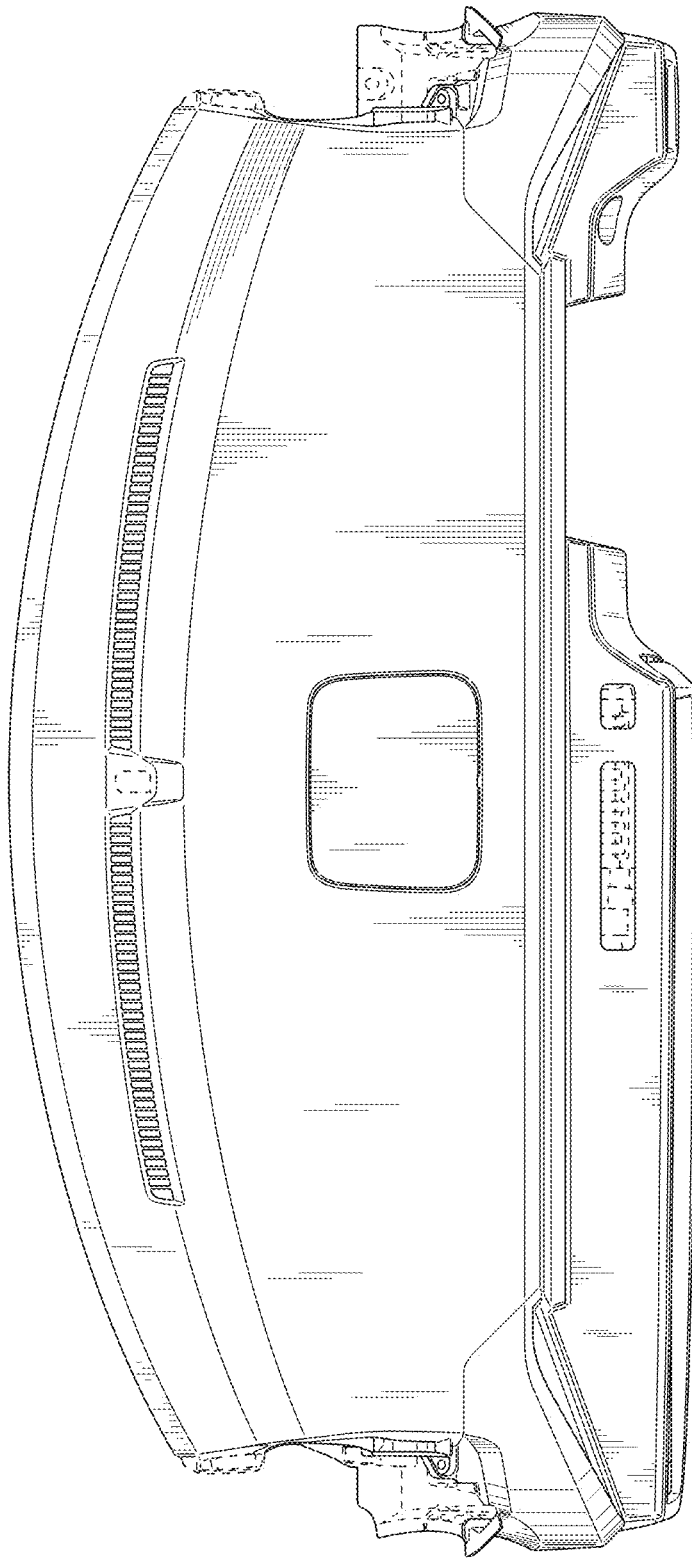
