DESCRIPTION


FIG. 1 is a top, right, and front isometric view of an ornamental design for a vehicle arch;
FIG. 2 is a top, right, and front isometric view of the vehicle arch of FIG. 1, wherein environmental portions have been removed for clarity;
FIG. 3 is a front elevational view of the vehicle arch of FIG. 2;
FIG. 4 is a right side elevational view of the vehicle arch of FIG. 2;
FIG. 5 is a left side elevational view of the vehicle arch of FIG. 2;














