I claim the ornamental design for a bowl, as shown and described.


DESCRIPTION

FIG. 1 is a perspective view of a bowl, showing the new design;
FIG. 2 is a front view of the design of FIG. 1;
FIG. 3 is a rear view of the design of FIG. 1;
FIG. 4 is a right side view of the design of FIG. 1, the left side view being a mirror image thereof; and,
FIG. 5 is a top view of the design of FIG. 1.










