(57) **CLAIM**

The ornamental design for a crane cab, as shown and described.

DESCRIPTION

FIG. 1 is a side and front perspective view of a crane cab showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side perspective view thereof taken from the right of FIG. 1;

FIG. 4 is a side elevational view thereof taken from the right of FIG. 1;

FIG. 5 is a side elevational view thereof taken from the left of FIG. 1; and,

FIG. 6 is a rear elevational view thereof.








