FIG. 1 is a front perspective view of a battery cover for a handset showing our new design;

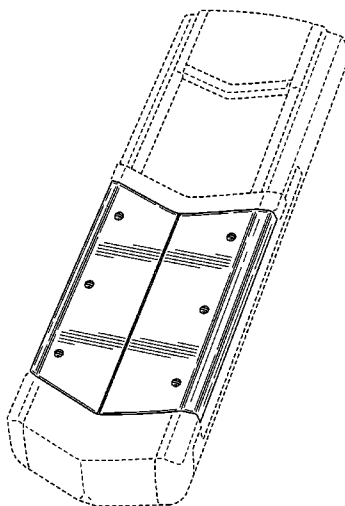
FIG. 2 is a front view thereof;

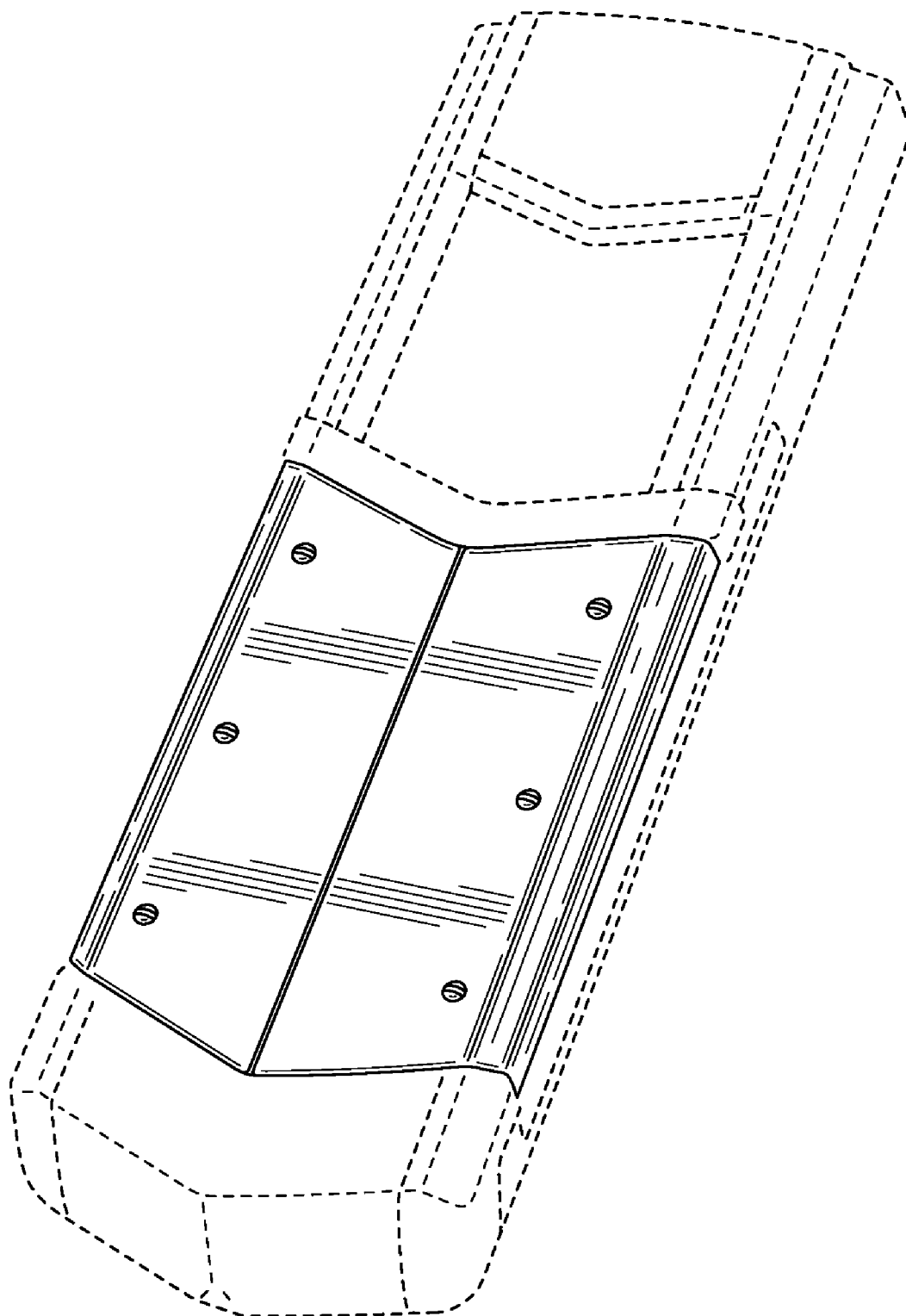

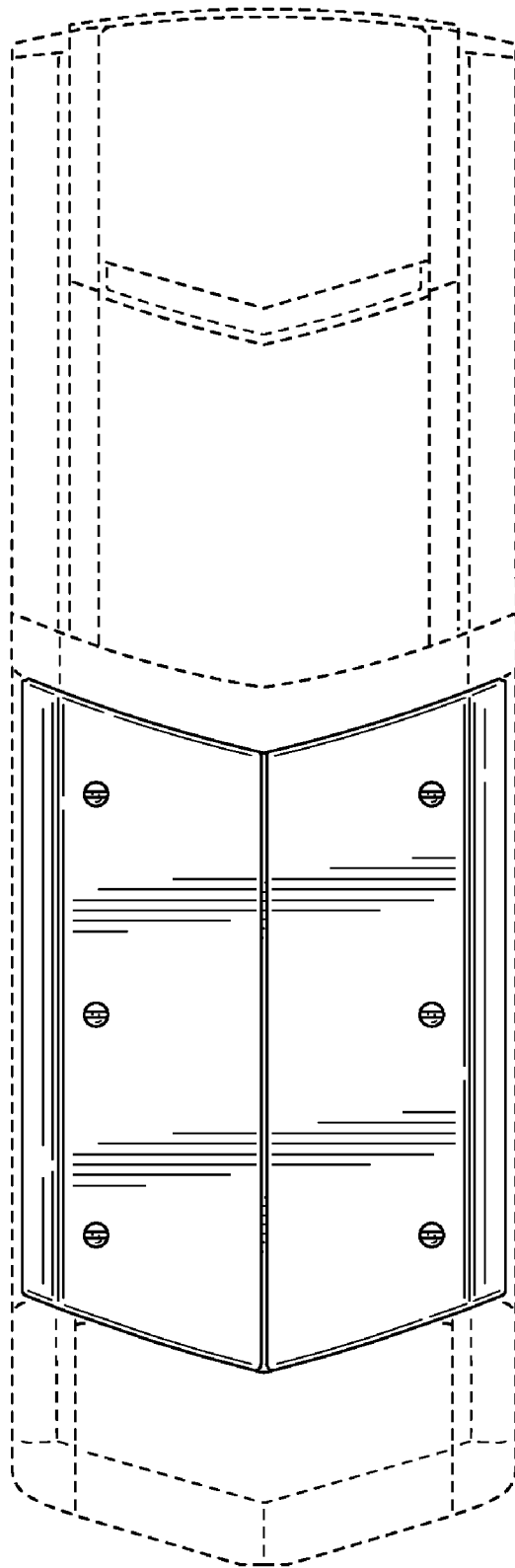

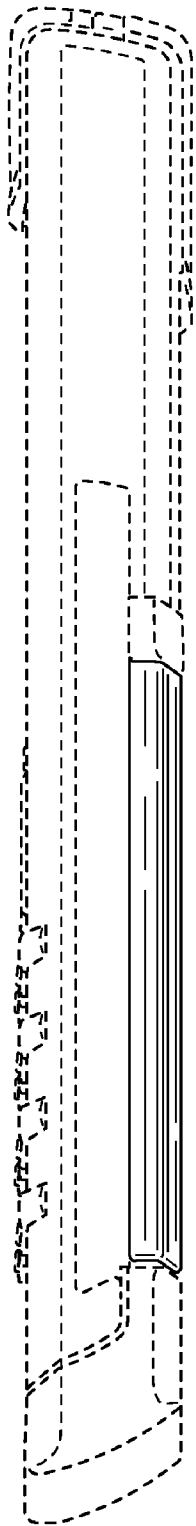

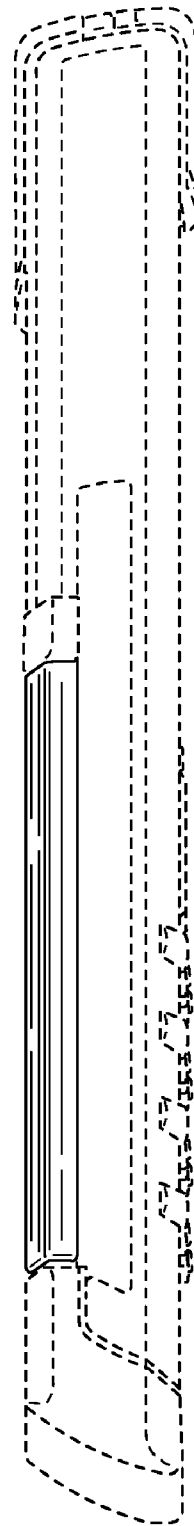
