

(57) Abstract: The present invention discloses a workflow oriented multi-screen healthcare information management system. The system allows the user to simultaneously display, access, and manipulate healthcare information that is logically related on multiple screens without having to jump around, or enter and exit various screens. Various tasks in the workflow are streamlined using the present invention. First and second screens display complete patient history; physicians can write orders while viewing labs and medications; an X-ray report and problem list will be visible while a physician prepares SOAP notes. In addition, physician orders are transmitted and processed automatically.
