
(57) **CLAIM**

The ornamental design for a multifunctional orthodontic tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multifunctional orthodontic tool;
FIG. 2 is a top plan view of the multifunctional orthodontic tool shown in FIG. 1;
FIG. 3 is a bottom plan view of the multifunctional orthodontic tool shown in FIG. 1;
FIG. 4 is a left side view of the multifunctional orthodontic tool shown in FIG. 1;
FIG. 5 is a right side view of the multifunctional orthodontic tool shown in FIG. 1;
FIG. 6 is a front view of the multifunctional orthodontic tool shown in FIG. 1;
















