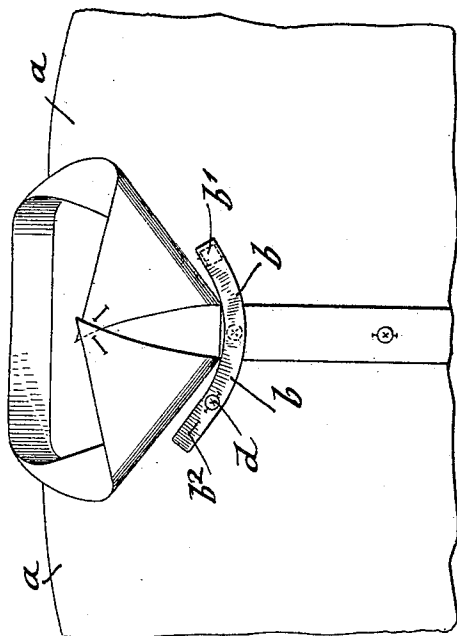

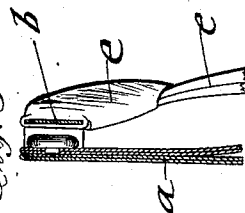
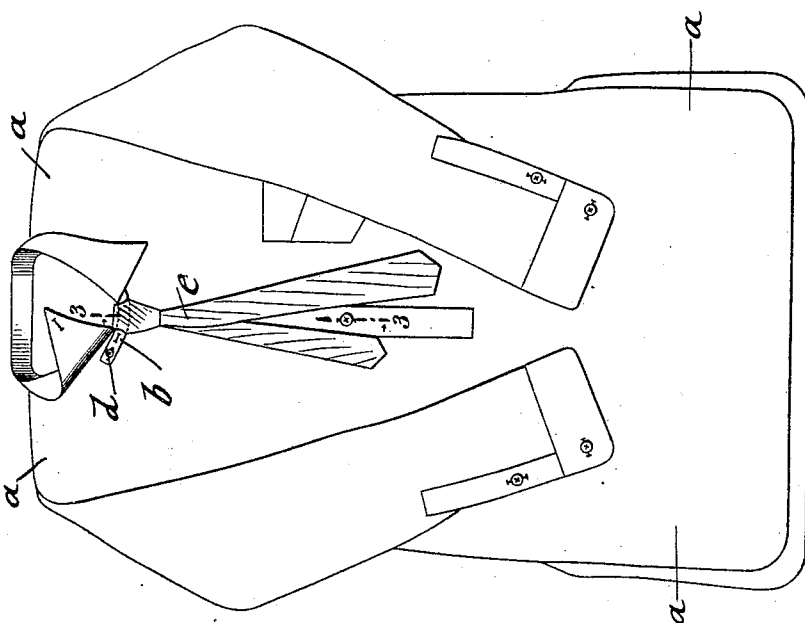

NECKTIE-HOLDER FOR NEGLIGÉE SHIRTS.

To all whom it may concern:

Be it known that I, CÄCILIE KOEHL RUEBE, a citizen of the United States of America, residing in Jersey City Heights, in the
5 county of Hudson and State of New Jersey, have invented certain new and useful Improvements in Necktie-Holders for Negligée Shirts, of which the following is a specification.

10 This invention relates to an improved device for holding a so-called four-in-hand neck-tie in position on a negligée shirt, without passing the neck-band of the tie around the collar of the shirt, so as to relieve the
15 neck as much as possible from surplus bands during the summer months and also dispense with the frequent tying of the neck-band.

The objection to so-called four-in-hand neckties is that they are inconvenient in
20 tying, and that the neck-band of the same renders the collar-portion of the shirt too warm in summer.

The object of this invention is to furnish a simple attachment for negligée shirts
25 which serves to support the necktie, which requires only one tying when the same is applied to the shirt and dispenses thereby with the frequent tying of the same and also with the necessity of extending the
30 necktie around the neck-band of the collar of the shirt; and for this purpose the invention consists of the negligée shirt hereinafter described and claimed.

In the accompanying drawings, Figure 1
35 represents a front-elevation of a negligée-shirt with my improved necktie-holder shown in position for use, Fig. 2 is also a front-elevation, showing the supporting strip in position thereon, but with the necktie re-
40 moved, and Fig. 3 is a vertical transverse section on line 3, 3, Fig. 1, drawn on a larger scale.

Similar letters of reference indicate corresponding parts throughout the views.

45 In the drawings, *a* represents a negligée shirt of any shape or style, whether an open-front shirt coat or other shirt. To the upper part of the shirt, below the front-ends of the collar, and adjacent to the upper
50 front-button, is arranged a curved strip *b*, which is attached at one end *b*¹ to one side of the shirt-bosom and at the other end by means of button-holes *b*² to an extra-button
55 *d*, which is attached to the opposite side of the front-part of the shirt, below the collar as shown clearly in Figs. 1 and 2. The

necktie *e* is tied in so-called four-in-hand style around the supported strip *b*, without being passed around the neck-band of the collar, and retained in position thereon as
60 long as the shirt is worn. When the shirt is required to be washed, the strip *b* is unbuttoned from the button *d* of the shirt and the looped portion of the necktie removed from the supporting strip by slipping it
65 over the free end of the same. After the shirt is washed and is to be used again, the supporting strip is placed in position by being buttoned over the extra-button *d*, after which the necktie is again tied in four-in-
70 hand style around the supporting strip, in the usual manner, it being not removed until the shirt is again required to be washed.

In place of button-holes in the necktie-supporting strip *b* and a button on the shirt-
75 bosom below the collar any other fastening device for the strip may be used, such as a hook and eye, spring-fastener and the like. This attachment saves a great deal of time and a great deal of annoyance as the tying
80 of the necktie is dispensed with, and likewise the passing around of the same on the neck-band.

Having thus described my invention, I claim as new and desire to secure by Letters
85 Patent:

A negligée-shirt having a button and buttonhole at the front-part of the neck and provided with a side-button attached to the bosom of the shirt some distance to one side
90 said first-named button and buttonhole, and a strip stitched to the bosom some distance from said first-named button and buttonhole and on the opposite side thereof from said side-button, the free end of said strip
95 being provided with a pair of buttonholes, each of which is adapted to receive said side-button, said strip covering and hiding said first-named button and buttonhole and the distance from said side-button to the at-
100 tached end of the strip being greater than the width of a four-in-hand tie, whereby a four-in-hand tie may be knotted on said strip and lie in front of said first-named
105 button and buttonhole.
