

(57) **CLAIM**

The ornamental design for a peep sight, as shown and described.

DESCRIPTION

FIG. 1 is a rear isometric view of my new peep sight design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof, it being understood that the bottom plan view is a mirror image thereof. FIG. 7 is a rear isometric view of my new peep sight design in accordance with a further embodiment of the invention; FIG. 8 is a rear elevational view thereof; FIG. 9 is a front elevational view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a right side elevational view thereof; and, FIG. 12 is a top plan view thereof, it being understood that the bottom plan view is a mirror image thereof.
























