## CLAIM

The ornamental design for a combined bottle and cap, as shown and described.

## DESCRIPTION

FIG. $\mathbf{1}$ is a front elevation of a combined bottle and cap showing my new design, the rear elevation is the same; FIG. 2 is a right side elevation thereof, the left side elevation is the same;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. $\mathbf{5}$ is a front elevation of a second embodiment of the combined bottle and cap, the rear elevation is the same;
FIG. 6 is a right side elevation of FIG. 5, the left side elevation is the same;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a front elevation of a third embodiment of the combined bottle and cap, the rear elevation is the same;
FIG. $\mathbf{1 0}$ is a right side elevation of FIG. 9, the left side elevation is the same;
FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom plan view thereof.
