
(57) **CLAIM**

The ornamental design for an automobile tire, including the peripheral boundaries of the claimed surfaces, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the automobile tire of the invention; FIG. 2 is a rear view thereof; FIG. 3 is a left-side thereof; FIG. 4 is a right-side view thereof; FIG. 5 is an enlarged fragmentary right-side view thereof; and, FIG. 6 is an enlarged end elevational view of the section 6 in FIG. 5, taken along line 6A–6B in FIG. 5. The broken line showing of portions of the automobile tire is for illustrative purposes only and forms no part of the claimed design.












