**DESCRIPTION**

FIG. 1 is a perspective view taken from a top, front, right side of a connector, according to a first embodiment of my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a perspective view taken from a top, front, right side of a connector, according to a second embodiment of my new design; and,

FIG. 4 is a front elevation view thereof.










