The ornamental design for a lighting unit, as shown and
described.

DESCRIPTION

FIG. 1 is an isometric view of a lighting unit, showing a first
embodiment of our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side view thereof, the right side view being a
mirror image thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is an isometric view of a lighting unit, showing a
second embodiment of our new design;
FIG. 8 is a bottom view thereof;
FIG. 9 is a left side view thereof, the right side view being a
mirror image thereof;
FIG. 10 is a front view thereof;
FIG. 11 is a back view thereof; and,
FIG. 12 is a top view thereof.




















