(57) **CLAIM**

The ornamental design for a doll, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a doll.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image of the left side view.

FIG. 4 is a top plan view of the doll.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is an alternate embodiment of the doll showing a front elevational view thereof.

FIG. 7 is a rear elevational view thereof.


FIG. 8 is a left side elevational view thereof.





















