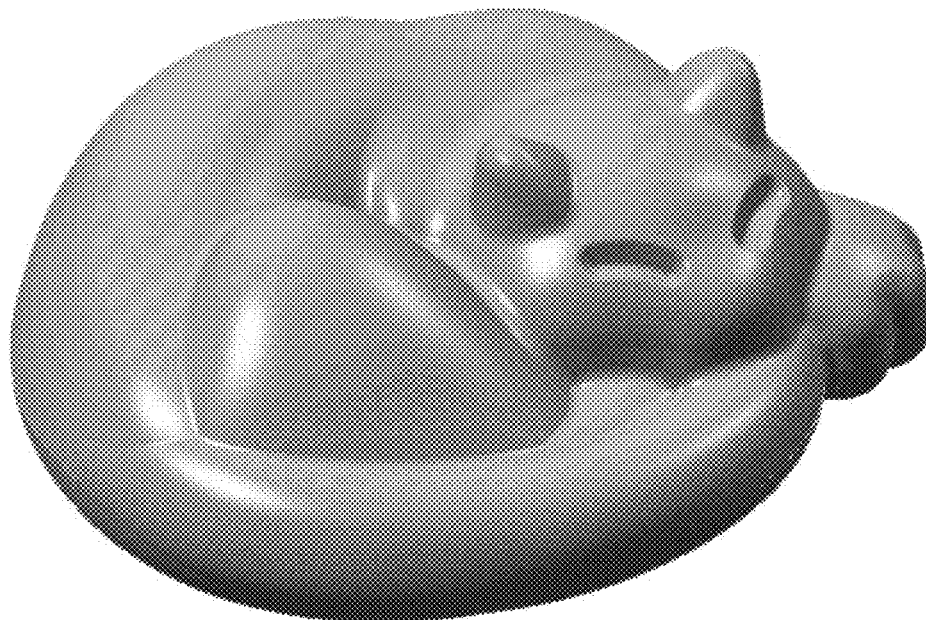

The ornamental design for baker's product, as shown and described.

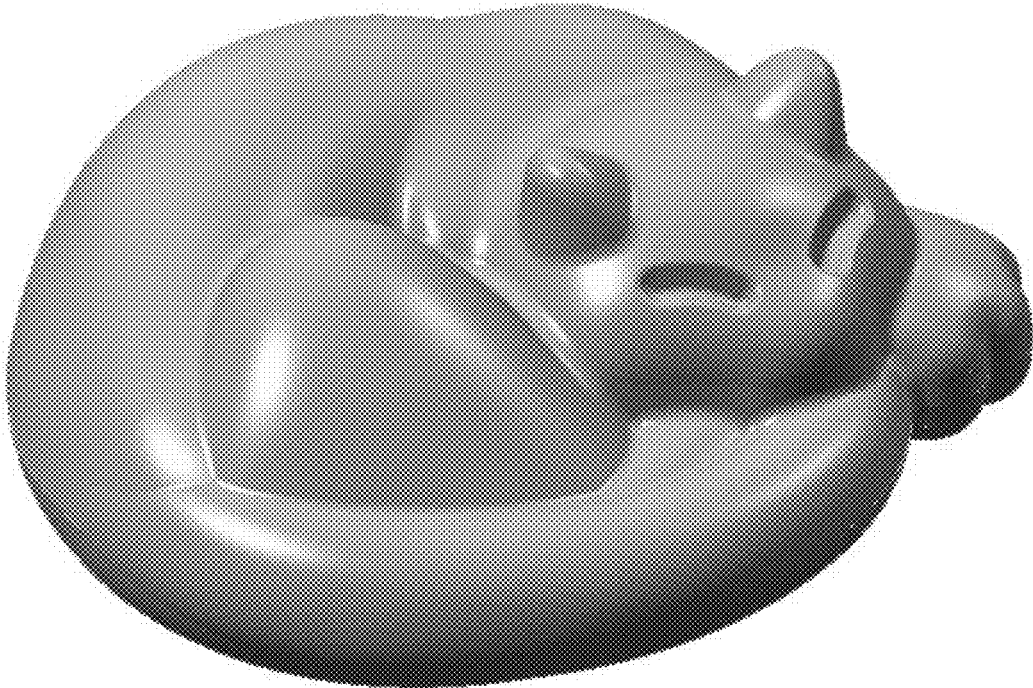
DESCRIPTION

FIG. 1.7 is another side elevation view thereof.

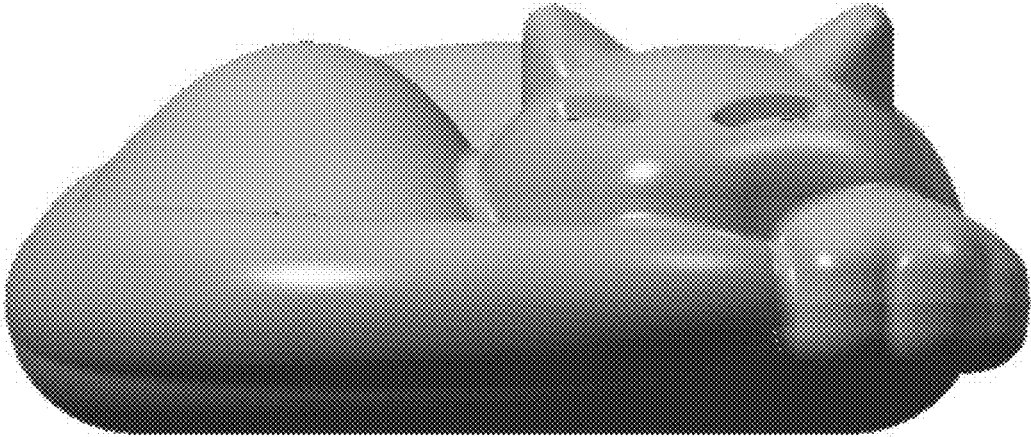

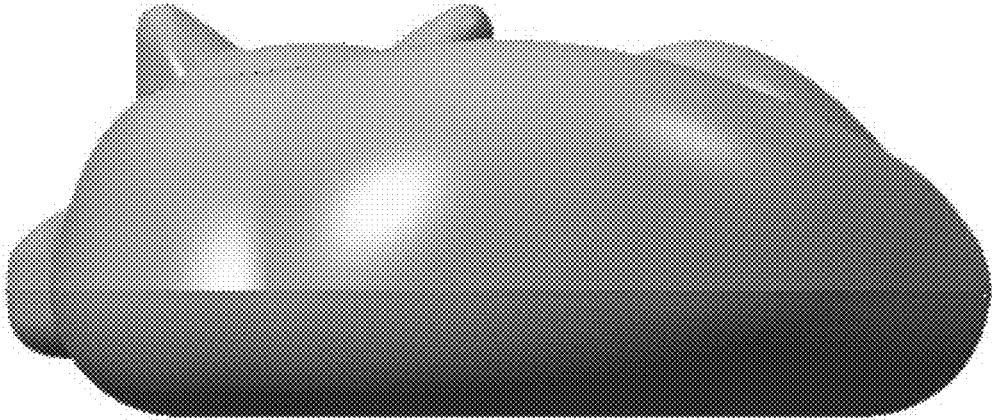

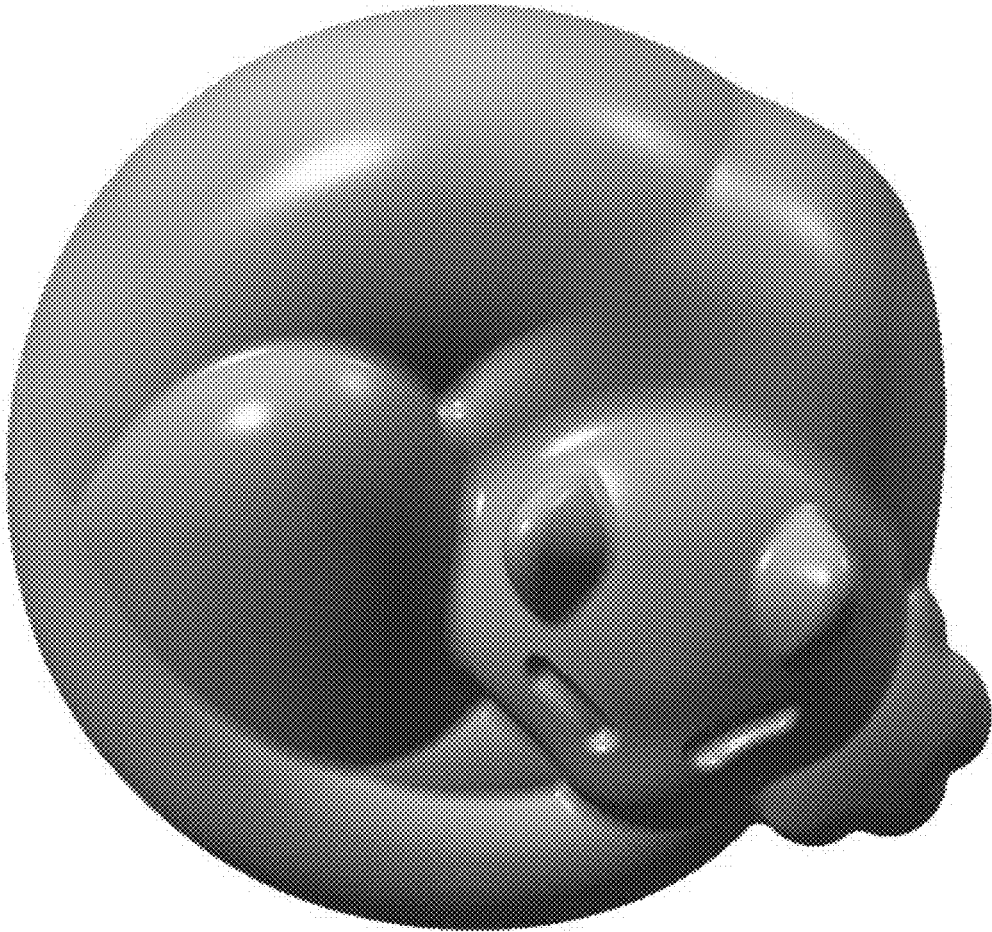

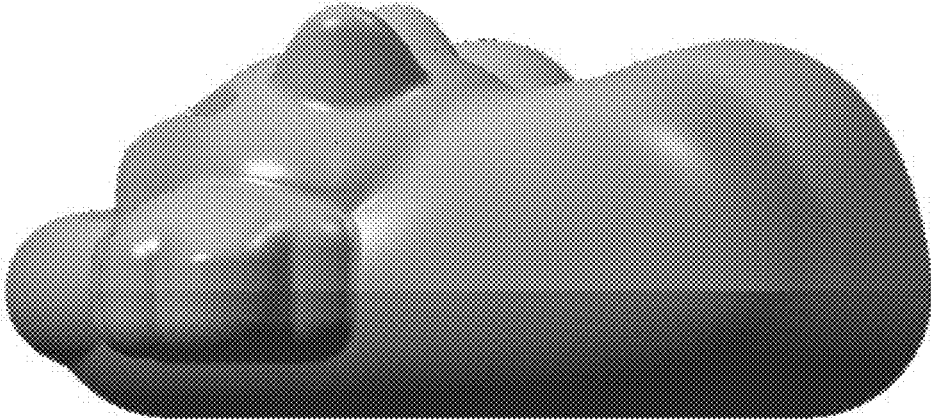
