
(57) **CLAIM**

The ornamental design for a front panel with openings for air cooling a data storage transfer archive repository, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a front panel with openings for air cooling a data storage transfer archive repository, the broken lines being shown for environment only and form no part of the claimed design;  
FIG. 2 is another perspective view thereof showing the detailed views of FIGS. 3-5;  
FIG. 3 is an enlarged, fragmentary view of the lower, front, left section thereof;  
FIG. 4 is an enlarged, fragmentary view of the lower, front, central section thereof;  
FIG. 5 is an enlarged, fragmentary view of the lower, front, right section thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof;  
FIG. 9 is a left side elevation view thereof; and,  
FIG. 10 is a right side elevation view thereof.













