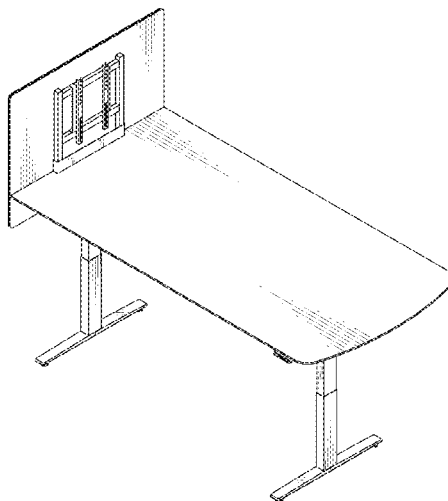
(57) **CLAIM**

The ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the right side of a table.
FIG. 2 is a perspective view from the left side thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a left side elevation view thereof.
FIG. 7 is a top plan view thereof.
FIG. 8 is a bottom plan view thereof.
FIG. 9 is a cross-sectional view taken along the line 9-9 in FIG. 5, which omits the internal structure.
FIG. 10 is a cross-sectional view taken along the line 10-10 in FIG. 5.
FIG. 11 is a perspective view of the table in an alternate lower position; and,
FIG. 12 is a perspective view showing the table in use.
The broken lines in FIG. 12 illustrate environment and form no part of the claimed design.

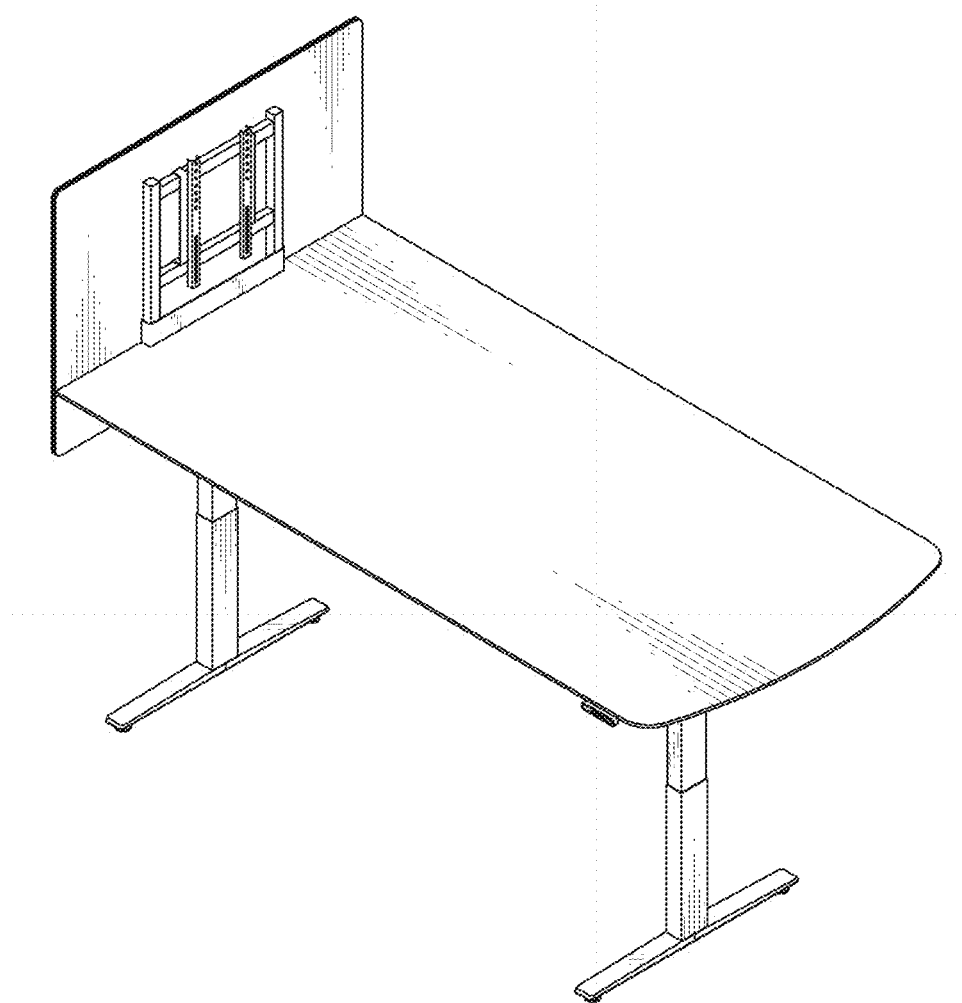

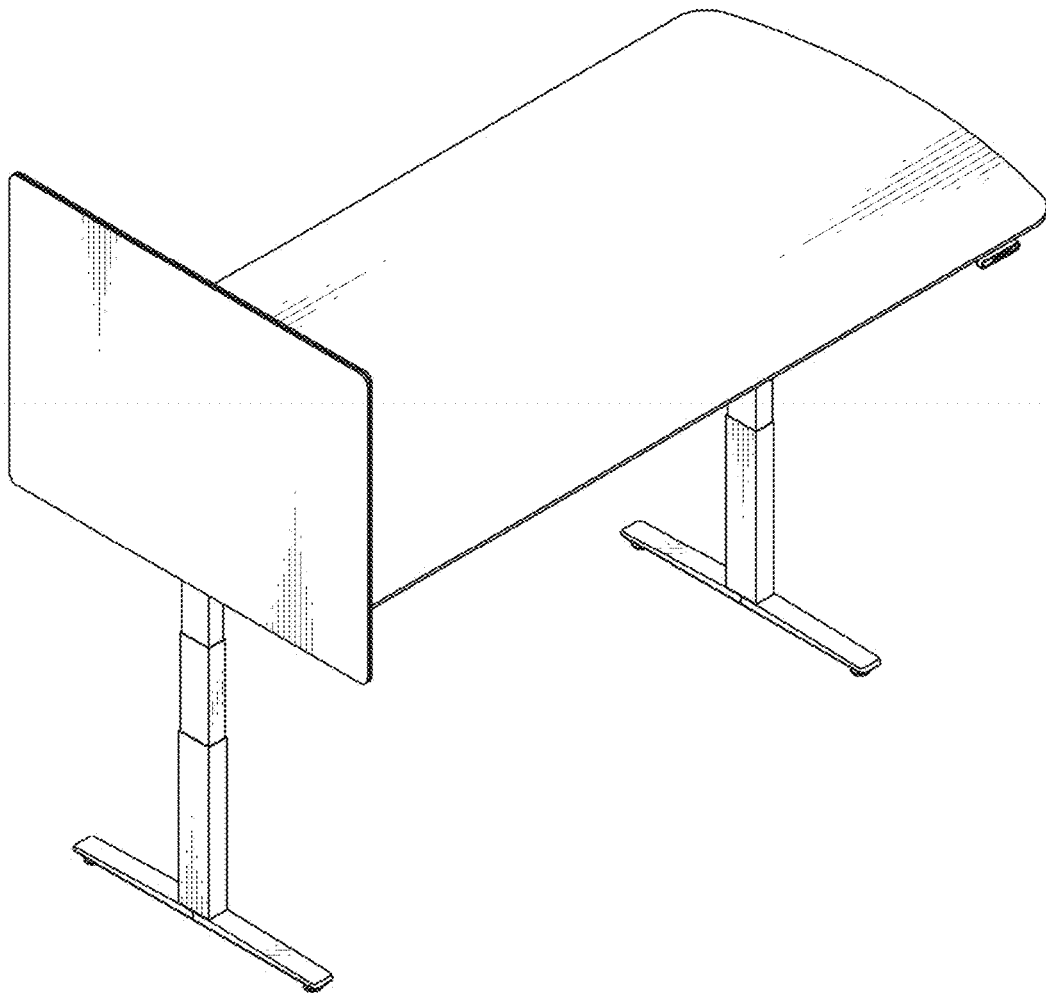

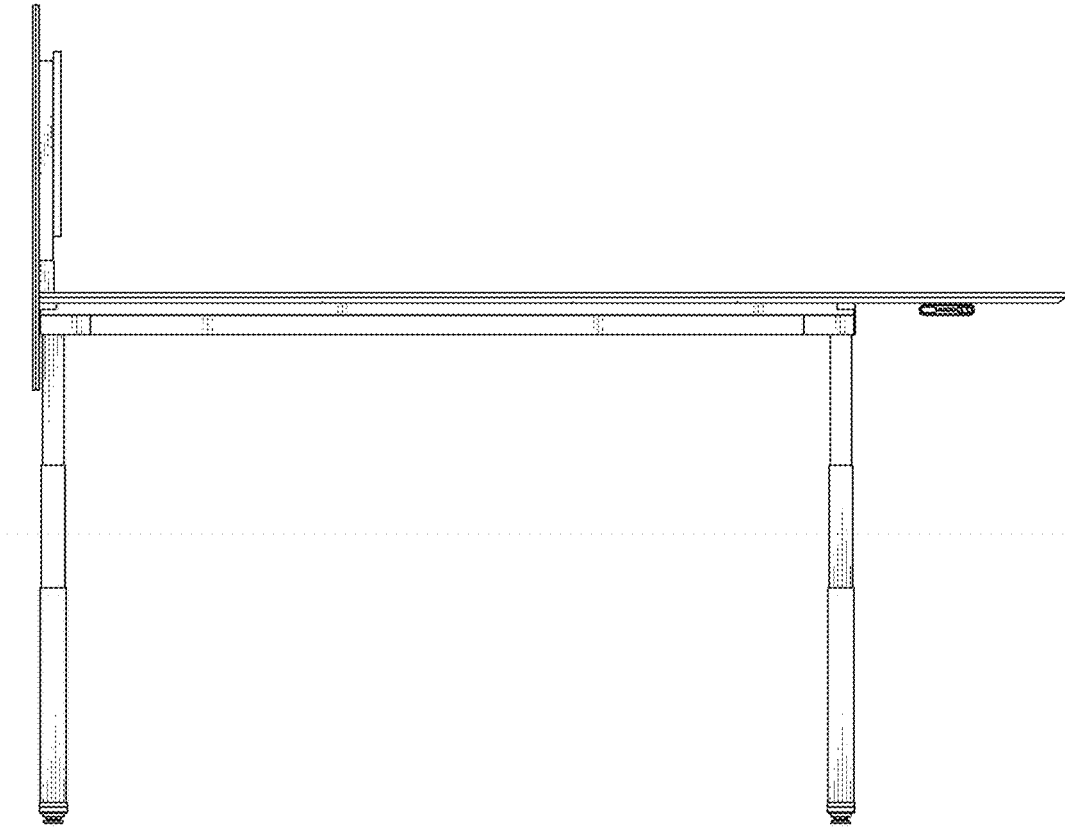

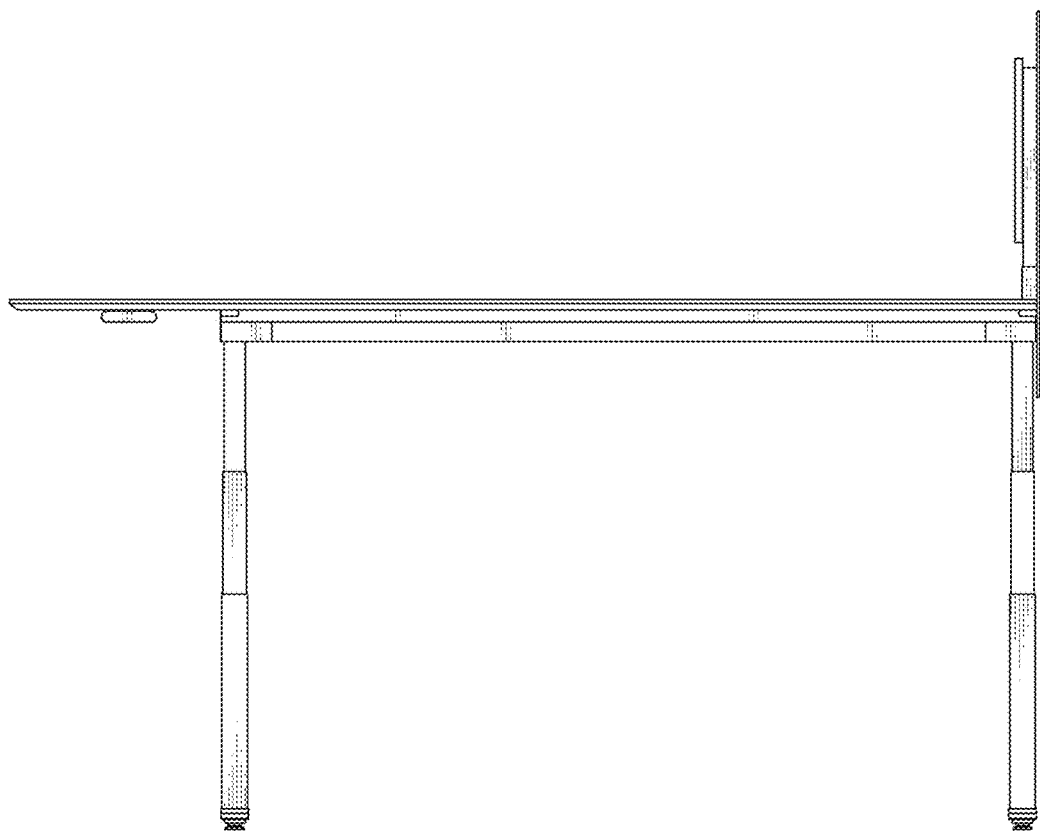

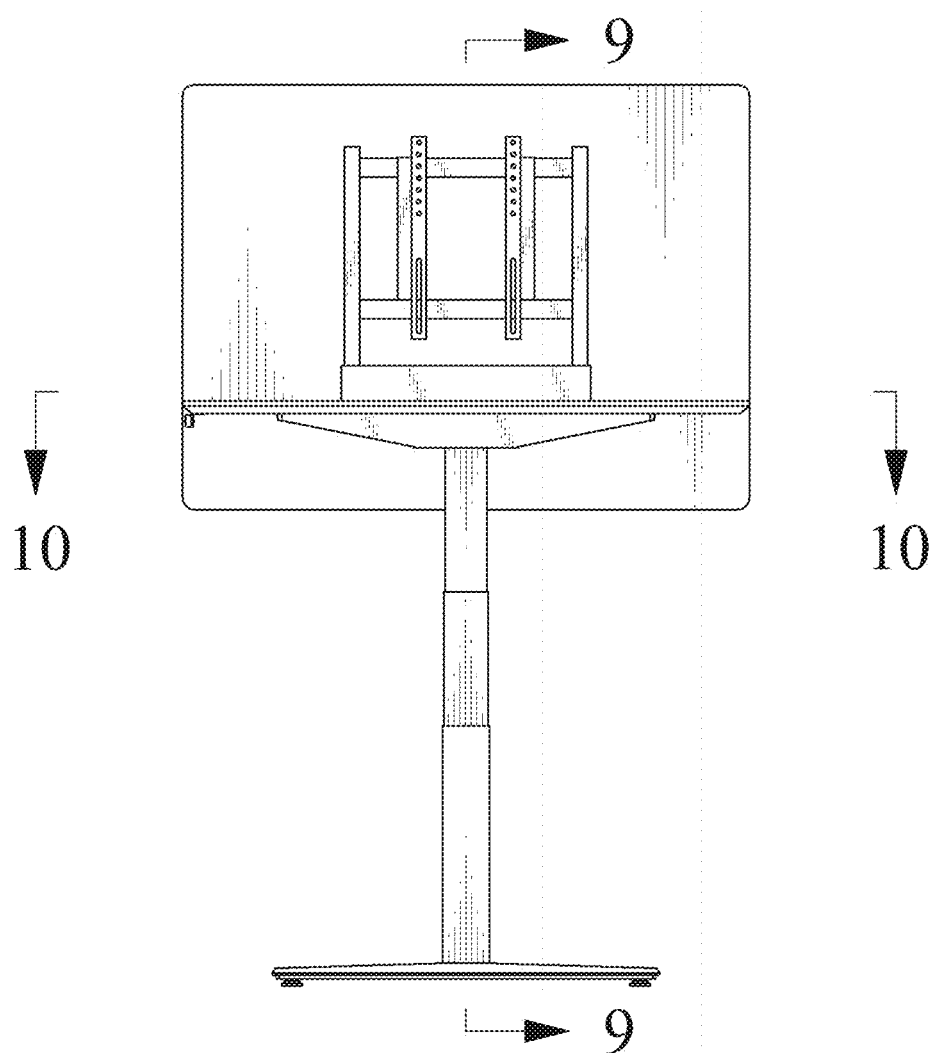

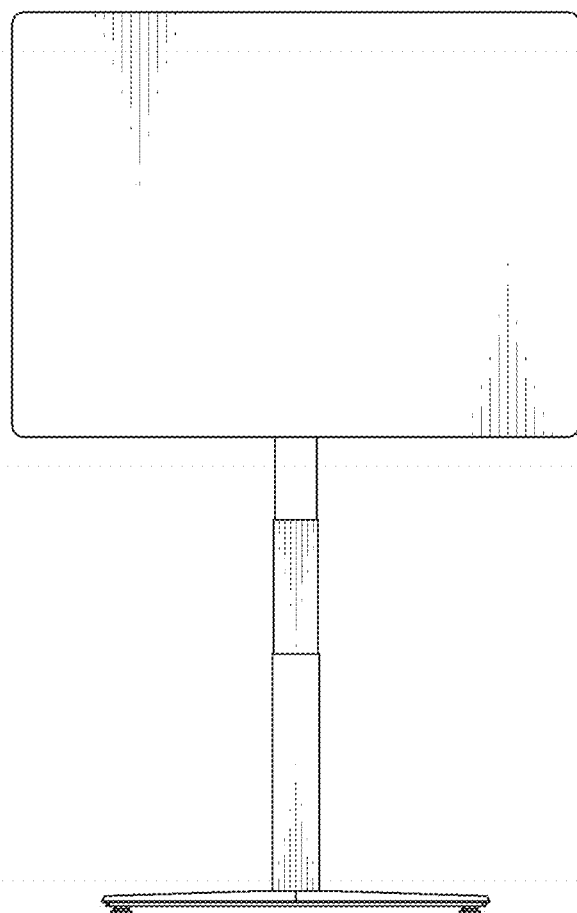

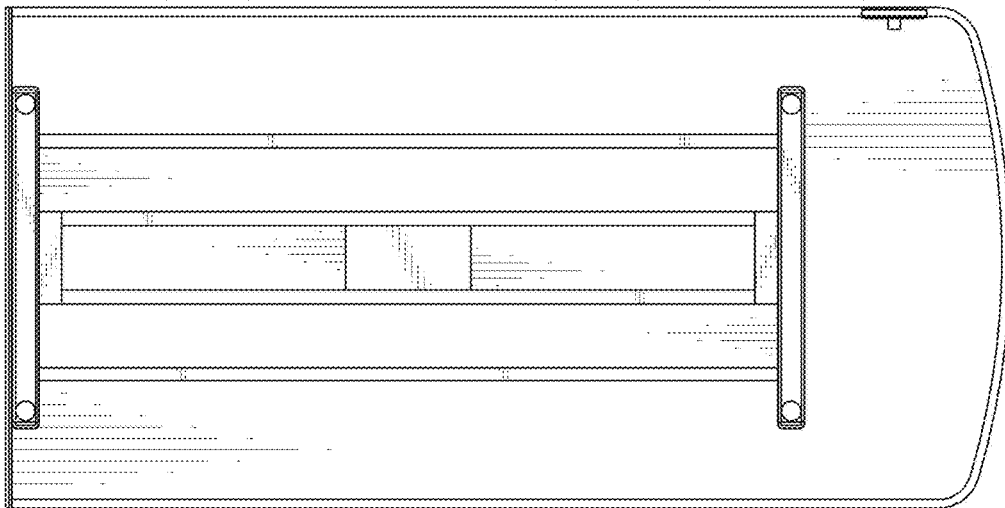

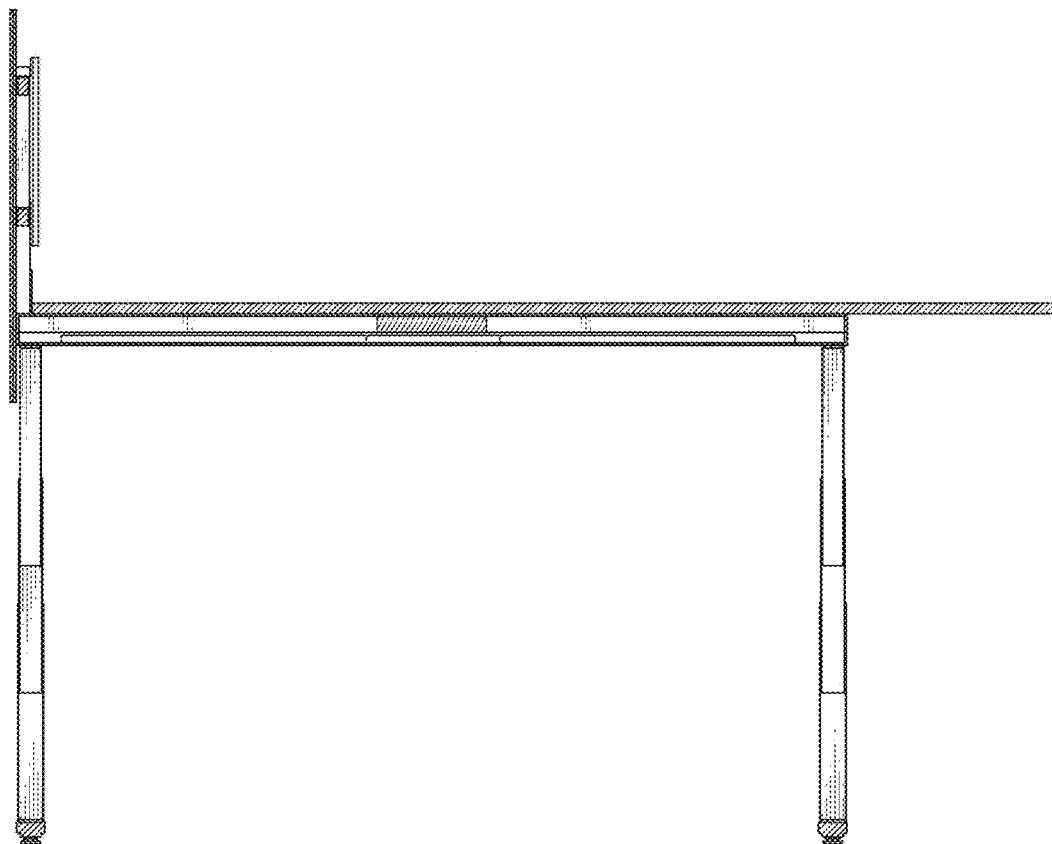

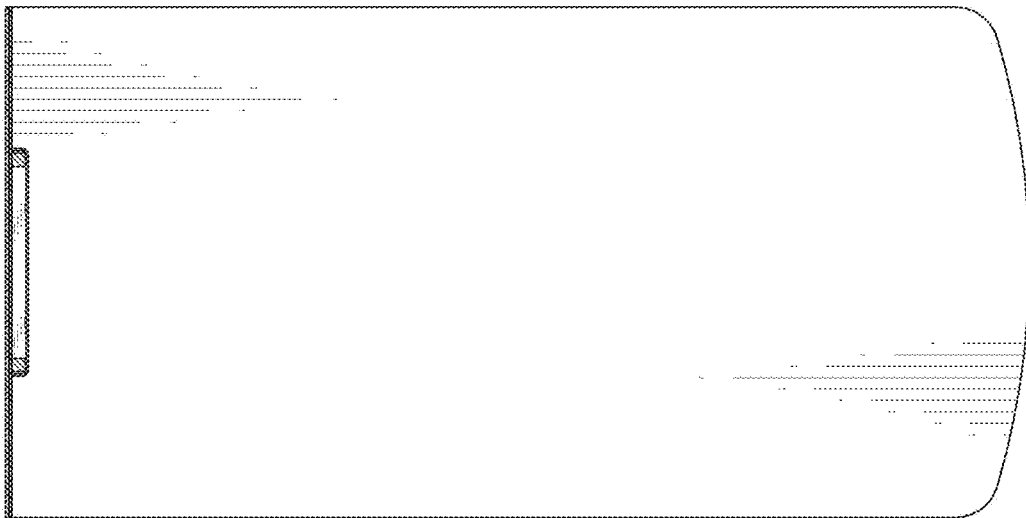

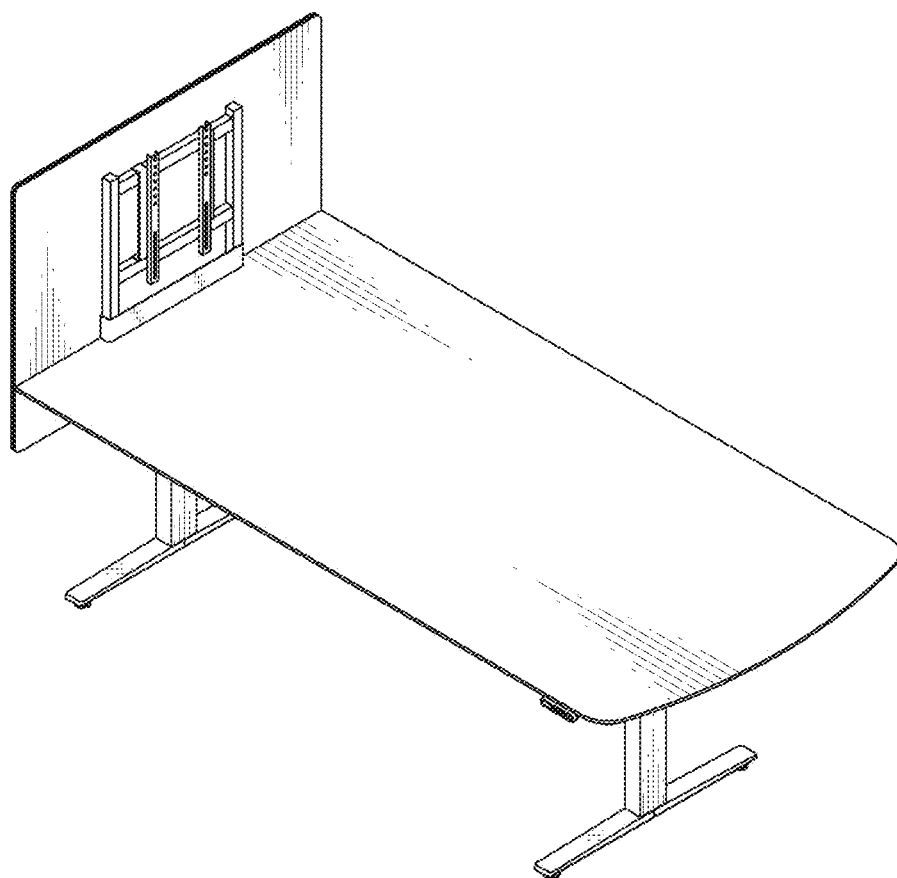
