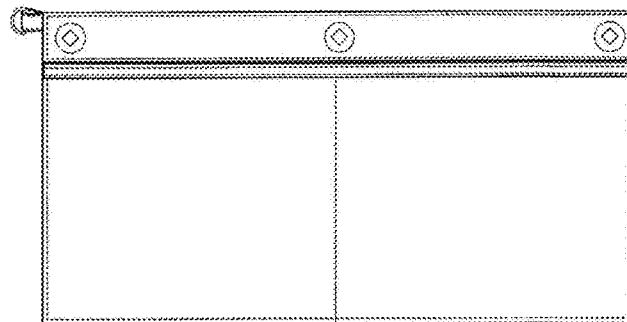
The ornamental design for a handbag organizer insert, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a handbag organizer insert according to a first embodiment of our new design;

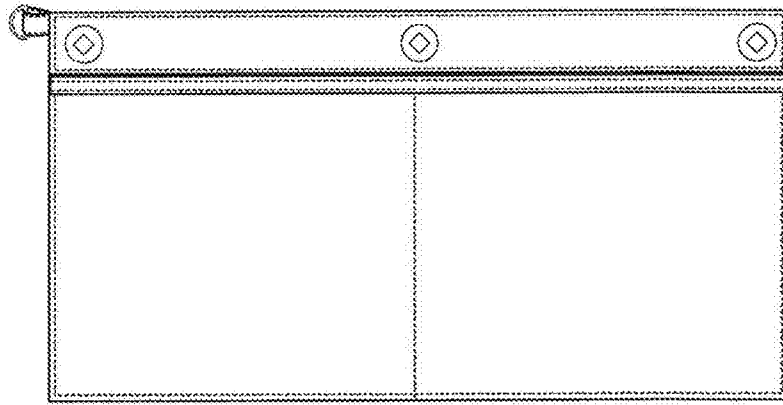

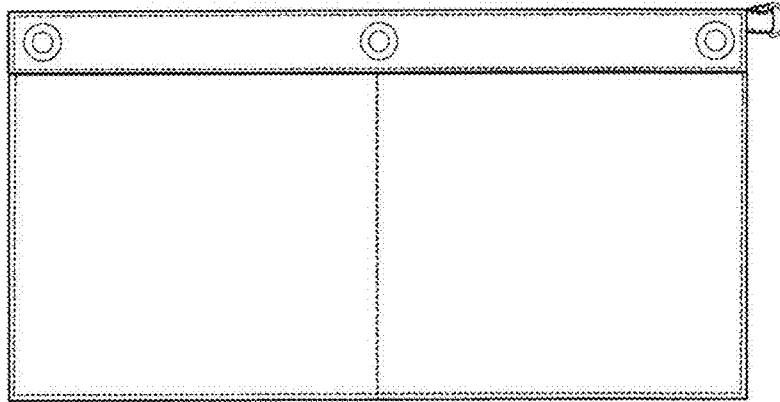

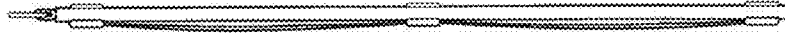

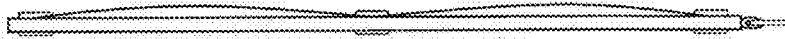

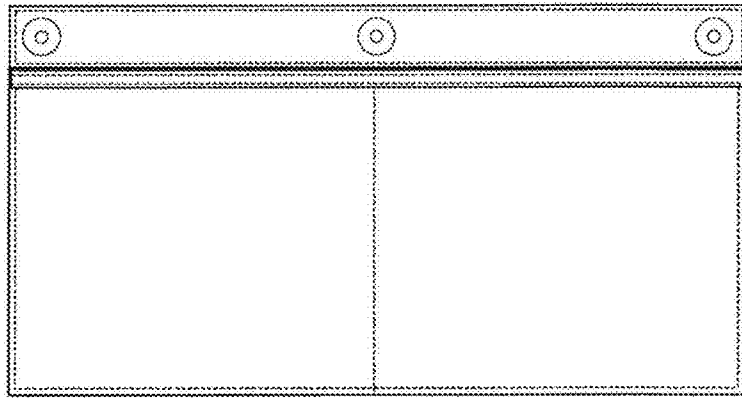

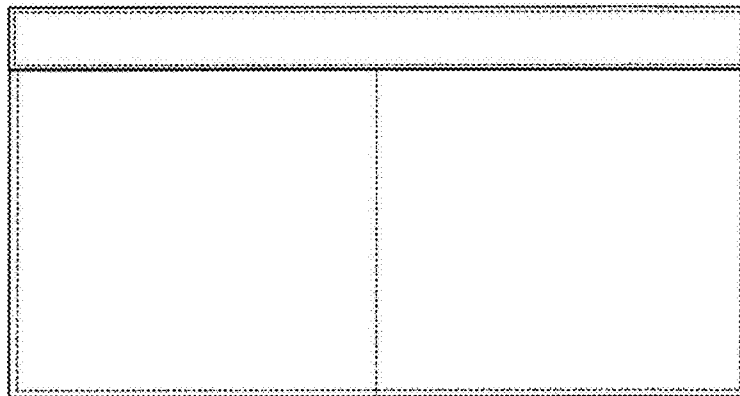

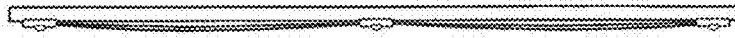

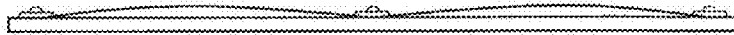

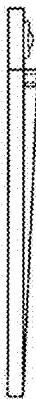
