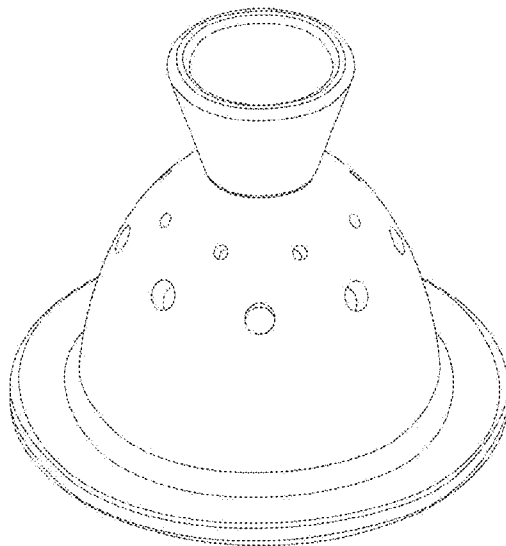
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the brochette holder according to my design;
FIG. 2 is a bottom perspective view of the brochette holder shown in FIG. 1;
FIG. 3 is an elevation view of the brochette holder shown in FIG. 1, the left, right, front and rear views being identical; and,

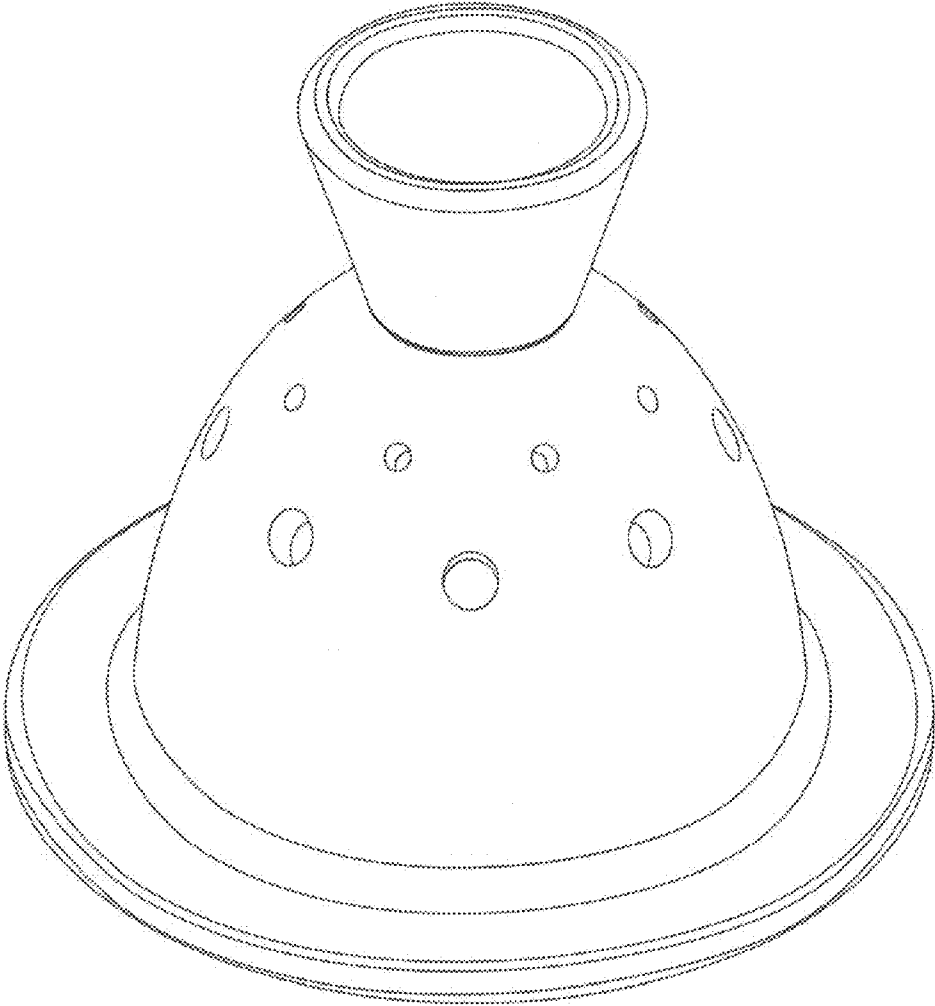

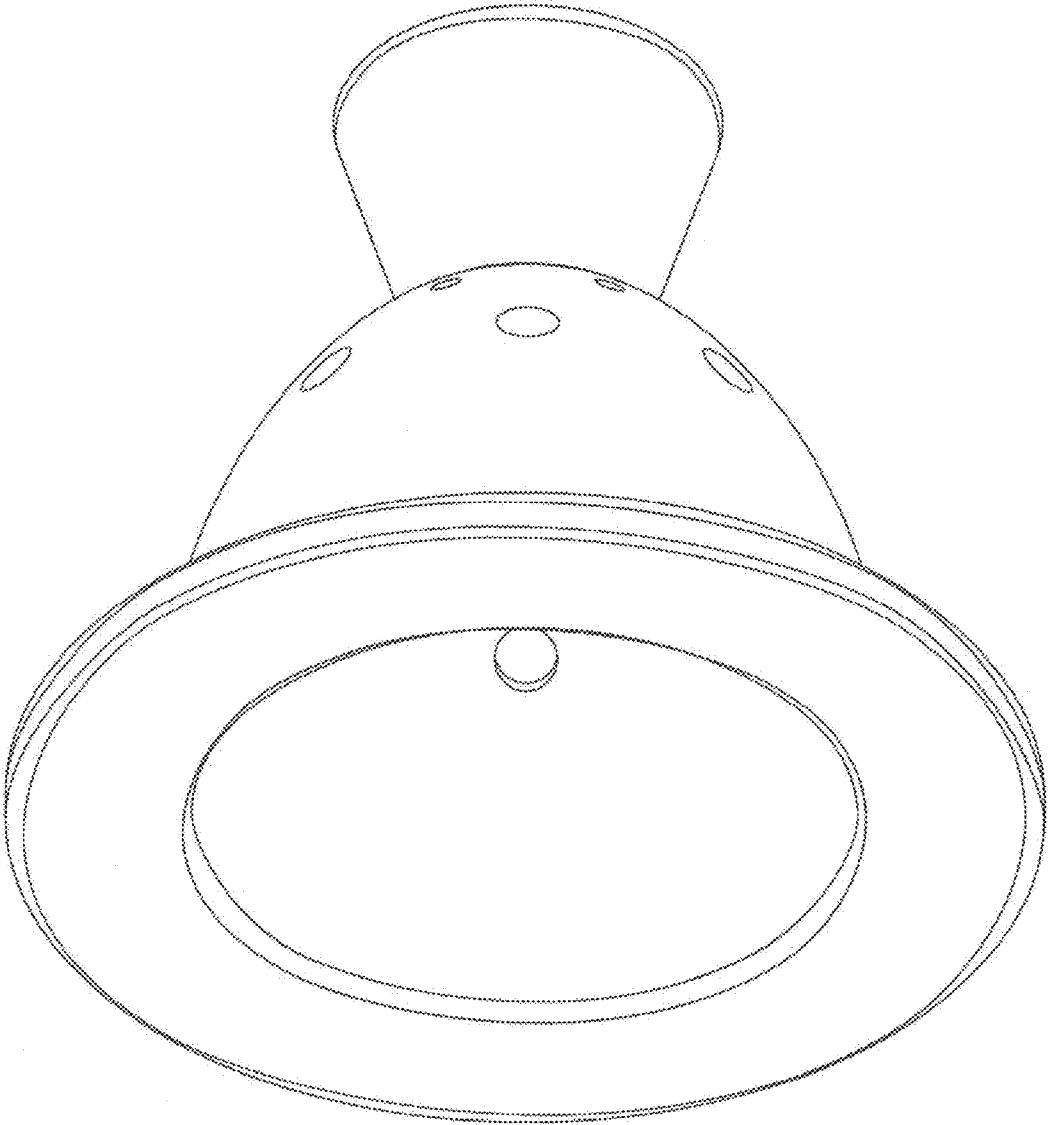

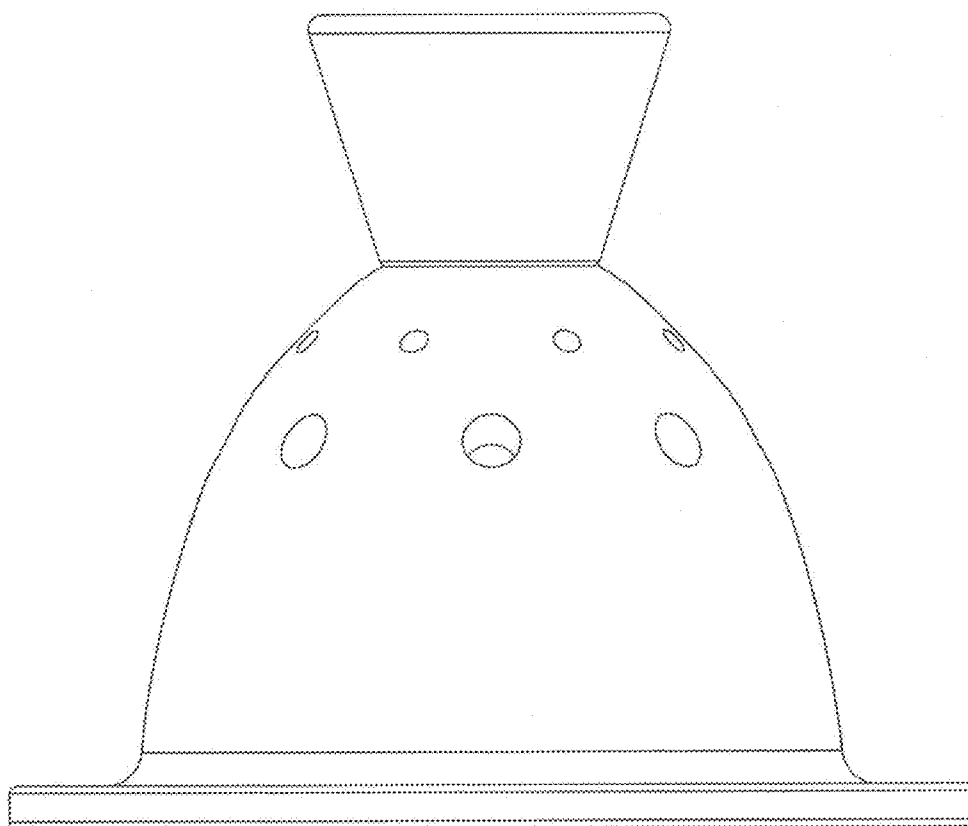

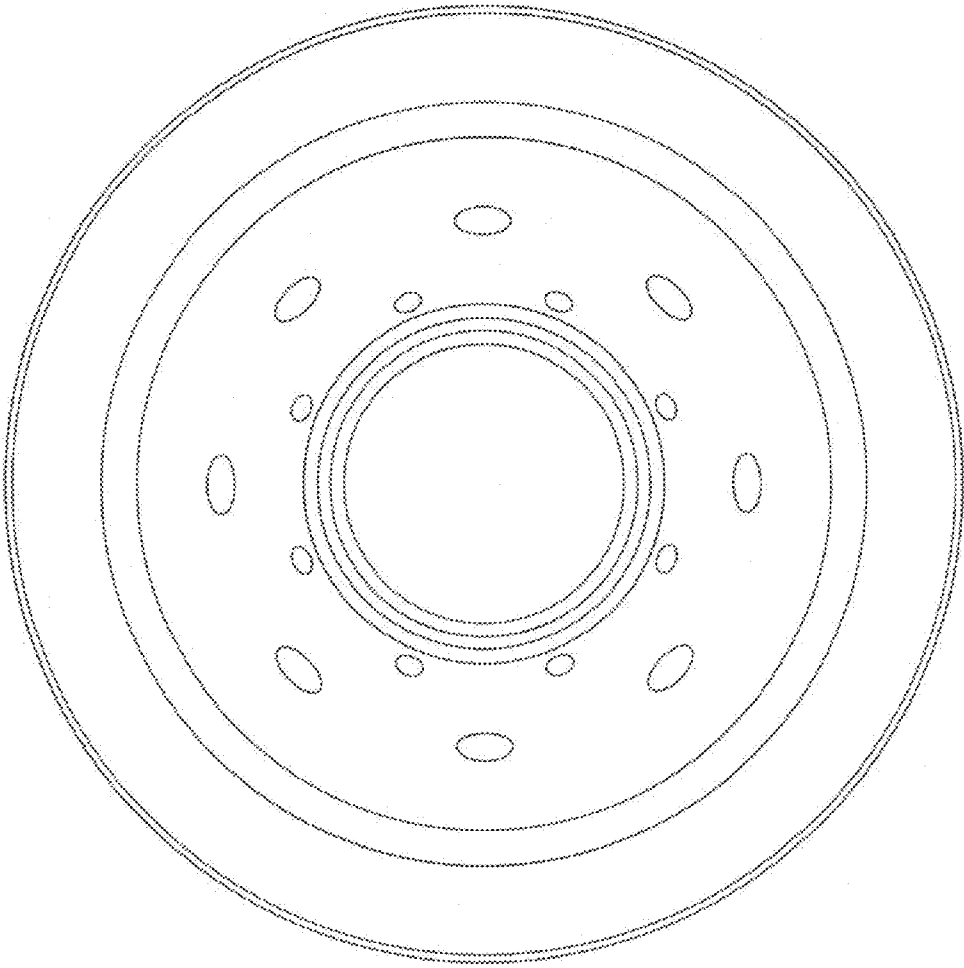
