**CLAIM**



(57) The ornamental design for a “sound bar speaker,” as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a “sound bar speaker” showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a perspective view viewed from another visual angle.

The sound bar speaker is shown with symbolic breaks in its length in the FIGS. 1-3 and FIGS. 6-8 drawing views. It is understood that patentability is based only on those portions of the article that are shown in solid lines, and the appearance of any portion of the article between the break lines forms no part of the claimed design.
















