FIG. 13 is a first side view of the embodiment of FIG. 9;

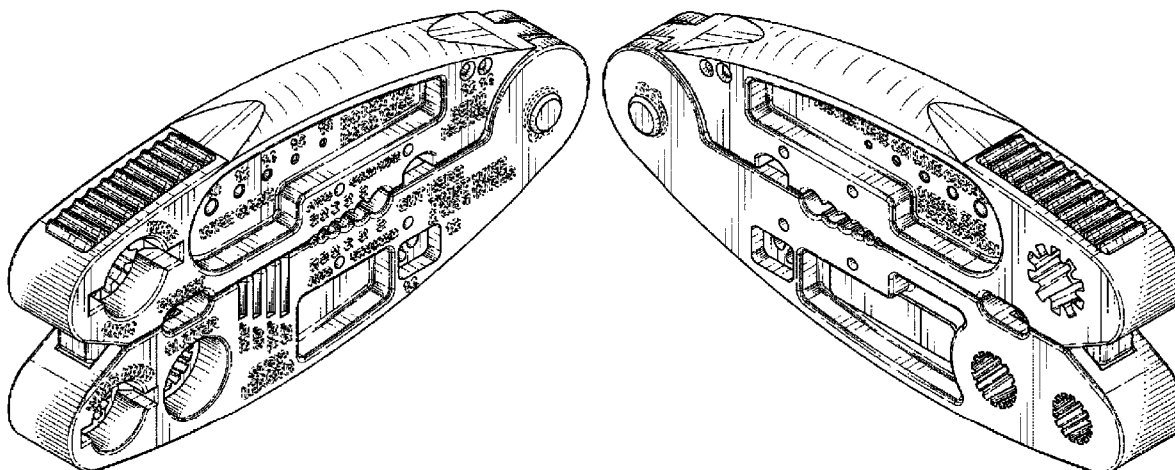
FIG. 14 is a second side view of the embodiment of FIG. 9;

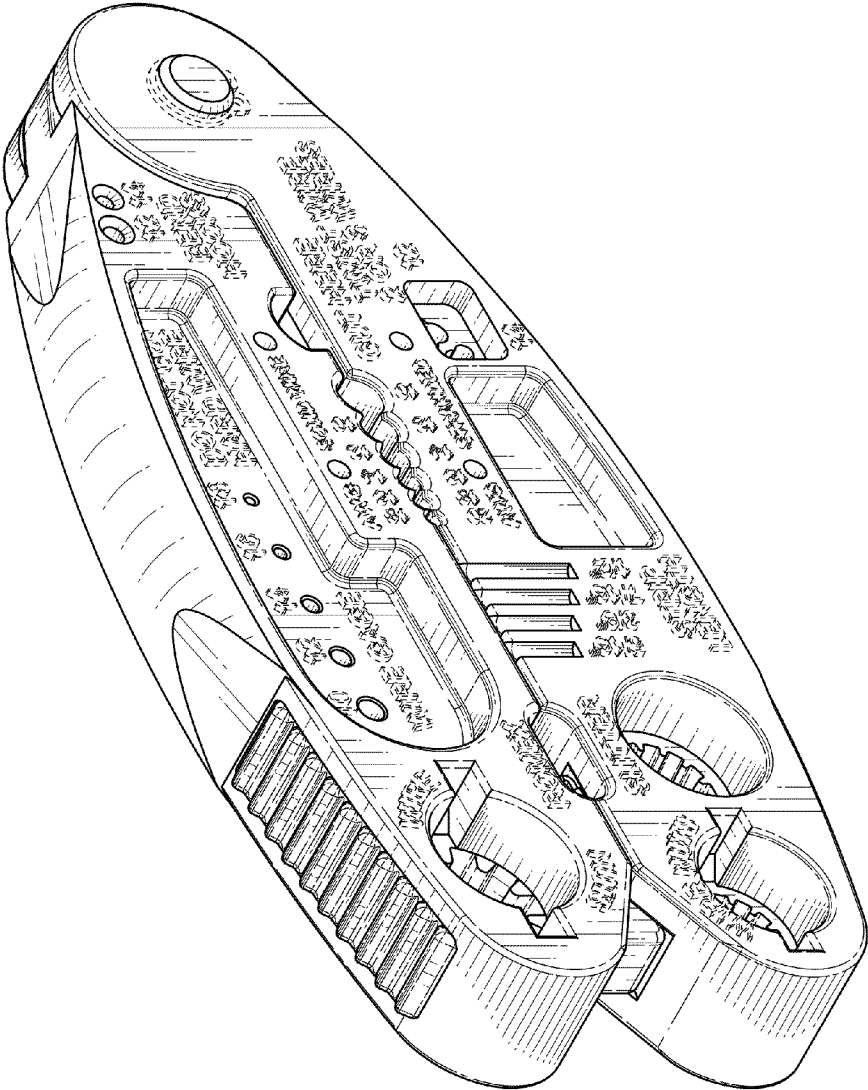

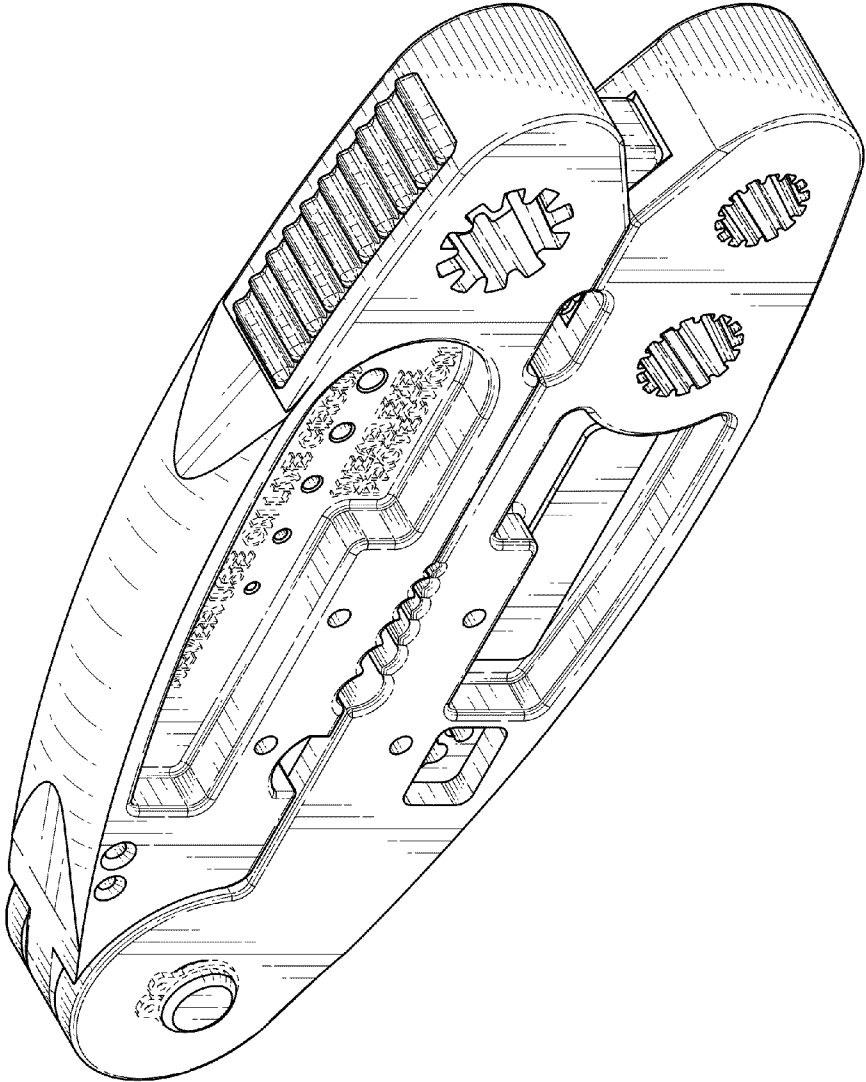

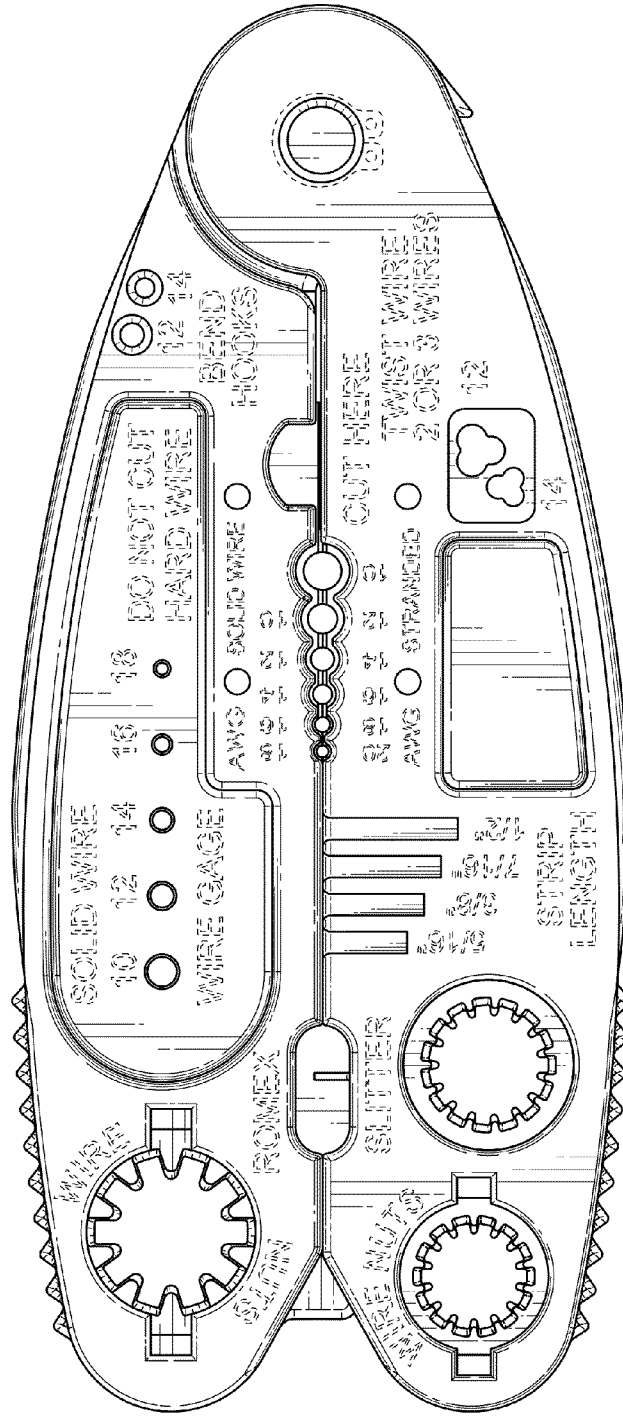

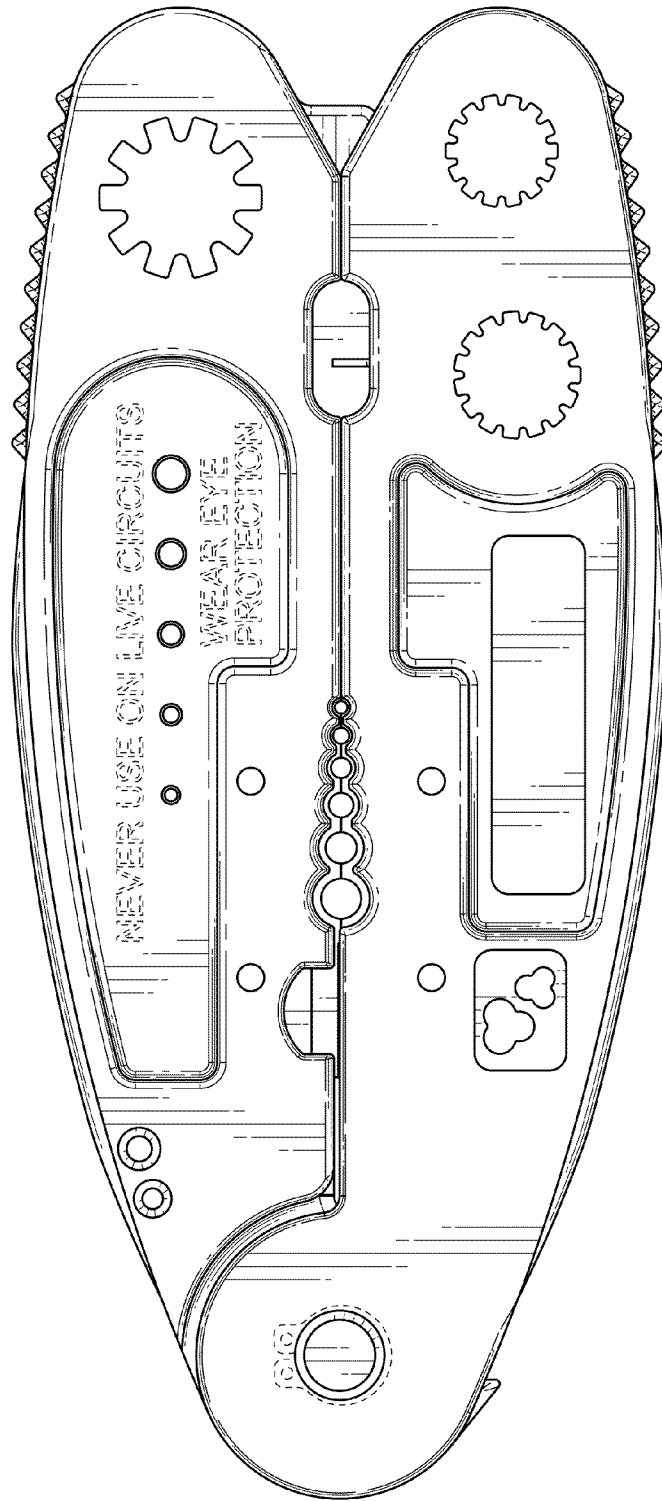

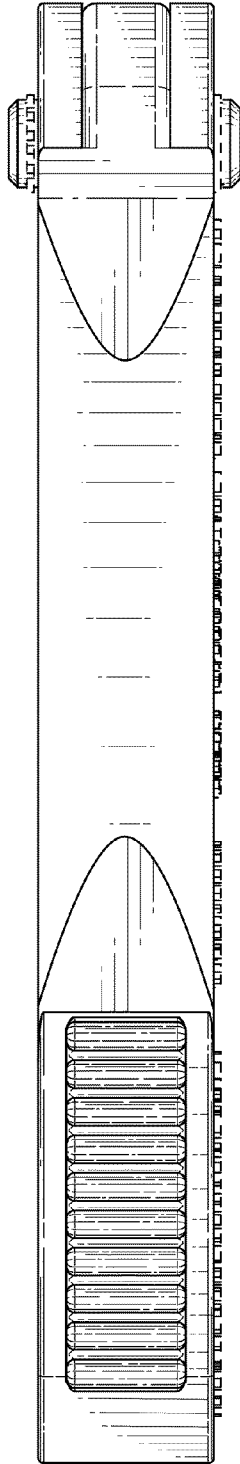

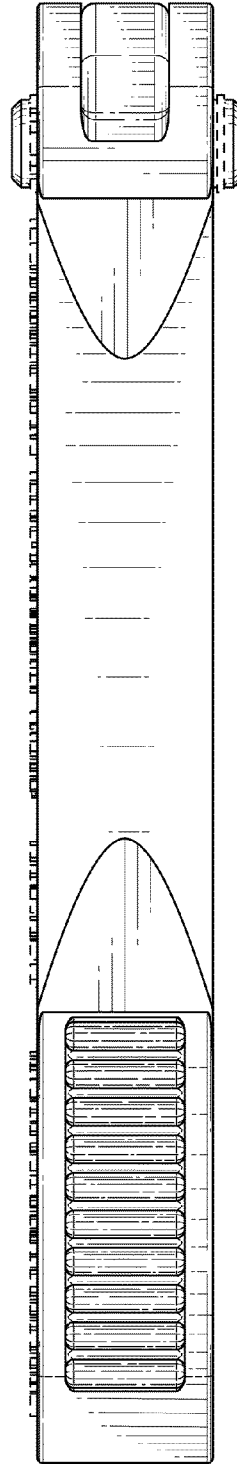

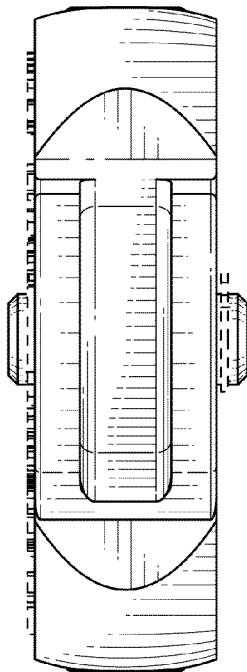

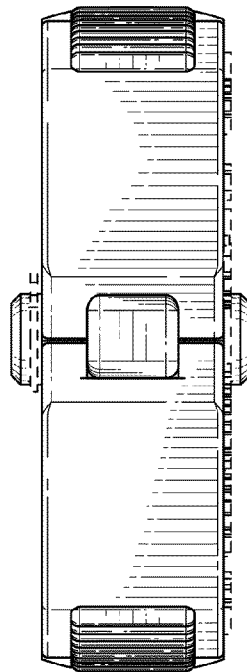

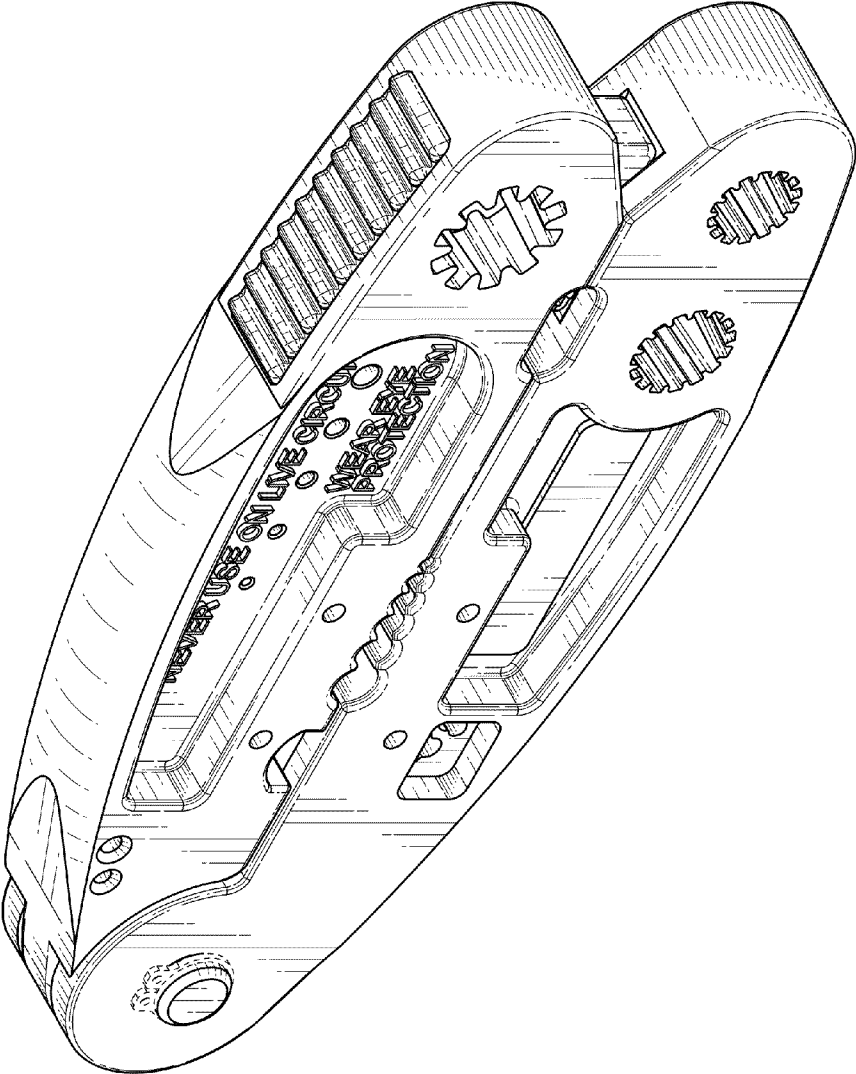

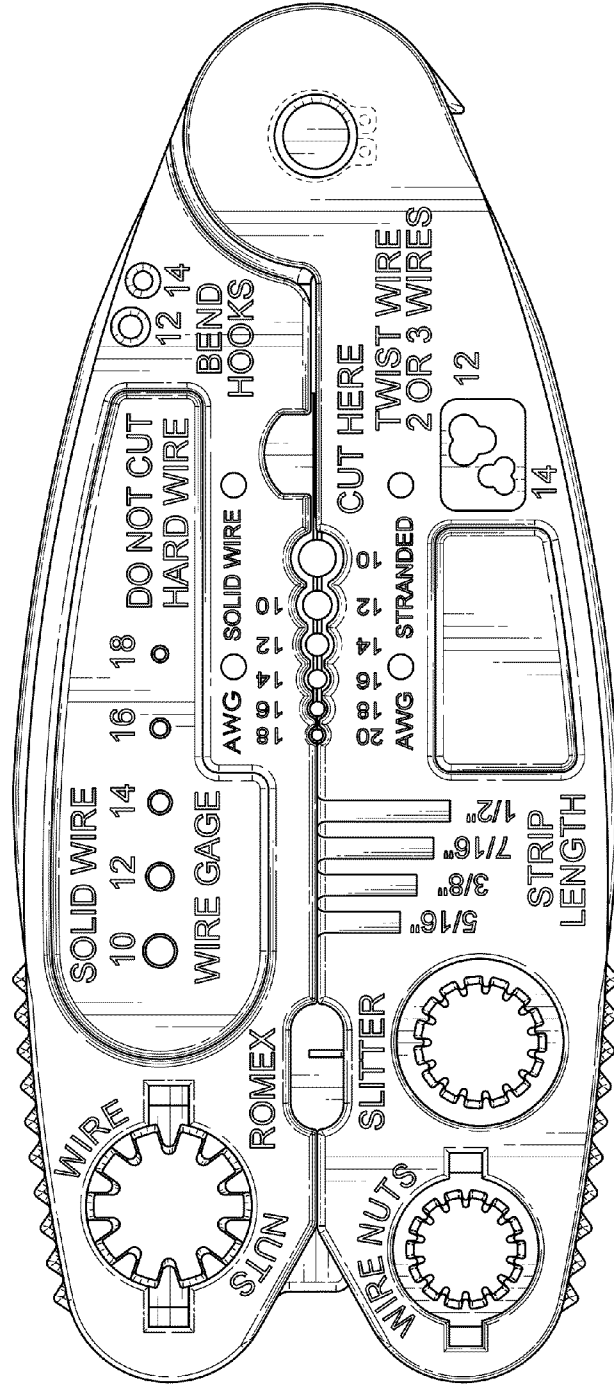

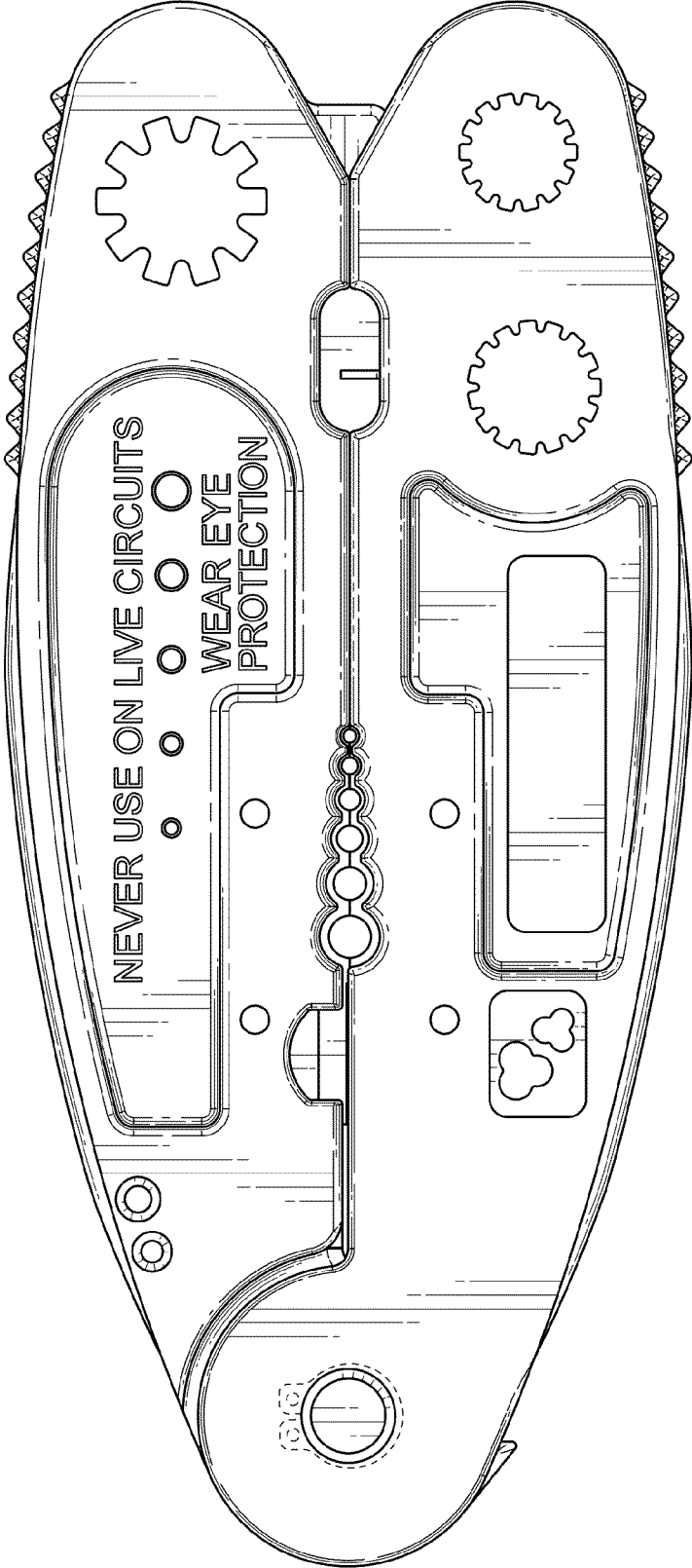

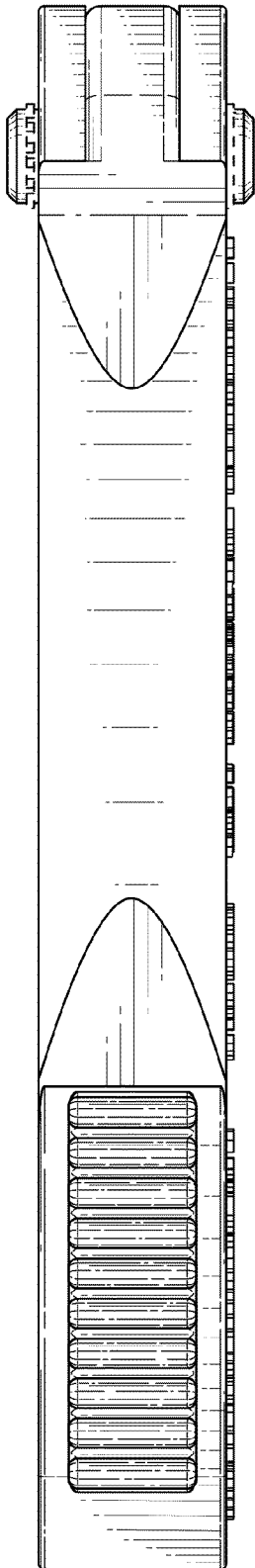

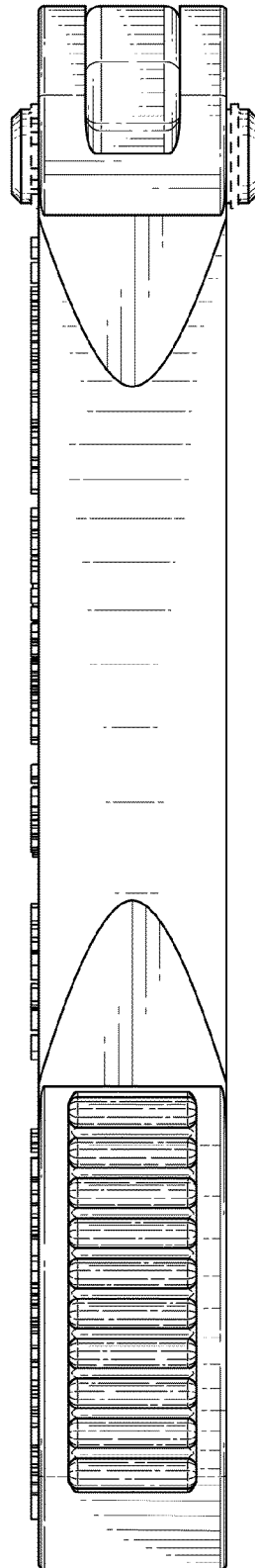

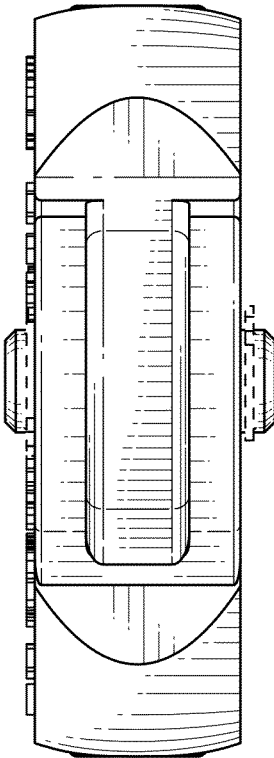

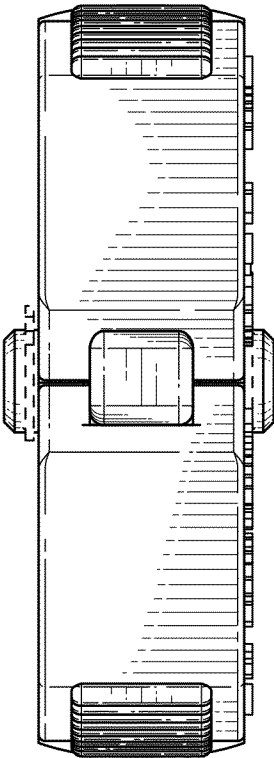
