
Reproduction **1.1** shows the design with a rectangular base body with an hourglass-shaped absorbent pad and a transverse stripe being attached transversely at the base body and laterally overlapping said base body by forming rectangular side wings from a top view; reproduction **1.2** shows the design with a rectangular base body with an hourglass-shaped absorbent pad and a transverse stripe being attached transversely at the base body and laterally overlapping said base body by forming rectangular side wings from a bottom view; reproduction **2.1** shows the design with a rectangular base body with an hourglass-shaped absorbent pad and rectangular side wings being attached at the long sides of said base body from a top view; reproduction **2.2** shows the design with a rectangular base body with an hourglass-shaped absorbent pad and rectangular side wings being attached at the long sides of said base body from a bottom view.






