

CLAIM

The ornamental design for a deck umbrella mount, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the deck umbrella mount as installed on a deck railing; FIG. 2 is a front perspective view of the deck umbrella mount; FIG. 3 is a side perspective view of an embodiment of the deck umbrella mount; FIG. 4 is a rear perspective view of the deck umbrella mount; FIG. 5 is a side perspective view of the deck umbrella mount; FIG. 6 is a bottom perspective view of the deck umbrella mount; and, FIG. 7 is a top perspective view of the deck umbrella mount. The broken lines in the figures represent environment and form no part of the claimed design.




