The ornamental design for a storage box, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a storage box showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left view thereof;
FIG. 5 is a right view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

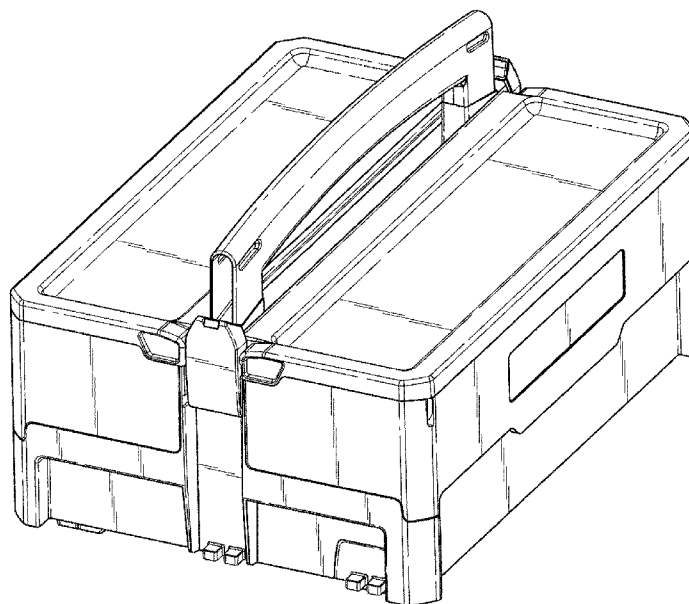

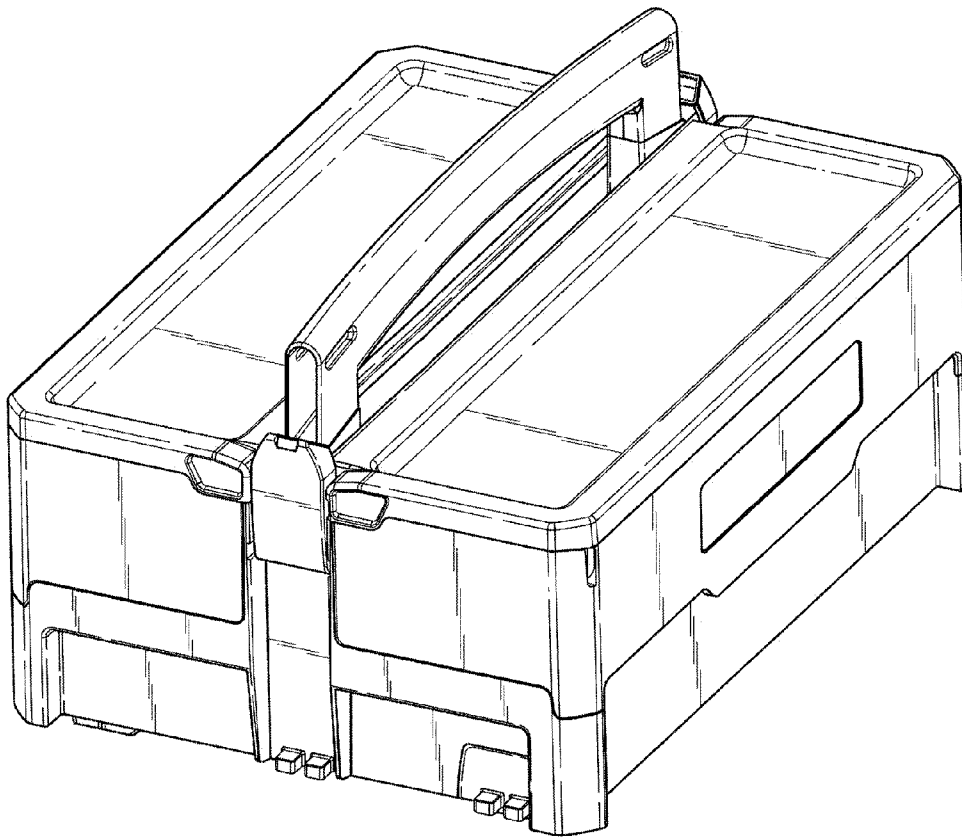

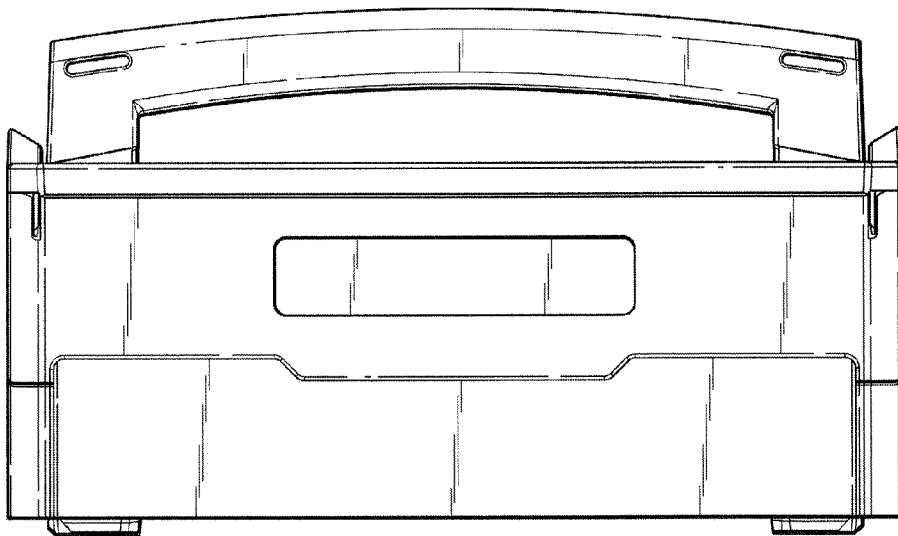

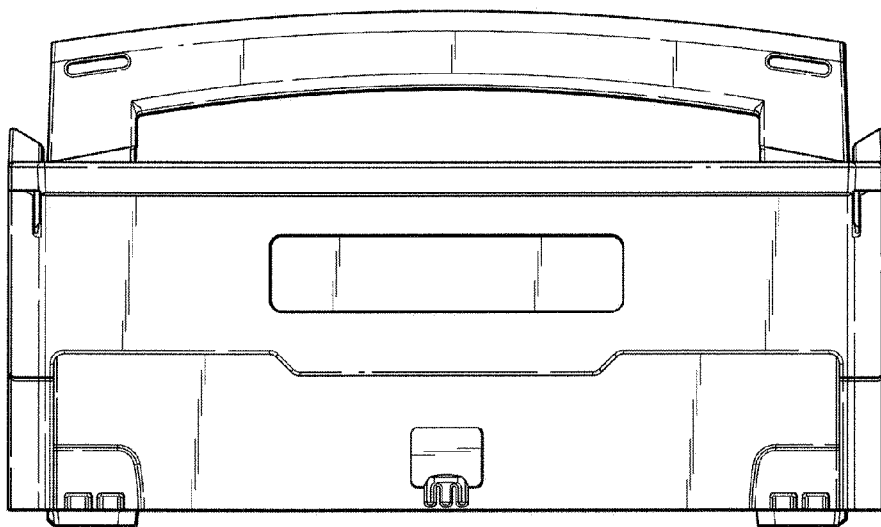

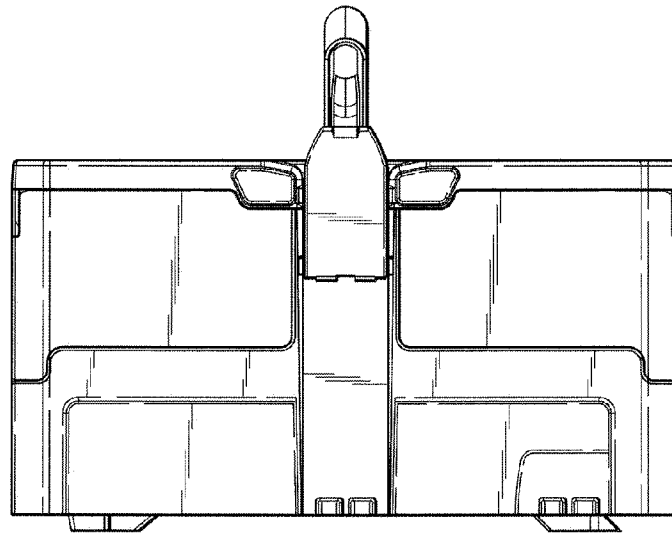

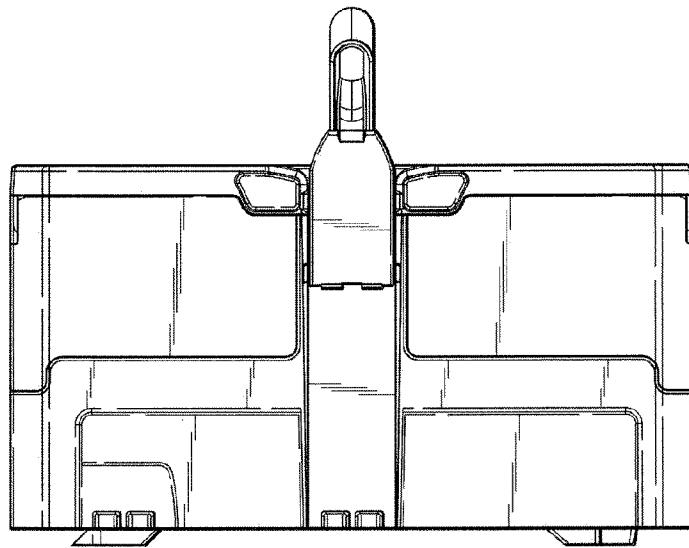

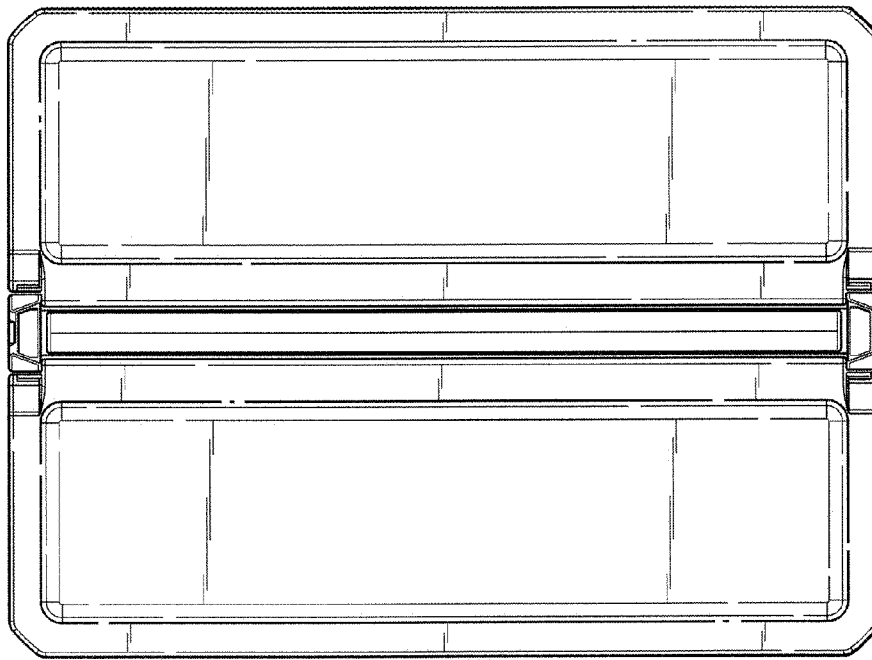
