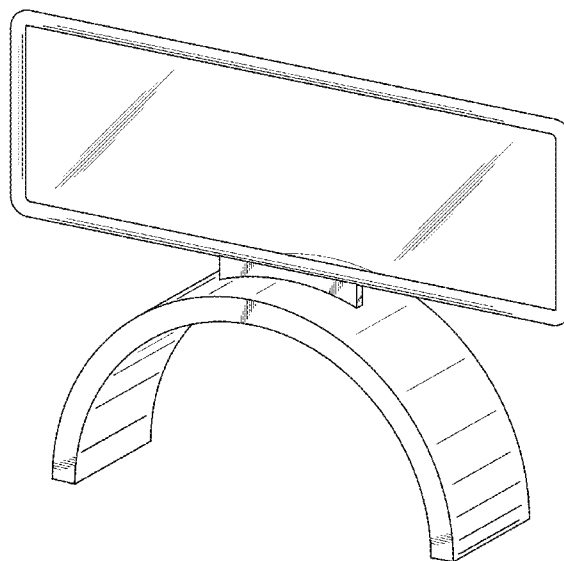

The ornamental design for an attachable sight for firearms, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an attachable sight for fire-  
arms;  
FIG. 2 is a front view thereof, wherein a rear view is a mirror  
image of the front view;  
FIG. 3 is a left-hand side view thereof, wherein a right-hand  
side view is a mirror image of the left-hand side view;  
FIG. 4 is a top view thereof; and,  
FIG. 5 is a bottom view thereof.

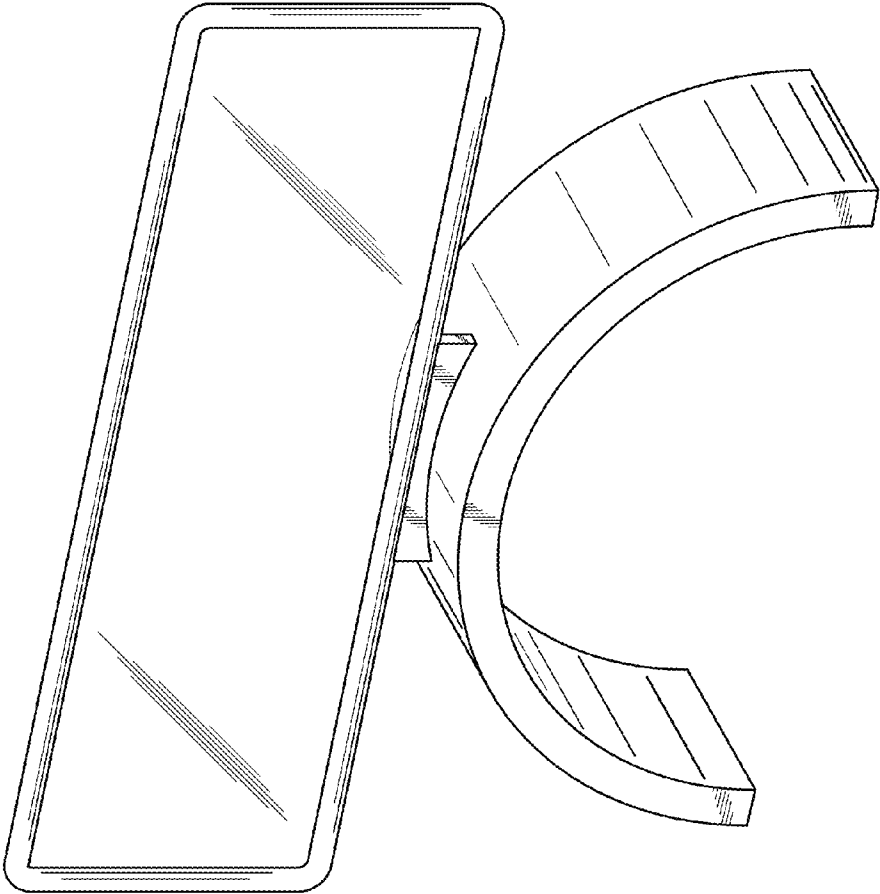

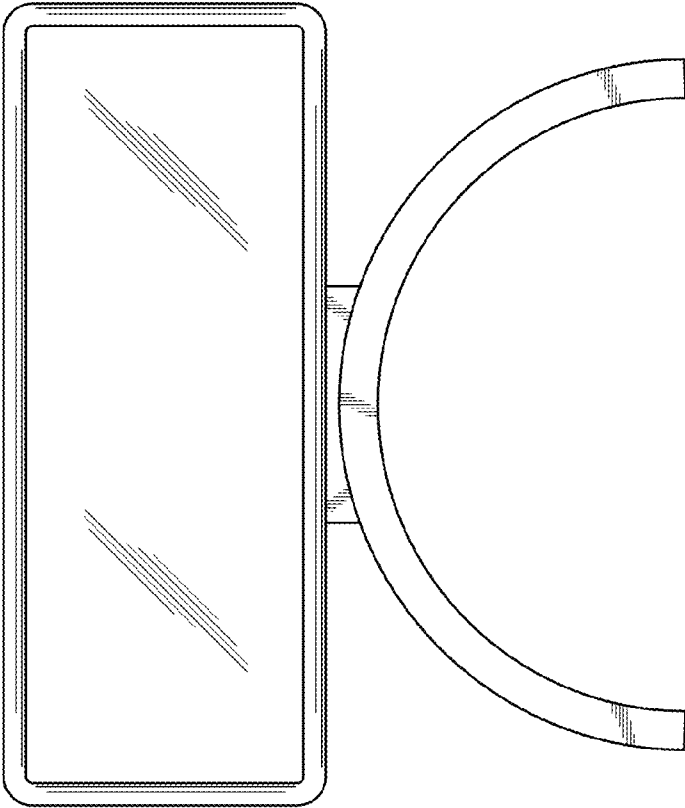

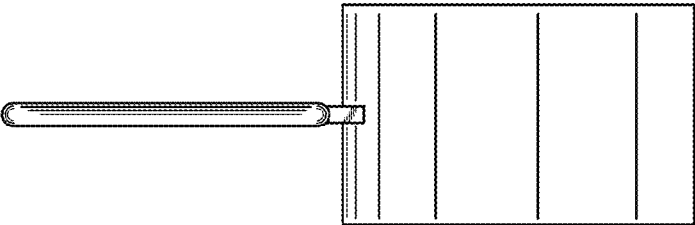

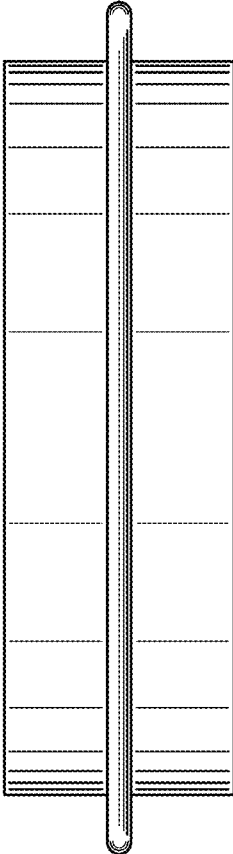

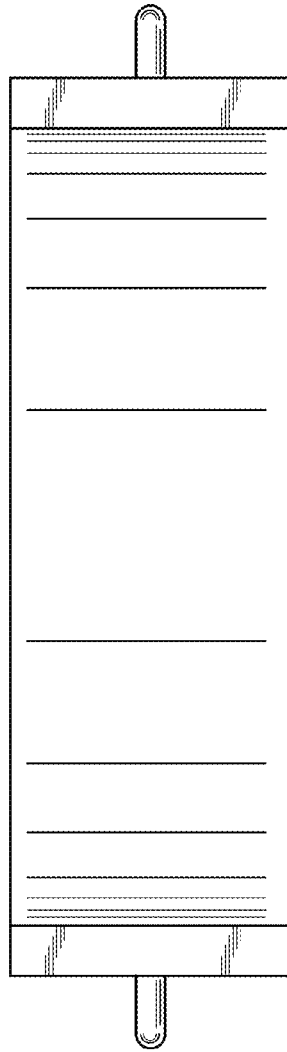
